34 pilgrims from Maharashtra stranded in Iran

Three fresh cases of coronavirus in Delhi, Telengana and Rajasthan

Since Iran has suspended flights to Asian countries including India and China, following outbreak of coronavirus, 34 pilgrims (most of them senior citizens) from Sangli, Kolhapur, Solapur and other districts of Maharashtra are stranded in Tehran with no chance of they returning to India soon. The pilgrims reached Tehran on 21 February, as part of 12 days package tour organised by "Saad Travel". From Tehran they wanted to travel to Najaf (Al-Najaf al-Ashraf, also known as Banigia is a city in central-south Irac about 160 km south of Baghdad). Al-Najaf is site of the burial place of Muhammad's son in law and cousin, Imam 'Alî ibn Abî Tâlib. The city is a centre of pilgrimage throughout the Shi'ite Islamic world. However the pilgrims could not proceed to Iraq and remained stranded in

Tehran.
The pilgrims wanted to return to India on 28 February, but in absence of flights they could not travel to India and are stranded in Tehran since then. The hotels where they were lodged earlier, are reluctant to give them accommodation, some of the pilgrims communicated their relatives through video caller.

In response to their message for rescue, NCP MP Supriya Sule has sought intervention of Union External Affairs Minister Subrahmanyam Jaishankar to rescue the stranded pilgrims. In the letter dated 29 February to Jaishanker, she has forwarded full details of the pilgrims including their names, passport numbers etc. (A copy is in possession of IT) and sought his immediate attention since all the pilgrims are senior citizens. Another MP Sadashiv Mandalik (Shiv Sena) has also forwarded similar letter to Jaishankar seeking his intervention in In another development.

three patients suspected to be infected by Coronavirus have been found in Delhi. Jaipur (Rajasthan) and Telangana. The first two passengers travelled from Italy to Delhi and Jaipur respectively, while the patient in Telangana arrived from Dubai. They have been admitted to the hospitals and their health condition is being closely monitored. The patient admitted to Sawai

national admitted to Sawai Mansingh Hospital in Jaipur has tested positive.

Similarly a 36 year youth who had returned to Payyanur (Kerala) from Malaysia died on Friday. He was admitted to the Ernakulam Govt Hospital. He was suffering from Pneumonia and had tested negative for coronavirus. The doctors are not yet clear, whether he died of coronavirus.

In the meanwhile, Directorate General of Civil Aviation (DGCA) has ordered the country's international airports to extend passenger screening to all travellers arriving from Nepal, Vietnam, Indonesia and Malaysia. Airports in India were previously directed to only screen passengers arriving from China, Hong Kong, Japan, South Korea, Thailand and Singapore. This move is aimed at limiting

the spread of the Covid-19 coronavirus, which has pread to 32 countries so far. DGCA stated that the screening should be conducted 'once the passengers step out of the specific locations at all the airports'. They will have to fill in self-declaration forms, according to the instructions of the health and family welfare ministry.

Airlines have also been directed to conduct in-flight announcements on incoming flights from the above countries. Last month, many airports around the world. including in India and the US, had started screening passengers arriving from China and Hongkong.

Empowering the women Manipur's perspectives

With the month of March begins the world once more starts celebrating International Women's day under the theme 'Each for Equal'. The day is being celebrated across the world to show respect to the women community and also to uplift them from the crunch of the male dominated society.

Every year Manipur joined the world community in celebrating the International Women's Day. This year the state government seems to have realized the need for respect for women in the

Well the observation of the day has its root at New York The mass protest of the women garment worker in 1908 demanding improvement of their working condition had brought significant changes to the condition of women. Commemorating the day the United States of America observed February 28 as the National Women's Day in 2009.

Since then various uprising across the European countries took place. The United Nations later deeply felt the need for recognizing a day particularly for women and since 1975, the March 8 has been observing as the International Day across the globe.
Like every nations across the globe, the erstwhile kingdom

of Manipur had witnessed various historic events. The first Nupi lal of 1904 and the 2nd Nupi Lal of 1939, are some of the events where Manipuri women contribution towards bringing

a change in the society is worth remembering.
Unlike the western countries which celebrate International Women's Day, the kind of observation being taken place in a by various organizations in the state is rather to find a solution to the problems being faced by the women of today's Manipuri society. And unlike in the mainland Indian states and other developed and developing countries, the issues are of the

women here in Manipur are very different.

There are certain issues like domestic violence, polygamy, rape and crime against women, issues of widows, orphan girl child may be somewhat similar in almost all human society. But the kind of subjugation being faced by the women of Manipur under the draconian laws and the women becoming most venerable object during conflict between non state actors

and state actors is serious.

Women of Manipur have always been in the forefront at every historical event. Manipuri women had been known for their contribution in supporting the society in economy upliftment and societal changes. History proves it. But one thing that confuse to many is why the women still are the seems to be lacking far behind their male counterpart both in education and participation in the governance. As per record female literacy rate of Manipur is only 65, 46%, when the literacy rate for male is 82.14%. This means that women are still seen deprived in education.

On the other hand Manipur's societal structure is always seen as male dominating society even after knowing that women have been always in the forefront - whether it may be fighting against immoral activities, drugs or wrongs of the government besides taking active role in supporting their respective family economically. But when it comes to rituals women are still forbidden to take the lead role. For example women are not allowed to do Keiyna dan during the marriage of her daughter when she is the only parents left. A widow with only daughters still has to wait some male relative to perform the last rite of her husband or near and dear one. In both Sanamahi and Manipuri Veishnavite culture women are always told to follow the male. They are not allowed to sit at 'Phambal'- a place where head of the family often sit. This means that women are never considered as the head of family

For Manipur Women's day observance is very significant. But organizations observing the day need more courage to voice the problems of Manipuri women and also urged every political party to uplift women by way of providing them chances to become lawmakers.

Empowerment of Rural Women: Role of Nutrition and Health with special reference to North East India

We give names of our daughters as 'Annapurna', 'Laxmi', 'Indira' and 'Kamala' which are outer Goddess 'Mahalaxmi' who is in charge of storing of food, preparation of foo and distribution of food. We worship 'Maa Durga' who is the source of strength and power. Then why should we think about empowerment of rural women, particularly in the field of food and nutrition? Women act as producer, processor, storekeeper and distributor as far as agriculture and food processing is concerned. There is hardly any activity in agricultural production except ploughing in which women are not actively involved. She cooks, she serves, she thinks of other's satisfaction, works day and night, take care of present workforce and gives us future work force, plays prime role in the development process, but ignores very often her own needs, is ignorant about her nutritional requirement and very rarely aware about the indicators of health.

If we analyze the health status of women in India, the maternal mortality rate of India is 130, but is 237 in Assam as per National Family health Survey (2015-16). Similarly as per the same survey, Infant mortality rate of the country is 29, but 48 in Assam and 40 in Mizoram. Among the other north eastern states. Arunachal Pradesh has the lowest IMR of 24 while Manipur has 25. When we see the overall nutritional status of women in India. about 53% of women are anaemic and underweight (NFHS-4, 2015-2016). These women often give birth to underweight children who are stunted. With regard to the data in North Eastern states, Meghalaya has got the highest percentage of anaemic women (56.2%) followed by Tripura (54.5%), Assam (46%), Arunachal Pradesh (43.2%), Sikkim (34.9%), Nagaland (27.9%), Manipur (26.4%) and Mizoram (24.8). Thus women in these states are more prone to fatigue, weakness, breathlessness and eventually this affects their work performance as well. It is a well known fact that poor nutritional status often negatively affects the cognitive development of children and this gives rise to less cognitive active minds. Thus, programmes and policies specifically focusing on the lives of the north Eastern women may be framed and implemented strictly in regions where the vulnerability of women is highest for malnutrition and other related

In our culture, women usually take food after all family members eat. Very often the left over food is inadequate in quality and quantity. During pregnancy and lactation women need special care and nutritious food but they pay little attention to it. Lack of education is a hindrance to development. Increase in educational level of girls will accelerate to achieve better health, upbringing of children in a scientific way, use of hygienic methods, use of nutritious food for the family, improving the status of women within the household will deliver significant improvement in the society The religious traditions very often restricts the women to do number of rituals by restricting their food, particularly when they need special attention. Further taboos in the society or food fads or not to take different types of vegetables or leafy vegetables etc. affects the women's health which can be overcome by spread of nutrition education.

As in Indian culture, the guest is considered as God, whenever any guests comes, we compromise with the food of the family and the worst sufferers are the women. In this case, a nutri-sensitive garden in the backyard system and Integrated Farming System (IFS) can provide immediate solution as fruits, vegetables, mushroom poultry and fish production, etc. will be available at the doorstep and can be used as emergency need. The strategic use of various under-utilized fruits and vegetables needs to be strengthened in the families. In the North eastern region, use of 'sticky rice' and variety of green leafy vegetables in the daily diet is an important feature. But some of the unhealthy food practices like regular use of sodium bicarbonate nthetic soda) in the diet deteriorates ealth making people weak which can be avoided. It is worthy to mention that in some districts of Garo hills of Meghalaya usage of soda is banned

now considering its harmful effects. Teenage pregnancy is a common eature in North Eastern states. Most of the girls become mothers when their body is not ready for it which is associated with anaemia and poor health conditions thus adding to their problem. In addition to this, frequent pregnancies with less interval also adds to the women's vulnerability. Higher total fertility rate, early births, lower rate of usage and knowledge of family planning methods, less institutional deliveries, use of unhygienic menstrual practices, poor reproductive health, lack of proper knowledge about menstruation and other reproductive health problems make the women compounded with the burden of infected with the so called 'Silent diseases of women.' Home deliveries by untrained rural women is another cause of maternal and infant mortality programmes like Janani Suraksha Yojana, and incentives for institutional deliveries, posting of ASHA, distribution of iron, folic acid and vitamin A tablets and proactive role of Anganwadi workers but the rural areas require the active participation from the stakeholders sides. Therefore active participation of stakeholders is required to fight with incidences of infant mortality and maternal mortality

Lack of access by women to nutrition education and training also has a profound impact on nutrition. A public survey on hunger, conducted in the year 2011, concluded that mother's education level determines their children's nutritional status and that the rates of underweight and stunted children were found to be significantly higher among mothers with lower levels of education. Women comprise about 40% of the labour force and also take up maternal roles that is central to the development of the next generation. As the role of women in society continues to evolve, it is vital to help them be the best they can be, enabling both gender equality and the benefits of improved nutrition for future generations. Women in North eastern states have a better social status as compared to the other parts of the country as evidenced in regions of Meghalaya, Mizoram, Arunachal Pradesh and Manipur where women are seen being active in other spheres of life. Still simple awareness programmes for food related items, conservation of nutrients, better cooking methods and increasing bi availability of nutrients would surely result in some positive consequences.

The impact of climate change on food

and nutrition security are worsening the existing inequalities in access to resources, especially for women who are primarily responsible for food production and for feeding their families. In view of the high risk of malnutrition and disease that women face at all the three critical stages of - infancy and childhood, adolescence and reproductive phase focused attention should be paid to meet the nutritional needs of women at all stages of the life cycle. This is also important keeping in view the critical link between the health of adolescent girls, pregnant and lactating women with the health of infant and voung children.

Empowerment is defined as the process by which one can have control

and ownership of their lives through expansion of their choices. This is a process that moves through several stages from participation, decision capacity to take responsibility for

Empowering women is vital because it allows them to be better and strengthen their lives as well as the lives of their children. Women are the true mirror of social, religious, cultural and spiritual values and contributing in almost every firsts of life whether it is social, economic or political.

Aholistic approach to women's health that includes both nutrition and health services should be adopted and special attention should be given to the needs of the women and the girl at all stages of life cycle. Special efforts need to be taken to tackle the problem of macro and micro nutrient deficiencies especially among the pregnant and lactating women as it leads to various diseases and disabilities. Widespread use of nutrition education should be made to address the issues of intrahousehold imbalances in nutrition.

Women play a decisive role in the food security, health and nutrition of their families and this should be taken into account in the design and targeting of policies. In recent times, Government of India has prepared a draft on National Policy for women empowerment (in the year 2019) with a priority on their education, food ecurity and nutrition. It has identified the priority areas of food security, nutrition, education, economy, violence against women, governance and decision making. Some of the strategies to incorporate essential nutritional interventions for mothers in the north eastern region of India are as follows:

* Improving the quantity and nutrition level of food consumed in the household.

Preventing micro-nutrient deficiencies and anemia.

* Increasing women's access to basic nutrition and health services.

Improving access to water and

sanitation education and facilities. Empowering women to prevent

pregnancies too early, too often and too close, together.

Thus, Nutrition justice will only be achieved when women are empowered and when policies and programs are gender sensitive. If we make efforts to educate girls and improve their nutrition level, we will be able to make our coming generations healthier and more prosperous. It is rightly said that we cannot end malnutrition, if we do not

BRINGING INTO DISREPUTE?

The murky affairs in Imphal's Catholic School Canchipur are yet to be resolved

The Catholic School Canchipur, located in Imphal near the Manipur University campus, has been in the news for all the wrong reasons. Established in 1982, it has a student population exceeding 4000 today but even then, all isn't well behind the high walls of the educational

institution,
The first shocking incident happened when Father Mathew, the Principal, was shot dead inside the school campus on 29th April 1990. The Revolutionary 29" April 1990. The Revolutionary People's Front, the political wing of the proscribed People's Liberation Army of Manipur, had written to me that they had executed Father Mathew for his purported dealings in the narcotics (read hearth) business.

heroin) business.
Then, on 2nd February 2001, another principal, father Tommy Manjalee was shot at but he survived the attempt on shot at but he survived the attempt on his life. Nobody claimed responsibility for the attack but it was suspected that he might have been following some non -canonical norms. Last year cam the turn of then principal

Father Soni Thomas. His was not for drug dealings but an alleged illicit affair with a lady staff member. A rumour was circulated alleging financial wrongdoing involving the principal and the Archbishop. On 5 June 2019, Father Thomas

tendered his resignation to the tendered his resignation to the Archbishop relinquishing his post and everybody thought things would die a natural death as it was assumed that Father Thomas had taken moral responsibility for the alleged transgression. However, the Local Guardian Association of the Catholic School trooped to Bishop House and almost forcibly extracted the confession from the Archbishop, who then agreed to take him back. In the meantime on 24 June 2019,

Sanasam Basantkumar Meitei, computer teacher of the CSC, was summoned to Singjamei Police Station and charged with being the person who spread the

He was detained for the night in the lockup and the next morning, made to sign a confessional statement. He had to pay Rs. Three lakh to the father of the lady staff member in question. By the second week of July, Father

By the second week of July, Father Thomas was reinstated, albeit unofficially, by the Local Guardians Association, led by one Naorem Jibit Meetei. Then by 22 July, he was formally reinstated as the principal of the CSC by the Archbishop. On 18 August last year, the Kangleipak

On 16 August last year, the Kangletpak Kanba Lup, a vanguard organization of Manipur, held a press meet in Imphal and laid bare the nitty – gitty of the conversation between Father Thomas

and the lady staff member. Also revealed in the press meet was the revelation that they had both the text of the conversation between Father Thomas and the lady staff member, and also an audio recording of Father Thomas alleging the Archbishop's financial wrongdoing.

Archbishop's financial wrongdoing. There were no rejoinders of robuttals to that effect from the Bishop House. The Most Reverend Dominic Lumon, Archbishop of the Archdiocese of Imphal, informed me on 4 September 2019 that Father Thomas was being removed and that it would happen in front of gathering of some 40 teachers of the CSC. The lady staff member approached the Manipur Women's Commission on 30 August alleging that she had been subjected to gross mental harassment while also naming Basantkumar Meitei while also haming basantulmar victice and Ngamkheilakpa Luwang, general secretary of the Kangleipak Kanba Lup, as respondents.
The chairperson of the Manipur Women's Gommission, Meinam Binota ruled that

however as par investigation of the Commission, Sanasam Basantkumar Commission, Sanasam Basantkumar is found not guilty, so the school authorities may resolve his Suspension Order at the earliest." She added that "this Commission also feels compelled to put on record tha the present issue has hampered the proper functioning of the school to a certain extent functioning of the school to a certain extent and this Commission recommends the authority concerned to end the issue sooner than later for the sake of the school and the students' welfare'. Thereafter Basantkumar Meitei called on the Arabbidon, selim his intervention

the Archbishop, asking his intervention to resolve the inquiry against him. Dominic Lumon, however dodged the Dominic Lumon, however dodged the question stating that the Catholic Educational Society of which he was the head, is an autonomous body beyond his sphere of influence. As things turned out, the worst nightmare

of Basantkumar Meitei came true - he was terminated from service with effect from 22 November 2019. His two sons, who were students of the CSC, were also forced to seek enrolment elsewhere. This case involving the CSC in Manipur

has not been highlighted well enough Although the Vatican's Ambassador to India had been apprised of the entire episode, nothing concrete seems to be happening. Father Thomas has been replaced as principal by Father Stephen Touthang and the lady staff member in question has since expired due to cancer. Now the question remains with Cardinal Oswald Gracias. Archbishop of Mumbai who has been reappointed president of the Catholic Bishop's Conference of India.
