The graph of the COVID-19 cases in Manipur is rising with the coming of the stranded Manipuris from outside the state in the last couple of days. With two more new positive cases of COVID -19 today, the number of active positive COVID - 19 cases in Manipur reached 4 today.

Two more new cases have been detected at State Level Viral Research & Diagnostic Laboratory of RIMS, Imphal today, Both the patients hailed from Moreh town in Tengnoupal district and were returning from Mumbai. The two patient reached Manipur on May 14 and have been Earlier, a patient from

Kairang Khomidhok in Imphal East who return from Mumbai was tested positive on May 14. Following him another 21 years old girl from Kamjong district, who return from Kolkatta and had undergone quarantined at NIT Takvel, was tested positive yesterday (May 15). Today among 8 persons who have been tested at RIMS State Level Viral Research & Diagnostic Laboratory, 2 persons from Moreh who had return from Mumbai have been tested positive.

Both the positive cases detected today are mother and son. The son L. Inaocha (48 yrs) along with

her mother L. Inaocha, who were tested positive, return from Tata Memorial

Hospital, Mumbai. The first COVID-19 positive case in Manipur was detected on March 24. And the 2<sup>nd</sup> was detected few days later. Both the positive cases were discharged after being tested negative. Following that Manipur has been declared COVID-19 Free State in the country. COVID-19 positive cases so far detected in the stated reaches 6, even as active cases stands at 4.

Delhi Manipuri Society (DeMaS) has extended both moral and monetary support to around 16 nurses from Manipur who are working at New Delhi. Among the 16 nurses, four are nurses who had voluntarily tested for coronavirus at their own expenses before starting their journey for Manipur and later cancelled their journey as they were found COVID-19 positive.

The DeMaS also facilitated to lodge a complaint to Mrs. Soso Shaiza, Member, National Commission for Women regarding physical assault

A statement of the DeMaS said that the 4 nurses from Manipur who cancelled their return journey Manipur after they were tested positive are working in Pentamed Hospital, Model Town, Delhi.

Among the four, one Moirangthem Jenita was the first to be found positive. The other three nurses, namely Narmada, Ronibala and Dhnamanjuri, were also tested earlier at the beginning of this month but their results were found to be negative of underwent for retests at COVID19(SARS-COV2) at prognosis laboratories at that time. A statement from the DeMaS said that the three accused - a lady, his son and daughter in law - all have been arrested by the Gurugram Police.

Nengchoghoi Misao has en shifted out to another place by volunteers of the North-East helpline in a home of a Manipuri family.

Once a lovely place with lot of happenings, the city becomes a hotspot for the Pandemic. Like him, there are many others who are facing a never seen like crisis. It is a nightmare for many people who work in the unorganised sector or private sector. Stuck between a rock and a hard place, he sets out to the home state in the hope of finding solace. Is he to be blamed ?

Life as we all know will never be the same again. History taught us lessons and scientific predictions make us cautious. About a century ago, humankind disasters in the form of Spanish Flu and First World War. The pandemic claimed more lives than the waritself. It infected more than 500 million people worldwide and million succumbed to it.

The government has done the right thing to announce the nationwide lockdown early. Manipur was a step ahead. In fact, the Manipur government started the ground work quite early. It started the screening of arriving passengers at the Imphal

International Airport since January. Its also quite commendable to the frontline warriors, local administration, clubs and various NGOs who have made it possible for the government to contain the virus in the first round of fight.

A battle is won but the "War" remains to be won now. Many fellow Manjpuris are stranded in various parts of the country. They have gone there for various reasons - education, medical treatment, in a transit, business, and employment to name a few. With the third positive case in Manipur. It becomes a very difficult situation to take a right decision. But to fight the virus with a humane face becomes more important.

In this line, the National Carrier has been the backbone of the Vande Bharat Mission, Similarly, various state governments have started special transport facilities to take home the stranded people. The advantage here is Manipur is not a big state nor has the issue of having huge population. Despite limited resources, it is within the reach of the government to take care of the stranded population. As per the official report, more than forty six thousand people have registered in the website launched by the government. The moot question is can we control a

with the view to prevent a second wave in mind, all the incoming citizens of the state should be tested irrespective of

the symptoms. If tested negative, quarantine should still be made mandatory as per ICMR guidelines. However, they can be given the liberty to be home quarantined under strict guidelines and eligibility criteria or community quarantined. After completion of mandatory 14 days quarantine, another test should be conducted either at the expense of the returnee or at a subsidised rate. For these, the government constituted observers and local volunteers can be roped in. If somebody in a group of returnees is tested positive, then whole group should be immediately tested.

Since India is in the third stage of the transmission, community awareness is of the prime importance. Once one positive case is detected in the community, the whole area needs mass testing and contact tracing shall become harder. This is why many people are against the idea of taking in the stranded citizens. But since the decision has been taken and the plan has been already rolled out, then no stone should be left unturned to contain a second wave at any cost.

The best practices are out there to be copied from. Providing hygeine basis amenites during the quarantine period is key to calm the body. To calm the mind, some task or arrangement can be made while maintaining social distance like motivational speech or music. Even the return journeys can be

staggered to optimize the available resources -quarantine centres, testing capacity and support staff If one warrior is affected, everyone who has come into contact with him/her shall be quarantined Before travel, the stranded people should, if possible test themselves Positive people should get treated there itself instead of travelling back home. Else while taking the long journey, if social distancing and preventive steps are not taken then there is chance of contracting the virus from one asymptomatic to even tested negative cotraveller. Preference shall be extended to those with medical conditions and people under certain age category. This is the time to show the

This is the time to show the utmost discipline and compassion on the part of the people stranded outside and who are already inside the state. If self-discipline is not observed, the chances of spreading the virus one way or the other is inevitable. It is the responsibility of the returnees to be vigil and stay discipline at all times even after 14 days quarantine. For these every step has to be planned and no loose end should be there.

The green zone tag is no longer there and a big challenge lies ahead in front of everyone. The game is not over till there is a vaccine. Till then, our first target is to ensure that no new case arises and people should practice social distancing and hygienic lifestyle religiously.

# Senior Congress leader slammed for suggesting Govt to 'borrow gold' from religious trusts

Former Maharashtra Chief Minister and senior Congress leader Prithving Chavan is receiving flak from Hindu priests for suggesting the government should borrow gold from religious trust, for combating the economic crunch of the country due to the COVID-19 outbreak.

However Swami Paramhamns, Tapaswi Chhawni in a video message said that "Before taking gold from Hindu temples, money should be taken to combat Coronavirus from Congress leaders who have amassed huge wealth since independence,". He also branded the Congress leaders as 'anti-national' and questioned Chavan for not seeking to borrow

s, money "from mosques and at churches" but Hindu trusts.

Former Mahant of Kashi Vishwanath temple (Utar Pradesh) DF Kulpat Tiwari said that Chavan has lost his mental balance and as such a life long ban will be imposed on him and his family by the Kashi Vishwanath temple. The priests of other 12 "Jyotirlings" in the country should also impose a similar ban on him, he said and added that no Government takes anything donated to temple by devotees. In 1983 a theft had occurred in Kashi Vishwanath temple and hat time the Congress was ruling at the centre. As such the Congress must have played activerole in that theft, he alleged.

Ramesh Shinde, spokesperson of "Hindu Janjagruti Samiti", alleged that the Congress has been imposing 'anti-Hindu' policies for the last 70 years, and that the party has looted massive public money inthe form of scans. Similarly former BPL Lok Sabha MP Kirit Somaiya lashed out at Chavan and tweeted a video, alleging whether the demand was made by Chavan on behalf of Congress president Sonia Gandhi and Congress-ruled state government leaders.

Sensing aggravation on his statement, Chavan later tweeted that his suggestion of gold monetisation was not a new one. The Gold Deposit Scheme (GDS) was started back in 1999 by the Vajapayee govt after the failout of economic sanctions, post- 1998 Pokhran Atomic tests. The same scheme was later renamed as "Gold Monetisation Scheme" by the Modi government in 2015. "According to a finance ministry report, 20,547 kg of gold has been mobilised by 2,952 entities between November 2015 and January 2020 under the scheme and two temples from Maharashtra have deposited their gold with 11 banks,".

Earlier this week, Tirumala Tirupati Devasthanams (TTD)(Andhra Pradesh) Chairman YS Subba Reddy had told the media that the trust will not be using gold deposits in the bank, despite the recent loss of Rs.400 crore in revenue and shall use other reserves to pay employees' salaries and take care of expenses for maintenance of the temple. The reserves rule out the gold deposits in the bank, stating that it will not be touched in any scenario. quoting that gold deposits hold 'sentimental issues'. The world's richest temple is reported to have nine tonnes of gold reserve and Rs,14,000 crore fixed deposits in various banks. Some of the richest temples of the country that hold billions of reserves in various banks include Padmanabhaswamy temple in Kerala, Shirdi Sai Baba Shrine (Ahmednagar, Maharashtra) and Siddhivinayak temple in Mumbai (Maharashtra) and Kashi Vishwanath temple(UP).

Wulnaa, viay to While dealing with a bunch of petitions filed by different industries challenging the Union Government's directives to pay full wages to workers during the lockdown period, the Supreme Court on Friday directed the government to put on hold its order of 29 March.

In response to the SC's direction, the Solicitor General of India, Tushar Mehta sought time to file a detailed report. Now the hearing of the petitions is scheduled for next week.

A three-judge Bench headed by Justice L. Nageswara Rao several companies challenging the

The petitions have been filed by entities from the micro, small and medium sector against the government's order to pay full wages to their workers. MSME industries have said that they are compelled to slide into insolvency by the government, which has ordered them to continue to 100% pay to their workers. The petitioners even prayed the court to order the government to support them by taking responsibility for 70% of their staffers' payby drawing funds from PM CARES Fund or the Employees State Insurance Corporation. "It is implicit in the fundamental

"It is implicit in the fundamental right of an employer to trade or business that there is an obligation to pay when work is actually done and there is no obligation if no work

is done. An employer and employee have reciprocal promises whereby the right of an employee to demand salary is reciprocal to performance of work by such employee. The employer has a right to not pay if no work is done," petitions filed by private firms like Nagreeka Exports Limited and Ficus Pax Private Ltd said. Nagreeka said it was engaged in manufacture and exportof cotton
