Lockdown strengthened in Imphal after confirmation of 5 positive COVID-19 cases

Imphal today saw complete lockdown scenario as streets bore deserted look with only one or two vehicle plying on the road today after the confirmation of 5 new positive COCID-19 cases in the state.

Lockdown has already been imposed in the state, but roads and streets were seen crowded till yesterday as people use to come out either with security pass or other excuses. People in the state seem to take lightly about the COVID-19 positive cases detected on recovered after being treated at JNIMS and

3 booked for holding public funeral of COVID-19 patient

IT Correspondent Mumbai, May 17:

Three members of a family have been booked by the Ulhasnagar police (Thane district, Maharashtra) for organising an elaborate funeral for a 59-year-old suspected patient residing at Khanna Compound, about 43 kms from Mumbai city, in violation of COVID-19 protocol, early this week

The police have registered an office against the deceased's two sons and his brother, under section 188 of the IPC (disobedience to order duly promulgated by public servant) and provisions of the Epidemic Disease Act, 1897. The

offence was registered based on a complaint by Ulhasnagar Municipal Corporation commissioner Dr Sudhakar Deshmukh wrote to Sudhakar Desnmukri wrote to the Central Police station. Of the 70 people who

attended the funeral, 9 have now tested positive and the rest have been quarantined. The deceased was admitted to the Central Hospital in Ulhasnagar for suspected coronavirus. His test report came positive after his death. After his death family allegedly pressurised the hospital and even gave in writing that they would follow all norms and adhere to the specified protocols for a COVID-19 patient, if they were handed over the body.

As per the norms, the body is wrapped in a plastic sheet and the final rites are to be performed at the nearest cremation site. The plastic covering on the body should notbe removed. Not more than 5 people are allowed at the cremation site. But the family defied this and gave the body

a final bath as per their rituals.

The deceased's test report came positive after his death. Of the 70 people who attended the funeral, 9 have now tested positive. The rest have been quarantined. "We have booked three people who gave the undertaking to the municipal corporation. Central Police station said.

Maharashtra loses 11 policemen, 1154 cops infected with COVID-19; An IG level officer admitted to hospital for coronavirus

By Raju Vernekar Mumbai, May 17:

The COVID-19 pandemic claimed lives of two more policemen in Mumbai, thus taking number of police personnel becoming victim to the deadly virus to 11, with 1154 police personnel getting infected.

A 32-year-old assistant police inspector (API) Amol Kulkrani, posted at Shahu Nagar police station in Dharavi, a coronavirus disease hotspot, and a 57-year-old police assistant sub-inspector (ASI) from Nagpada Police(Motor transport) died of the killer viral infection

API Amol Kulkarni was suffering from fever and cough and was sent on leave. On May 13, his sample was taken for Covid-19 at Sion Hospital, which proved positive, DCP Niyati Thaker said. At around 5 AM on Saturday, he accidentally fell in the bathroom at his Pratiksha Nagar residence in Central Mumbai and lost his consciousness. He was rushed to the nearby Sion Hospital, where he was declared dead even before

the doctors could treat him.
While the deceased ASI was working as a driver and was posted in the motor transport (MT) section of the Mumbai Police in Nagpada. He was sent on leave about 15 days ago, as at 57 he belonged to the high-risk group.

Those deceased till now include: Amol Kulkami. ASI Madhukar Mane, ASI Murlidhar Waghmare, Naik Bhagwan Parte, Sunil Kargutkar, and constable

On April 27, Mumbai Police commissioner Param Bir Singh had announced Bir Singh had announced that the personnel, who are above 55 years, need not report for work after three policemen died due to Covid-19. Singh also allowed the personnel, who are above 50 years and suffering from medical issues, to proceed on

leave. So far, 1154 policemen have tested positive for Coronavirus, which includes 128 officers and 1026 police constables. While 174 police personnel have successfully recovered from COVID-19

A large number of policemen have also been put in self-quarantine, which has left a staggering shortage of personnel in the police department. To match present requirements of police personnel, the union government on Saturday sent 9 companies of rapid action force to Maharashtra The state government had asked to send around 2000 additional policemen from the Central Armed Police Forces to provide some respite to its own fatigued

officers.

FM Sitharaman unveils structural reforms for 7 sectors in 5th tranche of Atma Nirbhar Bharat package

New Delhi, May 17:

Finance Minister Nirmala Sitharaman unveiled the final tranche of financial stimulus and policy measures for various sectors to help build a self-reliant India under the Atma Nirbhar Bharat Campaign, today, Prime Minister Narendra Modi had on Tuesday in his address to the nation announced a special economic package equivalent to 10 per centof India's GDP, amounting

to 20 lakh crore rupees.

Addressing a media briefing in New Delhi, Finance Minister nnouncement of the fifth tranche of measures to address the economic situation in the country amid COVID-19, outlined structural reforms with focus on seven areas of MNREGA, Health and Education. Health and Education, Business during Covid, Decriminalisation of Company Act, Ease of doing business, Policy related to Public Sector Units, State government and resources

Announcing the relief measures of fifth tranche Nirmala Sitharaman said under the MNREGA scheme, an additional 40 thousand crore rupees will be allocated for employment generation in the rural parts of the country. She said this will help to generate nearly 300 crore person days to provide relief to the migrant workers.

On the Health reforms and

initiatives taken to fight the Covid-19 pandemic, she said, public expenditure will be increased and Health and Wellness Centres in rural and urban areas will be ramped up. She said, infectious diseases hospital blocks in all districts and integrated public health labs in all districts and block level will be set up to prepare India for the future pandemic. She said, National Digital Health blueprint will be implemented under the National Digital

Health Mission.

ce Minister said, PM-e-Vidya programme for multi mode access to digital online education will be launched immediately and it will consist of e-content and QR coded textbooks for all grades. She said, one TV channel per class from 1 to 12 will be operated and extensive use of Radio and Community Radio will be made. She said, top 100 universities will be permitted to automatically start online courses by 30th May of this month.

She said, an initiative by the name of Manodarpan will be launched

immediately for psychological support of students, teachers and their family for mental health and emotional well being. Finance Minister said, minimum threshold to initiate insolvency proceedings has been raised to one crore rupees from one lakh to provide relief to the MSMEs. She said, special insolvency resolution framework for MSMEs code will be notified and no fresh initiatiation of insolvency proceedings will be done

Speaking over, decriminalization of companies act, she said violation involving minor technical and procedural default will not be accounted which in turn will help to de-clog the criminal courts and NCLT. She said, under the ease of doing reforms, Indian public companies can directly list securities in permissible foreign jurisdiction. Finance Minister said government will announce new policy related to the Public Sector Enterprises, PSEs. She said, list of strategic sectors requiring presence of PSEs in public interest will be notified. She said, in strategic sector, at least one enterprise will remain in the public sector but private sector will also be allowed. She said to minimise the wasteful administrative cost,

number of enterprises in strategic sectors will be limited to four.

On the support extended to the State Government, Finance Minister said, more than 46 thousand crore rupees have been devolved in April and revenue deficit grants of more than 12 thousand crore in April and May have also been given to the states despite centre's stressful resources. Ms. Sitharaman highlighted government's decision to increase the net borrowing ceiling for the states from 3 percent to 5 per cent of the Gross State Domestic Product, which would result in increased resources of 4 lakh 28 thousand crore rupees for them.

She said, more than 11 thousand crore rupees have been released as advance from State disaster relief fund in the first week of April and Ministry of Health and Family Welfare released another 4 thousand 113 crores rupees for direct anti-covid activities. Referring to Prime Minister Narendra Modi's address, Finance Minister said, government is working with the targeted approach to provide the benefits to the people belonging to all strata of the society. She said, under the Prime Minister Garib Kalyan package, free food grains were provided to 80 crore people and under the PM Kisan Yojana more than 16 thousand rupees have been given to the 8.19 crore people through direct benefit transfer.

She said, more than 10 thousand crore rupees were released to 20 crore Jan Dhan account of women and construction workers got 3 thousand 950 crore rupees. She said, 6.81 crore beneficiaries got the cylinder under the Uijala scheme and 12 lakh EPEO holders withdraw the advance amount. She said, Shramik Special trains were operated for the migrant workers and 85 percent of the cost was borne by the Central

Earlier on Wednesday, the Finance Minister announced a measures to help the Micro, Small and Medium Enterprises, MSMEs sector that employs an estimated 11 crore people. The announcements ranged from Non-Banking Finance Companies (NBFCs), real estate, nower distribution sector, to relaxations on contribution to Employees Provident Fund (EPFO). In her second announcement on Thursday the focus lies on migrant workers, street vendors, small traders, the selfemployed and small farmers.

Third announcement saw major relief packages for agriculture and allied activities while yesterday key sectoral reforms were announced in the sector of coal, minerals, defence production, civil aviation, power distribution companies, space sector and atomic energy.

Comprehensive Economic Package: A transformational moment

We have witnessed for the last few days the presentation of a comprehensive economic reforms - five days of briefing by the Finance Minister that covered in great detail an economic package covering almost all aspects of national economic life. The 20 lakh crore package is phenomenal - not just in terms of the sheer size of the money it pumps in to boost the economy, but also in terms of laying down a reformist vision for the future. The changes envisaged in economic policies and laws makes this exercise bigger than any usual annual budget. It is the recognition of the fact that it will take an exceptional effort to overcome a crisis of unprecedented global

order. PM's Vision

Prime Minister Shri Narendra Modi gave a call for Atmanirbhar Bharat or Self-Reliant India with five pillars – Economy, Infrastructure, System, Vibrant Demography and Demand. He announced that the government will bring a Special Economic Package of Rs 20 lakh crores equivalent to 10% of India's GDP to cater to the needs of various sections including industry, MSMEs, labourers, middle class, industries and infrastructure. He said that it is time to become vocal for our local products and make them global.

Helping the poor first
On the first day of her presentation of details of the economic package, Finance Minister announced Rs. 1.70 Lakh Crore relief package under Pradhan Mantri Garib Kalyan

fight the battle against Corona Virus. The package includes insurance cover of Rs 50 Lakh per health worker, and for the next 3 months, 80 crore poor people will be given benefit of 5 kg wheat or rice per person per month, 1 kg pulses for each household for free every month, 20 crore women Jan Dhan account holders will get Rs 500 per month and Gas cylinders. free of cost will be provided to 8 crore poor families.

The Central government increased MNREGA wage to Rs 202 a day from Rs 182 and increased budgetary support to the programme. It announced ex-gratia of Rs 1,000 to 3 crore poor senior citizen, poor widows and poor Divyang Pradhan Mantri Garib Kalyan Package. Government front-loaded Rs 2,000 farmers under existing PM-KISAN, benefitting 8.7 crore

A slew of measures were announced to support the vibrant but vulnerable MSMEs. This included emergency Credit Line to Businesses/MSMEs from Banks and NBFCs up to 20% of entire outstanding credit and also revision of definition of MSMEs by upward revision of investment limit. Manipur, which has the highest number of MSMEs in the North East, will be hugely benefitted from this push.

For Migrants and Urban Poor Government of India permitted State Governments to utilise State Disaster Response Fund (SDRF) Disaster Response Fund (SDRF) for setting up shelter for migrants and providing them food and water and released Rs 11,002 crore of its contribution in advance to all States to augment funds in their SDRF. Hygienically prepared

provided for the residents of Shelters for Urban Homeless (SUH) during the lockdown w.e.f March 28, 2020. Labour Codes will be modified to benefits workers. This includes universalization of right of minimum wages and timely payment of wages to all workers including unorganized workers (presently minimum wage is applicable to only 30% of workers).

Agriculture The next announcements were meant to strengthen Agriculture Infrastructure, Logistics, Capacity Building, Governance and Administrative Reforms for Agriculture, Fisheries and Food Processing Sectors. This included Rs 1 lakh crore Agri Infrastructure Fund for farm-gate infrastructure for farmers, Rs 10,000 crore scheme for formalisation of Micro Food Enterprises, Rs 20,000 crore for Fishermen through Pradhan Mantri Matsya Sampada Yojana (PMMSY), National Animal Disease Control Programme and setting up of Animal Husbandry Infrastructure Development Fund of Rs. 15,000 crore. Government also announced that there will be Amendments to Essential Commodities Act to enable better price realisation for farmers and Agriculture Marketing Reforms to provide marketing choices to farmers. Majority of Indians are directly or indirectly dependent on agriculture sector and a revolutionary change here is sure to transform the country and raise the quality of life for all its citizens.

The changes announced here are structural and will transform the entire sectors to give long lasting benefits to the nation. Under 'Make in India' for Self-

FDI limit in the defence manufacturing under automatic route will be raised from 49% to 74%. This will bring a total benefit of about Rs 1000 crores per year for the aviation sector. Government also announced 13 more World-class Airports through PPP and there is a push to make India a global repairing

hub for aircrafts.

First train for migrant workers from Bihar, West Bengal leaves Mumbai

The first trains carrying migrant workers to Bihar and West Bengal, which had so far disallowed labourers to come back, departed on Saturday from Mumbai, after Maharashtra Chief Minister Uddhav Thackeray and NCP president Sharad Pawar spoke to respective CMs to resolve the dispute.

The migrant workers from Bihar and West Bengal were stranded in Mumbai and other parts of Maharashtra since these states had not given clearance for their return. "We could not send trains to Bihar and West Bengal since these states did not allow

it. As such Pawar and Thackeray spoke to West Bengal Chief Minister Mamata Banerjee and Bihar Chief Minister Nitish Kumar, to resolve the dispute, Maharashtra Home Minister Anil Deshmukh said.

Notably, Union Railway Minister Piyush Goyal had on Thursday had hit out at West Bengal Chief Minister Mamata Banerjee for not allowing migrants to return and had appealed to all the states to give railways approval to run more

On Saturday, a train carrying migrant workers to West Bengal and Bihar was flagged off. Pawar has also expressed the need to operate at least 10 trains daily each to West Bengal and Bihar. Thackeray has sanctioned Rs 55 crore from the chief minister"s relief fund for sending these workers ad the ticket fare is not being sought from any worker," Deshmukh added.

He said the Maharashtra government has so far transported about 2.45 lakh migrant workers

to their respective home states, by running 191 special trains services till now, amidst the coronavirus-induced lockdown" Deshmukh said in a video message.

The trains are being run from parts of Maharashtra to Uttar Pradesh, Rajasthan, Karnataka, Madhya Pradesh, Odisha,

Jammu and Kashmir, Jharkhand and Andhra Pradesh. As of now 3,71,310 migrant workers have been camped in 3,884 shelters in Maharashtra and the state government has being arranging for their food.

In the meanwhile additional 1.21 lakh migrant workers from Bihar and Uttar Pradesh have ought permission from Pune collector to return to their native places and required clearance has been sought from both the states. Pune Collector Naval Kishore Ram informed officers during a video conference on Saturday. No sooner the clearance is received, arrangement will be made for special trains, in coordination with railways, he added.

He said, decisions like corporatisation of Ordnance Factories with the stock listing option and a positive list for the domestic companies for Defence production would go a long way in making India self-reliant in arms and ammunition of modern

What is most admirable is that the government, while grappling with one of the most difficult challenges, is thinking and taking bold decisions with a firm belief that investments will happen if we, as a nation, continue to remain stead fast on the path of reforms'
