connection has been submitted today. The memorandum stated that some prominent former leaders of the United Naga Council in openly extending ceremoniously designed relief aids to the two well established camps of the NSCN (IM) in Manipur at Huthrong Brigade camp in Senapati and Ashiho Chaomi Battalion in Chandel District on May 8 and 13 as per reported to Eastmojo web portal.

It further said that the incident have definitely proven the unrestrained and open operation of the cadres of the NSCN(IM) inside the territory of Manipur and added that such operation contradict the declaration of the late Prime minister of India Atal Bihari Vajpayee on the 27th of July 2001 that the Ceasefire Agreement between the Government of India and NSCN (IM) was not extended

to Manipur . "Such act of the UNC leaders insults the martyrs of the Great June Uprising of 2001 and provoke the sentiments of the peace loving people of Manipur . The people and UCM are now suspecting if the Government of India and our own state Government are betraying us. MHA guidelines for National lock down 4.0 ministries/departments of covers is compulsory:

In view of the surging nber of Covid-19 cases in the country, based on the advice of the National Disaster Management Authority (NDMA) the national lock down was extended by the Union Government with freedom to state governments to delineate red, orange and

green zones, on Sunday, As per the guidelines of the union ministry of home affairs, all domestic and international air travel haven been prohibited till 31 May, barring air ambulances. In ar issued on 17 May, the NDMA said, "considering the lockdown measures need to be implemented for a further period in the country to contain the spread of COVID-19, NDMA in exercise of the powers under Section 6 (2) (i) of the Disaster Management Act, 2005, hereby directs the

Government of India, State governments and State authorities to continue the lockdown measures up to 31 May, 2020. The authority further directs the National Executive Committee (NEC) to issue modifications in the guidelines as necessary, keeping in view the need to open up economic activities while containing the spread of COVID-19."

The MHA guidelines are: Inter-state movement of buses allowed with mutual consent of states , except in containment zones, Metro and air travel remains suspended, movement of individuals for non-essential activities remain prohibited from 7 PM to 7 AM. States can decide delineation of red, orange and green zones and sports complexes and stadia will be permitted to open only for sports activities. However, spectators will not be allowed in these complexes. Wearing of face

spitting will be punishable with fine as may be prescribed in accordance with its laws, rules or regulations by the state/ UT local authority; and social distancing is to be followed by all persons in public places and in transport. Marriage related gathering shall not have more than 50 guests. For funerals/ last rites, the maximum number of persons allowed has been cept at 20. Consumption of liquor, paan, gutkha and tobacco etc., is not allowed in public places. The practice of work from home (WfH) should be followed to the extent possible and staggering of work hours should be adopted in respect of all offices and other establishments. There should be provision for thermal scanning, hand wash and sanitizers at all entry and exit points and common areas and all work places and other sensitive locations are to be

sanitized regularly. Local authorities should ensure that shops and markets open with staggered timings, so as to ensure social distancing. All shops shall also have to ensure six feet distance (2 gaz ki doori) among customers and also not allow more than 5 persons at one time. With a view to ensure safety in offices and work places, employers on best effort basis should ensure that the Arogya Setu application is installed by all employees having compatible mobile phones. District authorities will advise individuals to install the Aarogya Setu application on compatible mobile phones and regularly update their health status on the app. This will facilitate timely provision of medical attention to those individuals who are at risk. India evacuates thousands threatened by cyclone amid coronavirus pandemic

allowing the Armed forces to

May 18: India began evacuating thousands of villagers and halted port operations ahead of a cyclone expected to hit its east coast this week, officials said on Monday, piling pressure on emergency services grappling with the

coronavirus pandemic. The cyclone, expected make landfall on Wednesday, comes as India eases the world's longest lockdown, imposed in April against the virus, which has infected more than 96,169 people and killed 3,029.

The states of Odisha and West Bengal sent disaster management teams to move families from homes of mud and thatch to places of shelter from the severe cyclonic storm, Amphan, which is expected to gain strength in the next 12

"We have to evacuate people from low-lying areas, and protect them from the coronavirus too," said a senior official of India's home ministry who sought anonymity.

"It's not an easy task." The cyclone season usually runs from April to December, with severe storms forcing the evacuations of tens of thousands, causing widespread death and damage to crops and property, both in India neighbouring Bangladesh.

Authorities at the port of Paradip in Odisha ordered ships to move out to sea to avoid damage as the cyclone formed over the Bay of Bengal was likely to intensify into a super cyclonic storm

"Operations have been wound down," said Rinkesh Roy, chairman of the Paradin Port Trust. "We are clearing the port." Prime Minister Narendra

Modi is set to hold a meeting in New Delhi, the capital, to plan how to mitigate damage and injuries.

"The extremely severe cyclonic storm 'Amphan'...is likely to gain more strength and intensify further into a super cyclonic storm in the next 12 hours," weather officials said in a statement, forecasting heavy rain in eastern and southern areas.

India, with a coastline of 7,516 km (4,670 miles), gets hit by more than a tenth of all the world's tropical cyclones, the bulk of them hitting its eastern coast around the Bay of Bengal.

There is also the unfortunate fact that the situation might not improve enough to warrant the risk of opening educational institutions in the next few months. Our children are the most precious treasure for the whole of humankind. They are the future, the torch bearers of our species who will ensure the survival and progression as a distinct race that has come to rule the world and almost everything in it. commentson usin front of everyone, that day our lovely pet dog was kidnapped and killed, that thunderstruck day our dearest Grandma suddenly passed away when we were out stationed, that day we failed in an examination and our parents, teachers, friends were disappointed with us very much, that day our lover betrayed and left us for another person, those days where we were not selected at the applied jobs, that one 'life and death situation' day when You couldn't grab hold anymore and tried to end our life, all those days, you, dear body always seemed to forget to look upon me, and instead, consulted with Mind, yet, I constantly tried to console you and even wanted you to not recall all those bad memories and go on with our life without any remorse of the past, but, Mind was very intolerant and it let you to still remember those sad and bad moments even till today.

Dear body, that day when you had to be forcefully taken to the mental health clinic, because you weren't able to sleep or eat properly, couldn't carry out life's tasks normally, couldn't focus or concentrate in studies, couldn't meet anybody and sulked all alone in the dark corner of our room, constantly finding ways to end yourself, constantly feeling fearful, scared, and felt being looked upon by every eyes of the world, always weeping softly

feeling that you were all alone in this big wide world, and unable to sought help from anyone; Did you know how much I cried in pain seeing your gloomy and feared face, which was once a smiling and happy face.

Now, during those sad and miserable days, what was Mind doing? Always supporting you to end ourselves for you felt somehow a burden to your own self and to all around us. Mind was corrupted, for it alvays brings up all of our past sorrowful memories, and guilts every time you felt sad, and also, even when you tried your best to make yourself happy, Mind tries to stop that bright feelings by bringing up the dark sided feelings. Finally, I admitted that we needed treatments in order to save vourself, and me too, so, it was Mind who needed the treatments and therapies the most. That Mind, ugh, why did it always resist the treatment procedures? It seemed like it was becoming a separate alien being. Why isn't it cooperating with both of us and the therapies?Oh! Well, it seemed both of your bonding still to this day was too strong and I was unheeded

Our parents felt ashamed of us in front of everyone, for in our society even though it is the year 2020, the knowledge of mental health and problems are very vague and seen in a verv bad manner/taboo/aspect to this very day itself. Our friends started to call us 'psycho' for you had all those panic attacks regularly and acted weird due to the fears and

us specially as if we were somebody totally different from the rest. The feeling of being different and abnormal made you feel even more insecure and scared that you wanted to stay all alone or even give up. I o suddenly realized, besides Mind and I, you had a separate instinctive social animal consciousness that made you function separately. This was the moment after the realization. that I pushed myself to the limits and tried to connect with you even more and strongly. You did realize that you were being played all along by Mind, and even you admitted that there was a strong and urgent need of mental support and care from someone who will understand us very clearly and dedicatedly. Our therapist, yes, they tried their best professionally, our parents, they are the ones who must play the major role in making us feel better, our friends, never give a 100% trust to any of them for they have their own lives too and it can't be assured whether they will feel sympathetic or caring towards us, but, by the act of God, there's always a few limited and rare individuals who'll appear before us and provide us with many mental supports and care, regardless of their own benefits.

"Finally, it is you, Body, I, your Soul, and Mind, the three of us who must make Ourselves feel better. happier, enjoyed, relaxed, and optimistic all the time."

Organic farming will open ways for unemployed youths and make them sedentary amid corona virus pandemic?

Corona virus has paralysed normal life and restricted movements of migrant workers for atleast one year. Neither central government nor state government have sufficient resources to feed unemployed workers/vouths for one year. Unemployment is the gravest and greatest challenge our society faces today. The curre population of India 1,378,367,849, based The current on projections of the latest United Nations data. There are 29 states in India.

Their populations range massively in size – the largest, Uttar Pradesh, holds almost 200 million people, the smallest, Sikkim, just over half a million. As per Centre for Monitoring Indian Economy, 27 million youth in the age group of 20-30 years lost their jobs in April 2020 following a nationwide lockdown to prevent the spread of Covid-19. Organic farming can be life saving for these unemployed youths in present situation because there is large scope in organic farming. India is home to 30 per cent of the total organic producers in the world, but accounts for just 2.59 per cent (1.5 million hectares) of the total organic cultivation area of 57.8 illion hectares, according to the World of Organic Agriculture 2018 report. Organic farming has to be understood in detail before stepping in it. The concepts of organic agriculture were organic agriculture were developed in the early 1900s by Sir Albert Howard, F.H. King, Rudolf Steiner. Prime Minister Narendra Modi declared Sikkim as the first organic state in the country on 19 January 2016. He also called the state a harbinger of organic farming, not only in India but around the world. Currently India ranks 33rd in terms of total land under organic cultivation and 88th in terms of the ratio of agricultural land under organic crops to total farming area. In today's time where people are falling prey to chronic diseases easily, who

would like to risk their life with entrepreneurship development the harmful pesticides and fertilizers? We should know that there is a way to rescue ourselves from these life threatening chemicals and that is Organic Farming. Organic Farming is a farming method which aims at cultivating the land and raising crops in such a way that the soil is kept alive and in good health by use of organic wastes (crop, animal and farm wastes, aquatic wastes) and other biological materials.

Government is promoting organic farming through various schemes/ programmes viz National Mission for Sustainable Agriculture (NMSA)/ Paramparagat Krishi Vikas Yojana(PKVY), Rashtriya Krishi Vikas Yojana (RKVY), Mission for Integrated Development of Horticulture (MIDH). National Mission on Oilseeds & Oil Palm (NMOOP) Network Project on Organic Farming of Indian Council of Agricultural Research (ICAR) and National Programme on Organic Production (NPOP) of Agricultural & Processed Food Products Export Development

Authority (APEDA). National Centre of Organic Farming is also organizing the training programmes for farmers in Saansad Adarsh Grams (SAGs) from year 2015-16. There is need to make villages of our country as organic farming hub. This will facilitate villages to promote efficient and sustainable use of natural, biological and human resources. This will also strengthen and upgrade rural food energy and livelihood security. A organic farming village/hub integrates various elements such as agriculture, horticulture, animal husbandry, soil and water conservation, entrepreneurship development, rural income improvement and ecological preservation using a cluster model approach for social economic development. It addresses crop production and other critical aspects like agri-input production, value addition, sustainable and clean energy, skill development, tourism and

etc. According to many studies on employment opportunities in organic farming, organic farming requires more labour input than the conventional farming system. India which has a very large amount of labour unemployment and underemployment can generate agricultural jobs through organic farming in rural areas. In India the organic food market is approximately of Rs. 5.6 billion and is an emerging opportunity for generation of employment and income at village level. Therefore, it is pertinent to put emphasis on organic farming to generate job opportunities within states and avoid migrants of vouths from one state to another state in search of jobs

Points to dwell upon before starting an Organic Farm:-

-Learning the basics of natural and organic farming is the first step in starting an organic -The organic farm site should

be near a clean water source as water is a non-negotiable resource for crop growth and health

-The proximity of the farm to the marketplace also plays a big role in the sustainability of the farm. -The farm's closeness to the

market allows for the easy transport and also helps in saving money in transportation of materials to the farm.

It is extremely important to assess the site's soil condition as well as the resources available

-It is very important to know the type of market that a farmer is catering for. This consideration is very helpful in making the venture sustainable.

-Prepare the soil and make good compost because good soil means soil with nutrients necessary for the growth of plants.

-The process of growing a crop is a lengthy one. Organic farming takes time and it required more attention compared to conventional farming. -There are certain techniques

that need to be considered

depending on the plant and farm condition

-Regular watering is necessary for the plants to grow Generally, plants are watered 2-3 times a day depending on their type as well as the location where they are being grown. another

Weeding is important maintenance task.

-It is also very important to network with people who can help in selling farm products. These people also connects organic farmers to the right markets.

-Patience plays a key role because growing organic crops is a slow and tedious process. The farmer needs to be persistent

and patient. Various methods for racticing organic farming: -Crop Diversity: Now a days

a new practice has come into picture which is called Polyculture in which a variety of crops can be cultivated simultaneously just to meet the

-Soil Management: Organic agriculture initiates the use of natural ways to increase the ealth of soil. It focuses on the use of bacteria that is present in animal waste which helps in making the soil nutrients more productive to enhance the soil.

-Weed Management: Organic agriculture pressurizes on lowering the weed rather than removing it completely.

-Controlling other organisms: There are both useful and harmful organisms in the agricultural farm which affect the field. This can be done by the use of herbicides and pesticides that contain less chemicals or are natural.
