Asian Games gold medalist boxer Dingko Singh has started a journey of 2,400-km to reach his home in Imphal from Delhi. As per reports, he is set to complete the journey in 48 hours without taking any overnight stops. He is accom-panied by his wife, a nurse and two drivers who would be travelling with him till Manipur. Singh was in Delhi for his can cer treatment and was also suffering from jaundice. According to reports, he was flown to Delhi with efforts from Boxing Federation of India for his radiotherapy appointment at Delhi's Institute of Liver and Biliary Sciences (ILBS).

Soon after Singh was examined by the doctors, he was suggested chemotherapy instead but couldn't be administered as he was already suffering from jaundice at the time. All this while, Dingko Singh was under quarantined at ILBS. Dingko contracted jaundice in January as was admitted at ILBS in Delhi where he was suspected of having a strong re-lapse of a form of live cancer. Since he had already undergone a whole cycle of chemo-therapy in 2017, radiation was suggested for him but due to his low blood count, it had to be put off. In an attempt to improve his blood count, he went home in early March after spending six weeks at the ILBS, before returning for treatment only to face a delay again and more problems due to the pan-India lockdown in force.

Delimitation Commis sion of India had directed the Speakers of the Manipur Legislative Assembly along with Nagaland, Assam, Arunachal Pradesh and Jammu and Kashmir to nomi-nate associate members for delimitation of the parlia-mentary and assembly con-stituencies of the state. Under the delimitation Act 2002 delimitation had been conducted in 2008 based on the 2001 census across the country leaving aside the

five north east states including Jammu and Kashmir. Chetan said that delimi-tation of the constituencies without increasing the num-

ber as according to the growth rate cannot be accepted. He added that the five states- Manipur, Nagaland, Assam Arunachal Pradesh and Jammu and Kashmir were not included in the 2008 delimitation as the population growth found in 2001 census growth found in 2001 census was impossible. As for the state of Manipur, population growth as per 2001 census in the 4 subdivision of Mao-Maram, Paomata, Purul and Chakpikarong, has been ex-

traordinarily increased. And due to the prevailing law and order problem in the said areas in those time, the delimitation was not done after the approval of the President of India. On March 6, 2020, government has established Delimitation commission for delimitation of the five states based on the 2001

Agency New Delhi, May 21:

Health and Family Welfare Ministry said that a to-tal 45 thousand 300 people affected with corona virus have cured and the recovery rate reached to 40.31 per cent in the country. During the last twenty four hours, three thousand two people have recovered and five thousand 609 fresh cases of COVID-19 have been reported taking the total num-ber of cases to one lakh 12 thousand 359. A total 132 deaths have been registered in last 24 hours taking the nationwide toll to three thousand 435.

A total one lakh three thousand 532 samples of corona virus were tested in the last 24 hours. Indian Council of Medical Re-search said that the total number of tests reached to 26 lakh 15 thousand 920 in the country. Meanwhile, ICMR is continuously scaling up its testing facilities for COVID-19 by giving approval to government and private laboratories. As of now, total 567 laboratories across India have been given approval to conduct the test for COVID-19 including 396 government laboratories and 173 private laboratories' chains.

The Ministry said, 3 thousand 27 dedicated Covid hospitals and health centres along with more than 6 lakh 50 thousand Covid Care Centres have been identified. More than 2.81 lakh isolation beds and 11 thousand 387 oxygen supported beds have al-ready been identified in dedicated Covid hospitals and health centres. Ministry said, government has sup-plied 65 lakh PPE coveralls and more than one crore N95 masks to the states. In addition, the government is involving epidemiologists at all levels in order to combat COVID-19.

Railways to start 200 trains from June 1: **Online booking begins**

Agency New Delhi, May 21:

The booking of tickets for 200 trains which will run from 1st of June commenced from 10 AM today. Railways said these trains will be fully re-served trains having both AC and Non AC classes. General coaches shall also have re-served seat for sitting. There will be no unreserved coach in the train. Only four categories of Divyangjan concession and eleven categories of patient concessions are permitted in these special trains.

Railways Ministry said. these special services will be in addition to the existing Shramik special trains and Special AC trains. The Ministry said, other regular Passenger services including all mail and express, passenger and suburban ser-vices shall remain cancelled until further advice. The fare in these trains will be normal and for General coaches, second

seating fare shall be charged seating fare shall be provided to all the passengers. No catering charges will be included in the fare. Provision for pre paid meal booking, and e-catering shall be disabled be disabled.

AIR correspondent re-ports that all stalls at stations including food plazas will be opened but only take away food will be given. For these trains, only online E-Ticketing can be done through IRCTC website or through Mobile App. No tickets will be booked across the reservation counter on any Railway Station. The Advance Reservation Period will be a maximum of 30 days. RAC and Wait list will be gen-erated. However, waiting list

ticket holders will not be permitted to board the train. No tatkal and premium tatkal book-ing shall be permitted in these trains. Only passengers with Confirmed tickets will be allowed to enter the Railway sta tion

Counting on our collective responsibilities

The count is increasing from a trickle to a steady flow and the trend is more than likely to increase in the coming days with thousands more coming back from various places across the country most of which are already the most affected zones of Covid-19 pandemic. Many in the state are getting vocal of their growing concern for the efficiency and stringency of the quarantine centres being set up in different places to accommodate the thousands who are returning home.

The concern seem legitimate given the reports of mismanagements and lack of coordination in a number of these designated quarantine centres ranging from wining and dining by outsiders inside these centres to reports of quarantined persons roaming outside the designated centres. There are also repeated reports of returnees who are made to wait for hours and shuffling between centres before assigning one to them. Reports of inadequate facilities are also getting to a frequent event. These unfolding unfortunate events points to a flaw in the overall system of managing and running the centres and also an evident lack of coordination by the authorities. The state government and those entrusted with the

administration of these centres must immediately draw up and implement a standard procedure and practice for all the centres across the state including diet and hygiene. While the task is admittedly challenging and humans make mistakes even with the best laid plans, this is one time anything less than perfection will mean the difference between life and death. It would, however, be irresponsible on our part to dump everything on the state government and wash our hands off. Everybody in the state is in this fight as much as any government official or frontline health workers and any lack of cooperation or disregard of social protocol will certainly put everybody's efforts to waste. We should not hesitate to remind anyone who does not follow protocol of the dangers and risks to their lives and others. And for those who are guarantined at the designated centres across the state, it would prove more productive if their stay is considered a social responsibility rather than a favour to the society and bear the insignificant hiccups in management or facilities which are bound to happen from time to time. One other dilemma the public is facing during the present lockdown is that of the state security forces imposing penalty or 'fine' on 'curfew violators' while shops are allowed to remain open for specific period. The habit of bunching up even during waiting in queues is another issue we need to address ourselves. These social norms are implemented for the benefit of the

public in that these social obligations may become habit over time and will definitely help save lives- our own and that of others. We need to have this concept clear. Meanwhile, shops, petrol pumps and other public utility places should enforce social norms on the customers without which their service should be denied. Cooperation, coordination and a mindful approach can certainly save us from the scourge of Covid-19 oandemic

Over 200 booked in connection with misuse of social media in Maharashtra

The Maharashtra Cyber police has taken into custody nearly 213 people in 400 odd cases of misuse of social media, including offensive WhatsApp messages, sharing abusive Facebook posts and has removed 102 objectionable posts.

The cases include : 170 cases of forwarding offensive WhatsApp messages, 158 of sharing abusive Facebook posts and posting religious messages related to Coronavirus and spreading misinformation about the COVID-19 pandemic.

Maharashtra Home Minister Anil Deshmukh's directions to the Special Inspector General of Police, the Cyber Cell, has decided to take strict action against cybercriminals, in a bid to curb the spread of rumours and misinformation on social and misinformation on social media. The Cyber police has began stringent action against offenders, by serving notices under section 149 of the Criminal Procedure Code

(CrPC) to the culprits. The state's cyber cell is now keeping a close watch on controversial videos on Tiktok Facebook, Twitter, and other social media platforms. Till first May, the cell has registered at

to least 400 offences at various police stations across the state amid the COVID-19 lockdown. They include 18 offences related to Tik Tok video shares, 07 offences related offences related to objectionable tweets, 04 offences related to wrong Instagram posts and 43 offences related to misuse of audio clips/ You Tube, Deshmukh said and added that to women's safety would be given the top priority. The crimes include making

Tik-Tok videos, posting various provocative posts on social media, spreading misinformation about the COVID-19 pandemic, taking names of Coronavirus victims besides posting false

posters to defame political

leaders. Offences like slander, rsonal attack, online financial fraud are included in cyber crimes. The alleged offender can be prosecuted under the Indian be prosecuted under the Indian Penal Code 1860, Information Technology Act 2008, besides other laws. To prevent such crimes, strict action is taken also under section 149 of the CrPC 1973 by sending individual notices to offenders.

Warning the companies running Tik-Tok, Facebook, Twitter, and other social media platforms in India Deshmukh has directed them to immediately remove misleading and socially divisive content from their platforms.

Liquor stock to reach wine shops from bars and hotels in Maharashtra

In response to pleas from a hospitality association, the Maharashtra Excise dept has decided to allow hotels and bars to sell their stocks of perishable Indian Made foreign liquor (IMFL) to wine shops, so that the hoteliers could recover the loss to some externt.

In an order issued by Maharashtra Principal Secretary (Excise) Valsa Nair Singh, the department has permitted establishments holding FL3 licences to sell stocks of imported beer and wine to wine shops. However, the establishments will have to apply for special transport passes from local authorities in order to complete these transactions.

As per the ongoing lockdown rules, hotels, bars and restaurants are barred from selling liquor to valid permit holders for consumption on premises. "The exemption from the lockdown rules, which have ordered bars, hotels and restaurants to remain shut, will remain in force until the lockdown ends or until stocks last", states the order. Singh said that the exemption was aimed at ensuring that stocks of perishable liquor do not expire. that stocks of

"We are trying to make it easier for establishments to sell their stocks," she said. However, Gurbaxish Singh

Kohli, president of the Hotel and Restaurant Association of Western India (HRAWI), described the order as "illogical". "Why would wine

shops want to buy liquor from us when they have greater sales than we do? We will have to sell our stocks to them at MRP or bur stocks to them at MRP of less," he said and added that establishments would be reluctant to get into the process of applying for transport passes. This order is a knee-jerk reaction to what we had asked for. We will write to the Excise department asking what this order means". The Maharashtra

government on Tuesday announced that it will allow liquor shops to provide home delivery services subject to conditions for both the buyer and the seller. This scheme would be applicable to only those who have permits to consume alcohol. However, the order, issued by the state home department, will come into effect only after guidelines are finalised.

Only those who have permit for drinking can order home delivery. Liquor shops which have been allowed to reopen since 5 May, will be able to take orders on phone. The purpose is to avoid crowding at liquor stores and prevent the spread of coronavirus. "The mode of payment has to

be decided by the buyer and the seller. A person can order up to 12 IMFL (Indian-Made Foreign Liquor) bottles," an official said and added that the rules regarding possession of various types of liquor at home are displayed on the Excise department's website which buyers can check before

ordering. The decision comes after social distancing norms were flouted at several liquor shops that amid the lock down.
