Over 3 lakh 78,000 people recover from COVID-19 infection in country in last 24 hours

Agency New Delhi, May 17:

Over 3 lakh 78 thousand people have either been discharged from hospitals or are reported to have been completely cured since yesterday. So far, over 2 crore 11 lakh people have recovered from the COVID-19 infection in the country. Ten States including Maharashtra, Karnataka, Chhattisgarh, Delhi, Tamil Nadu, Uttar Pradesh, Punjah, Madhya Pradesh, Gujarat & Kerala continue to be the major hotspots of the viral pandemic. Nearly 75 per cent of the new cases are reported from these 10 states. The Health Ministry has informed that four thousand 106 COVID related death were reported in the last 24 hours taking the cumulative toll to 2 lakh 74 thousand 390.

In the last 24 hours, the nation registered 2 lakh 81 thousand 386 new COVID cases.

Despite 32 centers in 16 district, Covid-19 vaccination done in just 16 centers; many irked

Even as the state Health Directorate had announced to begin Covihied vaccination for people abve 18 years to 44 years from today at 32 centers in 16 district of the state, Vaccination was doe only in 16 centers one each at the respective district.

As per memorandum issued by the Directorate of Family Welfare Services, Manipur n May 14 and 15, a total of 39780 doses of the vaccines have been allotted, and this means at least a total of 39,780 people in between 18 years to 44 years should be vaccinated. As only one center at each district has been open for vaccination, obviously half the number will not get vaccination today. Reason for the vaccination

at only one center at each district is not let known to the people. Is it because the state does not have adequate quantity of vaccine stock or is it bekeeping some stock for the VVIPs or the VIPs demand, these are lot of questioned comes from various sections as the state authority is reluctant to put in public the exact number of vaccines in stock.

"They (health department) are simply trying to show that vaccination is going on and not with a dedication to safe the people', said Premjit, a social worker while interacting to Imphal Times.

Meanwhile, what shocks the people is the circulation of information by the Covid-19 Common Control Room and the Chart for vaccination report issued by the concern health department authority. In the Chart it has been reported that 1st dose vaccination done from January 16 till May 16, 6 pm is 3,09,896 people above 45 years. And the total number of people above years who got 2nd dose is 79,113.

However, in the press statement issued by the Covid -19 common control room, the total number of persons (above 45

Such error cause by dereliction duty or perhaps due to lack of qualifications causes confuse and people sometimes wonder on which information to be rely on . Mizoram Government going two steps ahead of Manipur in dealing COVID-19 issues

The state of Mizoram seems to be a step or two shead form Manipur Government when it comes to the preparation of containing the Covid 19 pandemic. The state which have just one medical college have decided to form a research team comprising medical experts and scientists to conduct a scientific study on the second wave of COVID-19. This was officially announced by the Mizoram Government authority last Saturday. Mizoram have one medical College called Zoram Medical College headed by former Director of RIMS Dr. Fimate.

The College has very new and few facilities. The VRDL was established just last year. However, scholars from the Biotechnology Dept, of Mizoram University trained the medical staffs in RTPCR and other logistics, said professor Robert Thangjam of the Mizoram University.

Manipur which have two major medical Institute – JNIMS run by a society established by the Manipur Government and RIMS, one of the premier institute of the North East India with all facilities including well equipped pathology departments and the recently opened Virology department are being occupied on testing of COVIS -19 suspects and slow pace of vaccinations be-

Killing 18 bulky animals by lightning an absurd argument: Assam engineers' forum

Tragic death of 18 wild Asiatic elephants due to electrocution by lightening within seconds can be justified only with an absurd argument, asserted All Assam Engineer's Association (AAEA), demanding a high-level scientific investigation into the Nagaon incident that took reportedly place on 12 May night. The forum of engineering graduates termed it as a matter of concern (caveat) for the wildlife and entire human race, if such a massive thunderbolt hit

the planet.

As the State government in Dispur, precisely the forest minister and the preliminary

findings of a probe committee, claimed that it might be a thunderbolt that killed all 18 bulky animals within seconds, the debate needs to focus on the essential volume of energy to strike on the jumbos at a time. Even if, it is assumed that the animals were close to each other during the incident, they needed more than 100 squaremeter area to accommodate themselves (means the area of impact), pointed out the AAEA statement.

Engineering science nar-

Engineering science narrates that a lightning strike, created by the electrical discharges due to imbalances caused between the Earth and storm-clouds (or sometimes within the clouds), can produce 40 Kilovault to 120 kV and 5 Kiloampere to 200 kA. Hence in an average a lightning bolt (from cloud to ground) may generate around 1,000,000,000 Watt (around one billion volts of electricity) and it can heat the surrounding air to 53000° Fahrenheit (5 times hotter than the Sun's surface).

When the cloud-to-ground lightning hit an animal, it creates sudden disturbances to the internal electric signals of a living being, which is necessary for functioning of organs like heart, lungs and the nervous system. Normally the affected animal faces a cardiac arrest, brain Injuries, spinal cord damages or even severe burns and subsequently it succumbs to wounds. Worldwide around 2,000 people are

killed every year by the incidents of lightning, where of course many survive with long lasting injuries.

"Hammering all the elephants within seconds demands a huge volume of energy that could have generated a massive thunder and light. Hence the news of such a thunderbolt in the Nagaon locality could have preceded the actual happening," claimed AAEA president Er Kailash Sarma, working president Er Nava J Thakuria and secretary Er Inamul Hye, adding that there was no major burns on the site and none in the locality admitted that they heard such a massive sound of thundering during the last few days.

Lok Sabha MP of the Inner Manipur Parliamentary constituency have even appealed the government to donate to Chief Ministers Covid -19 relief fund for pro curing oxygen and also for providing assistance to the victims of the Covid-19 Pandemic. Moreover, MLA Joykishan of Thangmeiband Assembly constituency had openly announced to spnd Rs. 20lakhs for procuring of Oxygen from his local area development fund and MLA RK Imo have started donating Oxygen concentrators to JNIM hospitals.

terday. So far the state of Manipur recorded a total of 39,729 covid-19 positive cases since the beginning of tis pandemic since March 2020. As per offi-cial statement from the Covid-19 Common Control Room, the number of death so far is 578. The total number of positive cases of Covid -19 so far is 32,729. And the total active cases of Covid-19 stands at 6477. One good news is that the recovery rate is told to be 82.24%. But the raise of the Covid positive cases in the last 15 days is alarming. Starting from May 2 till May 14 the total number of people tested positive is and the total number of people succumbed to Covid -19 is This report is based on the official statement released by the Covid -19 Common Control room. However as per medical experts the number of casualty due to Covid -19 cases may have been more then the number provided by the government authorities, as there are report of many died during this period without coming to the hospital or without hav-

ing tested.

Now with the spike of the positive cases and the rise in the death toll the government had open 14 (fourteen) Covid Care centers at some districts. The CCC open by the government are at BalBhan in Imphal East, National Sports University, Lamboikhongnangkhong KKK in Imphal West, RD Wing in Imphal West, Lanva

TD Block in Churachandpur district, Government College in Churachandpur district. Jiribam, DIET in Kangpokpi, TML Hr. Secondary School in Tamenglong district, Th. Tengkhojang in Noney district, GNM Hostel in Thoubal district, Kakching Higher Secondary school in Kakching district and Transit Hostel in Ukhrul district. Beside these, some of the Community Care center has also been open at various assembly constituency under the supervision of the respective MLAs of each constituency as directed by

the Chief Minister of Manipur.

Now many people as well as MLAs and Ministers have spared no pains to procure oxygen as the state is in need of oxygen. The CCC open by the government has been reportedly empty with few people only. As per a social media pot uploaded by Dr. Ranjan Sapam, who is also the health advisor there are 1094 beds available vacant in all the

According to the government statement 1488 D type oxygen cylinders and 568 B type oxygen cylinders have been made available to different Health Institutions. If this is true and if the news about the procurement of oxygen from outside the state is true, than definitely the state authority can new arrange some oxygen cylinders to at least the those 14 CCC opened by the government. Besides, the State health authority should assigned some health workers by providing proper PPE kits for emergency calls at each centers. In addition to this, the government can spare some money from the Chief Minister's Covid Care Fund for at least two meals to these centers or else the government can organized fund drive sepa rately for those inmates at

With all the facts, the government is nearing on the right track but due to lack of something which the common people cannot expressed something still is not on the right track.

We suggest the government hand this matter to Dr. Sapam Ranan and let him start planning with the help of experts to make sure that the CCC open by the government serves the people.

Not only is the health infrastructure in the villages weak but there is also a shortage of trained health workers. In the last one-year, these employees should have been trained to deal with corona, but this does not seem to have happened and so the Union Ministry of Health had to ask the community health center officials to train them for rapid antigen testing. This has to be done with immediate effect on a war footing as time is short. Corona infection has not only reached the villages but is also wreaking havoe. There are some rural areas of the contravalible. At least for now, the shortage of testing kits sould be addressed on a priority basis. It is a difficult task but it has to be done because it can save the villages from the wrath of Corona. It is also important for the state governments to work hard to empower the underprivileged and the deficient health infrastructure. All such centers are run in rented buildings and the employees working in them are also hird on contract basis. Open Letter to Chief Minister, Manipur

Submission of the recommendations of Indian Medical Association Manipur State Branch with regard to the second wave of COVID 19 in the state

Respected Sir,

In this regard the association in due consultation with the "IMA Manipur COVID Task Force" has come up with certain recommendations to help in the management of COVID-19 in the state. Copy of the recommendations is enclosed herewith for your kind perusal and necessary action.

Further, we would like to stresses that Indian Medical Association is the largest association of adoctors in the country and the association has contributed much in insues related to health. IMA Manipur State Brach has also contributed much in the health issues of the state. The association has been spearheading in spreading COVID health waveness since the first wave of COVID 19 last year. More than one hundred COVID 19 health waveness programs were organized since May last year. The biggest association of doctors in the state would like to stress upon the necessity of representing well in the State Consultative Committee on COVID 19 in the larger interest of public.

We are hopeful that you will consider our recommendations and subsequently convert them into actions.

Recommendations of the Indian Medical Association Manipur State

Branch in regard to the second wave of COVID-19 Pandemic in the state:

1) Ideally compulsory COVID 19 testing, either by RAT or RT-PCR on arrival of all passengers at Imphal Airport and all other entry points should be followed otherwise rigorous checking of all RT-PCR test results that the passengers produced on arrival by verifying with ICMR's SRF No should be done.

 A common SOP for admission and treatment of all COVID-19 patients for both private and government hospitals is a must to avoid any confusion in this difficult time. This will help in rational admission, judiciou treatment and optimizing the limited resources.

3) Conversion of some hotels to paid COVID Care Centers for the mildly symptomatic cases with good referral system with the higher COVID centers may be considered in the interest of those who can afford it as this will reduce undue pressure for admission of mildly symptomatic cases to Referral COVID Hospitals.

4) Strengthening of infrastructure of the parishboral builds are supported by the control of the second of th

reduce undue pressure for admission of mildry symptomatic cases to Accertal COVID Hospitals.

4) Strengthening of infrastructure of the peripheral health centers like the CHCs and DHIs to manage the mildly symptomatic with a robust referral system with the Referral COVID Hospitals will reduce the burden on Referral COVID Hospitals.
5) Givil bodies like Local Clubs and Meira paibis may be engaged in enforcing COVID Appropriate Behavior among the general public.
6) Junior Dectors and other Health Care Workers engaged on COVID duties on contractual basis must be well paid as per their regular counterpart. Further, preference should be given to them while seeking for regular government post later. Acknowledging their contribution in this way during this challenging time will boost their morale.
7) Life insurance scheme of the COVID Health Care Workers will also help to boost the morale of those who are risking their life in fighting the pandemic.

8) Guidelines for Home Quarantine, Home Isolation and Community Home Isolation Centers must be available readily to the public with strict nitoring.

9) All long duration indoor meetings should be discouraged in the

present situation.

10) Backup workforce of healthcare workers need to be developed at the earliest since the present HCWs are likely to burn out soon due to stress and infection. With regards,
