Manipur today observed the 172nd Death Anniversary of Maharaj Nara Singh at Kangla, Imphal. Chief Minister N. Biren Singh led the Ministers, MLAs and other officials in paying floral tribute to the portrait of Late Maharaja Nara Singh at his memorial. He also led other dignitaries in offering Tarpan at Nungjeng Pukhri Achouba.

The observation function was organised by Manipur Archaeology, State Department of Art and Culture, Government of Manipur.

After the floral tribute, a contingent of 1st Battalion Manipur Rifles offered guard of honour, gun salute and sounded the last post as a mark of respect to Late Maharaja Nara Singh.

Speaking on the occasion, N. Biren Singh stated that the State Government had started paying tribute and respect to our great forefathers, great organising functions at State level, to make people aware of their sacrifices towards protecting their motherland. Stating that whatever we have today is all because of the hard work and sacrifices of our great leaders, he added that our society would have no



value if we don't honour them and follow their paths. The Chief Minister recalled

the hardship faced by our forefathers during the Seven Years Devastation period (1819-1826) and hard work of great leaders namely Maharaj Gambhir Singh and Maharaja Nara Singh towards regaining their land from Awa. The Editorial **Delayed Recruitment Process:** CM Biren should drop the mic and declare the results

Ever since taking office as the Chief Minister of Manipur for the second term, Mr. Biren, time and again, on various occasions, pompously declared that he would move the mountains or die trying to make a corruption-free Manipur. Where there is a microphone, Biren always makes this promise. But has he done something substantial to prove his attempt? A big NO resounds.

Even just yesterday, he told a gathering at Manipur University that all state government recruitment would be conducted on a merit basis only in his so-called bid to root out corruption in the recruitment process. But his inability to declare recruitment results of various departments' examinations conducted before the election made people examinations conducted control in the focus in male people recall senior Congress leader Okram Joy's famous quote packed with mockery: "Biren-na nganba wabu, wa-oina louba yabra."

After the new government formation, Mr. Biren's announcement of "100 action points for the first 100 days" came as a surprise and shock to many. After taking oath as the Chief Minister of Manipur for the second term, Biren said that the first task of his government would be to make the corruption-free - a mission which is also included in the 100. But it was nothing new.

To commoners, recruiting employees based on bribes or through their connections with high-ranking officials or lawmakers is seen as one of the government's top corrupt practices. In addition, taking a long time in the recruitment process is deemed a delay tactic. Therefore, if the new government is genuinely striving for a corruption-free Manipur, the first step should be to declare the results of all recruitment examinations held just before the Assembly polls now; it will undoubtedly give an impression that Biren walks the talk. But he hasn't done it yet.

Kudos to the Election Commission of India for completing the entire election process of the 12th Manipur Legislative Assembly in just 62 days. The feat was something N Biren Singh & Co. should learn and digest to help themselves expedite the recruitment process of state government departments.

Scores of government departments invited applications for various vacant posts, and recruitments exams were conducted ahead of the election date announcement. According to a highly placed source, most departments have already completed checking the examination papers by 3 April 2022, following strict instructions from CM N Biren Singh to even work on Sundays. But, surprisingly, the results have not been declared till now. What is cooking here? Is it a delay tactic? Is the chief minister reluctant to give the nod to announce the results? Amid all these developments, rumors have it that directors of some departments have started sending out their aides to collect money from candidates giving ample time to people to fill the dots.

It is high time that Mr. Biren drops the mic and starts acting on his promises to display his commitment to corruption-free recruitment. The youths are watching.

A team of state police stationed at Mao Police Station in Manipur's Senapati district detected and seized suspected heroin powder worth around Rs 70 lakhs in international market during a regular frisking and checking of vehicles at Mao gate, 110 km north of Imphal on Saturday, reports said.

Inspector Worchipem Ngalung, Officer in Charge of Mao Police Station led police team stopped one Tata Truck (NL01L-3563) coming from Imphal towards Mao Gate for

checking at Mao gat and the team detected 2 packets containing white powder suspected to be Heroin,police said

The truck driver who identified himself as Maibam Nasir Khan (30) of Thoubal Moijing under Thoubal Police Station disclosed that it was heroin powder. Then the two packets

suspected to be heroin powder weighing about 1Kg and the Tata Truck were seized in presence witnesses, police added. Hence a regular case under ND&PS Act has been registered for investigation.

Sleep deprivation, **Diabetes are closely** connected

this figure is projected to triple. A simple formula for how many hours of sleep a healthy person should get per day is that if you feel tired after waking up, it means that you should sleep a little more. According to the US Center for Disease Control and Prevention, an adult person needs at least 7 and more than 9 hours of sleep a day. If after sleeping for 7 hours, your body remains active throughout the day, then that much sleep is enough for you. But if you feel tired and lethargic during the day, it means you should sleep a little longer. Research from the University of Bristol,UK also revealed the fact that sleeping and waking up at a certain time every day reduces the problem of insomnia. The habit of eating late at night should also be discarded. Also, people who make yoga and exercise a part of their lives get relief from the problem of insomnia. If the problem of insom-

nia still persists, then it is necessary to consult a doctor. Getting less sleep can increase blood pressure. Such people are 20 percent more likely to have a heart attack. They can also be surrounded by obesity. Actually, sleep acts as a bal-ance of hormones, due to which the development of the body and the mind remain agile. Getting good sleep increases effi-ciency. Due to this the immunity of the body increases and weight remains under control. Getting enough sleep keeps diseases like heart diseases and diabetes away. It is famous about Portugal's famous football player Cristiano Ronaldo that he never gets eight hours of sleep like common people. On the contrary, he sleeps five times a day for one and a half hours. This routine of his is going on since he used to play for Manchester United. A 40-minute power nap after lunch is also a part of his routine.

BJP leaders demand for ban on meat is against the indian constitution

8 out of 10 people in the country including the Hindus consume meat

First they wanted a ban on Hijab. Then they wanted a ban on Halal meat and loudspeakers for Azaan. Now, they want to ban meat.

On April 5, the South Delhi Municipal Corporation [SDMC] Mayor Mukesh Suryan attracted criticism from the citizens when he wrote a letter to the SDMC Commissioner Gyanesh Bharti, requesting him to order the closure of meat shops under its jurisdiction during Navratri. Navratri is a nineday Hindu festival, celebrated this

day Hindu festival, celebrated this year from April 2-11. According to the letter, as reported by the Indian Express, Suryan wrote "During Navratri days, people visit temples to pay respect to the goddess and to seek blessings for themselves and their families. People forgo even the use of onion and garlic, and the sight of meat being sold in open or near temples makes them uncomfortable. Their religious beliefs and sentiments are also affected when they come across meat shops or when they have to bear the foul smell of meat on their way to offer daily prayers to the goddess

An appeal from SDMC's counterpart, the East Delhi Mayor, came the next day. He appealed to the traders to close their shops on all nine-days or at least in the last three-days of Navratri. But no official order was published in this regard. Both Corporations are ruled by BJP.

In 2018, the SDMC also passed a resolution directing all restaurants and eateries to put up prominent boards, specifying if they were serving 'haltal' or 'jhatka meat' in theirregion. Halal and jhatka are two different forms of slaughters, wherein the former is permissible in Islam as it is claimed to have been designed in such a way that it reduces the pain suffered by the

animal. Whereas, jhatka is killing the animal instantaneously.

Similar orders were also passed by the District Panchayat of Aligarh [DPA] and the Ghaziabad Nagar Nigam [GNN] for shutting down meat and fish shops during Navratri. The official directive issued by the DPA President Vijay Singh, as reported by Hindustan Times, gave an ultimatum to the traders that failure to comply with the same may also lead to cancellation of the licence without any prior notice. Whereas, GNN order issued by Mayor Asha Sharma, stated "It has been directed by the mayor to maintain cleanliness in temples, and to close meat shops during the period. It has been directed that cleanliness be maintained in respective zones, in temples and to ensure meat shops remain closed", as reported by Indian Express.

The officials of the GNN claimed that such directions, which are applicable on five zones in the district, are routine orders issued every year during Navratri. The said order, which was issued on April 1. was reversed the next day stating that there is no official regulation from the government yet. However, these executive orders eventually led to ruckus between the traders as they were ultimately forced to close shops under the fear of actions from the authorities.

Although the ban led to hue and cry between the communities, the nail in the coffin was the politically charged statements on this issue. BJP MP Parvesh Sahib, from West Delhi constituency, came in support of the ban and told the NDTV reporters, "I welcome the decision which was taken by South MCD. I want all three municipal corporations to implement this. Also, I want Delhi-NCR and the whole country to implement this". Loni MLA Nand Kishor Gurjar

has a history of forcefully shutting down meat shops in his

constituency. Last year, in October, the MLA went from shops to shops and ordered the owners to close it. According to the MP, as reported by TOI, all meat shops in Loni are legal.

Yunus Idres Qureshi, Vice-President of the Delhi Meat Association, in response to the orders of the SDMC Mayor said, "The Mayor's request is politically motivated". On the other hand, Lok Sabha MP Mahua Moitra tweeted her criticism against the ban remarking "I live in South Delhi. The Constitution allows me to eat meat when I like and the shopkeeper the freedom to run his trade"

National Conference Leader Omar Abdullah called out against the order of the SDMC Mayor and tweeted, "During Ramzan we don't eat between sunrise & sunset. I suppose it's OK if we ban every non-Muslim resident or tourist from eating in public, especially in the Muslim dominated areas. If majoritarianism is right for South Delhi, it has to be right for J&K."

According to the 2021 Pew Research Survey, most Indians, except 39 per cent that describe themselves as pure vegetarian, do not abstain from eating meat and only 44 per cent Hindus consider themselves as pure vegetarians. Only 8 per cent of Muslims and 10 per cent of Christians consider themselves as vegetarians respectively

Essentially, 8 out of the 10 people consume meat in India including those from the majority religions This survey can also be corroborated by the 2014 nationwide survey published by the Registrar General of India. The survey indicated that males above the age of 15 who ate meat, fish or eggs was 71.6%. Whereas, the proportion of females was marginally lower to 70.7%.

The ban started in Karnataka when various Hindu outfits including Bajrang Dal and Vishwa Hindu Parishad were found to have been running door-to-door campaigns asking people to not use halal meat, when a section of Hindus organised 'Hosa Todaku' after the Ugadi (New Year's Day).

The Ugadi was celebrated on April 2, after which the Hosa Tadaku is celebrated in which those Hindus who consume non-vegetarian food, cook meat and offer it to gods.

These bans, especially the one on meat, comes down to two issues. First, are these bans necessary to maintain the sanctity of a religion? Second, if yes, how does that ban take place?

answer the first, it is important to understand that the Constitution grants the fundamental right to carry out trade under Article 19(1)(g). The only permissible limitation of this fundamental right is through imposing reasonable restrictions under Article 19(2)-(6). However, any reasonable restriction under Article 19(2) (6) must only be through a statutory 'law' as held in Bijoe Emmanuel & Ors. v. State of Kerala (1986). The orders by Mayors are executive orders and are not suffice to restrict the freedom of trade. The existence of law is a necessary requirement. Second, even if these bans were

backed by statutory law, it has to pass the tests of the golden triangle (Article 14, 19 and 21). To pass the test of Article 14, the law has to be tested through the parameters of reasonableness since the guarantee of equality is a guarantee against arbitrariness. Any law which is disproportionate or excessive, would be manifestly arbitrary as held in Sharaya Bano v. UOI (2017).

These laws prima facie fail the

test of equality since the Constitution does not permit a blanket ban on meat. The only restriction, that too not without any statutory law, is the one on cow slaughter under Entry 15 of List II of the Seventh Schedule of the Constitution. The ban is not backed by a legitimate aim since it's not just meat that people do not consume during Navratri. A blanket ban on meat whereas onion and garlic are also not consumed as even claimed by the SDMC Mayor, is unreasonable. Further, if the smell of the meat affects the sentiments and beliefs of a community, the same should be there throughout the year and not just on Navratri.

Second, if the state wants to restrict Article 19(1)(g), there must be a legitimate state interest since it will ensure that the law does not suffer from manifest arbitrariness. These bans are enforced on the grounds of respecting religious morality, in the absence of a statutory law to its effect. Morality, although a permissible ground of reasonable restriction on the right to carry out any trade, must not mean motivated by majoritarian sentiments. Constitutional morality, as observed in NCT Delhi v. UOI (2018), holds a balance against popular morality. The meat shops, that have been closed or led to forceful closure, are owned by individuals from different communities whose livelihood is dependent on it. Thus, even if the minuscule population is affected, which in this case is, the constitutional courts are bound to protect their rights as held in K.S Puttaswamy v. UOI (2017) and Navtej Singh Johar v. UOI (2018).

Moreover, it violates the right to freedom of choice of individuals under Article 21. The right to food as reiterated recently in In Re: Problems and Miseries of Migrant Labourers (2021) and the right to choose as observed in Soni Gerry v. Gerry Douglas (2018), is an intrinsic part of Article 21. Thus, it is understandable that the freedom to choose a particular food of choice would also be a matter of personal liberty and individual autonomy.

Lastly, Article 51(A)(e) of the Fundamental Duties promotes harmony and spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities

According to the Census of India, apart from the majority religions, more than 6 million people profess other religions and faith. Every religion and faith has its own custom and practice. An attempt to give these orders any legislative colour would infringe upon the secular feature of the Constitution because then it would lead to floodgates of different claims from different religious communities. shaking the very essence of Article 25. Article 25 of the Constitution allows to freely profess, practice and propagate religion.

Sans legitimacy, these bans only create societal unease leading to communal disharmony. While many communities do observe restraints on eating meat on certain occasions or eating certain types of meat, there is no logical corollary on putting a blanket ban on meat consumption for others when more than 70% of the people in India consume the same

Thus, any political overreach, regulating from the choice of clothes to wear to the type of food to consume, is surely unwarranted and constitutionally unsound. (IPA Service) Courtesy: The Leaflet

the importance of Hindi. Knowledge of English was an added advantage to Indians and this is perhaps one of the reasons for Indians being preferred in IT industry world over particularly in software. This is true of medicine engineering and Science. Indians are a cut above others in the World due to this advantage. It appears Indian government is ensuring that this advantage be lost when other countries like China is trying hard to acquire it. In mid-90s, Chinese authorities felt they were handicapped in their pursuit of export-led economic development to take advantage of globalization because of this language

barrier. So the government in China decided to make learning of English compulsory in schools. Today all Chinese passing out of schools in China know English very well. As Mahatma Gandhi said one should practice what he preaches. While BJP top brass may advocate imposition of Hindi, but one wonders why most of these BJP politicians send their children and grand-children to English medium school when they advocate learning and speaking in Hindi for common man. This applies to politicians in South as well. Late Karunanidhi, former Tamil Nadu Chief Minister and DMK supremo, who spearheaded

India's energy security cannot be compromised A rupee-rouble trade offers best protection

Russian Foreign Minister Sergei Lavrov's offer to India to consider a rupee-ruble mechanism to settle trade in goods between the two countries to avoid sanctions imposed by the US-led NATO comes at a time when the Indian economy is reeling under high prices of oil putting the country's energy security at risk. India needs a at risk. India needs a guaranteed supply of petroleum at stable prices to ensure its energy security and economic growth. The country's massive dependence on imported oil is fast exposing its economic weakness under pressure of the NATO financial and trade sanctions on Russia as oil prices in the domestic market are zooming up to unsettle the economy. India is entire around 86 percent dependent on imported oil. The latter account for the single largest share of the country's gross merchandise import bill. India's crude oil import bill may have exceeded the \$100-billion mark in 2021-22. The amount is nearly double its spending in the previous year as international oil prices are trading at seven-year high levels. According to the government's Petroleum Planning & Analysis Cell (PPAC), India spent \$94.3 billion on oil imports in the first 10 months (April-January) of the last financial year.

A return to the rupee-route trade after a gap of nearly four decades will be extremely beneficial to both oil-starved India and petroleum-glut Russia, which is sitting over possibly the world's largest oil reserve in any country. In fact, India should link its entire oil import with Russian suppliers depending on the landed cost (c.i.f.) of the commodity. It will considerably reduce India's annual trade deficit in terms of US dollars. India's trade deficit widened to a record \$192.41 billion in the last fiscal. In 2020-21, India's trade deficit was \$102 billion. Other than

petroleum and gas, India is a major importer of gold and diamond, coal briquettes and fertilisers. Russia is also India's single largest source of defence imports. Russia is the world's third largest producer of gold after Australia and China and accounts for about 10 percent of global mine production which, according to the World Gold Council totalled 3 500 tonnes last year. Polyus and Polymetal are Russia's top two gold producers. Till now, Russian miners mainly sell their gold to the country's commercial banks which then export it. The US-led sanctions on the

energy tie-up with Russia have been contested by a number of gas-starved NATO members, including Germany, Europe's largest economy. Even Japan, the world's third largest economy after the US and China, says it will maintain oil and gas projects in Russia citing the country's energy security concerns as the reason. Germany and Japan are most important strategic partners in Europe and Asia, respectively. Only a week ago, Japan's Economy, Trade and Industry Minister Koichi Hagiuda made an emphatic statement that his country "does not intend to withdraw" from oil and liquefied natural gas development projects in Development projects in Russia as they make a choice between energy security and tightening sanctions on Russia for the war in Ukraine. Several Japanese trading and other firms have invested in the Sakhalin-1, Sakhalin-2 and Arctic LNG 2 (ARC 2) projects. Each has been deemed essential to Japan's energy security. "We have interest in them and have secured long-term claimants," said Hagiuda. "In the current situation of sudden energy price increases, we can procure energy at prices cheaper than the market price. Cheaper than the market price. This is extremely important for energy security." He also said Japan "does not intend to withdraw" from the ARC 2 project in the Arctic. The Western economic

European investment in Russia's energy sector. Japanese and French companies that have invested in ARC-2 are no longer able to make new investments. "We want to analyse the impact of sanctions and respond appropriately," the Japanese minister said. Lately, Russian President Vladimir Putin signed a presidential decree requiring companies from "unfriendly countries" like the US, Japan and those in western Europe to pay in rubles when purchasing Russian natural gas. Sakhalin-1 has received funding from Itochu, Japan Petroleum Exploration Company, Marubeni and Inpex. Sakhalin-2 counts Mitsui and Mitsubishi among its investors. ARC 2 has received funds from Mitsui and Japan Oil, Gas and Metals National Corporation. Indian state-run oil companies also hold stakes in Russian oil and gas fields, while Russian entities including Rosneft along with another Russian firm own a majority stake in India's second largest single-location oil refinery Nayara Energy.

Russia's oil and petroleum product exports to India is only worth \$1 billion, and there are clear opportunities to increase this figure, Russia's Deputy Prime Minister Alexander Novak said in a recent statement. "We are interested in further attracting Indian investment to the Russian oil and gas sector and expanding Russian companies' sales networks in India," Novak told India's Petroleum Minister Hardeep Singh Puri. The Western economic sanctions have led to a funding squeeze on Nayara Energy. The Gujarat-based annual 20-million-tonne capacity refinery is 49 percent owned by Russian energy major Rosneft, the world's 53rd largest public company boasting total assets of \$228 billion in 2021.

In 2016, Rosneft roped in a Singapore-based multinational energy and base metals trading company, Trafigura Group Pte., and Russian investment group

prohibit new UCP to buy out Nayara Energy from its original Indian promoters, the Essar group. Navara Energy is facing increased finance costs due to Western pressure, even as India works to maintain trade with Russia. The sanctions now threaten to delay Rosneft's planned petrochemicals expansion at its Indian refinery. Last year, Nayara had signed a financial agreement with a State Bank of India-led consortium for a term loan of Rs 4,016 crore for the proposed 450,000 tpa capacity polypropylene plant at its Gujarat refinery. The SBI is believed to have told its clients that it will not process any transactions involving

Russian entities subject to international sanctions irrespective of the currency of the transaction. Presumably, Nayara will not be able to pay dividends to Rosneft due to problems in moving money internationally. Had Rosneft owned a majority stake in Navara, the refinery could have been in deeper trouble, unable to even source crude.

A bilateral rupee-rouble trade and investment agreement seems to be the best way out for India to ensure its energy security and reduce exposure to US dollar-linked trade and investment. Such an agreement will drastically cut down India's international trade deficit in terms of dollar, strengthen its own currency and help control inflation. Russia, the world's third largest oil producer and second largest natural gas supplier, should arguably become India's biggest partner in the energy trade. Incidentally, Russia expects both countries to continue cooperation also on civilian nuclear power and build new plants, including additional units at Kudankulam in Tamil Nadu. Notably, Russia and India have remained trusted

partners of each other despite strategic changes in the world order since the emergence of China as a top economic and military power. (IPA Service)
