Centre extends ceasefire agreement with three Naga insurgent groups for 1 year



The Centre has extended the ceasefire agreement with three different Naga groups for one more year. The groups are National Socialist Council of Nagaland/NK (NSCN/NK), National Socialist Council of Reformation (NSCN/R) and National Socialist Council of Nagaland/K-Khango (NSCN/K-Khango).

All three groups are breakaway factions of NSCN IM and NSCN K and have signed ceasefire agreements

with the government over the

A statement from the Ministry of Home Affairs said that the ceasefire agreements were extended from April 28, 2022 to April 27, 2023 with NSCN/ NK and NSCN/R and from April 18, 2022 to April 17, 2023 with NSCN/K-Khango. The agreements were signed on

The development comes even as NSCN-IM leaders, led by general secretary Th ah, on Tuesday met with A K Mishra, Centre's representative for Naga peace talks, at the outfit's headquarters. Camp Hebron near Dimapur.

Former special director of the Intelligence Bureau, Mishra, who replaced R N Ravi as the Centre's representative last year, arrived in Nagaland on Monday to discuss the Naga political issue. He is expected to meet the state government's core committee, as well as the Naga National Political Groups (NNPG) during his stay.
This is the first time that

talks on the Naga issue were held inside the NSCN-IM headquarters. The discussions on Tuesday lasted for

little more than two hours.

The meeting comes a week after Nagaland Chief Minister Neiphiu Rio, Deputy Chief Minister Y Patton and former chief minister T R Zeliang me Prime Minister Narendra Modi and Union Home Minister Amit Shah in Delhi to discuss the status of peace talks, which seems to have hit a roadblock since 2019.

The government has been trying to engage with various Naga groups, and not just NSCN IM, to finalise the Naga peace accord. It is an approach that the NSCN IM has not been comfortable with, particularly since former Naga interlocutor Ravi said the Naga peace deal would happen with or without NSCN IM

Last September, the government had signed ceasefire agreement with the Niki Sumi faction of the NSCN K. The NSCN K had signed a ceasefire agreement with the government in 2001, but withdrew from it in 2015 under the leadership of S S Khaplang, who is now dead.

of Uttar Pradesh and Haryana. Apart from the state capital Lucknow, most other such cities are located around Delhi. Cases have definitely increased in northern parts of the country, but this time the infection is not as serious as it was during the second wave in April and May last year. Freedom of Expression & Indian Constitution

Expression is a matter of liberty and right. The liberty of thought and right to know are the source of expression. Free Speech is live wire of the democracy Freedom of expression is integral to the expansion and fulfillment of individual personality. Freedom of expression is more essential in a democratic setup of State where people are the Sovereign rulers. **Iver Jennings** said, without freedom of speech, the appeal to reason which is the of democracy cannot be made. Freedom of Speech and Ex-pression is defined under **Article** 19(1) (a) of the Constitution of India which states that all the citizens of India have a right to freedom of speech and expression. The philosophy behind this Article lies in the Preamble of the Constitution of India- 'where a solemn resolve is made to secure to its entire citizen. their liberty of thought and expression'. The exercise of this right is, however, subjected to reasonable restrictions for some purposes being imposed under Article 19(2) of the Constitution of India. The following are the essential elements of the freedom of Speech and Ex-pression: This right is solely available to a citizen of India and not to persons belonging to other nations i.e. foreign nationals: the freedom of speech under Article 19(1)(a) includes the right to express one's views and opinions about any kind of issue and it can be done through any kind of medium, such as by words of mouth, by writing, by printing, through picturisation or through a movie; this right is not absolute as it allows the Government of India to frame laws which can impose reasonable restrictions in the cases which are involved ith the sovereignty and integrity of India or the security of the state, or friendly relations with foreign nations, even public order, decency and morality and contempt of court, defamation and incitement to an offence :such a restriction on the

Thus, if failure is found on the part of the State to guarantee to all its citizens the fundamental right to freedom of speech and expression would also constitute a violation of Article 19(1)(a). In a democracy like India, the

concept of freedom of speech & expression opens up channels of free discussion of issues. Freedom of speech plays a very important role in the formation and the showcasing of the public opinion on social, economic & political matters throughout the country. It ensures within its scope, the freedom related to propagation and interchangement of ideas, dissemination of information which would, later on, help the formation of one's opinion along with their viewpoint on certain issues and give rise to debates on matters which involve the public. So long as the expression is confined to nationalism, patriotism & love for our nation, the use of National flag by the way of expression of those sentiments would be a Fundamental Right. The independent judiciary of India has held and stated it's an opinion that the right to receive any information is an-other part of the right to freedom of speech and expression and the right to communicate and receive any kind of information without any sort of interference is a crucial aspect of this right. This is because a person cannot form an informed opinion or make an informed choice and effectively participate socially, po-litically or culturally without receipt

of adequate information. A print medium is a powerful tool for broadcasting any kind of information to any citizen of the nation. Thus, access to printed material is very crucial for the satisfaction of a person's right to freedom of speech and expression guaranteed to him under the Constitution. If any failure is found on the part of the State to make legislative provision for enabling access to people having print impairment of material in alternative accessible formats would constitute a deprivation of their right to freedom of

speech and expression and such an inaction on the part of the State shall fall in the wrong place of the Constitution. It is an obligation on the part of the State to make sure that sufficient provisions are made in the law which enables people with a print impairment to access printed material in accessible fornats. Under the Freedom of Speech and Expression, there is no separate guarantee of freedom of the press as it is already included in the freedom of expression, which is given to all the citizens of the na-tion. Freedom of the Press is not mentioned anywhere in the Constitution of India. However, it is present as a right under the meaning of freedom of speech and ex-pression (not directly expressed though) as laid down under Article
19 of the Constitution. If by democracy it is meant that the Government of the people of the nation, it by the people and it is for the people, then it is necessary that every citizen should be entitled to participate actively in the democratic process of the nation. Free debates and open discussions about certain matters are not possible unless there is a free and independent press. The freedom of the press includes one of the pillars of democracy and indeed lies at the foundation of democratic organization. It has been held so by the Supreme Court of India in many decisions that the freedom of the press is a part of the Freedom of Speech and Expression and covered under Article 19(1)(a) of the Constitution of India, the reason for this is that the freedom of the press is nothing but an aspect of freedom of speech and expression. Therefore, it has been rightly explained that although the Press is considered to be a medium for reaching the people's views to the everyone and yet it has to stick to the limitations which are imposed upon them by the Constitution under Article 19(2). In this case it was established after observing that the term "freedom of press" is not used under Article 19 in its language but it is contained in the form of its essence within Article 19(1)(a) of the Constitution of India, and hence, there cannot be any interference with the freedom of press which involves the public interest and security. Therefore, it was concluded that the imposition of censorship of a journal or prohibiting a newspaper from publishing their own views about any issue which involves public interest would amount to a restriction on the press' liberty.

There are many grounds on which the freedom of speech and expression can be restricted up to some reasonable restrictions by the state. Such restrictions are defined under the clause (2) of Article 19 of the Constitution of India which im-poses certain restrictions on free speech under the following: Secu-rity of the State; Friendly relations with foreign States; Public order; Decency and Morality; Contempt of court; Defamation; Incitement to an offence, andSovereignty and in-tegrity of India. Expressing one's opinions through speech is one of the basic rights guaranteed by the Constitution of India and in the modern context, the right to free-dom of speech and expression is not just limited to expressing one's own views through words but it also includes the circulation of those views in terms of writing, or through audiovisuals, or through any other way of communication. This right also comprises of the right to freedom of the press, the right to information, etc. Hence it can be concluded that the concept of freedom is very much essential for the proper functioning of a Democratic State. The words "in the interest of public order" and "reasonable restrictions" mentioned under Article 19 of the Constitution of India are used to indicate that the rights provided under this section are not absolute and they can be restricted for the safety of the other people of the nation and to maintain the public order and decency.

India's Hindu Rashtra Consolidating at Breakneck Speed

And the tactics employed are striking a chord with the Hindus. It's being driven home that time is fast running out for the Hindu way of life unless he pulls up his socks.

The resultant resonance suits Hindutva. The Congress-led UPA is aware of the crippling tactics employed but knows not how to retaliate in a patently Hindu-ma-jority country. The attempt to drive a wedge between "Hindu" and "Hindutva" fell flat, as was seen in the state elections held last and earlier this year.

The advantage to the BJP is that unlike the Congress and the other so-called secular parties, the BJP has never been shy in declaring its intent. In fact, polariza-tion is the BJP's USP, the most "basic" part of its strategy. Don't be surprised if some BJP Smart Alec with a degree from Harvard or Yale doesn't rename the BJP, Bharatiya Hindutva Party!

The sad part of the story is that the Congress party particu-larly has lost connection with the Hindu. The majority of Hindus at one time used to vote for the Congress, which was proof that an overwhelming number of Hindus were "secular-minded." But there was a chink in the secular armour and the Congress chose to ignore the warning signs. Hindutva was eroding the secular mindset.

Today, the rank and file of the Hindu, who are younger by the yard and mile, are bound by reli-gious nationalism, which is driving them to the Hindutya fold. It no longer quiet acquiescence, "reluctant acceptance of some-thing without a protest." The 'Hindu is waking up' is no longer a cliché. The belief is finding currency that for far too long the Hindu has suffered the humiliation of being labelled a "nation of cowards.

That said, if CAA has gone into 'thanda-buxa", it was because the Hindutva forces realized that something which didn't basically hurt the "Muslim minority" and therefore was not the glue to bring Hindus together wouldn't work towards polarization. It's the same with the "hijab". Muslim women wearing or not wearing the hijab does not hurt the Hindu, and therefore useless aid to polarize.

But 'halal' and 'loudspeaker' are potent weapons, patently polarizing because it is written in their dna. If 'halal' denies outright the "Hindu way of life", the "azaan on loudspeaker" is a daily provo-cation that plays on the sentiment that, for far too long, the Hindu has been at the receiving end, taking it on the chin and vet unable

to put a stop to the humiliation.
The possibilities are endless For instance, the "other" faith has only one god to flaunt. The Hindu had at last count 36 million! If push comes to shove, there could be countless "shobha yatras" every day of the year, countless provocations to the ones who choose to be easily provoked.

The confounding part is the "One God" people are falling for the trap, believing they are living in the medieval age. Their usage of terms like "Muslim areas" aren't doing them any good, either. After Partition and Pakistan, there shouldn't have been mention of "Muslim areas."

If India is pitted with Muslim and Hindu areas, then what? If India cannot be "Hindu Rashtra". India cannot also be "Muslim areas." It is dangerous. But to be-lieve that the Hindus threaten the idea of India because of their sheer numbers is missing the woods for

the tree. A growing number of Hindus believe that the "believers" are the Trojan to be feared.

Also, a misconception and complacency has crept in, which was spelled out by AIMIM's Akbaruddin Owaisi when he challenged the "100 crore" to "remove the police for 15 minutes." Yes, people on both sides of the aisle believe that the "coward nation of Hindus" survives at the mercy of the police and the army, remove them and the Hindu won't last even 15 minutes!

For the politician and political parties, the spate of communal ri-ots following the "shobha yatras" is what the doctor prescribed to win elections. What the rioting and polarization are doing to the Hindu and Muslim is something worse than unimaginable. No wonder a slumbering Amit

Shah is trending on Twitter even Snan is trending on lwitter even as the combined Opposition has written to Prime Minister Narendra Modi to wake up to the dangers of his ways. Maybe, a couple of Raj Thackeray's "bhompus" should be deployed to wake up the Rip Van Winkle. Politicians do not seem to know how the world changes when they are sleeping.

India's Covid-19 cases record 66% spike in 24 hours; death toll in China's Shanghai rises to 17

Agency New Delhi, April 20:

Recording a 66 per cent jump in daily Covid-19 cases from the previous day, India reported 2,067, new infections Wednesday, according to the Union Ministry of Health and Family Welfare. The death toll climbed to over 5.22 lakh with 40 fresh fatalities from a single one on Tuesday, the health ministry data also showed.

Active cases currently nd at 12,340 and comprise 0.03 per cent of the total infections. As many as 480 active cases were reported in a span of 24 hours. The government is ex-pected to issue an official order regarding the mandatory use of masks soon.

in Covid-19 cases.

Earlier, on Tuesday, Delhi recorded 632 fresh cases of Covid-19 however the number of hospitalisations are very low and deaths due to Covid are negligible.

Delhi Health Minister

Satvendar Jain had said on Monday that the Covid situation was not alarming in Delhi although cases were ris-ing. The number of hospitalisations were low and the government was keeping watch on the situation, he had

Meanwhile, following an increasing trend in Covid-19 cases in Delhi and the National Capital Region (NCR), some neighbouring states have also made the mask mandatory in public places in many of their districts.

Amid the fear of the fourth wave of Covid-19, the governments of Uttar Pradesh and Haryana on Monday decided to bring back the mask mandates in some of their districts. These mask mandates will apply to everyone in the city, especially schools.

ATSUM submits memorandum to VC MU for restoration of Non NET **University fellowship**

The All tribal Student's Union Manipur (ATSUM) submitted a memorandum to the vice chancellor of Manipur University demand-ing restoration of Non-Net University Fellowship to Research Scholars of Manipur University working under college Teacher affiliated to Manipur University.

In the memorandum the ATSUM said, "the Scholars who were admitted to any Central University under the proper channel laid down by the concerned department or the concerned department or following the norms of UGC or the University rule are eli-gible to apply for the univer-sity Non-Net fellowship once they register from their re-spective university. But the Organisation is shocked about hearing the news of some scholars in Manipur University working under college teachers are debarred from availing Non-Net Fel-lowship which can be termed as double discrimination and

injustice.
"The Organisation is very much aware of the fact that the scheme of Non-NET fel-

lowship is being provided to all eligible candidates in all the central universities for pursuing M.Phil/Ph.D. and who are not in receipt of any fellowship from any other sources. An amount of rupees 8000 per month is given to the con-cerned scholars who is regis-tered at the University.

"As per grievances re-ceived from our tribal scholar of Manipur University only those who got departmental guideship are eligible to avail of the Non-NET fellowship from the university despite same process of getting en-rolled into Ph.D. courses. Prashant Kishor, A ray of light

Right now, the issue is how prepared is the Congress, the main national party challenging the BJP in the elections, and to what extent will it be in a position to reiuvenate itself to take on effectively the elec-toral challenge to the BJP in the states where it is the main party against the saffrons. The poll strategist Prashant Kishor busy undertaking detailed talks with the Congress leaders led by Sonia Gandhi on a joint strategy to ensure the BJP's defeat in the 2024 Lok Sabha polls. PK's strategy has not got green signal yet, but if it happens, that will be posi-tive for the Congress Party.

There are some important elements in PK's concept which minimise the areas of differences between the Congress and the regional parties and underline the importance for the Congress to focus on the seats where it is the number one or number two party of the oppo-sition against the BJP. PK's note advises the Congress lead-ership not to spread the re-sources of the GOP to the areas where there are little chance of success. The party is already cash-starved and it has to use its financial resources judiciously so that optimum results are obtained.

Let us take a look at the Congress's present strength of the Lok Sabha. Out of its 53 members, 28 are from South India. There are 15 from Kerala, eight from Tamil Nadu, three from Telangana and one each from Karnataka and Puducherry. In Punjab, Congress has got eight members from Punjab, three from Assam and two each from Chhattisgarh and West In several states, the Con-

gress has just one member. These include Uttar Pradesh, Bihar, Maharashtra, Jharkhand, Madhya Pradesh, Himachal, Goa and Meghalaya. This grim position has to be change drastically in favour of Congress if the party has to cross 100 seats in2024 polls. PK has to perform this job which is only possible by adopting an innovative strat-egy which will facilitate the polling of maximum number of anti-BJP votes in favour of the Congress Party. This requires drastic reorganisation of the party units at grassroots level, massive collection of re-sources and ensuring the minimum division of non-BJP votes on the polling day.
