Congress Legislature Party wing leader Okram Ibobi Singh, who had hold the post of Chief Minister of Manipur for 3 consecutive years today hit hard to the BIP, saying that the number that the party get in the just concluded 12th Manipur Legislative Assembly Election is not the mandate of the people but was elected using unfair means.

Prime Minister Narendra Modi had stated – "We want the world to act with urgency. There had been reports of experts predicting droughts in the North-Eastern region of the country in the year 2016, and further deterioration in the amount of rainfall and availability of water with a concurrent rise in temperature. According to experts, a 2-degree Celsius increase in global temperature from the current level will be catastrophic,
but at the current rate of emission, the world will be warmer
by 3.6 degree Celsius by the middle of the century thereby

Why such a shortage of skilled hands in IT?

during the lockdown period, while most employees worked from their homes. Now that everything is in place, the work environment has also started to change. While qualified employees are changing jobs in search of better pay and working conditions, there is a shortage of skilled workers. According to a recent survey, 88 percent of IT firms are facing a shortage of qualified employees and a lot of difficulty in retaining them. A survey by a startup called Scalar revealed that 56 percent of IT companies feel that their industry is short of skilled and experienced hands. In the last few months, the annual rate of quitting from the IT sector has increased to 30 percent. Due to the increasing use of digital technology, the demand for IT professionals is increasing in the Indian markets. Employment opportunities are being created in technology, healthcare, e-commerce and manufacturing sectors. The job opportunities in the field of IT are much more than one can imagine. The way experienced and qualified professionals are in demand in the IT sector, qualified candidates are not much in supply.

To prevent employees from leaving their jobs, many companies have

To prevent employees from leaving their jobs, many companies have made up their mind to increase the salary and allowances of their qualified workers by up to 30 percent. According to a survey, 60 percent of the companies in the country are working on the plan to recruit new employees between the first quarter of the new financial year i.e. between April and June. A similar proportion is for companies that intend to increase their salaries to retain their qualified employees. The percentage of such companies is also around 60. One may ask, what happened that there was a sudden shortage of skilled workers in the IT sector? Actually, this is happening due to the rapid pace of progress in this industry. Startups are growing fast in the country, because the government is promoting startups and the number of unicoms has also increased. Due to these reasons there is a shortage of skilled workers.

Preparations are underway to make India the world's largest startup hub. At present, India is the third largest country in the world in this regard. Commerce & Industry Minister Piyush Goyal said in Abu Dhabi that India aims to develop the world's first largest startup ecosystem. For this, emphasis is being laid on synergy of investors and budding entrepreneurs. India is a country of 440 million youth. Such a huge young population does not exist in any other country. These include those who are born between 1981 and 1996. In US lingo, they are called Millennials. There is a need to make technical education accessible for them. Meanwhile, the process of issuing advertisements for recruitment to 20,000 government posts in Punjabis in the final stages. The Aam Aadmi Party government took this big decision as soon as it came to power, which is being praised. The number of unemployed in the state increases by more than one lakh every year. In such a situation the decision of recruitment is going to give relief.

Negligence towards children's education

As soon as the month of April comes, the school bells are ready to ring once again. After a long time the cries of children of pre-primary schools are ready to be heard from the school rooms. The most affected by the lockdown period in the country is education; And in education, the condition of pre-primary and primary education has been spoiled. In government schools, where the child is ready to go to school at the age of 5 to 6 years, education starts with admission in pre-primary classes from the age of 4 in private schools. Till now a full 2 years have

passed. Some children who were eligible for admission in the primary class have not even seen the face of the school; And if somehow the children of these ages are admitted in the school, then the schools closed due to the corona epidemic have not been seen. For them, school education and the fun and learning there is like a fairy tale. As soon as the new session starts, the teacher will have a new challenge for the elementary education of the children, because understanding the learning gap of 2 years, planning the upcoming action plan and preparing for the session. The school has an integral relationship with the children. Yes, if a child learns something after his home, it is from school. In the school, along with studies, education is given to the children for all round development. While in school, children do not learn their cognitive knowledge, emotional knowledge, social knowledge, physical development, intellectual development, logical knowledge as well as life useful skills. The basic skills of the children need more attention from the beginning of the session. Children's classroom has developed in the last two years, but the development of their academic skills seems to lag behind their mainstream. For this learning gap, every school is preparing at its own level, how much mentally prepared children need to be in this preparation, it depends on the schools, there is a possibility of increasing responsibility on the parents as well. Without the co-operation and support of parents, the concept of positive results will prove to be a dream.

To bridge the learning gap of school children, schools are ready to be operated from April, while some schools have even started the next classes. There may be a need to start from the first page to bring the children into the general stream in the elementary classes and primary classes. First of all it has to be found out what is the learning level of the child now and in what level he should have been. After this is detected, appropriate efforts should be made to rectify the weak aspect. Now it comes to the process of group learning-teaching, in such times there is a need to delve into the progress report of the children one by one; Otherwise, once a child backward in studies will go backward in further studies as well and his learning will be affected.

Chap of Corruption in Manipur

Corruption is a form of dishon-esty or a criminal offense which is undertaken by a person or an organization which is entrusted with a position of authority in order to acquire illicit benefits or abuse power for one's personal gain. Corruption may involve many activities which include bribery and embezzlement and it may also involve practices which are legal in many countries. Political corruption occurs when an office-holder or other government employee act in an official capacity for personal gain. Political corrup-tion occurs when an office-holder or other government employee act in an official capacity for personal gain. Corruption is most common in kleptocracies, oligarchies nacro-state and mafia states. Corruption and crime are endemic sociological occurrences which appear with regular frequency in virtually all countries on global scale in varying de-grees and proportions. Each individual nation allocates domestic resources for the control and regulation of corruption and the deterrence of crime. Strategies which are undertaken in order to counter corruption are often summarized under the um-

brella term "anti-corruption".

Stephen D Morris, a Professor of politics, wrote that a political corruption is the illegitimate use of public power to benefit a private interest. Economist Ian senior, defined corruption as an action to secretly provide goods or a service to a third party to influence certain actions which benefit the corrupt, a third party or both in which the corrupt agent has authority. World Bank economist Daniel Kaufmann extended the concept to include "

legalcorruption" in which power is abused within the confines of the law-as those with power often have the ability to make laws for their protection. The effect of corruption in infrastructure is to increase costs and construction time, lower the quality and decrease the benefit. Corruption can occur on different scales. Corruption ranges from small favor between a small number of people (petty corruption) to corruption that affects the government on a large scale (grand corruption) and the corruption that is so prevalent that it is a part of the everyday structure of society, including corruption as one of the symptoms of organized crime (system corruption). According to R Klitgard, corruption will occur if the corruption gain is greater than the penalty multiplied by the likelihood of being caught and pros-ecute. Since a high degree of monopoly and discretion accompanied by a low degree of transparency does not automatically lead to corruption, a fourth variable of " mo-rality or integrity"; has been intro-duced by others. The moral dimension has an intrinsic components and refers to a "mentally problem" and an extrinsic components refer-ring to circumstances like poverty, inadequate remuneration, inappropriate work conditions and inoperable or over-complicated procedure which demoralize people and set them search for "alternative solution"

Based more on concept than on evidence, it is taken for granted that corruption is caused by few dominating factors; authoritarian rule, intervention in economy and premodern cultural values and institutions. In this conception, corruption is a problem among poor states like Manipur. Certainly corruption in Manipur is conceived as a titanic challenge, causing damage to every aspect of social fabric, political instability and undermining confidence in public institutions. The popular concept of petty vs grand corruption suggests only a distinc-tion about the amount of money or political and economic actors involved in corrupt transactions. For a long time, the abuse of public office for private gain also known as corruption is a part of public life in Manipur. Nepotism, embezzlement and bribes are business as usual, a natural component of political culture of Manipur. Influenced by this context, leaders, academics, politicians met the debate about whether corruption is controllable with pessimism and skepticism. Its prolific growth begs the question: is corrup-tion omnipresent part of history, culture of state or are reforms strategies able to attack the problem sys-tematically? The involvement of politics and reforms to address corruption poses an even greater question: how can corruption are controlled in the state? This has become the central question challenging policy makers, leaders, students, activist and analysts. The argu-ments ofthis question raises such as: whether corruption is just a moralist demand to government in the state or new version about homemade obstacles to development and whether corruptionought totackle by public policies and reforms dending strategies beyond moralist discourse and lip service.

In Manipur the capacity to re-

spond on the policy level to these utmost demands is still weak and produces evasive reactions like discourse on morals and good intentions. Transforming corruption control and consolidation of good governance into public policy and institutional reforms in Manipur is still a herculean challenge. Growing awareness about the problems link to corruption resulted from either deterioration of moral standards of all stakeholders of government or a higher sensitivity to the public or both. Local institutions like police, bureaucracy, courts and legislative are deeply involved in the network of corruption and organized crime. The state political system lost its capacity for self-recovery. The expec-tations of walking scot-free set strong incentives for corrupt behaviors in the state. Citizens of state may commonsensically concludes that corruption pays of economically while integrity depends exclusively on a firm stance on moral and values. The dimensions of systematic damaged by corruption is difficult to measure but nonetheless has relevant consequences and includes the impact oncitizen'strust in public institutions. Sadly, there is no concerted effort or campaign in the state to fight against the menace of corruption. So the common people are in tight spot, the state forces unleashing bedlam on the people, while at the same time non-state actors (insurgent groups) generating may hem in the lives of the people who have no resources and power. The power of the gun and thirst for money and power make Manipur a moribund society.

With 1,086 new coronavirus infections being reported in a single day, India's total tally of Covid-19 cases rose to 4,30,30,925 while the active cases dipped to 11,871, according to the Union Health Ministry data updated on Wednesday.

The death toll climbed to

5,21,487 with 71 fresh fatalities, the data updated at 8 am stated.

The active cases comprise 0.03 per cent of the total infections, while the national Covid-19 rate remained at 98.76 per cent, the ministry said.

A reduction of 183 cases has been recorded in the active Covid-19 caseload in a span of

ecorded as 0.23 per cent and the weekly positivity rate as 0.22 per cent, according to the min-

The daily positivity rate was

istry.

The number of people who have recuperated from the disease surged to 4,24,97,567, while the case fatality rate was 1.21 per

The cumulative doses adnistered in the country so far under the nationwide Covid-19 vaccination drive has exceeded 185.04 crore. India's Covid-19 had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19.

The country crossed the grim milestone of two crore on May 4 and three crore on June 23 last year.

The 71 new fatalities include 66 from Kerala.

A total of 5,21,487 deaths have been reported so far in the

country including 1,47,793 from Maharashtra, 68,196 from Kerala, 40,055 from Karnataka, 38,025 from Tamil Nadu, 26,154 from Delhi, 23,497 from Uttar Pradesh and 21,199 from West Bengal.

Its Enforcement Directorate Versus Maharashtra SIT Now

By Raju Vernekar Mumbai, April 6:

While the Enforcement Directorate (ED) has been conducting raids on the premises of a couple of Maharashtra politicians in the last few months, under the Prevention of Money Laundering Act (PMLA-2002), the Maharashtra government set up a Special Investigation Team (SIT) to probe allegations of extortion against some of the ED officers, on Tuesday.

Maharashtra Home minister Dilip Walse Patil told the media on Tuesday said that an SIT under Additional Commissioner of Police Viresh Prabhu will conduct a probe into the allegations of extortion against ED officers. The investigation will be completed in due course and the decision over the action to be taken will be taken after the report is received, he added.

The decision to set up an SIT was taken based on the complaints of extortion received. Shiv Sena MP Sanjay Raut had alleged that some ED officials were involved in an extortion racket with one Jitendra Navlani, operating from Mumbai and New Delhi. He was threatening builders and corporate houses of Ed's action against them. In 2017, after ED raided 7 companies, Rs 25 crore was deposited in Navlani's bank account. Subsequently, additional Rs 15 crore was deposited in his account, as the ED raids continued. Raut had stated. The Mumbai police has lodged a formal complaint based on the application made by Shiv Sena leader Arvind

Bhosale against ED. The Maharashtra Minis-

ters Anil Deshmukh, Nawab Malik, and other leaders of the Maharashtra Vikas Aghadi (MVA) (Maharashtra Development Front), are already facing ED's action. On Tuesday, the ED issued a provisional notice to attach eight land parcels at Kihim in Alibaug (Raigad dis-trict) and a flat in Dadar in Central Mumbai, totally valued at Rs 11 crore linked to Shiy Sena MP Sanjay Raut and his family members. The Alibaug plots attached by ED are in the name of Varsha Raut (wife of Sanjay Raut) and Swapna Patkar (wife of Sujit Patkar) another associate of Sanjay Raut.

The money-laundering case against Sanjay Raut and his associates and family members is linked to a Rs. 1,034 crore land 'scam' related to the redevelopment of "Patra Chawl' at Goregaon in North Mumbai. Pravin Raut, an associate of Sanjay Raut, was a director of Guru Ashish Construction Pvt Ltd (GACPL), entrusted with the work of the redevelopment of the Patra Chawl, housing 672 tenants, spread over 47ants, spread over 47-acre land, belonging to the Maharashtra Housing Area Development Authority (MHADA). GACPL is a subsidiary company of Housing Development Infra-structure Ltd (HDIL).

GACPL never completed the redevelopment and Pravin Raut through the HDIL direc-Wadhawan and Sarang Wadhawan, sold the floor space index (FSI) (maximum permissible floor area that a builder can build on a particular plot of land), to various builders for Rs 1,034 crore, harming the tenants' interest, the ED's statement said.

Pravin Raut, who received the money from HDIL, transferred it to his relatives and close associates. Out of this, the proceeds amounting to Rs 83 lakh, were allegedly received by Varsha Raut from Madhuri Pravin Raut, the wife of Pravin Raut. Varsha Raut utilized this amount to buy a flat in Dadar. After the ED investigation began, she transferred back Rs 55 lakh to Madhuri Raut.

Incidentally, groundbreaking ceremony for the redevelopment of Patra Chawl was held on March 01 Now the work is being carried out by MHADA at an estimated cost of Rs 143 crore, af-

ter13 a year-long wait. Eventually, Pravin Raut was arrested by the ED on February 2, 2022, under the PMLA and he continues to be in iail. The HDIL director Sarang Wadhawan and his father Rakesh Wadhawan earlier arrested by ED in connection with around Rs 4,300 crore fraud caused to Punjab & Maharashtra Cooperative (PMC) bank are at present in judicial custody at Mumbai's Arthur Road jail.

Reacting to the ED action, Sanjay Raut said that the Alibag land was purchased in 2009 for which a loan of Rs.55 lakh was taken from Pravin Raut's wife This was also reflected in his elec-tion affidavit. The loan was subsequently repaid. He claimed that he did not know where the Patra chawl was located.

"This is a vindictive action since the BJP failed to destabilize the MVA government. The properties seized were selfearned, and if it was proved that he and his wife had even a rupee in black money, he would donate all his properties to the BJP. Such low-level politics was never seen in Maharashtra," he added.

Raut said he is not scared and will fight and expose everyone. "I am not one to get scared, seize my property, shoot me, or send me to jail Sanjay Raut is Balasaheb Thackeray's follower and a Shiv Sainik, he'll fight & expose everyone. I'm not one to stay quiet, let them dance. The truth will prevail," he tweeted. In another cryptic tweet, he said, "Asatyameva Jayate" (untruth alone triumphs).

It has also been seen in most of the children that if they know how to read, understand and speak in the elementary classes. then they start completing any studies easily, on the other hand, a child has difficulty in reading, understanding and speaking. If so, he falls behind his syllabus, and is not able to keep pace with his syllabus and he lags behind in studies. The children around him start judging himself more and less than himself, due to this he starts disinterested in studies himself. The disinterest in children towards their studies affects their academic life. Teachers will have to pay good attention to these things as well as maintain constant contact with the parents so that proper coordi nation can be done in the studies of the children.

From the beginning of April the heat has started showing its attitude. Fuel prices were hiked once again on Wednesday by 80 paise a litre, the 14th price hike in the duration of 15 days. Petrol and diesel prices have gone up by Rs. 10 per litre each in the past 16 days, after a four-and-half-month long hiatus in rate revision ended on March 22.

Rates vary from state to state depending on the incidence of local taxation, with Mumbai having the highest fuel prices among the In Delhi, petrol can be bought for Rs. 105.41 per litre, while diesel now costs Rs. 96.67 per litre, according to the latest notification by state-owned fuel retailers. In Mumbai, petrol and diesel prices per litre were listed at Rs. 120.51 per litre, increased by 84 paise, and Rs. 104.77 per litre, increased by 85

The Centre has been facing the heat from opposition parties over the non-stop rise in petrol and diesel prices. On Tuesday, Aam Aadmi Party's Sanjay Singh took a iibe at the Centre over the

Sumit became the fourth Indian semi-finallist at the ongoing tournament, which has been witnessing high-voltage competition in presence of 130 top boxers, including 74 male and 56 females, from Asia, Europe, Oceania and Africa. Monika (48kg), Ashish Kumar (81kg) and Manisha (57kg) are the other three Indians who have already progressed into

the Last-4 stage. Six Indian pugilists will be seen in action on Wednesday. While Bhagyabati kachari (75kg), Amit Panghal (52kg) and Rohit Mor (57kg) will play in the quarter-finals, Govind Sahani (48), Varinder Singh (60kg) and Ashish Kumar (81kg) will fight for a place in the finals.

In the last edition of the Thailand Open, held in 2019, the Indian contingent signed off with eight medals—one gold, four silver and three
