The Chief Minister was addressing the inaugural session of the Technical Textiles Conference at Hotel Classic Grande, Imphal today,

N. Biren said Manipur has lots of potential in every sector. We have started exporting various items including ginger, pineapple, he said, adding that even in sports out of our seven athletes at the recently concluded Common-wealth Games, five of them brought medals for the country. He cited the silk produced in the State, highlighting the State's potential in the handloom and handicraft sec-

Manipur with its rich textile tradition, strategic location and vibrant entrepreneurial eco-system has significant potential. Manipur is the land gateway of India to South East Asia, he said.

Further stating that Asian Highway is progressing fast, the Chief Minister further appreciated the National Highways and Infrastructure Development Corporation for the work along Imphal-Moreh

highway. The Chief Minister also highlighted cheap labour, round the clock water supply. wer supply, customs office at Moreh, law and order improvement and added that all these has created investment opportunities for entrepreneurs and industrialists in the State.

Further commending road work taken up by the Border Road Organisation Arunachal Pradesh as highlighted in a power-point presentation by Chief Engineer (P) Arunank Border Roads Organisation, (BRO), the Chief Minister expressed that Manipur needs these new technologies.

Citing that Manipur has soft soil, witnessing frequent landslides and long mon-soons, the Chief Minister said that these types of technolo-gies including the geo-textiles are very much important. He further requested Secretary Ministry of Road Transport and Highways, Government of India to ensure that these technologies are utilized along the Imphal-Jiribam, Imphal-Mao, Imphal-Aizwal and Imphal-Moreh roads. Further citing the lack of transportation options in the State, the Chief Minister asked the Secretary for dedicated teams along the Imphal-Jiribam and the Imphal-Mao highways to expedite road work progress.

Lauding the officials from the central ministries visiting the State, the Chief Minister said that such visits are important as the officials could study and understand the local reality during such visits.

"It has been said that process will begin on 20th August and conclude by 21st September. The exact date of the election will be announced in a few days. Let's see what happens,

Notably, Rajasthan CM and Congress leader Ashok Gehlot vesterday stated that the party is 'unanimously in favour of Rahul Gandhi for president post.' He added that 'considering the sentiment of party workers, Rahul Gandhi should accept the role.'
"The unanimous opinion is

in support of his (Rahul Gandhi) becoming the president. So, I think he should accept it. It is not about Gandhi or the non-Gandhi family. It is the work of the organisation and no one is becoming a prime minister,' Ashok Gehlot said

"In the last 32 years, no person from the Gandhi family became the prime minister or

the union minister or the chief minister. Then why Modi ji is afraid of this family? Why does Delhi Cm Arvind Kejriwal have to say that nothing happened in the country in the last 75 years? Why is everyone at-tacking Congress?" he added. It is important to note here that Rahul Gandhi had tendered

his resignation as Congress president after the party's second consecutive defeat in the 2019 General elections. Sonia Gandhi took over the reins of the party again as interim president. But she also offered to quit in August 2020 after an open revolt by a section of leaders, referred to as G-23, but the CWC urged her to continue

# SC pulls up Baba Ramdev, says it's good you popularised Yoga but don't criticise allopathy medicines

New Delhi, August 23:

In a huge embarrassment for Baba Ramdev, the Supreme Court on Tuesday criticised the yoga guru for his state-ments against "modern medi-cine systems" like allopathy. "Why is Baba Ramdev ac-cusing Allopathy Doctors?

He popularised yoga. Good. But he should not criticise other systems. What is the guarantee that what he follows will cure everything?" asked Chief Justice NV Ramana during the hearing.

The apex court made the remarks while hearing a petition filed by the Indian Medical Association (IMA) seek-ing to control the smear campaign against the vaccination drive and modern medicines

in the country. Notably, the Delhi High Court on August 17, 2022 rebuked Ramdev for question-ing the efficacy of Covid-19



"I am concerned about the good name of Ayurveda not being destroyed. It is a recognised, respected and ancient system of medicine," Delhi HC judge Justice Bhambhani said while pulling up the yoga guru. Baba Ramdev had moved

the apex court seeking stay on the proceedings in connection with multiple FIRs lodged against him by the IMA in Bihar and Chhattisgarh over

his remarks against use of allonathic medicine during COVID-19 pandemic.

The FIRs were filed after

the IMA alleged that Ramdev's remarks may dissuade people from availing proper treatment against the coronavirus pandemic.

The yoga guru was booked under Sections 188 (disobedience to order duly promulgated by public servant), 269 (negligent act likely to aa infection of disease dangerous to life) and 504 (intentional insult with intent to pro voke breach of the peace) of the IPC.

The yoga guru's alleged statement against allopathy had led to a huge controversy with the Indian Medical association strongly reacting to it. Ramdev, however, had with-drawn his statements after receiving a letter from former Union health minister Harsh Vardhan who had called his remarks "inappropriate".

# **Manipur's traditions** is the product of its civilization

Understanding the way of life, culture, traditions and religion leaving aside the economic conditions and society's existence is perhaps one important subject that one is desirous of understanding that society. So it is important to let my readers understand the nature of the Manipuri soci-

ety before going to the core issues.

As found in some of the writings of social scientists - the arrival of Hinduism during the reign of Miedingu Pamheiba (1709-1748) had brought tremendous change in the religious practices of Manipur. With the adoption of this new religion, human values of the Meitei people have become much worthy. From birth till death there are various stages at which necessary rituals are performed. Poor or rich in the Manipuri society makes no difference this rituals are performed with religious and traditional fervor. If any scholars or social scientist want to see living culture of a specific community, there is no doubt in saying that Meitei community could be

The adoption of Hinduism by the Meitei people may have been due to political necessities of the time. The political scenario of that time - that is during the reigns of Meidingu Charairongba (1697-1709), Meidingu Pamheiba (1709-1748) and Meidingu Chingthangkhomba or Bhagyachandra (1749-1749) and Meidingu Chingthangkhomba or Bhagyachandra (1749-1798) was described by historians as - at the most critical junctures. And it was also during the reign of these three successors that the social life of Meitei people was transformed to a momentous change.

They played very significant roles in the history of Kangleipak. After the death of Paikhomba, his nephew Charairongba, the son of his younger brother Tonsenngamba, ascended the throne in 1697. His reign was a transition period from traditional Meetei social situation to a Hindu Meetei Society. He constructed several temples for Meitei deities like Panthoibi, Sanamahi and Hindu deities after his espousal with Vaishnavism. The relation with Burma was deteriorated and more strengthened with India after conversion into Vaishnavism.

The advancement in technology and the fast growing standard of lifestyle under the influence of western culture cannot really give any impact to the ritual practice of the Manipuri people. Perhaps it is because of this religious prac-tice that Manipur lady still remain as a symbol of Manipur's identity.

identity.

A Meitei Hindu performs Swasti puja of a child on the fifth day after its birth. Unlike the Hindus of other states of India, when a Meitei Hindu performed the Swasti puja it was associated with the traditional "ipan Thaba" which was followed before the coming of Veisnavite culture. The beauty of Swasti puja is the gathering of friend and relatives of the family coming to give blessing to the new family memthe family coming to give blessing to the new family mem-

Later, after the child is three month old another ritual called "Chakumba" is performed. Chakumba is another ritual which cannot be skipped as it is a ritual at which the new member of family can start taking rice.

When the new member enters 3 or 5 years old, another ritual called "Nahutpa" is performed. This ritual signifies that the child has grown up enough to join with his friend and other member of the society to learn his or her sur-

The above mentioned rituals are regarded as essential rituals to be performed for both boy and girl child. Another "Lukun Thangba" ritual. Here the boy have to tonsure his head and performed some rituals. This ritual is often performed when the boy is around 18 to 20 years or more. This ritual signifies that the boy is permitted to get married and start a new life.

Marriage is one important event of every human being. As for the Meitei veishnavite it is conducted in big way with cultural fervor. Five days after the marriage there is again Ningol Chakouba - at which the family of the bride called both the bridegroom and their relatives and friend to a grand feast. In both the event all Meitei have to wear the traditional white Pheijom and Pumyat for the male and tradi-

tional clothes for the lady.

Death is one of the most important events of the Meitei people. The Meitei mourn the death for 13 days by performing rituals. First the dead body will be burnt and pray to the God. Later, every afternoon the family and the elders of the locality will gathered and listen verses from the Gita by an expert priest till the Sardha is performed on the 12th day after the death. On the fifth day of the death there is also a ritual called ASHTI.

The death soul is then remembered by offering feast to the elders every month for one year. And then "Phiroi" a ritual on the completion of one year was performed. This is the last rituals of a Meitei veishnavite.

This is unique traditions hardly known by any Hindu of any other places in the world including those in the Mainland

# Five years of the Myanmar-Bangladesh Rohingya crisis: Where is the solution?



Some 30,000 Rohingya children are being born every year in Bangladesh on average. As such, the number of Rohingya population has increased to more than 1.2 million. In this context, Bangladesh has requested the United Nations (UN) to put emphasis on family planning in

the Rohingya camps.

Foreign secretary disclosed this information after the 39th meeting of the National Task Force on Rohingya affairs at his office on Sunday after-

The start of a horrific military attack against the Rohingya people in Myanmar, which prompted three quar-ters of a million Rohingyas to flee over the country's borders, was nearly five years ago on August 5, 2017. The Myanmar military's deliberate, systematic, and extreme violence in killing, sexually assaulting, and displacing Rohingvas from their homelands and out of the country has been correctly labeled genocidal - that is, violence "committed with intent to destroy, in whole or in part, a national, ethnical, racial, or religious group." Though the persecution of Rohingyas in Myanmar did not begin on this date (it has been going on for decades), it was undoubt-edly one of the largest and most methodical attacks against the minority in recent years. The unprecedented refugee flood of Rohingya people and other communities from Myanmar's Rakhine State into Bangladesh began

almost five years ago.
Following a briefing by the UN Secretary General's Special Envoy to Myanmar, Bangladesh's permanent representative addressed the UN General Assembly on Monday (June 12, 2022), urging the UN to expand its programs in Rakhine State, Myanmar, to return the forcibly displaced Rohingyas. The envoy further requested that the Special Envoy en-deavor to ensure that the bilateral return arrangements for Rohingya refugees from Bangladesh are implemented



as soon as possible.

Bangladesh's representative to the UN, we believe, was quite explicit in her speech. It's been nearly 5 years. In one of the worst man-made humani-tarian tragedies in modern history, almost a million Rohingyas were forced to flee their homes. And the assurance of their safe return has yet to be ful-

filled.

In November 2019, Gambia, on behalf of the fifty-seven-nation Organization of Islamic Cooperation, filed the first international lawsuit against Myanmar at the International Court of Justice, accusing the country of violating the UN Genocide Convention. The court unanimously ruled in January 2020 that Myanmar must take emergency measure to protect Rohingya from violence and preserve evidence of possible genocide. A fi-nal ruling in the case could take years. Separately, the ICC authorized an investigation into alleged atrocities in November 2019.The International Court of Justice ruled on July 22, 2022, that The Gambia's case for genocide against Myanmar would proceed despite Myanmar's preliminary objections. According to academics and rights campaigners, the Interna-tional Court of Justice (ICJ) ruling has opened up fresh opportunities for the international community to put pressure on the Myanmar military to provide justice for the Rohingyas.

We're also concerned because the Russian invasion of Ukraine has shifted the world's attention away from Rohingya migrants and toward millions of fleeing Ukrainians seeking asylum in a variety of European nations. The Rohingya agenda should, at the very least, take a backseat in the face of an ongoing war and a rap-

idly changing World Order.

The point is that Myanmar is at the heart of the Rohingya catastro-phe. The ruling military junta in that country must step up its efforts to secure the refugees' voluntary and dignified return.

Bangladesh has done more than enough to accommodate over a million Rohingya refugees at enormous economic, environmental, and security costs; now it is time for the UN to assess the situation. Bangladesh's efforts alone will not be sufficient to bring about a long-term solution to the situation.

At the same time, accountability for all transgressions and atrocities in Myanmar is critical. As a result, we would like to remind the UN Security Council to keep an eye on the Inter-national Court of Justice's (ICJ) Pro-visional Measures in the case brought by the Gambia on behalf of

The international community, par-ticularly UN member nations, has a tremendous humanitarian responsibility and commitment to Rohingya refugees.

The world community must awaken from its slumber and see that the man-made crisis was not caused by Bangladesh, but rather by Myanmar's internal turmoil, which was unfairly imposed on Bangladesh.

Despite a series of UN resolutions, Myanmar has showed little interest in repatriating the refugees in dignity and with full citizenship

Apart from UN member states, re-gional countries and Myanmar's commercial partners, such as China, India, Japan, Indonesia, and Germany, ASEAN and OIC countries must also step up to put pressure on Myanmar to solve the humanitarian situation

riously.

Last but not least, if the international community fails to find a long-term solution to the humanitarian catastrophe, it must commit to taking in a million or more forcibly displaced refugees currently sheltering in Bangladesh, as it has done with many other refugees in the past.

We urge immediate action to as sist in making significant progress in building the conditions for the safe, voluntary, dignified, and long-term return of refugees to Myanmar. It is vital to address the core causes of Myanmar's systematic discrimina tion, disenfranchisement, and com munal violence.

India logged 8,586 new coronavirus infections taking total tally of cases to 4,43,57,546 while the active cases have declined to 96,506, according to the Union health ministry data updated on Tues-

day.

The death toll climbed to 5,27,416 with 48 fatalities which includes six deaths reconciled by Kerala, the data updated at 8 am showed.

According to the ministry, 210.31 crore doses of Covid vaccines have been administered in the country so far un-der the nationwide COVID-19 crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on Septem-

It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the onecrore mark on December 19.
India crossed the grim mile-

stone of two crore on May 4. three crore on June 23 last ye and four crore on January 25 this year.

The level of prosperity of a country will be judged by the level of education there changing global

It is worth mentioning that the medium of education, research and extension work is the medium of fulfillment of these three objectives, whereas the knowledge of mankind, culture and society is governed by research. According to UNESCO, the creative work done in a planned manner to increase the store of knowledge is called research and development. For example, what is the status of India's research and development in today's scientifically competitive world? Why is India lagging behind countries like China and Japan in terms of research work? What is the obstacle in India's progress in research and development which is stopping the wheel of research? It is noteworthy that initially the transfer of knowledge creation in various universities was on the basis of global learning and global sharing. Due to marketism, education increased quantitatively and privately It also developed in institutions, but in terms of quality, it became weak. It was from here that the wheel of progress of higher education and the research involved in it

began to slow down.

There is no doubt that the challenges before India in the field of research and development have increased. Research shows that about five decades ago, more than fifty percent of scientific research was conducted in universities. Not only this, universities were also seen as bastions of higher education and research centers. But at present, the situation is now only till the distribution of titles appears limited.

A major reason behind this is also the lack of availability of funds for research. Along with this, there is also less involvement of youth in research and more involvement in other fields. In the case of women, it would not be irrational to say that access to higher education is the biggest achievement for them. Barring achievements in a few selected areas. India's position on the global stage in research and research does not appear to be strong. At present, the number of people pursuing higher education in the cour try is more than 40 million in all formats.

The number of all types of universities is also more than a thousand. There are more than forty thousand colleges. Apart from this, many government and private research institutions can also be seen. The sooner it is understood that research suggests such a scientific way of development in a proper, sure and estimating and predictable way, by which it is possible to strengthen not only the inclu-sive structure of the country, but also the face of self-reliant India can be achieved. It has progressed on the

path of development and can grow only when it has adequate means of research and research at the level of higher education. In research and innovation, India spends only 0.7 percent of its total GDP, while the US has a comparative advantage with 2.8 percent and China with 2.1 per cent. Not only this, countries like Israel and South Korea spend more than four percent of the total GDP on research related activities. If we look at the inclusive spending of America and China from the point of view of research, then fought the trade

war and diplomatic Apart from this, there is also heavy competition in both the countries regarding research and higher education. China has overtaken the US in publishing research and in higher education. If we look at the report of the Ministry of Science and Technology of Japan, it is clear that China has the largest share in the number of research papers published all over the world. It is followed by America and Germany. Significantly, be-tween 2018 and 2022, China published 27.2 percent of research papers, while the same figure in the US is 24.9 percent.

The report also reflects that while China is doing the most research in engineering, mathematics, materials science, the US is doing the most research in basic life sciences and physical sciences. Due to lagging behind China the US has de cided to spend two hundred US dollars in the next ten years to strengthen its research Now let's talk about India. India's global position in research is not good. This is the reason due to which the ben-

efit of research is not available to the public. Unless research costs increase till then the ground reality will remain some-thing else. Considering the global situation of knowledge and research, India also needs to increase efforts for research.

However, talk of setting up a National Research Foundation has already been made. With its establishment, all the ministries need to cooperate more with IITs in the field of cience and research. To put it bluntly, higher education and research are such shining words, if they are rubbed in better ways, then India's shine will never fade in the world. higher education and research they are the backbone of the progress of the nation. Research plays an important role in higher education. In other words, both are complementary to each other. If the combina tion of higher education and research takes a comparative edge with the slogan Jai Anusandhan, then along with inclusive development, good governance will also get a

However, India ranks seventy-seven in the Global Innovation Index, followed by Switzerland at first, the US at sixth and China at seventeenth Low-density countries such as the Netherlands Sweden the UK and Singapore are second in terms of innovation, respectively., third, fourth and fifth place. That is why educationist Professor Yashpal had said that educational institutions which do not pay attention to research and its quality, they can neither do good to education nor to society.

We also urge the world community to remain in soli-darity with Rohingya refugees, as well as the Bangladeshi government and people who are kindly hosting them. The United Nations is committed to providing active help in the future. The Rohingya's misery must not become a political football.

At a time when the funds for the Rohingyas are dwindling, and when the international community has grown evidently disinterested in safeguarding the community, the sustainable course of action that the international community should undertake is the safe and dignified repatriation of the Rohingyas through international mechanisms.

The United Nations High Commissioner for Human Rights, Michelle Bachelet paid an official visit to Bangladesh on 14-17 August 2022. The visit came ahead of the fifth anniversary this month of the Rohingya exodus from Myanmar to Bangladesh. Howacknowledging Bangladesh's great difficulty in dealing with the Rohingya crisis, UN High Commissioner for Human Rights Michelle Bachelet assured the UN's continued efforts to realise the safe and voluntary return of the Rohingyas to Myanmar, She e assurance when Foreign Minister Dr AK Abdul Momen said that the protracted stay of the displaced Rohingyas in Bangladesh bears the risk of the spread of radicalism and transnational crimes and thus may hamper regional stability.

During her trip to Cox's Bazar, the high commissioner visited camps housing Rohingya refugees from Myanmar and met with the forcibly displaced Rohingya people, officials and non-gov-ernmental organizations. High Commissioner Bachelet appreciated Bangladesh's humanitarian gesture towards the Rohingyas and recalled that the government took good care of the displaced Rohingyas during the pandemic by providing Prime Minister Sheikh

Hasina has rightly pointed out to the United Nations High Commissioner for Human Rights, Michelle Bachelet, that Rohingya refugees in Bangladesh must eventually return to Myanmar. It's been almost five years since the Myanmar military carried out its most recent genocidal campaign against the Rohingyas, forcing around a million of them to flee to Bangladesh in search of safety. For a resource-constrained country like ours, hosting so many of refugees for five years has been a great challenge indeed.

Thus, on the fifth anniversary of the Rohingya crisis, we urge the world to do something for the Rohingya refugees They are not naturally refugees have birth right to live in their birthplace, Myanmar, with proper dignity. Otherwise, as a conscious human being, we can't ignore our responsibility.
