MOS (RRS) Dr. RK Ranjan to visit Jakarta

Dr. Rajkumar Ranjan Singh, Minister of State for External Affairs and Education will be visiting Jakarta, Indonesia on 28-29 August 2022 for an official visit to ASEAN Secretariat. This will be his first visit to ASEAN Secretariat and Indonesia. During the visit, in addition to engagements with ASEAN Secretariat, MOS will also have engagements to strengthen bilateral relations and interaction with Indian Diaspora.

During his visit, MOS will inaugurate the ASEAN-India Network of University (AINU) along with the Secretary General of ASEAN, Lim Jock Hoi, while commemorating the 30th Anniversary of ASEAN-India Dialogue Relations. AINU was announced by Prime Minister Narendra Modi at the ASEAN-India Commemorative Summit in 2018, as a consortium of premier institutes from India and ASEAN that would build a core network of knowledge capital through partnerships among academic and research institutions in India and ASEAN member states. AINU is being implemented by Nalanda University and ASEAN University Network from India and ASEAN, respectively.

14 years old boy died of insect bite

A 14 years old boy studying class IX at Megha Manipur School died of insect bite at RIMS yesterday evening. Later, Doctors at RIMS diagnosed disease as Scrub Typhus.

Scrub typhus, also known as bush typhus, is a disease caused by a bacteria called *Orientia tsutsugamushi*. Scrub typhus is spread to people through bites of infected chiggers (larval mites). The most common symptoms of scrub typhus include fever, headache, body aches, and sometimes rash.

14 years old Kambam Henthoba, a student of class IX at Mega Manipur School and son of Kambam Barendro of Khurai Chingbam Leikai Tinsid Road was reportedly admitted to RIMS on August 23 after he had high fever. When admitted doctors confirmed Scrub Typhus to the boy. Family source also said that he was bitten by an insect at school on the previous day. The boy was detected with multi organ failure due to the insect bite (Scrub Typhus). As he was admitted to the hospital after severe infection, the boy succumbed on Friday evening, family source said.

Teachers, students of Megha School and the Kambam Sagei Development Committee condole the demise of the student. A two minutes silence was maintained as a mark of respect to the departed soul.

Drugs worth Rs 5 crores seized

Modi Battalion under the aegis of IGAR (South) along with Manipur Police seized narcotics from Bongmol village, Tengnoupal District yesterday.

Based on specific intelligence input, Mobile Vehicle Check Post near Bongmol village intercepted a white color Bolero. The vehicle was moving from Sita village towards Bongmol village.

On thorough search of the vehicle, troops of Assam Rifles recovered suspected W1Y tablets in 10 yellow plastic bundles well concealed in the oil tank of the vehicle. The seized narcotics weighed 11.755 kgs and assessed to be worth approximately Rs 5 Crores in the international market.

The drug peddler along with the seized narcotics were handed over to Machi Police Station for further investigation.

CorCom pay homage to Haipou Jadonang on his 91st Death Anniversary

CorCom, the region's common body of major rebel groups, pay revolutionary tribute to Haipou Jadonang on his 91st death anniversary, which is observed on August 29.

The statement issued by the media coordinator, M.Sakhen, said Haipou Jadonang is a leader who fought against the British Empire for the freedom of the nation.

The supreme sacrifice he gave on August 29, 1931 for his motherland has now become an event of extreme importance to the present and upcoming generations, it said.

After Kangliepak (Manipur) was colonised by the British

Empire in 1891 at the dawn of the 20th century, Haipou Jadonang was born in 1905 at Kambiron village in Tamenglong as a child of "Thiudai" and "Tabonliu".

It said that since his childhood, he had been a brave individual who had love and affection for his motherland. At the time, Jadonang resolved to fight against the British-instituted system of using villagers as labour by state officials during their trips and taxation imposed on them, according to the report.

His rebellion against the British ignited the movement for self-determination amongst the people to fight for independence from colonial rule.

It said that he believed that preserving the indigenous cul-

ture and traditions of the people could be the key to exposing the hidden agenda of the colonial government and protecting the people as well.

His movement for self-determination constantly disrupted the plans and efforts of the British colonisers. This made the British officials plot a plan to eliminate him forever.

Jadonang was apprehended in Binakandi, Cachar, on February 19, 1928. In such a hasty manner, he was hanged near the bank of the Nambal River on the backside of Imphal Central Jail on August 29, 1931, it added.

The CorCom appealed to the general public of both the hills and valley to work together to restore the sovereignty of Manipur.

Justice UU Lalit takes oath as 49th Chief Justice of India


New Delhi, August 27:

A day after Justice NV Ramana retired, Justice Uday Umesh Lalit was sworn in as 49th Chief Justice of India on Saturday. President Droupadi Murmu administered the oath of office of the Chief Justice of India to Justice Lalit at Rashtrapati Bhavan in the morning hours. He succeeds Justice NV Ramana, who retired on August 26.

Justice Ramana had recommended Justice Lalit as his successor in keeping with convention and norms of seniority. The President subsequently confirmed Justice Lalit's appointment as the new CJJ.

Justice Lalit will have a brief tenure of 74 days as the head of India's judiciary and would demit office on 8 November.

Yesterday at the farewell function of Justice Ramana, Justice Lalit said that during his tenure of nearly three months he will focus on three key areas and one of his top priorities would be to make the listing of cases simple,



clear and as transparent as possible.

Justice Lalit has also promised to ensure a clear-cut regime where any urgent matters can freely be mentioned before the respective benches of the top court.

He assured that there will be at least one Constitution Bench functioning throughout the year in the Supreme Court.

Justice Lalit said, "I have always believed that the role

of the Supreme Court is to lay down law with clarity, consistency, and the best possible way to do it is to have larger benches as early as possible, wherever the matters are referred to such benches so that the issues get clarified immediately, the matter has consistency and the people are well aware of what exactly are the contours of the peculiar positions in law."

This Day has also been using its platform to encourage dog ownership of all breeds, mixed and pure, and continuously pushes for all dogs to be allowed to live happy and abuse-free lives.

The increase in stray dog population dramatically and becoming a threat to humans in cities. To control street dog population it shall be incumbent for Municipal Corporation to sterilize and immunize street dog population with the participation of animal welfare organization / NGOs, and private individuals. The street dogs shall be sterilized and immunized by methods currently approved.

The Municipal authorities have successfully captured many stray dogs with the help of expert dog catchers, but were criticized for their cruel treatment and killing of the captive dogs by PETA and other animal rights activists. It is seen that the stray dog menace happens mostly in the areas where there are rubbish & wastages are thrown. To discard or litter the waste along the road sides should be penalized and the door to door collection of food wastes by the municipal authorities should be encouraged instead of the road side bins. Efforts should be made to ensure that the animal birth control and rabies vaccination programmes are run properly. Municipal authorities should clean up the streets to make them rubbish free. The stray dog menace is in fact a grave problem in the City and the authorities should act immediately to tackle this issue seriously and effectively.

According to the Supreme Court directive no stray dog should be culled and only sterilisation is permitted for controlling its population. If the laws were in favour of street dogs, the Government should take measures to safeguard the public from the stray dogs. To control rabies, the municipalities in the affected areas have to get a clear picture about stray dogs in the area that must be vaccinated and leave the dogs in some far away areas. Revolution of electric vehicles and their pros and cons

I'd like to start this story by asking you a question. If you are going to buy a car, would you consider purchasing an electric car or a petrol-based vehicle? The electric vehicle revolution is here because of climate change and the shortage of petrol and diesel. You know that an EV runs on batteries. Climate change is the new buzzword, and why wouldn't it be? One world is all we have, and our world is at risk. Countries' corporates and citizens claim to be doing all they can to save this planet from climate change. Green energy is being floated as one of the top solutions. We are replacing coal with hydropower, fossil fuels with solar energy, and petrol and diesel cars with electric vehicles. EVs are being pitched as cleaner, greener, and more sustainable. But are they actually the real solutions? What's clean for the environment may not really be clean. Hidden beneath the shiny exterior of an EV is a story of blood battles. Do you know what these batteries are made of? Where do they come from? But from rare metals like lithium, nickel and cobalt, which are explored and mined by companies and corporates from the earth's crust rock through child labour, violating human rights, especially in Congo, where 70% of the world's cobalt supply comes from it. These cars drive human rights violations, extreme poverty, and child labour. What this statement really means will be digested in the coming paragraph. Electric vehicles are paving the way for the future of the automobile industry. The biggest vehicle manufacturers are shifting to EVs in a bid to keep fossil fuel emissions in check. The government has a plan to ban or limit petrol and diesel vehicles within the next decade. EVs are the future, but we must

also know that they need an entirely new rule book regarding regulations, safety, and precautions to protect us from EV fires, battery blasts, and electric shock. The EV market is going to grow exponentially. The reason behind the boom of EVs can be mentioned. Firstly, electricity used in EVs can be generated using local resources. Secondly, they can help to reduce carbon emissions. Thirdly, they will give us independence from fossil fuels that we currently import at a high cost. Fourthly, EVs may be expensive to buy, but they are much cheaper to drive, with regard to maintenance and per km cost. Fifthly, the government supports EVs.

In India, both the government and private entities are aggressively pushing for green mobility. But are our customers ready for this electric vehicle revolution, especially in India? Electric vehicles are the biggest trend. Technology is gaining popularity worldwide. The reason for this is simple. Countries are trying to move away from air pollution-causing fossil fuels, which will be extinct in the near future, and there is a global push for sustainable solutions in all walks of life, including the automobile industry. At the recently concluded 2021 United Nations Climate Conference, India pledged to cut its carbon emissions to net zero by 2070. India is also steering towards a battery-powered automobile revolution. State-run refiners have also announced plans to build thousands of electric vehicle charging stations across the country. Tata Company is the front runner in this regard, including the manufacturing of electric vehicles in India. Again, the Indian Oil Corporation, as announced, will set up 10,000 electric vehicle charging stations in the next three years in India. Bharat Petroleum will provide EV charging infrastructure at its 7000 fuel stations in the next few years, and Hindustan Petroleum has plans to set up 5,000 EV charging stations in the country in three years.

EV growth in India is currently hampered by high prices and inconveniences caused by a lack of charging stations. There are so many reasons behind this highly-priced EV. The batteries, which are made of lithium-ion and are very costly, are



imported from other countries. This stands against the goal of becoming a global hub and self-reliant in making EVs. There are some major challenges in India. The high initial cost of buying an EV is a big obstacle for most, especially in a value-driven market such as India. On average, an EV is twice as expensive as compared to its fossil fuel counterpart, although the running cost of an EV is cheaper in the long run. The government claims that it doesn't need any artificial push for the sale of EVs in India because the economy is so good that, due to the low per km cost, consumers will naturally shift towards buying EVs. The per km cost of a petrol-based vehicle is roughly Rs. 10, and for diesel, it is Rs. 7 per km, while for EVs it is Rs. 1 per km. Another challenge is the infrastructure to maintain and operate these cars for those who are living in homes, apartment communities or rent. The owner of the property may or may not permit the installation of electric charging stations. Sometimes vehicles catch fire due to battery blasts or there is a high current shock while charging due to non-certified or unrated charging points. These problems have been haunting the EV industry. The batteries need to be kept at room temperature, otherwise unfortunate things may happen. The recent reports of electric scooters catching fire could discourage many from adopting e-vehicles. This concern about safety needs to be addressed. Because an EV is a high-tech and complex electrical vehicle that connects to the internet, we must be concerned about high-potential security issues such as hacking, data breach, being vulnerable to attack, or having the car stolen.

Last but not least, it may be mentioned that environmental effects may happen due to the exposure or throwing away of used carbon-based EV batteries into the environment. This is one part of the story. Are we ready to buy an electric vehicle? The petroleum-based vehicle industry remains a dominant player in the automobile industry, but with rising concerns about fossil fuels and global warming, clean vehicles like electric vehicles are gaining popularity. The single most important factor driving the shift to electric vehicles is undoubtedly the battery. Performance, production, and the supply chain are all playing a decisive role. But are battery technologies and supply chains ready for the electric vehicle revolution? Anyway, the EV revolution is here. There's no doubt about it. Everything changes with time, from the stone ages to this highly modern generation, because necessity is the mother of invention. The only question is what the next innovation in electric vehicle battery technology will be and how that will impact the market. It's certainly hard to keep up with the accelerating pace of change. But we must keep up.

For every change, there are pros and cons to it. Now, let us digest some of the pros of EVs. First, money is saved due to lower running costs. With the coming of electric vehicles into the market, we will be able to save some budget that was spent a lot on petrol and diesel-based vehicles. The running cost of an electric vehicle is much lower than an equivalent petrol or diesel vehicle. Electric vehicles use electricity to charge their batteries instead of using fossil fuels like petrol or diesel.

Herbal Remedies for Sun-Tan in Monsoon

Many people skip applying sunscreen during the monsoon season because they believe the dark, grey skies won't have the same damaging effect as a bright sunny one. If you're under the impression that there's no sun amid the cloudy weather, then you couldn't be more wrong. Even if you do not see sunrays in the monsoon, they affect your skin.

Simply put, as long as there is daylight enough to distinguish the time of day from night, there is sunlight. And if there is sunlight, there are sun rays.

These rays easily pass through clouds in monsoon season and hit our skin. Clouds do not prevent us from UV rays

Sunrays consist of harmful UV and infrared rays that can cause a host of skin conditions like tanning which can happen during monsoon also.

Sun tanning is one of the immediate effects of sun exposure during monsoon. What causes tanning? Exposure to the sun increases the production of melanin, which is the skin's pigment, or colouring matter. Melanin actually protects the skin from the sun's harmful ultraviolet radiation. Once melanin is produced in the lower layers of the skin, it moves up to the skin surface. Since it is dark in colour, the skin also becomes tanned.

Since the sun is playing hide and seek these monsoons, let's find out some easy ways on how to remove tan with these natural remedies that can be easily made at home. They will help repair the affected cells, revive sunburn skin and make it glow as well.

Using a facial scrub is useful. You can buy a facial scrub according to skin type. If the skin is dry, a scrub should be used only once a week, but for oily skins, it may be used more often. The scrub should be applied and rubbed gently on the skin with small circular movements. Then wash it off with plain water. This helps to remove dead skin cells, along with their contained pigment. The skin becomes brighter and the tan is gradually removed.

You can make scrubs and packs at home with kitchen ingredients. In fact, many such ingredients can be applied on the skin to gradually remove tan and also soothe the skin, in case of sun burn.

Scrub: Ground almonds

(badaam) make a good facial scrub. Soak the almonds in hot water till the skin comes out easily. Then allow them to become totally dry. Grind them into a powder, making sure to follow absolute hygiene and cleanliness. Keep this powder in an airtight jar. Every morning, add a little curd or cold milk to two teaspoons of the powder and rub the mixture gently on the skin. Wash it off with water. Mixing rice powder with curd and using it as a scrub helps oily skins.

To remove tan: Add a pinch of turmeric (haldi) to curd and apply daily. Wash it off after 20 to 30 minutes. Or, mix one teaspoon honey with two teaspoons lemon juice and apply daily on the face, washing it off with plain water after 20 minutes.

Take the sandalwood powder and make it into a paste with the help of tender coconut water. Apply it to the tanned skin and wash it off with water after a while. You may replace coconut water with rose water or use the juice of cucumber instead.

To remove tan on oily skin: Mix cucumber pulp with yoghurt and apply it on the face daily. Wash it off after 20 minutes. It will suit oily skin, since cucumber is an astringent.

For oily skin: Mix tomato pulp with one teaspoon honey and apply daily for 20 minutes.

For sunburn: Cold milk applied daily, using cotton wool, not only helps to soothe the skin, but also

keeps it soft. It also makes the skin colour lighter over a period of time, if used daily. It would suit normal to dry skins.

To soothe the sunburn: Another remedy to soothe sunburn and protect the skin is by using sesame seed, or "til". Taking a handful of the sesame seed, crush it and add half a cup of water. Let it stand for two hours. Strain the liquid and use it to wash your face.

Cleansing and Skin Lightening Mask: Mix cucumber and papaya pulp with one teaspoon curd, one teaspoon honey, 4 teaspoons oatmeal and one teaspoon lemon juice. Apply on face and neck, twice a week and wash it off after half an hour.

Body: Massage daily with sesame seed oil. Mix besan with curd, lemon juice and a little turmeric. The paste should be thick and should not drip. Apply on neck, arms and legs three times a week for 30 minutes. Wash it off and then apply the oil, as recommended.

For hands: Take 2 tablespoons of sunflower oil and 3 tablespoons of coarse sugar. Mix together till it becomes a paste. Apply and rub into hands. Rinse off after 15 minutes.

For feet: Add lemon juice to water and soak feet in it. Cools cleans and removes tan and odour. Rubbing a lemon on the feet also helps.

India's active caseload drops below 90k-mark; 9,520 Covid-19 cases today

New Delhi, August 27:

With 9,520 new COVID-19 cases being reported in a day, India's tally of infections has gone up to 4,43,98,696, while the count of active cases has declined to 87,311, according to Union Health Ministry data updated on Saturday.

The death toll due to the disease has climbed to 5,27,597, with 41 new fatalities being reported, including four deaths reconciled by Kerala, the data updated at 8 am showed.

The tally of active cases

now comprises 0.20 per cent of the total infections, while the national COVID-19 recovery rate has increased to 98.62 per cent, the health ministry said.

A decline of 3,396 cases has been recorded in the active COVID-19 caseload in a span of 24 hours, the data showed.

The daily positivity rate was recorded at 2.50 per cent and the weekly positivity rate at 2.80 per cent, according to the ministry.

The number of people who have recuperated from the disease surged to 4,37,83,788, while the case fatality rate was

recorded at 1.19 per cent, as per the data.

According to the ministry, 211.91 crore doses of Covid vaccine have been administered in the country so far under the nationwide vaccination drive.

India's COVID-19 infection tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5, 50 lakh on September 16, 60 lakh on September 28, 70 lakh on October 11, 80 lakh on October 29, 90 lakh on November 20 and the one-crore mark on December 19, 2020.

The country crossed the grim milestones of two crore cases on May 4, 2021, three crore on June 23, 2021 and four crore on January 25 this year.

Thirty-seven new fatalities due to the disease were reported in the country a day back six from Haryana, four each from Maharashtra and Punjab, three each from Himachal Pradesh, Karnataka, Rajasthan and West Bengal, two each from Delhi, Gujarat and Odisha, and one each from Chandigarh, Goa, Jammu and Kashmir, Madhya Pradesh and Uttar Pradesh.

Revolution of electric vehicles and their pros....

The electricity cost can be reduced further if charging is done with the help of renewable energy sources installed at home, such as solar panels. 2. Price increases under control. There is no effect of the price rise on essential commodities due to the fuel price, road blockade and bandh blockade. 3. EVs are environmentally friendly and will have the least impact on the environment due to zero carbon emissions, potentially saving us from health risks and global warming. 4. Increased mileage. The cost of a litre of petrol is above Rs. 100 and may cover nearly 15-20 km, but the electricity that we get from this Rs. 100 will get more mileage in EVs as compared to fuel-based vehicles. 5. Low maintenance cost. Electric vehicles have very low maintenance costs because they don't have as many moving parts as an internal combustion vehicle. The servicing requirements for electric vehicles are less than the conventional petrol or diesel vehicles. Therefore, the yearly cost of running an electric vehicle is significantly lower. 6. Tax and financial benefits. Registration fees and road tax on purchasing electric vehicles are lower than for petrol or diesel

vehicles. There are multiple policies and incentives offered by the government depending on which state we are in, like registration fee exemption, purchase incentives, coupons, interest subsidies, road tax exemption, income tax benefit, scrapping incentives, and others such as interest-free loans, top-up subsidies, special incentives on electric three-wheelers, etc. 7. No noise pollution. Electric vehicles have the capability of silent functioning as there is no engine under the hood. No engine means no noise. Electric vehicles are so silent that manufacturers have to add false sounds in order to make them safe for pedestrians. 8. The ease of charging at home. Imagine being at a busy fuel station during peak hours, and you are getting late to reach your workplace. These problems can easily be overcome with an electric vehicle. Simply charge your vehicle at home for 4-5 hours before you plan to leave. If you are able to get a charger where you park at home, it is very convenient to plan your journeys in advance. What if you forget to plug in your machine someday? Then you can easily take the help of fast chargers or even battery swapping services if

you are on a two-wheeler on the road. 9. Electric vehicles are easy to drive and quiet. Electric vehicles don't have gears and are very convenient to drive. There are no complicated controls, just accelerate, brake, and steer. 10. Since the EV runs on electricity, there will be no problem with fuel unavailability in remote hill areas. 11. No dependence on oil-producing countries such as the Arabs. Since EVs run on electricity that comes from local resources, countries will become self-reliant regarding transportation. 12. Reverse charging of battery. One of the significant good points of EVs is that the car itself charges its battery while running. We know that an EV runs on a battery. But when we drive an EV, we use the brake to disconnect the accelerator panel from the engine. At this time, the rotation of the car wheels makes the car dynamo rotate (through electromagnetic effect), producing electricity which in turn charges the car battery.

Before we proceed with any decision, we need to go through all its cons too. 1. Limited charging stations. The EV industry is growing rapidly, but it faces several challenges. In order to achieve its full potential, manu-

facturers will need to overcome the current lack of infrastructure for charging stations, supply-chain issues, and many other operational concerns that are currently holding back the industry's growth. Public charging stations are not available in most places, and the charging process is very time-consuming. There is no standardisation across vehicle manufacturers, which leads to incompatibility between chargers and batteries. Depending on the state, these reduced charges range from Rs 5 to Rs 7. As a result, the cost of charging has decreased dramatically, and more EV charging infrastructure has been installed. However, there is still a long way to go until EV charging infrastructure catches up to the penetration of gas stations (over 78,000). 2. High prices. As of now, EVs are very costly. The base model of an EV costs at least Rs. 14 lakh. A middle-class family can't afford it. 3. Long-distance travel and charging time. Charging time is a big issue, especially for commercial users of electric vehicles. This may become a huge burden for emergency transportation like hospitalisation and exams. And also, what will happen if we travel a long route and the car

discharges its battery? But as the battery industry has made a lot of progress in driving range, battery cost, and weight reduction, innovations that reduce charging time are lagging. 4. Battery blast and electric shock. There is a high chance of EV batteries blasting due to over-charging, short circuits, high atmospheric temperature or using un-rated charging points. Over and above, charging an EV during rain is dangerous. People fear charging their EVs in the water because we all know that water is a great conductor of electricity. So, there is a high risk of being shocked by high current, voltage, or loose wire. Also, waterlogged areas are not safe for EVs either. 5. Environmental Consequences. When the batteries of EVs finish their life cycle of nearly 10 years, surely they will be thrown away, thereby affecting the environment's ecosystem from harmful carbon batteries. Are these EVs really climate-eco-friendly? We all know that petrol and diesel-based vehicles play a big role in global warming, triggering temperature rises through carbon emissions. But these EVs too need batteries made of metals like lithium, nickel, and cobalt that are derived after being mined

from Earth's crust rock. After they are used in cars, these carbon-based batteries will be disposed into the environment. We know how this story ends. 6. A large sum of money spent on replacing the old battery. The batteries used in EVs are not for lifetime. They have time and may expire after 8-12 years. Customers will face a significant financial burden in replacing their old batteries, which may cost up to Rs. 2-3 lakhs. 7. High risk of an accident. Since EVs are silent when driving, there is a chance of frequent accidents and road rage incidents because pedestrians may not notice the coming of EVs.

I am just expressing my opinions and claiming that what I say or express is right at all is completely wrong. No one is perfect and we learn from each other. As compared to its same model petrol or diesel-based vehicle

counterpart, EVs are more costly by nearly 5-6 lakhs, and also, when the battery needs to be replaced after 8-10 years, the expenditure that is to be borne may be 2.5-3 lakhs. However, if we buy fuel-powered vehicles instead, the extra lakhs can be used to purchase petrol or diesel, and the vehicle can drive and last for 7-10 years. Child labour and human life abuses are prevalent in the mining and exploration of lithium, nickel, and cobalt from the earth to meet the metal demand for EV batteries, particularly in Congo. Much like the claim of EVs being clean, these cars run just like on dirty energy of blood batteries and this is not a climate solution. This is human rights abuse, and the two can't coexist. A climate solution is not supposed to be at the expense of human lives. EVs have miles to go before they can claim to be cleaned.

FIFA lifts ban on AIFF, decks cleared for India to host women's U-17 World Cup

Zurich/New Delhi, August 27:

World football governing body FIFA on Friday lifted the ban imposed on the AIFF after the Supreme Court terminated the mandate of the Committee of Administrators (CoA), clearing the decks for India to host the Women's U-17 World Cup in October.

FIFA had suspended the AIFF on August 15 for "undue influence from third parties" and had said the U-17 Women's World Cup "cannot currently be held in India as planned."

The suspension, the first time in AIFF's 85-year history, lasted just 11 days after the Supreme Court on Monday dissolved the three-member CoA, constituted by it in May, while modifying its earlier orders to ensure that India hosts the FIFA Under-17 Women's World Cup from October 11-30.

"The Bureau of the FIFA Council has decided to lift the suspension that was imposed on the All India Football Federation

(AIFF) due to undue third-party influence," the FIFA said in a statement.

"The decision was taken after FIFA received confirmation that the mandate of the committee of administrators that was set up to assume the powers of the AIFF Executive Committee had been terminated and that the AIFF administration had regained full control of the AIFF's daily affairs.

"As a consequence, the FIFA U-17 Women's World Cup 2022 scheduled to take place on 11-30 October 2022 will be held in India as planned."

FIFA said it and the AFC will continue to monitor the situation and will support the AIFF in conducting its elections in a timely manner.

Sports Minister Anurag Thakur termed the lifting of ban as a victory for the game.

"Delighted to share the Bureau of the FIFA Council decided today to lift the suspension of the AIFF with immediate effect. The FIFA U-17 Women's World Cup 2022

scheduled to take place on 11-30 October 2022 will be held in India as planned!

"A victory for all football fans!" Thakur tweeted.

AIFF acting general secretary Sunando Dhar welcomed the move and thanked FIFA, AFC and Thakur for their roles in lifting the ban.

"The darkest hour of Indian Football is finally over. The suspension that was slapped on midnight of August 15 on the AIFF, has been lifted by FIFA.

"We sincerely thank FIFA and AFC, especially the AFC General Secretary Datuk Seri Windsor John for guiding us in such difficult times. We also take this opportunity to express our sincere thanks to the Ministry of Youth Affairs and Sports, and the Hon'ble Sports Minister Shri Anurag Thakur ji for solidly standing by us at this crucial juncture," Dhar said.

On Tuesday, Dhar had requested FIFA secretary general Fatma Samoura to "reconsider their decision of suspending the

AIFF".

"It is with immense pleasure that we inform you that the Hon'ble Supreme Court of India took up our matter and vide order dated 22.08.2022 was pleased to pass directions regarding the full repeal of the CoA mandate and consequently the AIFF having full charge of the AIFF's daily affairs," Dhar wrote in the letter.

"In view of the above, we request the FIFA and especially the Bureau to reconsider their decision of suspending the AIFF. "Since the conditions set out in your Letter for lifting of the suspension stand satisfied, we request that an order to that effect be passed at the earliest for the AIFF to continue with the smooth running of football in India," the letter further stated.

The CoA, headed by former Supreme Court judge AR Dave, had been overseeing the affairs of the AIFF since the May 18 order of the top court, which ousted Praful Patel as the president of the federation.

NSCN-IM resolves to stand by Framework Agreement for solution to NPI

The NSCN-IM Friday resolved to stand by the Framework Agreement for an early, honourable and acceptable solution to the vexed Naga Political Issue (NPI).

The solemn declaration by the outfit was made during the NSCN-IM Nagaland State National Workers Convention at Dimapur.

"We firmly believe, profess and stand by the Framework Agreement signed on 3rd Aug 2015 for an early honourable and acceptable solution as two sides (The Centre and NSCN-IM) have already agreed to work out the details on the competencies", it said.

The NSCN-IM workers also reiterated to stand by the decision of its May 31 National assembly held at its general headquarters Hebron to uphold and protect Nagas unique history and national principle at any cost.

The Naga group has been holding negotiations with the Government of India for an early political solution since 1997 post the ceasefire agreement.

The Framework Agreement was signed between the two sides on August 3, 2015 after several rounds of talks as the base for a settlement of the decades-old Naga Political Issue.

However, the NSCN-IM resolved to remain firm on its demand for a separate flag and constitution for the Naga people.

Foregoing the Naga National Flag and Constitution in the name of Naga solution is "tantamount to selling out the Naga National identity as stoutly defended by our forefathers, it said.

Chairman of NSCN-IM, Q Tuccu, who was among those who spoke on the occasion, said We cannot give away our rights for the sake of Naga solution and we can never compromise the Nagas' rights .

The NSCN-IM in a release called the Convention "historic" as nearly 7000 Naga national workers from 16 regions of Nagaland, both civil and from the army had participated and pledged to stand by its demands.

Justice UU Lalit takes oath....

The outgoing CJ Ramana on his last working day apologised for not being able to list all the pending matters and said the court has been firefighting pendency, which rose alarmingly during the pandemic months. Justice Lalit was a renowned senior advocate before he became the judge of the apex court. He was appointed a judge of the Supreme Court on August 13, 2014.

Justice Lalit will be the second CJ who was directly elevated to the Supreme Court

bench from the Bar. Justice SM Sikri, who became the 13th CJ in January 1971, was the first lawyer to be elevated directly to the top court bench in March 1964.

Justice Lalit was born on November 9, 1957, in Maharashtra's Solapur. His father, UR Lalit, was an additional judge at the Nagpur bench of the Bombay High Court and a senior advocate at the Supreme Court. Justice Lalit enrolled as an advocate in June 1983. He specialised in criminal law and

practised at the Bombay High Court from 1983 to 1985.

He shifted his practice to Delhi in January 1986, and in April 2004, he was designated as a senior advocate by the top court.

He was later appointed a special public prosecutor for the CBI to conduct the trial in the 2G spectrum allocation case.

After Justice Lalit's retirement on November 8, Justice DY Chandrachud is expected to be appointed as the 50th Chief Justice of India.

She has won India's first-ever gold at the World Championships across any age group, be it cadet, junior or senior level.

Linthoi is a part of the Target Olympic Podium Scheme (TOPS) scheme beneficiaries as



a development group athlete.
