## Imphal-Moreh rail line survey on track

The Northeast Frontier Railway (NFR) has started a final location survey of the 111 km Imphal-Moreh section for construction of a new broad gauge railway line intending to link India with the neighbouring Myanmar, NFR General Manager Anshul

Gupta said. The NFR General Manager, while talking with the media, said that the final location survey up to Moreh along India-Myanmar border is expected to be completed by July or August this year, fol-lowing which the budget estimate would be finalised

Railway Minister Ashwini Vaishnaw, after visiting

Manipur last month, accorded sanction for the final location survey of the 111 km Imphal-Moreh section.

The commercial capital of Manipur and India's gate-way to South-East Asia, Moreh is a rapidly develop-ing trade point in India on the border with Myanmar, with the city of Tamu on the other side of the border. The India-Myanmar Friendship Bridge in Moreh connects India to Kalewa in Myanmar's Sagaing Divi-

According to the other railway officials, the proposed new broad gauge rail-way line, once constructed, would be of strategic importance and form an important part of the proposed Trans-

Asian Railway which would connect India with South East Asia on a rail network.
The NFR is now imple-

menting the Rs 14,320 crore broad gauge railway project to connect the Manipur capital Imphal by 2024.

After the completion of

the vital 111 km railway line from Jiribam, along the Manipur-Assam border to Imphal by 2024, Imphal would be the fourth capital city in the Northeastern region after Assam's main city of Guwahati, Tripura capital Agartala and Arunachal Pradesh's Naharlagun.

The NFR is also laying new railway tracks to connect the capital cities of two more Northeastern States Mizoram and Nagaland.

Dr B Srinivas, Assistant Director General (Medical Education) and Member Secretary of the Medical Counselling Committee, in an order dated Thursday, said, "a lot of representations were being received from medical doctors regarding a request to delay NEET-PG 2022 examination

Also, many of the interns would not be able to participate in the PG Counselling 2022 by the month of May/ June 2022."

He said keeping the above facts in view, the Union Health Minister has taken the decision to postpone NEET PG 2022 by 6-8 weeks or suitably.

# 4984 cases pending against MPs, MLAs of which 1899 cases more than five yrs old: SC told

Agency New Delhi, Feb 4:

A total of 4,984 cases are pending against Members of Parliament and Members of Legislative Assembly/Council out of which 1899 cases are more than five years old, the Supreme Court was told on Thursday.
In his latest report, senior

advocate Vijay Hansaria, appointed as amicus curiae, told the top court that it may be noted that the total number of cases pending as of December 2018 was 4110; and as of

October 2020 were 4859. "Even after disposal of 2775 cases after December 4

2018, the cases against MPs/ MLAs have increased from 4122 to 4984. This shows that more and more persons with criminal antecedents are occupying the seats in the Parliament and the State Legislative Assemblies. It is of utmost necessity that urgent and stringent steps are taken for expeditious disposal of pending criminal cases", said the report filed through advocate

Sneha Kalita.

The top court has been passing a slew of directions time-to-time on the plea filed advocate Ashwini Upadhyay for ensuring expe-ditious trial of cases against lawmakers and speedy investigation by the CBI and other agencies. Hansaria said that the sta-

tus report filed by the High Courts also shows that spe-cial courts are constituted in some of the states whereas, in others, the courts of the respective jurisdiction are conducting trials in terms of the directions passed from time to time. "These jurisdictional courts conduct the trial of the cases against MPs/MLAs along with discharging other roster allocated to them. In many of the States, the same iudge is a Special Court under various statutes such as SC/ ST Act, POCSO Act, etc", the

The amicus pointed out that no response has been filed by the Central Government as per the order dated August 25, 2021, concerning the expeditious investigation/trial of cases, providing of infrastructure facilities to the Courts, and constitution of the Monitoring Committee to evaluate the reasons for the delay of investigation. "It is necessary that all the Courts trying cases against MPs/MLAs are equipped with necessary infrastructure for the conduct of court proceedings through internet fahe said. Hansaria sought directions from the court that the courts dealing

with cases against MPs/ MLAs will exclusively try these cases against lawmakers and other cases would be taken up only after trials of such cases are over. trial would be conducted on a day to day basis in terms of section 309 Cr.P.C. Necessary allocation of work would be made by the High Court and/ or the Principal Sessions Judges of every district within two weeks", he said. He further sought direc-

tion that both the prosecution and defence shall cooperate with the trial of the case and no adjournment shall be granted in the case, the pub-lic prosecutor and/or the prosecution fail to co-operate in the expeditious trial, the matter shall be reported to the Chief Secretary of the State who will take necessary reme-dial measures. He added that in case, the accused tries to delay the trial, his bail shall be cancelled. "The trial court shall send

a report on each of the cases where the trial has been pending for more than five years before the respective High Courts, as to the reasons for the delay and suggest remedial measures. The High Court shall consider these reports on the judicial side in the suo motu writ petitions registered in terms of the order dated

September 16, 2020, and pass appropriate orders to remove the stagnation of trial", he said.

Hansaria also sought direction that the Central Government will provide funds for ensuring the smooth function ensuring the smooth function-ing of Courts through virtual mode that is by facilitating the availability of video confer-ence facilities. "The High Courts shall

submit a proposal to the law secretary of the Government of India in this regard as to the funds required, which shall be made available by the Central Government within two weeks of the proposal", he said.

engines. The Reserve Bank of India will issue a Digital Rupee of its own. A Digital University will be established. Digital banks will be set up across India. An e-portal will be created for skilling and employment purposes. Kisan Drones will be used to make agricultural operations easier and faster. In the budget speech, the Finance Minister said that the digital rupee will work through Blockchain technology and can also be converted into the current currency. The digital rupee will be of two types, retail and wholesale. The general public will get the benefit of retail digital currency and banks will use wholesale digital currency. A digital university will be formed, in which education will be available in regional languages. Under this initiative, One Class, One Channel scheme will be applied. At present, 12 TV channels are engaged in the work of imparting education, whose number will be increased to 200. Through these channels, education from class 1st to 12th will be possible. TV sets will be installed in every

According to the plan, digital banks will be set up in 75 districts of the country. Through these it will be possible to save time and money. Common consumers will get convenience from the arrival of these banks. In addition, post offices and banks will be interconnected, so that money from post offices can be sent directly to banks. Similarly, a huge digital platform will be created, which will be linked to 16 ministries. The ministries to be brought under one umbrella with the intention of strengthentries to be brought under one umbreila with the intention of strengthening infrastructure will include roads, railways, power, petroleum and gas, shipping, telecom, civil aviation and industrial parks. The new infrastructure plans will include 109 new airports, 51 heliports, 12 water aerodromes, 2,000,00 kilometer long highways, 200 mega food parks, etc. The length of national highways will be increased by 25,000 km. The expansion of roads will give impetus to the country's economy. An e-portal of the digital ecosystem will be started for skilling and employment. This portal will be used to enhance the skills of youth through digital medium. Digital teachers will be hired to develop digital content. 750 virtual laboratories of mathematics and science are also to be started

Kisan Drones will be used to ease agricultural operations in the country. Startups making drones will be encouraged. Drones will be used as a service. Kisan Drones will be used for identification of crops, land records and spraying of insecticides etc. The use of drones in agriculture can prove to be transformative for Indian agriculture, making farming smart and efficient, but their cost is still very high and this may stop small farm owners from being able to take advantage of the drones. The number of farmers using high technology is currently less than one percent. But it is good that at least a step is being taken to use technology in agriculture. Such plans should be welcomed. Farming has always been far from technology. The use of technology like telecom, internet, social media and drones will certainly usher in a revolutionary

# Saraswati Puja: The festival of learning

India is the country of religions, faiths and festivals. There are more festivals celebrated in India that anywhere else in the world. Each festival has its own customs, occasions and impor-tance. Saraswati Puja is one of the eminent festivals heralding the arrival of spring season. It is celebrated on Panchami of Magha Shukla Paksh of Indian calendar; hence it is also termed as Vasant Panchami, Sri Panchami, Saraswati Panchami in some parts of the country. The festival usually falls in last January or February month of Gregorian calendar. In south India, Saraswati Puja is also celebrated as "Aayudha Puja" during Navratri festival (which usually falls in October/November). Saraswati Puja has its own sig-

nificance as the young children starts their first step in the field of education by writing the letters of alphabet with ritual known as "Akshar Abhyasam", "Vidya Arambham" or "Patti Pujan". On this day, Goddess Saraswati is worshipped in Mandirs, schools, col-leges, educational institutions, Musical & cultural houses as well as other public places, particularly by students and teachers.

In Saraswati Puja, yellow and white colours have its own importance. The Goddess is dressed in yellow or white and traditionally people dress up themselves in yellow or white coloured cloths. Actually yellow colour represents en-ergy, knowledge and enlightment, whereas white colour symbolizes light, knowledge and truth.

Goddess Saraswati is known by several names such as, Vageshwari (Goddess of Speech), Veenapani (Goddess carrying Veena in

Bharati (Goddess of history), Vani ( m e l o d i o u s speech), etc. by their devotees.

Maa Saraswati lds Pustak holds (book), Mala (Rosary), Jalpatra (Water pot) and Veena in her four arms, which has symbolic meaning of importance. The book symbolizes Veda or learning,

the Rosary represents a meditation and spirituality, the Water pot signifies purifying power to separate right from wrong and the Veena symbolizes all creative arts & sciences. Her four arms denote four sides as well as four aspects of human personality in learning, namely-Manas (mind), Buddhi (intellect), Chitta (alertness), and Ahankar (ego). Her vehicle is Hansa (Swan), a sacred bird, which if offered mixture of milk & water,

symbolises the abiltween good & evil. Sometimes Mayur (peacock) is also shown sitting near her feet, which s y m b o l i z e s colourful splendor & prosperity.

Maa Saraswati is a part of Tridevi

- Saraswati, Lakshmi, and Parvati, who are associated with almighty Tridev - Brahma, Vishnu and Mahesh. During Navratri, on seventh day Goddess is worshipped in the form of Maha Saraswati, in honour of Goddess of learning & knowledge.

Goddess Saraswati has mention in Rigved, Upnishad and other Dharmashashtra and remained significant from Vedic period through modern times. In Shanti Parva of Mahabharat, She is called mother of Vedas. Rigved signifises her both as a holy river as well as a deity. As per Rigveda - 2.041.16, "Ambitame Naditame Devitame Saraswati", i.e. Saraswati is the best of mothers, mightiest of riv-ers, and supreme among Goddesses. Mythologically, she is one of the three holy rivers of Triveni Sangam at Prayag in an invisible form. Shrishti Khand of Padma Puran as well as Skand Puran have detailed mention of Saraswati becoming the river on earth.

The Goddess is referred as Maha Saraswati in Kashmir Shakti Peeth, and as Shardamba in Sringeri. The ancient Sharda Peeth, located in Pak-captured portion of Northern Kashmir on the bank of river Kishanganga (now renamed as Neelam), is one of the oldest surviving temple of Saraswati. As one of the ancient Mahashakti Peeths, Sharda Peeth is the spiritual location of fallen right hand of Goddess Sati.

In Jainism faith also, Saraswati revered as the Goddess of source of learning and responsible for dissemination of Thirthnkars. In Bud-dhism sect, Saraswati is considered as the consort of Manjushree - the knowledge of Bodhisatwa.

Saraswati Puja is celebrated in a large number of countries such as Bharat, Nepal, Bali (Indonesia), Thailand (earlier Siam), Myanmar (earlier Burma or Brahma Desh), Pakistan, Bangala Desh, Bhutan Mauritius, Surinam, Fiji, Japan, and Tibet as per their own custom.

Maa Saraswati is the deity of language, music and arts. She represents Sattwa Guna and Gyan Shakti. She is the possessor of knowledge and protector of universe. It is believed that every intellectual endeavor should begin with Saraswati Vandana.

# Omicron in India infected younger population: Govt data on 3rd wave

New Delhi, Feb 4:

In the Omicron-driven third wave of the Covid-19 pandemic in India, a comparatively younger population was more infected, a survey by the Indian Council of Medical Research into hospital data has revealed. The data has been sourced from 37 hospitals across the country. director general of ICMR, Dr Balram Bhargaya said.

The average age of hospitalisation during the third wave was around 44, while ear-lier the average age was 55. The hospitalisation data between December 16, 2021, and January 17, 2022, was compared with that of November 15 and December 15.

Explaining the clinical profile of those who got hospitalised during the third wave in India, Dr Bhargava said that they were comparatively young but with surpris-ingly high co-morbidities. "Having said that, the co-morbidities present in this younger population were pretty high. About 46 per cent had co-morbidities, these are the people who are younger...but nearly half of them had some co-morbidi-ties," Dr Bhargava said.

Difference between Delta

and Omicron wave in India.
The third wave, which is believed to be waning in In-dia now, has been markedly different from the second wave of the pandemic which witnessed a huge number of deaths. There have been other differences too, the government data pointed out. As doctors treating Omicron patients earlier pointed out, the government data said that all symptoms were in lesser proportions among the hospitalised patients. Sore symptom.

Here are the differences etween the Delta wave and the Omicron wave

1. Breathing difficulty and loss of smell or taste were not the primary symptoms in the Omicron wave. Sore throat, fever and cough were reported among the patients more predominantly.

2. All symptoms were lesser in the 3rd wave

3. The average age of infected and hospitalised patients in the 3rd wave was 44 years compared to 55 years

4. The presence of comorbidities was 46% as compared to 66% earlier.

5. Lesser use of drugs were noticed during the third wave and there were lesser compli-

# In 1 month, 65% teenagers jabbed with first dose: Mansukh Mandaviya

Agency New Delhi, Feb 4:

A month after India began vaccinating its teenagers against Covid-19, as many as 65 per cent eligible beneficiaries in the 15-18 age group have received their first shot of a Covid-19 jab, Union health minister Mansukh Mandaviya said on Friday.

Young India's historic effort continues. In just one month, 65 per cent of those

aged between 15-18 have been administered their first dose. Under the leadership of Prime Minister @NarendraModi, the world's largest inoculation drive is creating new records," Mandaviya's tweet, translated

roughly from Hindi, read. Since January 3, when the nationwide vaccination drive opened for the 15-18 age group, the number of teenagers inoculated with the first dose stands at nearly 50 million, while the number of those fully

vaccinated (both doses) is at close to 3.5 million, data published by the Union health ministry shows.

At present, Hyderabad-based Bharat Biotech's Covaxin is the only jab being used for the said age group. ZyCoV-D, developed by Ahmedabad-based Zydus Cadila, was the first vaccine to be cleared for those below 18 years (aged 12 and above), after it was granted emergency use authorisation (EUA) from the Drugs Controller General of India (DCGI) on August 20,

2020.

The nationwide drive began on January 16 last year, with health care workers and frontline workers first in line. The exercise was gradually ex-panded to include everyone aged 18 and above.

The vaccination for the 15-18 age group was announced by Prime Minister Narendra Modi in an address to the nation on December 25 last year.

# India Covid-19 cases: Daily caseload drops to 149,394; total deaths top 500,000

Agency New Delhi, Feb 4:

India has reported 1,49,394 new Covid cases in the last 24 hours, the Union Health Ministry updated data informed on Friday. Additionally, the country's death toll from Covid-19 crossed 500,000 on

The country witnessed a single day rise of 1,072 Covid-29 deaths, taking the death tally up to 500,055 in the last 24 hours, the updated data stated.

The active cases comprise 3.42 per cent of the total infec19 recovery rate improved to 95.39 per cent, the ministry said. A reduction of 98,352 cases has been recorded in the active Covid-19 caseload in a span of 24 hours.

The country, which has the fourth-highest tally of deaths globally, recorded 400,000 deaths by July last year after the devastating outbreak from the Delta variant of the coronavirus, according to official data. Some experts believe the figures were much higher, as per Reuters report.

"Our study published in the

# Scientists develop self-disinfecting, biodegradable face masks to combat COVID-19

New Delhi, Feb 4:

A team of Indian Scientists in collaboration with an industry partner have developed a self-disinfecting 'Copper-based Nanoparticle-coated Antiviral Face Mask to fight against the COVID-19 pandemic. The mask exhibits high performance against the COVID 19 virus as well as several other viral and bacterial infections, is biodegradable, highly breathable and wash-

Public mask wearing is most effective in reducing the spread of the virus COVID-19 caused by SARS-CoV-2, an enveloped positive sense single-stranded RNA virus, where the mode of transmission is via respiratory particles that are mainly airborne.

With the science around the use of masks to impede transmission is advancing rapidly, the Indian market is selling expensive masks that neither exhibit antiviral nor antibacterial properties. Hence, it is very difficult to control the transmission by wearing the conventional mask particularly in densely populated places like hospitals, airports, sta-tions, shopping malls and so on where the virus load is very high. In the present scenario, where mutations in coronavirus causing the COVID-19 pandemic are fast emerging, it is an urgent ne-cessity to develop a low-cost antiviral mask.

To this end, Scientists at International Advanced Research Centre for Powder Metallurgy and New Materials (ARCI), an autonomous R&D

ence and Technology (DST), Govt. of India, in collaboration with the Centre for Cellular & Molecular Biology (CSIR-CCMB) and Resil Chemicals, a Bengaluru based company have developed the self-disinfecting 'Copper-based Nanoparticle-coated Antiviral Face Masks' under the DST sponsored Nano-Mission project, to fight against the COVID-19 pandemic. ARCI developed copper

based nanoparticles of around 20 nanometres by a Flame Spray Pyrolysis (FSP) processing facility. FSP process involves conversion of solution precursors into nanopowders by high temperature pyrolytic decom-position. Stable nanoparticle suspension were obtained by optimizing the solid loading and pH.

# CCI imposes Rs. 1,788 crore penalty on five tyre manufacturers for cartelisation

The Competition Commission of India (CCI) has imposed a collective penalty of Rs.1,788 crore on five tyre manufactur-ers and the Automotive Tyre Manufacturers Association (ATMA) for indulging in cartelisation.

As per the statement issued by the CCI on Thursday, the order to impose penalty passed by the three member bench of CCI on August 31,2018 is being implemented following dis-missal of the appeals preferred by these companies by the Supreme Court.

The companies include: Apollo Tyres Ltd (Gurugram, Haryana) (penalty- Rs. 425.53 crore), MRF Ltd (Chennai, Tamil Nadu), (Rs. 622.09 crore), CEAT Ltd. (Worli, Mumbai, Maharashtra), (Rs. 252.16 crore), JK Tyre and Industries Ltd.( New Delhi) (Rs. 309.95 crore) and Birla Tyres Ltd. (Kolkata, West Bengal) (Rs. 178.33 crore).

In addition, a penalty of Rs. 0.084 crore was imposed on ATMA. The association was also directed to disengage and disassociate itself from collecting wholesale and retail prices through the member tyre companies. Further, certain individu-als of these companies and ATMA were held liable for the anticompetitive conduct in terms of the provisions of section 48 of

the Competition Act, 2002 Act.
The order was passed under section 27 of the Competition Act, 2002 by the bench comprising members-Augustine Peter, U.C. Nahta and Justice G. P. Mittal while dealing with the case (No. 08 of 2013) filed by the Union Ministry of Corporate Affairs (MCA) under Section 19(1)(b) of the Act based on a representation made

by All India Tyre Dealers Fed-

eration (AITDF).

The CCI booked these companies for indulging in cartelisation by acting in concert to increase the prices of cross ply/bias tyres variants sold by each of them in the replacement market and to limit and control production and supply in the market, in contravention of the provisions of Section 3(3)(a) and 3(3)(b) read with Section 3(1) of the Act.

Earlier the CCI order was kept held in abeyance as per the directions of the Madras High Court, in response to the litiga-tion (W.A. No. 529/2018), filed by MRF Limited. Thereafter, the division bench of the Madras High Court by its order dated January 06, dismissed the writ appeal. Then aggrieved tyre companies preferred Special Leave Petition before the Supreme Court, which was dis-missed by the SC with its order dated January 28.

The CCI noted that the tyre manufactures had exchanged price-sensitive data amongst them through the platform of their association-ATMA and had taken collective decisions on the prices of tyres. The Commission also found that ATMA collected and compiled company-wise and segmentwise monthly and cumulative data on production, domestic sales and export of tyres on a

real time basis. Thus, the Commission noted that the sharing of such sensitive information made the coordination easier amongst the tyre manufacturers. Accordingly, the Commission held above five tyre manufacturers and ATMA guilty of contravention of the provisions of Section 3 of the Act, which pro-hibits anti-competitive agreements including cartels, during

He added that a monitoring committee may be consti-tuted, headed by a former Judge of the Supreme Court or Chief Justice of a High Court to monitor the investigation of cases pending before the En-forcement Directorate, Central Bureau of Investigation, and National Investigation Agency in terms of submission recorded in the order dated August 25, 2021. "The trial courts may be directed to pass a specific order in all pending cases that the benefit of the Witness Protection Scheme 2018, has been made available to the witnesses in terms of the order dated November 4, 2020", he said.

On November 24, last year, the top court had asked the Allahabad High Court to issue a fresh notification to set up special magisterial courts to try minor offences involving lawmakers and ensure alloca tion of cases to sessions or magisterial courts depending upon the gravity of offences, saying the non-setting up of such courts in Uttar Pradesh was "based on an evident misconstruction" of its orders.

The top court had taken

exception to the non-setting up of special magisterial courts in Uttar Pradesh for trying lawmakers in minor offences and said that the notification is-sued by the high court on August 16, 2019, was based on an "evident misconstruction" of its directions.

The order had come on pleas raising the legal question of whether minor offences, triable by magisterial courts, against lawmakers can be prosecuted before a special court presided over by a sessions judge who is senior to a judi-cial magistrate.

Japan made their intentions clear in the first minute with Hinata Miyazawa testing China custodian Yu Zhu from distance, while Riko Ueki missed a golden opportunity to put the defending champions ahead three minutes later from inside the box.
