The silver world spreading like the full moon

The demand for silver is increasing across the world. In a way the world of silver is growing like the full moon and there are many reasons for this change. Work from home (WFH) became a neces-

In India only last year SEBI approved Silver ETF (Exchange Traded Funds). ETFs are sold and bought on exchanges and like stocks, their prices fluctuate up and down. These funds provide many types of benefits to the investors.

The demand for silver is increasing year by year and will further increase in view of the changes taking place in the economies globally. Silver has many uses in the technical field, due to which its demand is increasing worldwide. Silver is used in many 5G devices. 5G technology is expected to consume up to 500 tonnes of silver by the year 2025. Similarly, in the next four years, the automobile industry, particularly car industry, is expected to consume 2,800 tonnes of silver at an annual growth rate of 22 per cent. This Code contains a set of guidelines for the political parties and candidates during the elections. ately comes into force as soon as the election schedule and dates are announced for the states to make sure that the election and polling process remains fair and free. The main reason why EC's Model Code of Conduct is imposed in the poll-bound states is to make sure that the central government or the ruling parties in the states do not misuse their position of power to gain unfair advantage in the election.

The fact is the MCC evolved as part of the ECI's drive to ensure free and fair election and was the result of a consensus among major political parties. It has no statutory backing. Simply put, this means anybody breaching the MCC can't be proceeded against under any clause of Code. Everything is voluntary. The ECI can issue a notice to a politician or a party for alleged breach of the MCC either on its own or on the basis of a complaint by another party or individual. Once a notice is issued, the person or party must reply in writing – either accepting fault and tendering an unconditional apology or rebutting the allegation. In the latter case, if the person or party is found guilty, subsequently he/ it can attract a written censure from ECI- something that many see as a mere slap on the wrist. However, in extreme cases, like a candidate using money/ liquor to influence votes or trying to divide voters in the name of religion or caste, the ECI can also order registration of crimi-nal case against the candidate under relevant sections of Indian Penal Code or Income Tax Act. In case of a hate speech, a complaint can be filled under IPC and CrPC; there are laws against the misuse of a religious place for seeking votes etc. The expert view is that, as of

now, following the MCC is purely hinged on morality, not the fear of law. Since poll campaign are turning uglier, more personal and com-bative, the moral obligation entailed in the model code can really bear down heavily on candidates at a time when they are trying show to the voters how upright and com-petent they are for the job. The MCC carries significant moral weight; indeed former Chief Election Commissioner SY Quraishi had described it as the Moral Code of Conduct. Filling an FIR, particularly against a senior leader dur-ing the election, in itself becomes a cause of huge embarrassment to It presents the candidate represent. It presents the candidate as ethi-cally wrong to the people. Even if it just rap on the knuckles, most politicians do not relish the reprimand by the ECI. What if a party or politician ignored the notice? The ECI believes that the voters doesn't forget or forgive a politi-cian who tries to take on the elec-

tion regulators or attempts to brazen it out. There are numerous examples of politicians who got into a slanging match with the ECI over MCC violations and were severely punished by voters. And yet the abysmal depth the many states election campaign plumbed has underscored the inadequacy of the MCC in dealing with erring politician, with many wondering if giving statutory backing to the Code could be the answer. After all, it is argued, which politician would flinch from a mere reprimand if the prize is victory in an important election? Both ECI and several indepen-

dent experts however believe that giving statutory backing to the MCC would only make the job of the Commission more difficult. This is because every alleged offence will then have to go to an appropriate court and right up to the Supreme Court. Given the slowness of our legal system- election petitions filled decade ago are still pending before many High Courtsit is anybody's guess what that situations might lead to. Former CEC VS Sampath had once told that the MCC is meant to provide an "**immediate solution**, instant remedy to certain situation". When notice for Model Code of Conduct violation is issued, we give 48 hours to reply and reply is usually in by the 47th hours, however big a politician may be. If the contestant is wrong, the person tenders an apology. Since such an apology brings the candidate to the immediate notice of the voters as the wrong doer; it is a deterrent unlike a situation when a case against a candidate goes to the court and may linger, giving the benefit of doubt to him/her. One

may say, we only give censure or reprimand but that is not the point. Parallely, under the laws of the land action will be taken. An FIR will be filed, that case will continue for months and years, Sampath had said. The previous UPA-2 govern-ment did, in fact attempt to quietly give statutory backing to the MCC. A former Law Minister dur-ing UPA-2 regime announced a scheme after the declaration of Model Code in an upcoming elec-tion. Though the EC advised him not to do so, he didn't pay heed. So the EC wrote to the President and the Minister was censured and fined. The move came soon after the Law Minister had a very public run-in with the ECI, UPA ended up with egg on its face and the hush-hush moved was dropped. Later, the parliamentary standing Committee on Person nel, Public Grievances, Law and Justice recommended that the MCC be given statutory backing by enacting a law. However that recommendation found very little acceptance. Incidentally the rea-son the parliamentary Panel made the recommendation was that the ECI, while enforcing the MCC, sometimes appeared to be en-croached upon legislative power of parliament. In the coming days, with electioneering heating up in the five poll-bound states, there may be more occasions for the EC to not just issue show cause notices but even order FIR against high profile candidates for MCC violations. *If there are* instances of senior leaders vio-lating MCC, " there are also those who understood their moral sanctity".

who are willing to get tickets for the BJP party (3rd February 2022)'. Those crore of money have been used for their personal benefits and vested interests (*Ibid*.) though many politicians of the BJP Manipur like the Minister of Works Th. Biwajit Singh denied many such strong allegations from other parties. It is quite evident from the NDTV report that BJP is the richest party in India by declaring its assets worth Rs. 4,847.78 crore in the financial year 2019-20, the highest among all political parties, followed by the BSP at Rs. 698.33 crore and the Congress at Rs. 588.16 crore based on the Poll Reforms Advocacy (ADR) group after analyzing the assets and liabilities of national (seven) and regional parties (44) in 2019-20 (29th January 2022).

^h January 2022). The more justly interesting and thrilling one is the springing of Bihar based JD (U) party in the soil of Manipur which many scholars think and say orally that this party is being appeared as the 'B-Team party of the present government. It has been able to capture the imagination of many former BJP candidates and others including those who are BJP ticket seekers. So far 36 candidates have been listed as the final one for the JD (U) party. The most striking one is out of the 36 candidates, least two are sitting MLAs and it has many more former MLAs in the final list. Almost all the candidates were intending BJP candidates. There is a high chance that these candidates can well eat into the vote share of the ruling party. An-

other important point is that of giving of a JD (U) ticket to Sikander Ali. To ensure the victory of the BJP candidate Dr. Usham Deben Singh, an arch rival of Congress MLA Fajur Rahim, Sikander Ali got JD (U) ticket after denying to the intending candidate Sakir Ahmed for JD (U) ticket. One more possible reason is that of sharing of votes among the clans to Fajur Rahim and Sikander Ali as both of them belonged to the same sagei (clan) called *Cheshaba Sagei* in the Wabagai Assembly Constituency. Sageism (Clanism) played a crucial role for the vote sharing and distribution in this constituency.

It is orally said by the people of Manipur that Bihar based JD (U) is springing out increasingly as a 'B-Team' party of the present gov-ernment in Manipur. Why not others including the regional parties such as NPP? People started asking why many ex-MLAs of Manipur including its own mem-bers of BJP got denied of BJP tickets and joined other political par-ties especially JD (U) in the contemporary political scenario of the state of Manipur. Even BJP leaders who were denied tickets joined the NPP also. The NPP is contest-ing the polls on its own. Former bureaucrat turned politician Pukhrem Saratchandra Singh from the Moirang Assembly Constituency joined the Congress party af-ter BJP denied him a ticket. Why many of the new entrants into the BJP including the Moirang Ass bly Constituency got ticket of the BJP after denial of its own member on the ground that it is orally undoubtedly a fact that some BJP leaders took lots of money for those who are BJP ticket seekers and gave the tickets to the new

entrants. This news has been circulated among the local newspapers on a wider scale. It is noted that the Chief Min-

ister of Manipur claimed of the de-velopmental works done by the BJP led coalition government in Manipur for the last five years. Firstly, he talked that the state is peaceful and Manipur is a state which is free from violence though there are many violence related some incidents in the state ingru cluding the abduction and killing of renowned tribal social activist Athuan Abonmei by some suspected NSCN (IM) armed cadres from Tamenglong district head-quarters on Wednesday morning of 23rd September 2021. Justice has not been delivered till now. There was a hullabaloo over this barbarous killing of Abonmei in the hill and valley areas. Another example is that of killing of other party mem-bers that include one student and another one was the student's father who was seriously injured at Heirok Assembly Constituency by some persons who allegedly be-longed to the ruling party. Further, two persons including one Havildar and one active worker of state Agriculture Minister O. Lukhoi Singh were shot dead brutally at Samurou Awang Leikai near Machu Cinema Hall by unidentified persons but the problem is that of denial of justice over this issue. In the Mayang Imphal Assembly Con-stituency, many common people were taking pledge at bullet and gun point in the name of giving vote to the candidate who belonged to the ruling party. The videos are widely circulated in the social media and even in the TV channels also. There a fear of psychosis in the psyche of the common people. Addition-ally, in some other Assembly Con-

stituencies like Andro, Lamlai, Naoriya Pakhanglakpa and Singjamei, violence and tension had also gripped in the last few weeks. Where is the question that the state is peaceful for the last five years? Still many of the critics called this government an 'advertisement government though the party leaders including the CM himself de-nied such strong allegations in the Impact TV's Special Broadcast on 10 January 2022. In addition, in higher education, job employment, media tolerance, health infrastructure, drinking water facility, etc. nothing has changed in the last five years of Manipur. While consider ing the implementation of ILP in Manipur, in an attempt to silence the shrill anti-CAB agitation and win over other sections of the society as supporters of CAB, the Union Home Minister Amit Shah announced the extension of ILPS to Manipur by simply saying in the Parliament that "Mizoram is protected by ILP, which is a provision of Bengal Eastern Regulation Frontier Act, 1873. Now keeping the sentiments of the state, we are taking Manipur too under ILP, by which a very serious problem of Manipur has been fixed. Hon'ble Speaker! These Manipuri people have been demanding it for a long time. And now, on behalf of the Manipuri people, I would like to pay huge re spect to the Prime Minister" (De December 9, 2019). Who is a Manipuri? Which is the base year that defines Manipuri are the ba-sic fundamental questions that need to be kept while implementing the ILP system in Manipur. Such provisions are missing. It is just like a car driving without a wheel. Furthermore, based on the reports of Public Affairs Index (PAI) of the Bengaluru based think tank

Next Covid-19 variant will be more infectious than Omicron, possibly deadlier, warns WHO faster than the Alpha variant, which was 50 per cent more

Agency New Delhi, Feb 9:

Even as the world limps back to normalcy with the Omicron wave subsiding, experts have warned that the next Covid-19 variant will be more transmissible, and perhaps, more deadly than its predecessors

In a recent press briefing, World Health Organization (WHO) epidemiologist and technical lead on Covid-19 Dr Maria Van Kerkhove stressed that the pandemic is far from over and future variants will be in some way more virulent than Omicron is now.

"The next variant of concern will be more fit, and what we mean by that is it will be more transmissible because it will have to overtake what is currently circulating. The big question is whether or not future variants will be more or less severe," Dr Van Kerkhove said. She further warned that the next variant could more easily evade immunity, rendering vaccines less effective. However, she doubled down

4,844 foreigners granted Indian citizenship in 5 years, 1,773 in 2021 alone: Govt

Agency New Delhi, Feb 9:

As many as 4,844 foreigners have been granted Indian citizenship in the past five years, the government told the Lok Sabha Tuesday. In 2021, the government granted al-most three times the number of Indian citizenships compared to 2020, the House was

foreigners were granted Indian citizenship in 2017, 628 in 2018, 987 in 2019, 639 in 2020 and 1,773 in 2021.

"The citizenship of India is governed under the provisions of the Citizenship Act, 1955.

Citizenship to eligible foreigners is granted by registra-tion under section 5, by naturalization under section 6 or by incorporation of territory un der section 7 of the Citizenship Act, 1955. The reasons for taking Indian citizenship vary in terms of specific circumstances of each applicant subject to the provisions con-tained in the Citizenship Act, 1955 and rules made thereunder." Minister of State for Home Nityanand Rai said in

reply to a question. While rules for Citizenship Amendment Act (CAA) are yet to be framed, government data, earlier presented in Parliament, shows a significant majority of those granted In-dian citizenship since 2018 were minorities from Pakistan, Afghanistan and Bangladesh and belonged to Hindu, Sikh, Jain and Christian faiths.

According to data pro vided by the government in Parliament earlier, as many as 8,244 people from Hindu, Sikh, Jain and Christian faith from the three countries applied for Indian citizenship of which 3,117 were granted the same till December 2021. Interestingly, between 2018 and 2020, the total number of foreigners from across the world who were granted Indian Citizenship stood at 2,254. The overall data for 2021 was not available. "Number of citizenship ap-

plications received from Hindu, Sikh Jain and Christian minorities groups from Pakistan, Bangladesh and Afghanistan during the year 2018, 2019, 2020 and 2021 is 8244. The number of Indian citizenship granted to people belonging to Hindu, Sikh, Jain and Christian minorities groups from Pakistan, Bangladesh and Afghanistan during the years 2018, 2019, 2020 and 2021 is 3117." MoS Home Rai told the Rajya Sabha in a written reply to a question.

The CAA was enacted by Parliament on December 12, 2019, but its rules have not been framed as yet. The leg-islation, which grants citizenship to illegal immigrants be-longing to Hindu, Jain, Sikh, Parsi, Christian and Buddhist communities from Pakistan, Bangladesh and Afghanistan, was passed by Parliament amid vehement criticism from the Opposition that pointed out the communal agenda be-hind the law as it conspicuously left out Muslims. Indian does not have a refugee policy.

"All foreign nationals in-"All foreign nationals in-cluding refuge seekers are governed by the provisions contained in The Foreigners Act, 1946, The Registration of Foreigners Act, 1939, The Passport (Entry into India) Act, 1920 and The Citizenship Act, 1955," Rai said in his reply.

India logged 71,365 new coronavirus infections taking country's total tally COVID-19 cases to 4,24,10,976, while the active cases de-clined to 8,92,828, according to the Union Health Ministry data updated on Wednesday. The death toll climbed to

5,05,279 with 1,217 fresh fatali-ties, the data updated at 8 am stated. The active cases comprise

2.11 per cent of the total infections, while the national COVID-19 recovery rate has improved to 96.70 per cent, the

ministry said. A reduction of 1,02,063 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

The daily positivity rate was recorded at 4.54 per cent while the weekly positivity rate was recorded at 7.57 per cent, according to the minis-

try. The number of people who have recuperated from the dis-ease surged to 4,10,12,869, while the case fatality rate was recorded at 1.19 per cent.

The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has ex-

ceeded 170.87 crore. India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on Septem-5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on Oc-tober 11, crossed 80 lakh on

October 29, 90 lakh on November 20 and surpassed the onecrore mark on December 19. India crossed the grim mile-stone of two crore on May 4
