Supreme Court Notice to Centre, Manipur on plea against Inner Line Permit

Agency New Delhi, Jan 3:

The Supreme Court has issued a notice to the Central government and Manipur government on a plea chal-lenging the system of Inner Line Permit (ILP) in Manipur.

ABench of Justices Abdul Nazeer and Krishna Murari sought response from the Centre and Manipur governments and posted the matter for hearing after four weeks.

The petition was filed by Amra Bangali, a Kolkatabased organisation with a unit in Assam, demanding re-

the permit system contending that it provides unbridled power to the State to restrict entry and exit of non-indigenous persons or those who are not permanent residents

of Manipur.

The permit system was introduced by way of the Adaptation of Laws (Amendment)
Order, 2019 which extends 140year-old "colonial legislation"
Page 1 Feeters Frontier Regul Bengal Eastern Frontier Regulations, 1873 (BEFR).

The plea said that the BEFR was enacted by the

over the tea plantations in Assam (then part of Bengal) and to protect its commercial interests in the hilly areas from Indians. It prohibits Indians from engaging in trade with the tribal populace in the areas contained in the preamble of the BEFR

By virtue of the 2019 order, the ILP system has effectively been made applicable to the States of Manipur, Arunachal Pradesh, Mizoram and districts of Nagaland which are notified from time

to time.
The 2019 order violates

fundamental rights of citizens guaranteed under Articles 14, 15, 19 and 21 of the Indian Constitution since it grants unqualified power to the State for restricting the entry and exit of non-indigenous per-

sons, the petition stated.

It added, "The draconian ILP system is fundamentally opposed to the policies of social integration, development and technological advancement in the area beyond the Inner Line, apart from hampering tourism within the state, which is a major source of revenue generation for these

The Zeliangrong Civil Organizations (ZCOs) comprised of ZeliangrongBaudi, Zeliangrong Youth Front and Zeliangrong Students' Union being the civil body representing the interest and sen-timent of the Zeliangrong community, which is the largest tribal group in the North Eastern Region of the country has appealed the Manipur State Govt. to be tactful regarding the Scheduled Tribe Demand Committee of Meitei community for inclusion of Meitei in the Scheduled Tribe list of India which, the ZCOs says that it is a matter of great concern for the tribal people of Manipur who have been deprived of their rights de-spite the fact of certain Con-stitutional protection and safeguards provided in the Constitution.

A statement by the Media and Publicity Cell of the Zeliangrong civil

organisations (ZCOs) said that in a State like Manipur where different communities have been settled for ages, it would be wise for every community to respect and honor the due shares of others. Trying to trample upon an-other by way of adopting dominant policy may lead to further spoil the already strain relationship between the tribal and the non tribal people of the State, the state-

ment said. It added that the State had formulated a 100 point roster reservation policy with 31 percent reservation for tribal people at the time of job re-cruitment under the State Govt. But the successive govt. failed to implement as per the reservation policy thereby rendered the tribal people less representation in different departments. While this is one of the discontentment feelings of the tribal people of the State, the Scheduled Tribe Demand Committee spearheaded by



Foundations of Vernacular Innovation Program

world today, an innovator needs proficiency in English to fully participate in the mainstream innovation ecosystem. A vernacular innovator someone who does not know English, will likely struggle to raise investments as easily as may an English speaker, no matter how creative is their solution. Why should it be so? Is creative expression dependent on the language of transaction? Of course not! We have seen plenty of evidence for this in the fields art where some of our most creative artists do not know English.

It is therefore time to create a Vernacular Innovation Program (VIP) that systematically decouples creative ex-pression and language of transaction. Atal Innovation Mission (AIM), the flagship program of the Government of India housed in the NITI Aayog, is on the cusp of launching one such movement.

As per the 2011 census, only 10.4% of Indians spoke English, most as their second, third, or fourth language. Not surprisingly, only 0.02% of Indians spoke English as their first language. Ten years later these numbers are not likely to be very different. Why shouldn't we then create equal opportunity for the vernacular innovators who represent the staggering 90% of our population. After all, we know for sure that this excluded population, no matter which Indian language they speak, is at least as creative as the rest.

What does it mean to create a Vernacular Innovation Program? At one level, it means creating an innovation ecosystem where a vernacular innovator can (a) learn the modern subjects of design thinking and entrepreneurship, (b) access global markets, and (c) attract investments. To be sure, this is not about mitigating altogether the multitude of risks associated with innovation and entrepreneurship; it is

just about lowering the language barrier. For India, this means creating such ecosystems for the 22 scheduled lan-

The first step of making design thinking and entrepreneurship accessible to vernacular innovators requires adapting these modern subjects in local languages, but more importantly in local cultures. As such translation of subjects from one language to another has been done for ages. The Bhagavad Gita gets translated in more interna-tional languages with every passing year as compared to any other text, so the idea of simple translation is not new.

What has not been done so far is to adapt these subjects into local cul-tures; meaning, a schematic for such adaptation does not exist and it is necessary to have one. After all, a Punjabi business person is not a Tamil business person, even though they are both following business principals. Similarly, a Bangaliconsumer is not a Gujarati consumer. There are subtle differences in their cultures that we all know exist, yet we have not had the need to systematically articulate them. So, how to do it? Let us think about it as a system.

Learning of any subject has two primary dimensions: content and pedagogy. Content, at the highest level, requires learning theory and its application. For example, a doctor learns the theory of how the mind and body functions and applies it in their medical practice. The theory further breaks down into concepts and their interconnections.

Pedagogy is a way to teach and learn the content. While the content remains the same for a given subject and is also accessible worldwide today with the Internet revolution, it is the pedagogy that separates an effective teacher from a not so effective one. Pedagogy, at the highest level, has three parts: creating learning objectives, us-ing effective methods of teaching and learning the content, and assessing whether learning is taking place and, if not, adapting the pedagogy appropri-ately. The crises today is that, while the content spreads easily the pedagogy does not.

A vernacular innovation program need two additional dimensions: lan-guage and culture. Based on the above discussion, adaptation of a subject in another language requires translating the concepts, their interconnections. and examples. When we will translate the concepts and interconnections from English to the 22 Indian languages, we would have created a compendium that allows anyone bilingual person to go from their native language to another

Selecting appropriate examples is where the language dimension meets the culture dimension. The idea of culture is vast. We must therefore boil it down to what we need here. Consider the following two dimensions of culture: the *entrepreneurial culture* and *consumer culture*. These differ from region to region. The entrepreneurial culture, at the highest level, manifests itself in the assumptions, beliefs, risk appetite, capability, and ambitions of people of the region. Similarly, the consumer culture manifests itself in the needs, wants, customsand dreams of the people of that region. If we could articulate these aspects through rich examples, we would have succeeded in adapting a subject to a culture.

With more than seventy thousand registered startups in India, there are many contemporary examples to talk of an entrepreneurial culture. These however may stilexclude the vernacular innovators. We must therefore rely on the regional experience and literature. For example, Munshi Premchand's work has depicted various facets of life and people's deeply seated hopes and aspirations that amount to describing the underlying drivers of the entrepreneurial and consumer culture of a region that it is today. In other languages too, such classics have carefully captured what we may consider examples to learn from We must usher this depth of culture into our innovation ecosystem through

the examples we select.

To build the necessary capacity for such a program, Atal Innovation Mission has partnered with the Department of Design at IIT Delhi to identify and train a Language Task Force in each of the 22 scheduled languages of India. Each task force comprises of vernacular language teachers, design thinking experts, technical writers, and the leadership of regional Atal Incubation Cen-ters. Furthermore, industry mentors have joined hands to lend design thinking expertise, and CSR sponsors have agreed to generously joined the movement. Upon training the task force over the period of December 2021 to April 2022, the ecosystem will be opened to vernacular innovators.

India may be the first nation in the world to launch such an initiative, where an innovation ecosystem catering to twenty two languages plus English is being built. Of course, providing access to learning design thinking and entrepreneurship in one's language and culture is merely the beginng. Our work is not done until we build other ecosystem services such as access to mentors, markets, investors and policymakers. When we succeed, we would have unshackled the creative expression from a language of transaction to serve those who are our true VIPs.

COVID-19 vaccination for children aged 15-18 years begins

Agency New Delhi, Jan 3:

New Delhi: The vaccination of children between 15 to 18 years of age against COVID-19 began on Monday at various hospitals and inoculation centres across the country. Bharat Biotech's Covaxin is the only COVID-19 vaccine that will be administered to children in the age group of 15-18 years, according to guidelines issued by Union Health Ministry. "For all those aged 15 years

or more, option for vaccination would only be available for Covaxin as this is the only vaccine with Emergency Use List-ing (EUL) for the age-group 15-17," the ministry had said in

While making the announcement on December 25, Prime Minister Narendra Modi said this will reduce the worries of children going to schools and colleges and their parents, and boost the fight against the pandemic, adding



that the move is also likely to aid in normalisation of teaching in schools.

The estimated population to be covered in this category is seven to eight crores.

All those aged 15 years or more can register themselves for vaccination on Co-WIN portal. Beneficiaries can selfregister online through an existing account on Co-WIN or can also register by creating a new account through a unique

The beneficiaries can also be registered onsite by the verifier/vaccinator in facili-

tated registration mode, the guidelines read. Appointments can be booked online or onsite (walk-in).

Omicron effect: India's COVID-19 surge faster than second wave; massive spike in Maharashtra, Delhi

Agency New Delhi, Jan 3:

In recent days India has seen a massive surge in COVID-19 cases some cities almost doubling their tally overnight or reporting thousands of fresh infections. Delhi on Sunday reported its highest single-day spike since May 20, even as the positivity rate rose to 4.59%. The recent spike in cases is being recorded amid a significant jump in cases belonging to the new Omicron

Official data indicates that the numbers reported in just two days of 2022 are higher than the cumulative cases reported between August and November last year. As per a *CNN-News18 analysis* of the daily COVID-19 updates, the national capital had reported a total of 4,669 cases in these three months.

Over the last seven days, Delhi's daily caseload has gone from 331 cases last Monday (December 27) to 3194 fresh cases on Sunday (January 2). 496 fresh cases were reported on Tuesday, followed by 923 on Wednesday, 1,313 on Thursday. 1,796 cases were reported on Friday, while the number rose to 2,716 on Saturday. As of yesterday evening, the national capital has 8397

The surge is not limited to the national capital. Several other cities including Mumbai have seen their cases multiply by several thousand over the last few days. From 108 fresh cases on December 1, Mumbai reported 809 new cases last Monday. The week ended with 8063 fresh cases on Sunday (January 2) and an active caseload of 29,819. Led by its capital city, Maharashtra on Sunday reported 11,877 fresh COVID-19 cases - 2,707 50 Omicron infections.

According an analysis of the Health Ministry data by Hindustan Times, the Omi-cron-led 'third wave' appears to be progressing far more rapidly than its predecessor. Go-ing by the seven day average of cases, such a rapid rise in India's tally had not been seen even during the Delta-led second wave. As per official data, there are now 1,22,801 active

cases in the country.
While the Arvind Kejriwalled government has implemented a 'yellow' alert under the Delhi Disaster Management Authority-approved Graded Response Action Plan (GRAP), the city might soon become eligible for more strin-gent curbs. If a case positivity rate of 5% is reported for two consecutive days, it would trigger a 'red alert'

Even as cases rise exponentially, however, the Delhi government has urged people to not panic, insisting that the situation was not quite as grim as the deadly second wave seen in mid-2021. Recently, the administration had also refrained from putting the 'am-ber alert' in place after the positivity rate crossed the relevant marker. "As of now, only 82 oxygen beds in hospitals are occupied. Delhi government is prepared will 37,000 beds. I just want to tell you that all new cases are with mild symptoms, asymptomatic, so there is no need to panic," Chief Minister Arvind Kejriwal assured on

Sunday evening.
Drawing a comparison with last year, he said that there were around 6600 active COVID-19 cases in Delhi on March 27. "145 patients were on ventilators, as compared to

Assam: Pro-talks ULFA doubts Centre's 'sincerity' over peace talks

Agency Dibrugarh, Jan 3:

The pro-talks faction of ULFA has expressed doubts over the Centre's "sincerity" in taking forward the decadelong peace parleys with it, claiming that no dialogue has been held in the last two years and there was no government interlocutor at present to take the process forward.

The faction alleged that there has been "not much progress" in the peace talks with it since the Narendra Modi government came to power though the negotiations had reached the final stages during former prime minister Manmohan Singh's tenure.

It also maintained that the hardliner ULFA(I) chief Paresh Barua is unlikely to come forward for negotiations until the parleys with the pro-talks faction are completed.

The allegations come at a time when Assam Chief Minister Himanta Biswa Sarma is trying to bring Barua to the negotiating table for a settlement with all factions of the

group.
Talking to PTI, former selfstyled general secretary of ULFA and pro-talks faction leader Anup Chetia said, "The last round of talks with the government was held in January 2020. The term of the gov ernment interlocutor had ended in March that year."
"After that, there has been

no contact with us. Still, we are waiting with hope that our issues will be addressed and resolved by the government,"

Maintaining that the government is "more responsible" for taking forward the peace talks than the militant group, Chetia added, "There are reasons for us to doubt the sincerity of the government.'

Another senior pro-talks ULFA leader Mrinal Hazarika said, "Sincerity of the govern-

ment seems to be lacking. Discussions were almost over and in the final stages during Manmohan Singh's tenure. But there has not been much progress after Narendra Modi's government came to power.

He also maintained that the government was indulging in 'delaying tactics" in resolving the ULFA pro-talks faction demands, which were broadly based on ensuring economic, cultural, political and linguistic safeguards for the indig-enous people of Assam. "The BJP supports 'Ek

Bharat, Shrestha Bharat' (one India, greatest India) policy, through which they want to paint everyone with the same brush. That's why they are trying to delay granting our safe-guards," Hazarika said.

On the government's over-tures to Paresh Barua to come for talks, Chetia said, "I have heard Barua tell media that he wants the government to complete the negotiations with us

first."

"He also perhaps fears
"He also perhaps fears that his condition will be like ours and no progress will be made towards an actual resolution of all issues," he added. Hazarika also spoke on simi-

lar lines and added, "It won't be possible for the Paresh Barua group and our faction to be clubbed together for the talks. Our demands are a reflection of aspirations of the civil society, while his is a one-point agenda of sovereignty.'

A top Assam Police officer privy to the ULFA-government talks, speaking to PTI on con-dition of anonymity, accepted that there has been some "stagnancy" in the process.
"The interlocutor is yet to

be appointed. Yes, there has been some stagnancy, but various factors contribute to it, he said. The officer added that

change in government and top positions also lead to delay in

such peace talks.

As per Hazarika, there are over 1,000 pro-talks ULFA cadres, staying in nine camps as well as outside, living off the stipend provided by the gov

Hazarika added that the first lot of ULFA cadres and leaders, including himself, had come forward for talks in 2008. while extradition of top leaders of the outfit, including its self-styled 'chairman Arabinda Rajkhowa, from Bangladesh, where they were imprisoned, had started in

The formal peace talks with the pro-talks faction had commenced in 2011.

Chief Minister Himanta Biswa Sarma had on January 1 said that bringing ULFA(I) to the negotiation table is the "last hurdle" in bringing peace

Sarma said he has learnt from his personal interactions with the people who are di-rectly or indirectly in touch vith ULFA(I) chief Barua that the militant wants a negotiated settlement with the govern-ment.

"The stumbling block is 'sovereignty'. The ULFA(I) will want a discussion over it, which we cannot hold. We are working on breaking the dead-lock," Sarma said.

The chief minister, after taking oath on May 10, had appealed to the ULFA(I) to come forward for peace talks and resolve the 42-vear old in-

surgency problem in the state.
The hardliner faction of the outfit had responded with a declaration of unilateral ceasefire the same month for three months, which it has been extending since.

While terming the unilateral ceasefire a "positive step", Sarma said that the government has also reciprocated the gesture by not engaging in any "direct conflict" with the out-fit in the last eight months.

Amid global surge WHO chief says, we can end Covid-19 pandemic in 2022 if.....

With coronavirus cases on the rise again globally, and the Omicron variant slowly seeping in almost every country, World Health

Organisation (WHO) chief is hopeful that the pandemic can end in 2022. Tedros Adhanom Ghebreyesus, the directorgeneral of the global health body said, "if we end inequity, we end the pandemic.'

Hitting on countries over vaccine hoarding amid rising cases, the WHO chief said that narrow nationalism and vaccine hoarding by some countries have undermined equity, and created the ideal conditions for the emergence of the Omicron variant. "The longer inequity continues, the higher the risks of this virus evolving in ways we can't prevent or predict," Ghebreyesus said.



In a statement issued as the world welcomed 2022, the UN health body chief said as the world enters the third year of this pandemic, "I'm confident that this will be the year we end it but only if we do it together." Call it a threat to decades of progress made in healthcare, he said "Millions of people have missed out on routine vaccination, services for family planning, treatment for communicable and non-communicable diseases, and

The head of the World Health Organization has expressed worry over the new cases that he's worried about the omicron and delta variants of COVID-19 producing a "tsu-nami" of cases between them. First reported last month in southern Africa, it is already the dominant variant in the United States and parts of Eu-

rope.
"I'm highly concerned that omicron being more transmissible (and) circulating at the same time as delta, is leading to a tsunami of cases," Tedros said at an online news conference. That, he said, will put "immense pressure on exhausted health workers and health systems on the brink of

He maintained that Covid-19 is not the only health threat the world's people will face in 2022. WHO will continue to work around the world to protect and promote the health of everyone, everywhere.

'A new year brings new resolutions. Here is mine, for the world. First, we must end the pandemic. To do that, we need all countries to work together to reach the global target of vaccinating 70 per cent of people in all countries by the middle of 2022," the WHO chief said, advocating the need to build a stronger global framework for global health

security. He further urged all coun-tries to invest in stronger primary healthcare saving. mary healthcare saying, "Covid-19 has demonstrated that when health is at risk, everything is at risk."

States demand extension of GST compensation for another 5 years

Many states have de-manded that the GST compensation cess regime be extended for another five years and the share of the Union government in the centrally-sponsored schemes be raised as the COVID-19 pandemic has impacted their revenues.

As per a statement issued by Sangeeta Jain, Senior Direc-tor, All India Association of Industries, the GST compensa-tion to states for revenue shortfall resulting from subsuming of local taxes such as VAT in the uniform national tax Goods and Services Tax (GST) will end in

June this year. The Centre has not made arrangements to compensa the loss of revenue of about Rs 5,000 crore to the state in the coming year, so the GST compensation grant should be con-tinued for the next five years after June 2022, Chhattisgarh Chief Minister Bhupesh Baghel

"Many states have asked for this. We have also asked to extend GST compensation. If it is not extended, the finances of many states will be in a bad shape," Delhi Deputy Chief Minister Manish Sisodia said after pre-Budget consultation

tweet on Wednesday. GSTR 9 is an annual return to be filed yearly by taxpayers registered under the Goods and Services Tax (GST). It consists of details regarding the outward and inward supplies made or received under different tax heads.GSTR-9C is a statement of reconciliation between GSTR-9 and the audited annual

Benefit of reduced perfor-mance security extended till March 2023

The centre has also extended till March 2023 the benefit of reduced performance security in government contracts. According to the rules, a successful bidder awarded a gov-ernment contract has to deposit a performance security of 5-10 % of the value of the contract with the government. To help commercial entities and contractors tide over the liquid-ity crunch post the first wave of the COVID pandemic, the finance ministry had in Novem-ber 2020 reduced this perfor-mance security to 3% for all tenders or contracts issued or concluded till December 31, 2021. The finance ministry on Thursday said that the government of India has decided to extend the benefit of reduced performance security of 3 % up to March 31, 2023, for all central government tenders/contracts issued/concluded till March 31,

Centre notifies new rules for consumer commissions

The Centre has notified the Consumer Protection (Jurisdic tion of the District Commission. the State Commission and the National Commission) Rules, 2021, revising the pecuniary jurisdiction of the district, State and national commissions. According to the notifi-cation, district commissions will have jurisdiction to entertain complaints where the value of the goods or services paid does not exceed Rs.50 lakh. State commissions can handle complaints in the range of Rs.50 lakh-Rs.2 crore. "The National Commission shall have jurisdiction to entertain complaints where the value of the goods or services paid as consideration exceeds Rs.2 crore," it added.

ISL: FC Goa cancel out Luna's wondergoal, | Premier League round up: Manchester City's 'title to lose' after Chelsea, Liverpool fall on their swords

London Jan 3:

Even after a weekend in which Manchester City produced the worst performance of the Premier League's top four, the champions streaked further clear towards a fourth title in five years. City manager Pep Guardiola admitted his side were second best despite coming from behind to beat 10-man Arsenal 2-1 with a 93rd minute winner that secured an 11th consecutive league win.

As Guardiola's men have hit their stride, Chelsea and Liverpool have run out of steam to turn a tight threehorse race, into a procession. Struck down by coronavirus outbreaks and injuries, the two challengers for City's crown threw themselves into a titanic battle at Stamford Bridge on Sunday, but a 2-2 draw did little for either side's hopes of reeling in the leaders.

City's advantage now stands at 10 points from Chelsea, with Liverpool a further point back with a game in hand. "It's a big gap, so they have the title maybe to lose at the moment," said Liverpool defender Virgil van Dijk, one of those forced into a swift return to action after testing positive for Covid-19.

"We just have to get results, play good football and win games. It sounds pretty easy but it's tough." Rather than cutting the gap, there is a likelihood it could grow in the coming weeks as Chelsea and Liverpool tackle their own is-

Both are involved in twolegged League Cup semi-finals over the next two midweeks despite calls from managers for the ties to be switched to oneoff games.

games. Chelsea's record signing Romelu Lukaku was dropped for Sunday's crucial clash after an explosive interview with Italian media in which he revealed his displeasure with how his first season back at the Bridge

Liverpool manager Jurgen Klopp was also absent due to a Covid infection, along with

Alisson Becker, Roberto Firmino and Joel Matip. And the Reds now have to cope without their top goalscorers, Mohamed Salah and Sadio Mane, for up to a month due to their international commitments at the Africa Cup of Nations. Chelsea will also lose goalkeeper Edouard Mendy to the AFCON, while first choice wing-backs Reece James and Ben Chilwell face months out injured.

"How should we compete in a title race?" Blues boss Thomas Tuchel complained earlier this week after his side were forced to fulfil all of their December fixtures, while 18 other Premier League games were called off due to Covid out-

Even if Tuchel and Klopp's men recovered their early season form, City's relentless con sistency shows no signs of offering a ray of hope. They have averaged a total

of 95 points in each of Guardiola's three title-winning seasons in England and are on course to hit that mark again.
