the rescue operation will con-tinue till all the victims are found. He informed that three (3) more dead bodies are found, and the death toll mounts to 53 from the landslide that struck a railway construction site at Tupul in Noney district.

Considering the hardships faced by the officials and volunteers who had been carrying out the rescue and search op-eration for 12 days continuously, Awangbow said that a review meeting will be held to discuss for providing additional force in the rescue team. The minister also requested the

World population growing at a high pace

The world popula-tion is currently touching the figure of 8 billion. Looking at the speed with which the human population is increasing in vari-

ous countries of the world, it is estimated that by the year 2050, the total human population on the earth will reach 10 billion or more. This is a very huge number, which is posing a billion or more. This is a very huge number, which is posing a danger in terms of food supply and other day-to-day necessi-ties of the people. The burden of the human population on the earth is increasing every passing year, while humans are de-stroying other creatures and trees for their greed and to make their life comfortable. The life of all living beings in nature is dependent on each other. This makes an ecosystem. The bio-balance of the earth is disturbed when the number of any of these organisms or vegetation increases or decreases out of proportion. As a result, all kinds of natural calamities and problems arise. Man is increasing his population, and is bent on destroying trees, vegetation, insects, birds, animals, and wild-life in different ways. This is a matter of great concern. Problems are arising due to this reason not only in one country but in all the countries of the world. In terms of population, China ranks first in the world. India is second, and America is in third place. As the population increases, facilities like education, health, and housing decline. The crisis of the availability of fuel to food arises in front of the world. As the population increases, the standard of living falls and problems creep in. About 17 percent of the world's population lives in India, where illiteracy is the main reason for population growth.

The country remains politically unstable. The economies of south-east Asian nations like Sri Lanka and Pakistan have collapsed due to their dependence on China. A situation like Sri Lanka can get repeated in Pakistan any day, as is estimated by political experts. People in Sri Lanka are facing a severe shortage of food and fuel. There is an atmosphere of extreme anarchy in the country. The main reason behind this crisis is being told that the government there suddenly turned the country towards organic farming, and completely banned the import of fertilizers from outside. The people of Sri Lanka were not ready for such a big change. This created a crisis of agricultural production. Today the situation there is such that essential food items like tomato, potato, and rice are being sold at the rate ranging from Rs 500 to Rs 1000 per kg. The situation in Pakistan is also similar. The Pakistan government has to take new loans to pay the interest on its debt. The people there are also very upset. China gave huge loans to these two countries to implement many of its projects. Now China is not coming forward to help them.

The way floods create havoc in the northeast, particularly in Assam during the rainy season, almost the same devastation occurs every year in hill states like Uttarakhand and Himachal Pradesh as well. Due to excessive rainfall in these hilly regions, there is a lot of destruction to infrastructure and property. In many other states also accidents happen due to floods in riv-ers. Recently, a cloudburst near the Amarnath cave killed over 15 pilgrims, while many more are missing. Stones are falling on Kedarnath's all-weather road in Uttarakhand. Recently a car was badly damaged due to heavy stone falling in the Kasauli area of Himachal Pradesh. Those traveling towards the moun-tains during the rainy season should be very careful. Traveling on dangerous routes should be avoided as far as possible. It is not free from danger to visit places of tourist importance even on rainv davs.

Almost every person in India has a mobile phone, while a large population owns a smartphone. According to a recent re port by the Telecom Regulatory Authority of India (TRAI), 60 percent of the people in the country use the Internet. Economist think population as an asset but from environmental prospective, it's a curse. July, 11 is celebrated as the World Population Day as the world population reached 5 billion on this day dur-ing 1987. This day is observed to raise awareness among people about the impact of growing population, family planning, reproduc-tive health, maternal health, poverty, issues on gender equality, human rights and environmental issues

No simple relationship exists between population size and envi-ronmental challenges. However, overpopulation triggered climate change, pollution, water crisis, soil erosion, deforestation, loss of ecostems and biodiversity, fossil fuels and emergence of new diseases. We cannot have a sustainable planet without stabilizing population. It will lead to more starvation, hunger and unhygienic living conditions in poor countries. As human populations grow, the price of all this "growth" is paid for by other endangered plants and animals and an increasingly volatile and dangerous climate crisis.

Each human being has a legiti-mate claim on a sufficient and fair amount of Earth's resources. But with a population approaching 8 billion, even if everyone adopted a relatively low material standard of living, it would still push Earth to its ecological breaking point. Unfortunately, the average person on Earth consumes about 50% and in developed countries, it's almost five times more than the sustain-able yield of the planet. Thus mankind will need two Earths by 2030. Overpopulation and overconsumption will affect everything from climate change to sociopolitical unrest.

The current world population is 7.96 billion and India's population is 1.40 billion as on July 7, 2022 as per Worldometer. Thus 1 in every 5 persons on the earth is an Indian. The world population will touch 12 billion by 2100 and that will really be a population bomb. The theme for world population day, 2022 is "A world of 8 billion: Towards a resilient future for all - Harnessing op-India was the first country to launch the national family planning

program in 1952 with the objective of reducing birth rate to stabilize the population with the requirement of national economy. Reproductive health is a state of complete physical, mental and social well-being and not merely the absence of dis-ease. Therefore it implies the rights of the citizens to have access to safe, effective, affordable and acceptable methods of family planning at their choice.

It give the massages that to live together equitably on a healthy planet will depend on the choices and decisions we make now. This is an opportunity to celebrate our common humanity in diversity. It is also a reminder of our responsibil-ity to care for each other and our planet.

Human and environmental health underpins in the millennium development goals which seek to eradicate poverty and hunger and ensure environmental sustainability. But to fulfill the requirements for 7.96 billion peoples by the mother earth is almost impossible. Thus 821 million people in the world -1 in 8 - do not have access to enough food. Around 2.2 billion population i.e. 1 in 3 people do not have safety drinking water and 1 in 5 do not have their adequate housing.

One of the reasons for the rapid population growth is technological development which push environmental capacity to another limit. We mined, farmed, built power plants and many development works to make us suitable, which in turn leads to population growth. Another reason for population growth is improvement in health sector. People live longer and longer increasing the average global life ex-pectancy 67 years in 2000 to 72.6 in 2021

At present, globally, 5 persons are born and about 2 persons are died every second resulting an in-crease of approximately 9.46 crores population per year. FAO estimates that a person required about 1.57 kg. of food per day. Hence in order to feed these increased population, a huge tropical rainforest are cut to the size of 20 football grounds per minute amounting to 6 billion trees which is almost the size of North-East India every year. But, a tree can sink about one ton of CO2 and can also produce the oxygen re-quirement for 8-10 persons annually.

Due to faster in population growth in forest and tribal areas. naturally available forest resources and non-timber forest produces are becoming inadequate for their basic livelihood. Many tribal people are giving up their traditional lifestyle and taking up farming and cattle ranching in the forest areas causing irreparable damages. Such people, formerly the protectors of prests, are gradually becoming threats to the forests and wildlife Governments should devise schemes to avert this harm and save the dwindling forest areas including the flora and fauna.

Our planet can offer a quality of life to not more than 2 billion people. Human have a greedy tendency to want more and more in the name of development. Thus, there will come a time when population growth and welfare collide. That time, floods of people will trek all over the world searching for more food and welfare causing for politi-cal conflicts and wars. The only solution is a population policy ap-plied on a worldwide scale. The business world and the religions are generally interested in population growth.

In Manipur, the population im-pact to our environment is innumerous. To meet the requirement, many wetlands of the state have now turned into croplands and fish farms. But we know wetlands are the cradle for biodiversity. Hence, we should protect our wetlands and paddy fields by strictly implementing the Manipur Conservation of Paddy land and Wetland Act, 2014.Due to large scale poppy plantation, Jhuming, illicit felling of trees, extraction of firewood etc. have given a big challenge to our environment too. Therefore until and unless we

control the population explosion, we would not be able to save our environment and if we do not voluntarily accept this fact and take the responsibility, then we will surely be in an environmental dilemma within the next few years.

How can the plight of the elderly be removed in the last phase of life

Indian society is known for the service and respect of its elders. Of the three debts that have been said to not be released without repayment, one of the debts is also of the parents. That is, the service of the parents who raised them in old age is considered the highest

Plight of the Elderly man value. But it seems, these prices

are going to materialize. Com-plaints about parents, disrespect to their elders, not taking proper care of their maintenance, harassment etc., are heard a few times in the society, but the evidence of this is also available from a recent survey. Help-Age India survey shows that forty-seven percent of the elderly are financially dependent on their families

This survey has been studied by dividing it into several parts, in hich the serious aspect is that the elderly are dependent on their familv members due to lack of pension and deposit capital. They neither get proper medical treatment nor other health related things. Being financially weak, many elderly people get humiliated and neglected by their own children. From human point of view, this condition cannot be said to be a sign of a healthy society.

It is strange that the parents who spend their whole life in rais-

ing, educating, nurturing their future, in old age the same children start considering them as a burden. The truth of our own society is also that many elderly people live in old age homes in big cities. Many elders look to their children for food, water, treatment and suffer their scolding every day. How much has been written against this trend, how many films have been made, many voluntary organizations are trying to overcome this problem, but the reality is that the problems of the

elderly are increasing. Those whose children have left them and moved to other cities, their economic and emotional problems are different, those who are part of their children's family also do not get respect. Depend on the kids for pie-pie. Many elders have spent all their earning money on building houses for children, their education, other amenities etc. and are empty handed after retirement. Even if there is some pension or deposit, it is not worth living with respect.

However, keeping in mind the problem of the elderly, the govern-ments make arrangements for medical etc. Some governments have also made arrangements for pen-sion etc., but all that is so insufficient that their troubles do not go away. This has once again underlined the question of social security of the people. Now there is no pension facility even in government obs, what about private institutions

Many people have already spent out of the money of provident fund etc. while in the job, what is left is not useful for life. Those work-ing in the unorganized sector do not have any support for that either. Many times there was a demand to mobilize measures for the social security of the people, but no govern-ment took any practical step on this. In the coming times also, the face of social security from the governments is not visible. How can the plight of the elderly be removed in the last phase of life.

India reports 16,678 new cases, 26 deaths; BA.2.75 variant may be able to spread rapidly, say scientists the variant - called BA.2.75 -

Agency New Delhi, July 11:

With 16,678 new coronavirus infections being reported in a day, India's total tally of COVID-19 cases rose to 4,36,39,329, while the active cases increased to 1,30,713, according to the Union Health Ministry data updated on Monday. The death toll climbed to 5,25,454 with 26 new fatalities, the data updated at 8 am stated.

Meanwhile, the quickly changing coronavirus has spawned yet another super contagious omicron mutant that's worrying scientists as it gains ground in India and pops up in numerous other countries, including the United States. Scientists say

may be able to spread rapidly and get around immunity from vaccines and previous infection. "It's still really early on for us to draw too many conclusions," said Matthew Binnicker, director of clinical virology at the Mayo Clinic in Rochester, Minnesota. "But it does look like, especially in India, the rates of transmission are showing kind of that exponential increase." Multiple Chinese cities

are adopting fresh Covid-19 curbs, from business halts to lockdowns, to rein in new infections, with the commercial hub of Shanghai bracing for another mass testing cam-paign after detecting the BA.5 Omicron subvariant. As China sticks to its "dynamic

zero-Covid" policy of promptly stamping out all outbreaks, the strict curbs by local governments come de-spite low caseloads, at a time

when much of the world coexists with the virus. The active cases in India comprise 0.30 per cent of the total infections, while the national Covid-19 recovery rate was recorded at 98.50 per cent, the ministry said. An increase of 2,023 cases has been recorded in the active Covid-19 caseload in a span of 24 hours. The daily positivity rate was recorded at 5.99 per cent while the weekly positivity rate was recorded at 4.18

per cent, according to the ministry The number of

people who have recuperated from the disease surged to

4,29,83,162, while the case fa-tality rate was recorded at 1.20 per cent.

According to the ministry, 198.88 crore doses of Covid vaccine have been administered in the country so far under the nationwide vaccina-

tion drive. Meanwhile, Macau shut all its casinos for the first time in more than two years on Monday, sending shares in gaming firms tumbling as authorities struggle to contain the worst coronavirus out-break yet in the world's biggest gambling hub. The city's 30-plus casinos and other businesses will shut for one week and people were ordered to stay at home though short trips for essential services ere allowed.

The death toll in floods and landslides in the state has mounted to 192 this year so far. Nearly 5.39 lakh people in

12 districts are still affected by the deluge. In the last 24 hours, two people died after drowning in flood waters in the Hailakandi district. Out of this, 173 people died in floods, and 19 lost their lives in landslides.

According to the daily flood report of Assam State Disaster Management Authority (ASDMA), nearly 3.56 lakh people are still affected in Cachar district while 1.42 lakh people are affected in Morigaon district. 38751 people have still lodged in 114 relief camps in eight districts. The daily flood report of

ASDMA also stated that 390 villages and 7368 hectares of cropland are still under flood waters. Earlier, the people of the state are now worried over the post-flood complications including diseases.

As the flood water starts receding, there is an increased risk of water-borne diseases through direct contact with polluted waters. Many floodaffected people of the Morigaon district have suffered many diseases that as high fever and diarrhoea. More than 600 people of Solmari Dekargaon village have taken temporary shelter on roads, schools as their houses are still submerged under water.

Assam Floods: Death toll rises to

192 as 5.39 lakh people in 12 districts still affected by deluge

> "My house is still inundated by flood water. For the last six days, we have been staying at a school. We are very distressed," Moneswar Deka, a victim told news agency ANI. Hemanta Kumar Deka, a local villager said that many people including senior citizens, women and children

of the village have contracted many diseases. The water entered the village 15 days ago. Water is now receding, but it will take at least a month till the lands dry up. Many villagers developed several diseases during this period. They are doing self-medication. No doctor or medical team has visited the area yet. People are still in relief camps," Hemanta Deka said.

Sumitra Deka, a mother of a 4-year-old said that she and her son have also been suffering from many post-flood diseases. "My child is now sick, and I am too. Not only me or my child, but many others in our village have also suffered many diseases. We appeal to the government to provide some medicines."Another victim. Banti Deka said that the relief material provided by the administration has proved in-

sufficient People of Kampur area in Assam's Nagaon district are also worried about their future as the floods have left a trail of destruction. The devastating flood hit the Kampur revenue circle in the central Assam dis-

trict twice this year. Hundreds of families at Gejaipam, Kachua area have now become homeless after the flood washed away their homes and properties and they are now taking shelter on roads, and embankments by making temporary sheds Many school buildings, and religious institutions in the area were also damaged in the

deluge. After receding flood waters many villagers have moved to their areas, but they now see only devastation.

Prime Minister Narendra Modi said during a virtual event today for an Assamese newspaper, "Assam is facing the challenges of floods. Nor-mal life has been affected. CM Himanta and his team are working continuously on relief op-erations. I have been in constant touch with the officials and the people there."

According to the Assam State Disaster Management Authority (ASDMA), nearly 9.68 lakh people in 20 districts of the state are still affected by the deluge.

Shiv Sena to seek urgent hearing of petitions before Supreme Court on Monday

The petitions related to Maharashtra political crisis al-though were scheduled to be heard in Supreme Court (SC) before the division bench comprising Justices Surya Kant and JB Pardiwala on Monday, they were not listed till Sunday night.

With SC slated to resume regular functioning after summer vacation on Monday, Chief Justice N V Ramana constituted a three-judge bench on Sunday. However, the approval for the Maharashtra matter from the Chief Justice was pending. If the issues aren't listed, Se-nior advocate Kapil Sibal will request the urgent hearing on behalf of the Shiv Sena, on Monday.

Shiv Sena MP Vinavak Raut said that since the matter remains unlisted, the party will request the bench headed by Chief Justice to take it up for hearing as early as possible or allot it to any other bench.

The issues including the Shiv Sena's opposition to the governor's decision to invite rebel MLAs to form the government, the petitions on trust vote issues, the appointment of the chief whip in the Assembly by the newly-elected speaker. and disqualification pleas pending against 16 rebel Sena MLAs

are to be heard by SC. Cabinet expansion
