Biren Singh announced a reward of Rs. 5 lakh to the team of Doctors, Nurses and other technical staffs of Jawaharlal Nehru Institute of Medical Sciences (JNIMS). Those patients successfully

transplanted Kidney are Takhellambam Bikramjit Singh (37 vears) from Wangoo Tera, Kakching,

Kimsary (41 years) from Tuisonjang Village, Churachandpur and Hanso Wungleng (32 years) from Winitang, Ukhrul.

While congratulating the doctors, nurses and others, the Chief Minister termed the first successful conduct of kidney transplant by Government Hospitals in Manipur as an huge achievement. He continued that many people of the State faced financial hardship for kidney transplant and as such the State Government had taken up certain efforts under mission mode to upgrade the infrastructure and service of JNIMS. Flood in Assam worsen, Silchar still reels under water, Himanta **Biswa visits affected areas**

By a Correspondent Shilchar, June 26:

Flood in Assam gets worsen today with over 25 lakhs people affected in 27 districts of the state. Manipur's neighbour Shilchar in Assam continue to be inundated. Report said that the death toll due to floods and landslides reached 121 with four deaths reported today, where 21 are reported from Cachar district.

Chief Minister of Assam Himanta Biswa Sarma today visited Silchar and Cachar district for the second time to review the situation. Sarma had made an aerial survey in flood affected areas of Shilchar amd Cachar on Thursday. The Chief Minister took a boat ride in and around the city, where over two lakh people have been affected due to severe floods since June 20. Heavy rains on the hills of

adjoining Meghalaya and Mizoram swelled the water level in the Barak river causing a breach in an embankment This made the flood situation in Silchar and adjoining areas in the Cachar district grim since June 20.

Videos shared on social media showed people dangerously standing in waist-deep flood water for water bottles and food items being airdropped by IAF helicopters in Silchar. The helicop NDRF personnel also continued their rescue efforts while the administration stepped up efforts to distribute drinking water and food items.

deputy Cachar commissioner, Keerthi Jalli told DH on Sunday that the administration was using drones to drop drinking water

in the worst affected areas. "There are still areas in many narrow bylanes that couldn't access which is currently the area we are focusing for nearby delivery with a request for taking up distribution to local volunteers, or through ropes and human chain and now we are exploring drone technology as well", she said. The daily flood report issued by Assam State Disaster Management

Authority on Sunday said

25,10,989 people in 2,894 villages still remained affected by floods. A total of 2,33,271 people are taking shelters in 637 relief camps. Relief materials were also distributed to other affected populations, who are not taking shelter in relief camps, the official said.

The NDRF has been helping the district administration in safe evacuation of people from affected areas apart from our own SDRF, fire and fire and emergency service personnel, police and others.

The Quiet Transformation in Defence Pensions By: Rajnish Kumar Pensions Management, which in- have been onboarded to SPARSH, identification or life certification is

The mediascape is rife with narratives which may lead distinguished retired defence services personnel to get apprehensive about the quiet transformation which is happening in the management of Defence Pensions in India. The System for Pension Adminis-tration – Raksha or SPARSH, as announced in the Union Budget 2017-18, is a landmark policy decision of the Government of India, to provide comprehensive web-based interactive pension disbursement system for defence pensioners. The project is managed and implemented by the Defence Accounts Department under the aegis of the Ministry of Defence, with the support of Tata Consultancy Services (TCS) as the software development partner. This article is not a declaration

but a presentation of contrast, between legacy systems and technological innovation, and between facts and fiction. The phenomenon of governance in India has evolved. where numerous initiatives are being designed keeping the benefi-ciary at the centre. The Government is increasingly relying on digital systems to ensure transparency, efficiency and effective public service delivery. It is a privilege that the Defence Accounts Department, over the course of more than two and half centuries, continues to serve defence pensioners whose number is nearly 33 Lakh presently Within this system, steeped in history, outdated processes and regulations, SPARSH comes as a positive disruption, where the Department has adopted a paradigm shift towards enhancing and ensuring right pension to the right person at the right time by a transparent and

participative process. There is a need to examine these legacy systems and corresponding transformational innovation. For the benefit of the reader, here is a short primer on the old system of

Pensions Management, which involves nearly 2,500 offices across the Defence Services. When ser-vice personnel retire, their service details including their names, service records, commendations and details of their dependents inter alia are verified by the Pensions Initiating Agencies, be it Record Offices, Directorates, Head of Depart-ments, or others. These details are sent to the Pension Sanctioning Agencies (PSAs) which are various offices of the Defence Accounts Department, namely, Principal Controller of Defence Accounts (PCDA) Pensions in Prayagraj, Jt. CDA (Air Force) in New Delhi and PCDA (Navy) in Mumbai for audit and sanction of pension payment and generation of the Pension Payment Order (PPO). The PPO is communicated to the pensioners and the various Pension Disbursing Agen-cies (PDAs) such Banks and Defence Pension Disbursement Offices (DPDOs).

At this point, it is impressed upon the reader the importance and difficulty of audit. Errors in details are difficult to rectify by any sin-gular agency and disconnect within the ecosystem is a bane to efficiency. The systems are old and need reform. The scale and size of the process is concomitant with the size and complexity of how the Indian Armed Forces operate with their own rules and customs. This is why even the Comptroller & Auditor General (C&AG) in their report on Defence Pensions recommended that the three pillars -Record Offices, PSAs, and PDAsshould be connected online, enabling automated flow of informa-tion, in a secure mode, with proper validation and security checks The SPARSH Portal bridges a

long-pending lacuna in public service delivery, where the portal takes on the responsibility of connecting and interfacing with all stakeholders in the pension ecosystem. More than 5.13 Lakh pensioners have been onboarded to SPARSH, whereas more than 27 Lakh pensioners continue to be served by the legacy system. There is verifiable data of massive improvements in processing time and sanction, with majority of the PPOs being

generated within a week. There was a delay in credit of April 2022 monthly pension to 58,275 pensioners via SPARSH due to technical and procedural reasons was immediately addressed and pension was credited within four working days. In contrast, the department continues to actively pursue non-credit of pension in nearly 1.2 lakh cases which are disbursed by the banks. SPARSH has the capability and the flexibility to generate corrigendum PPOs at the click of a button. Fresh cases i.e. the new retirees who are coming onboard SPARSH have expressed satisfaction at the case of pension processing.

SPARSH services have further been expanded across more than 4 lakh Common Service Centres (CSCs) to ensure last mile access to pensioners, established backend linkage to fetch Aadhaarbased Jeevan Pramaan directly on the portal. Recently, a mobile number updation utility has also been deployed for pensioners for better communication and ease of access.

Principal Controller of Defence Accounts (PCDA) Pensions, Prayagraj is the primary agency for Pension Sanction on behalf of the Defence Accounts Department. However, it would be simplistic to assume only one agency or office is completely empowered and autonomous in function within a careful system of checks and balances.

The Pension Regulations for various Defence Services, as approved by the Parliament, are the primary rules based on which the Defence Pensions are regulated in India. The requirement for annual identification or life certification is drawn from these regulations, which bounds the Department as well all other audit agencies in India. The rule of law is the *sine qua non* of a functioning democracy.

TCS has been brought on board as software development partner. The SPARSH Portal has undergone testing and security clearances from the highest cyber security agencies in the country, to ensure that the handling of data of ex-servicemen and defence pensioners is protected and secured. With two rounds of pilots being run from February 2020 and despite the advent of a global pandemic, SPARSH was deployed in a phased manner successfully for the Indian Air Force, Indian Navy and the Indian Army. The technical complexity of pensions management is matched by the innovation.

The SPARSH Portal has truly transformed this entire process and it has been the constant effort on part of the Ministry of Defence to ensure that Defence Pensioners are provided the best possible services, which is a vast improvement over the legacy system de-scribed above. The pensioner should not have to run from pillar to post, seeking to move offices and departments for their rightful pension. The Department is using technology to do so. The Defence Accounts Department, with the sincere cooperation of the Service Headquarters, is striving to ensure satisfaction of all stakeholders and welcomes the continued cooperation of the defence pensioners in this endeavour to transform defence pensions management in In-

Continued focus and re-doubled efforts: Improving the Nutritional Status of Women and Children in Uttar Pradesh

Uttar Pradesh (UP) has accomplishments to claim, successes to celebrate and hopes to look up to as it rolls out Mission Poshan 2.0 in its efforts to improve the nutritional status of women and children.

The launch of PoshanAbhiyaanin 2018, Central government's flagship programme aimed to improve the nutritional status of children, adolescent girls, pregnant women and lactating mothers, in a time bound manner,drew the focus on fight against undernutrition among the most vulnerable groups.

The programme was based on four strategic pillars-use of technology for real time monitoring, community mobilization and behavior change, convergence of multiple departments of the state, and the focus on interventions during the critical first 1000 days of a newborn baby. The strategies were to translate into implementable activities, primarily through the Integrated Child Development Scheme (ICDS) mechanism.

This involved detailed planning and timely execution of training the Anganwadi Workers (AWWs) who are the backbone of the ICDS programme. The training was based on the incremental learning approach. UP was one of the first states to have completed the rollout of all incremental learning modules for the AWWs. Anecdotal evidence from the field suggested an improvement in capacities of the AWWs and it was expected to subsequently lead to a positive shift in the community knowledge and behaviors, on maternal, infant, and young child nutrition.

Anganwadi Centres in UP were equipped with approximately 1.57 lakh growth monitoring devices to strengthen the monitoring of nutritional status of children and pregnant women, which is one of the key services of ICDS. An almost similar number of AWWs were provided with smart phones to be able to operate the mobile-based application for real-time monitoring of their field activities and build their knowledge base by acces ing the e learningmodules.The initiatives have gathered momentum in UP slowly but steadily. Some of these efforts. got negatively impacted though during the pandemic.

However, the findings of the National Family Health Survey (NFIS-5) for nutrition status in the statehave been encouraging. There was an improvement in select nutrition indicators between NFHS-4 (2015-16) and NFHS-5 (2019-21).

Progress was evident in some of the indicators related to maternal, infant and young child nutrition (MIYCN) that can be attributed to the achievement of the objectives of PoshanAbhiyaan. Exclusive breastfeeding rate showed a marked improvement (at 59.7 percent in NFHS-5 vis-4-vis NFHS-4 when it stood at 45.6 percent). The percentage of underweight children showed a drop from 39.5 percent to 32.1 percent. There was an encouraging decrease in the percentage of stunted children from 46.3 percent to 39.7 percent. A drop in the prevalence of stunting reflects action at multiple levelsacross multiple sectors. Consumption of iron and folic acid tablets improved marginally and anemia prevalence in pregnant women also showed a decline.

Anganwadi Centresplayed a critical role as part of the Jan Andolan activities under PoshanAbhiyaan. Besides some centrally supported events, statespecific community-based events were also organized from time to opportunity for knowledge sharing by the AWWs on issues relevant to maternal and child nutrition and peer learning for pregnant women and lactating mothers in an environment of celebration.

To involve the community in this endeavor, the government adopted traditional events such as 'godbharai' and 'annaprashan' as platforms to promote optimal nutrition and health behaviors in the community. These events provided an opportunity to reiterate and highlight the core and critical elements of good, wholesome nutrition, diet diversity, and balanced diets. These were institutionalized as Community Based Events (CBEs).

Similarly, the PoshanPakhwada and PoshanMaah were celebrated in the state with as much zest and fervor as across the country. There were efforts to establish a statewide review mechanism with monthly meetings organized at the block and district levels under the chairpersonship of senior officers in the district. Convergence of stakeholder departments was initiated for synergistic action on malnutrition and undernutrition. Innovations were encouraged for facilitating the uptake of services, enhancing community knowledge and behaviors on maternal infant and young child nutrition. And all these efforts did yield positive results

With the launch of Mission Poshan 2.0, UP will continue to work towards infant and young child nutrition and will also focus on maternal nutrition to complete the spectrum of MIYCN and contribute to further improvement in the nutritional status of women and holidren. Children with severe and moderate acute malnutrition will receive due attention and the probability of averting morbidity and mortality in these children will be much higher.

Steadily and surely, the state is making progress on the indicators of nutrition that are the fundamental markers of long-term good health.

Droupadi Murmu is all set to become the next President of India

A New Pandemic (Food inflation)



In India, rural consumer food price has doubled in the year through March 2022, according to the All India Consumer Price Index (CPI) by the National Statistical Office (released April 12).at 13 per cent, the country's annual whole-sale inflation was at the highest in a decade. Food and fuel prices played a major role.

Such is the impact of inflation that the World Food Program (WFP), currently running one of its most expansive food relief operations in recent his tory, made a desperate appeal for further funding. Because food inflation has significantly increased the cost of its day to-day relief: It's paying USD 71 million (Rs 5.4 lakh crore) more per month now for the same operation level. In the context of the Rus-

sia-Ukraine war, energy security came into focus. The world has been debating how the fossil fuel disruption will derail the planet's efforts to reduce greenhouse gas emis-sions to stop global warming and resultant climate change. Fuel price is already rising and adding to the overall costs of everything, including food production and transporta-

tion. But, the war has also disrupted foodgrain supply and circulation further adding to the demand-supply equation. Extreme weather events continue to affect large swathes of areas growing food and thus bringing down overall production. To sum up, the most fundamental survival need is at stake.

This crisis exposes the globalised world's another fault line. When the COVID-19 pandemic struck, an interconnected globalised world suddenly woke up to a situation where every country retreated and scrambled for selfprotection; expectedly the rich world jealously colonised all re-sources needed to fight the pan-

demic leaving the rest helpless. The food sector is also interconnected and interdependent, though perilously. WFP calls its aftermath a "seismic hunger crisis" gripping the world. In Africa and West Asia, the hunger crisis has already set in. The World Bank has

warned that each percentage point increase in food prices would push an additional 10 million people into extreme poverty. The impact of food inflation is impacting the world's poor and developing countries the most because most of these countries are also food importers. For instance, some 50 countries. mostly poor countries, depend on Ukraine and Russia for

wheat, a staple grain. Country after food grainsurplus country are now hoarding through curbs on export. This makes the availability of food grains difficult

for deficit geographies. In an unprecedented joint appeal, the heads of the World Bank Group, International Monetary Fund, WFP, and the World Trade Organization gave an urgent call: We call on the international

community to urgently support vulnerable countries through coordinated actions ranging from the provision of emergency food supplies, fi-nancial support, increased ag-ricultural production, and open trade ... We also urge all coun tries to keep trade open and avoid restrictive measures such as export bans on food or fertilizer that further exacerbate the suffering of the most vulnerable people.

Learning poverty increases to 70 per cent, inequality widens South Asia among one of the two worst suffering regions approved additional financing middle-income countries find during school closures. In

The Global learning poverty has further increased to 70 per cent in 2022 with largest increases in South Asia and the Latin America and the Caribbean, as per the simulation result based on the latest available data and evidence. It means the world has lost the gains during 2000-2015 when it had fallen from

61 per cent to 53 per cent. "The State of Global Learning Poverty: 2022 update" prepared jointly by six organizations – World Bank, UNESCO, UNICEF, FCDO, USAID, and BILL & Melinda Gates Foundation - says that high rate of learning poverty indicates that education systems are failing to ensure that children develop critical foundational skills and thus are far from reaching, and in many cases are not on track to reach SDG 4 target of universal quality education for all by 2030 This makes it much harder for children to acquire the technical and higher-order skills needed to thrive in increasingly demanding labour markets, and for countries to develop the human capital needed for sustained, inclusive economic growth. The very high levels of learning poverty violate children's right to education, the undate emphasized

Learning poverty was on the increase even before the general closures of schools during February 2020 February 2022 on account of COVID-19 crisis. In 2019, when the learning poverty indicator was first launched, the learning poverty rate was already estimated to have increased by 4 per cent to 57 per cent between 2015 and 2019 in low- and middle-income countries, a category India falls in. On account of being largest populated country in South Asia, one of the two worst suffering regions, India is obviously among the worst suffering nations.

The update has come only two days after the World Bank

of \$250 million for Outcome Accelerated Learning (GOAL), a programme which aims to improve education results for children across Gujarat, the only state in India, where such a programme is being implemented. Education system in Gujarat has almost 12 million students, 65 per cent of which are in remote regions of 'priority districts'. Following the COVID-19 crisis, the state estimated learning losses of about 10 per cent, with students in priority areas being disproportionately impacted. The latest financing complements the original loan of \$500 million approved in March 2021. This Rapid Response Framework seeks to reach every child and retain them in schools, assess learning levels regularity, prioritise teaching the fundamentals, increase catch-up learning, and develop psychological health for students and teachers. The additional financing will scaleup the coverage from original 9000 to 12000 schools.

It should be noted that India is home to almost 25 per cent of world's children (over 2.2 billion), and students not only of Gujarat but of all the states in the country have been in need of such programmes to overcome learning poverty. The recent data available for a few countries, for example, for the state of Karnataka in India, shows learning losses equivalent to the extent of the school closure - meaning that one year of school closures maps to roughly one year of normal learning that was not achieved or was forgotten, the update says. World average of closure of in-person schooling was 141 days with highest of

273 days in South Asia. The update further says that the actual learning data now emerging from numerous countries show that there have been very large learning losses. More recent results from both lower- and uppereven larger losses. For example, it says that in India, between 2017 and 2021. average language and math scores for 5th graders on the national assessment have declined.

As response to the school closures countries resorted to remote learning, but due to lack of connectivity and the existence of a wide digital divide the efforts were found to have very low level of success, and insufficient to compensate for the learning losses. It failed for most students, and only the richer segments of the populationthose with broadband connectivity, access to devices for the use of each family member, a place to study, availability of books and learning material, and a conducive environment, among other conditions-were able to maintain a reasonable level of education engagement. It widened the inequality in

education. The latest update has even quotes a 16 year old student Shirin Rajesh from India as saying "...Schools haven't cut back much on their curricular expectations and "ineffective" learning becomes detrimental for students in the long run...It's a struggle to tackle the never-ending list of assignments, especially with mental health issues in teens being at an all-time high."

Drawing on recent experiences with accelerating learning at scale, UNICEF, UNESCO, and the World Bank have also recently proposed the RAPID strategy of learning recovery and acceleration. It gives specific example of Gujarat, that has realigned the entire curriculum for the first quarter of the academic year to focus on foundational learning. Results from the Periodic Assessment Tests (PAT), a weekly assessment that began pre-pandemic, were used to personalize remote education to the level of each student

addition, Gujarat has used a mix of low- and high-tech interventions to deliver personalized. adaptive education to each student. Ten-year-olds unable to read and understand a simple

story increasing to 7 out of 10 is very high in low- and middle income countries with exacerbated inequalities in education. We have narrow window to act decisively to recover and accelerate learning, but without urgent action to reduce it we face a learning and human capital catastrophe, the update summarized. If children do not acquire the basics of literacy together with numeracy and other foundational skills – the futures of hundreds of millions of children around the world, and their societies, are at grave risk. However, our action will require firm political commitment and implementation of evidencebased approaches for rapid imnact

Without action, the current eneration now risks losing \$21 trillion in lifetime earnings in present value, or equivalent to 17 per cent of today's global GDP. In low- and middleincome countries it implies an annual loss of \$975 person. Recovering from this massive shock with exacerbating inequality in education, we require broader national coalitions of families, educators, civil society, the business community, and other ministries of the government with firm political will, the update says. National commitments education require that all actors align in the design and implementation of reforms with the sole objective of improving the education and wellbeing of children and vouth-not the positions or interests of political parties or unions, nor the interest of suppliers, vendors, or providers, or other education anv stakeholders, but only the interest of students (IPA Service)
