The All Manipur Muslim Students' Organisation (AMMSO) wrote to the UGC secretary and the Member Secretary of AICTE in protest against the appointment of Bhabeswar Tongbram as Vice Chancellor of Manipur Technical University, claiming that he is not eligible or fit for the position.

In a press release, AMMSO stated that the continued appointment of Dr. Bhabeshwar Tongbram as VC of MTU despite continuous submission of memorandums

to the Government of Manipur is a clear example of corruption in the education sector, contradicting Biren Singh 2.0's

corruption-free slogan. The AMMSO cited the most recent UGC regulation, dated July 18, 2018, section 7.3 for vice-chancellor qualification. AMMSO stipulated that the VC be a distinguished academician with at least ten years of experience as a professor. He should also have a minimum of eight research publications in journals approved by the UGC, AICTE, and SCI. Tongbram Bhabeswar, the newly appointed VC, did not meet any of the criteria for

the position of VC of Manipur Technical University. He has been employed as a Lecturer at the government polytechnic institute in Takyel since 1991, and later as an Associate Professor at the same Diploma Institute. The AMMSO stated that there is a significant difference between engineering degree colleges and diploma institutes, as well as differences in service statuses. And he has never held the position of professor. Tongbram Bhabeswar received a Ph.D. in non-engineering subject from Manipur University's History department on the topic of

Manipur's traditional housing and architecture.

AMMSO further said that it is a huge surprise that a person who is ineligible to be the principal in charge of a diploma institute has been appointed as the vicechancellor of a degree college. He had previously been removed as Principal of Government Polytechnic because he was unfit for the position.

The North East Dialogue Forum (NEDF) expressed strong condemnation to the recent bomb blast in Manipur. A statement of the Forum said, "Manipur has been experiencing many incidents of bomb blast in Manipur and in public places for the last many years. However, we would lik to condemn the two bomb blast in Manipur in the last 4

months". On 5th March 2022, hours ahead of the 2^{nd} phase and last phase of assembly election, a crude bomb exploded inside the campus of Regional Institute of Medical Science.

Another incident happened when unidentified persons exploded a powerful bomb on the premises of Little Flower School, Imphal at 3.10 AM on June 5th 2022. There was no casualty although some portions of the school building, including window panes, were damaged. The Network has also received information from a credible sources that many members, a group suspected not to be from Manipur/ India are moving with arms openly in Moreh Town and nearby villages. "These types of incidents

are leaving fear and insecurity among the civilians which is creating more unrest among the people of Manipur" the NEDF said that urged the authority to take urgent action by appointing a special investigation team (SIT) to thoroughly investigate all the bomb blast case, the free movement of members of the groups with arms in Moreh and find the perpetrators so that civilians will feel safer at their own home

The Giant Himalayan Lily(Cardiocrinum giganteum) which grows on the hill slopes of this picturesque village located about 120 km northeast of Imphal in Senapati district attracts visitors including the Mega Miss Northeast during its flowering season this year. This came to light when this

War on Drugs: CM's exceptional skill in mobilising community

Even as many more are yet to be taken up to fight the menace of drugs in the state, Chief Minister N. Biren Singh had successfully made all people of the state irrespective of the differences of community to join in the war against drugs. Every communities of the state today have openly declared support to the Chief Minister's initiative and pledge to fight against the drugs.

The participation of all people of the state against the menace of drug is seen for the second time in the history of Manipur. In mid 1980s the state witnessed mass uprising against drug users and smugglers after a child was allegedly murdered by a user here in the state. Unlike that ne, the Chief Minister of Manipur personally takes initiative in making

all the people joined in the war against drug. If one recounts the sequence of events that took place in the mid 1980s in the aftermath of the murder of a child at Singjamei by a drug user, it will be easy to understand on how effective the war on drug was those days. Almost every club members of all communities started hunting for drug users and punished them. Even some underground autimize for utig users and puissed them, lover some underground groups also puisshed those drug users including alcoholic by shooting at their legs. However, punishing the drug users in front of public or by physically assaulting them fails to minimize the drug users those days. After some experts found that punishing the users by physically assaulting them is not the solution, it was learnt that lack of well prepared strategy to fight the drug menace was the main reason of the collective struggle of that time.

Reason for reminding the sequence of events that took place in mid 1980s was to convey a simple suggestion to the CMs initiative to the fight against drugs. It is a fact that every community has extended support to the CM's war on drugs. When there is a support to the good cause then the war is half win. If wanted to win this war then some more policy need to be framed. A policy for rehabilitation of the drug users should be a priority. And next, improvement of the socio-economic conditions of the people is also another factor. As the users now has been concentrated among the youths and the school going children the authority in power need to monitor the conditions of students in all government schools. Above these, the authority needs to be sincere in punishing the drug smugglers without bias.

Salient Features of Flag Code of India, 2002



1. The Indian National Flag represents the hopes and aspirations of the people of India

It is the symbol of our national pride and there is universal affection and respect for, and loyalty to, the National Flag. It occupies a unique and

special place in the emotions and psyche of the people of India. 2. The hoisting/use/display of the Indian National Flag is governed by the Prevention of Insults to National Honour Act, 1971 and the Flag Code of India, 2002. Some of salient features of the Flag Code of India, 2002 are listed below for the information of the public:-

a) The Flag Code of India, 2002 was amended vide Order dated 30 December, 2021 and National Flag made of polyester or machine made Flag have been allowed. Now, the National Flag shall be made of hand and hand woven or machine made, cotton/polyester/wool/silk spun and hand khadi bunting.

b) A member of public. a private organization or an educational institution may hoist/display the National Flag on all days and occasions, ceremonial or otherwise, consistent with the dignity and honour of the National Flag.

c) The National Flag shall be rectangular in shape. The Flag can be of any size but the ratio of the length to the height (width) of the Flag shall be 3:2.

d) Where the Flag is displayed in open, it should, as far as possible, be (a) where the rad is displayed in open, it should, as it as possible, to flown from survise to survey, it respective of weather conditions.
(b) Whenever the National Flag is displayed, it should occupy the position of honour and should be distinctly placed.
(f) A damaged or dishevelled Flag shall not be displayed.

g) The Flag should not be flown from a single masthead simultaneously

with any other flag or flags.

h) The Flag should not be flown on any vehicle except of the dignitaries mentioned in Section IX of Part III of the Flag Code, such as President, Vice- President, Prime-Minister, Governors etc.

No other flag or bunting should be placed higher than or above or side by side with the National Flag.

The meditations- deeper insights into the dark shadows of 'corruption'

The word 'corruption" comes from the Latin word 'corruptus', meaning 'mar', 'bribe', or 'destroy'. It is, therefore, defined as the dishonest or fraudulent conduct by those in power typically involving bribery. Corruption is a deviation from normal human behavior in a geopolitical setting whereby causing the derailment of individual and institutional accountability, transparency and natural justic Transparency International (TI) defines, "Corruption as the abuse of entrusted power for private gain," and include behaviours like public servants demanding or taking money or favours in exchange for services; politicians misusing public money or granting public jobs or contracts to their sponsors, friends and families, and corporations bribing officials to get lucrative deals. Hence, from aforementioned etymological analysis we can understand that corruption may be classified into five groups: 1. Collusive 2. Extortionate 3. Nepotistic 4. Investive 5. Nepotistic Investive Transactive. Collusive corruption means undue advantage extended to the relatives and friends. Investive corruption is a kind of investment that can help when future needs arises. Extortionate

corruption involves collection of payment/taxes payment/taxes by force. Transacting Corruption is a smooth give and take. Broadly speaking corruption is an abuse of trust to shamelessly fill pockets with super easy money. Such phenomenon are very much visibleto the wise eye and inquiring mind in our Naga society.

Let us all accept that the Nagaland is a corrupt state trying to survive on a slippery moss of failed governance. Corruption seems to have become a norm in the normal functioning of the state machinery and its nut-bolts. Much has already been written and spoken on corruption and corrupt practices in the state. There is a common consensus that corruption is entrenched at every level of the society, and tribal nepotistic influences over electoral politicsadministration-governance and filthy money power have been identified as the leading causes. The economy of Nagaland is fully dependent on the Central Government funds. The state cannot sustain on its own. Despite this fact, the embezzlement of these funds is

irresistibly an order of the day. For decades, as it is in the public domain, that the state financial plan presents deficit budgets. The root cause of this saddening financial drought is corruption. The observation of the Hon'ble Comptroller and Auditor General (CAG) of India in its report on the Government of Nagaland (Report No 2. of 2020) that it is a matter of grave concern that these malpractices (cases of excess) fraudulent drawal) persist despite being highlighted in past audit reports" is actually a moot point in the entire scenario. The culture of impunity has been killing the soul of Naga society. The culprits are roaming around freely well beyond the reach of the hands of law. This is the story of Nagaland through my eyes

I generally avoid participating in debates on corruption. It is not that I am avoiding my responsibility as a concernedyoung citizen, Public Intellectual and a Professor, however somewhere I feel that such 'ritualistic' talks have no use. My observation says that the people often understand corruption from a very narrow and shallow

perspective. Corruption or behavior that can be termed as a corrupt behavior is a manifestation of a problem which is invisible and much more complicated than its manifested symptoms

The causes and effects of corruption, and how to combat corruption, are issues that have been very much on the discussion table in the Naga society. Moreover, various historically influential philosophers, notably Plato (The Republic), Aristotle (The Politics) Machiavelli (The Prince and The Discourses) and Montesquieu (The Spirit of the Laws), have concerned themselves with political corruption in particular, albeit in somewhat general terms. For these philosophers corruption consisted n large part in rulers governing in the service of their own individual or collective-or other factional-

self-interest, rather than for the common good and in accordance with the law or, at least, in accordance with legally enshrined moral principles. Again, we can observe that the

Thinkers of the past too have failed to reach to the exact conceptualization of the reality of corruption.

DharamvirSingh:The architect of Doordarshan

Communication has always been of prime importance. With the advent of television in 1927, Indians also dreamed for this service and after independence television service was started in Delhi as a part of All India Radio (AIR) in 1959. For its expansion across the country, its management was separated from AIR and independent new body named "Doordarshan (DD)" was constituted. One of the architects of the ambitious Doordar shanservice was - Shri Dharamvir Singh.

Dharamvir Singh was born on 10 June 1932 in Barhin Patna district. His native village is SimraBilgawan on the banks of Son river under Bhojpur district. His father Shri Devsharan Singh (Former Chairman, Bihar Legislative Council) was a renownedCongress leader and freedom fighter at the national level and was advocateat Barh S an Sub-DivisionalCourt. Dharamvir Singh graduated from Bihar National College, Patna under Patna University. He was a meritorious student from the very beginning and along with studies, he also had special interest in journalism, sports and social works.He was selected by Sarat Chandra Bose as a member of the "International Brigade" to go for the independence of Indonesiain 1947. He was a member of Bihar Lawn Tennis Council in 1952 and Secretary of Bihar Table Tennis Association from 1954-67. He was also associated with New Patna Club, Delhi Golf Club and Delhi Gymkhana for a long time.

In the company of his father, Dharamvir Singh inclined towards active politics. In 1967, he was elected for the first time from the 193-Bakhtiarpur Vidhan Sabha constituency in Patna district and became the secretary of the Congress Legislature Party. In the election held on 21 February 1967. Dharamvir Singh (20772 votes) contesting on Indian National Congress ticket defeated Congress ticket defeated Independent Shri Ramlakhan Rai (18221 votes) and Shri R.S. Singh (15317 votes) of Jan Kranti Dal in a tough contest. Again in 1969, he elected from the 193-Bakhtiarpur Assembly Constituency and became the Chief Whip of the Congress Legislature Party. In this election held on 9

February 1969, Indian National Congress candidate Dharamvir Singh (19578 votes) defeated Ram Lakhan Rai (17896 votes) of Samyukta Socialist Party and Ramchandra Singh Chouhan (15364 votes) independent. In By-Er.Prabhat Kishore

inducted for the first time in the Bihar Cabinet as Minister of State for Labor, Information and Tourism.

On the special initiative of the then Prime Minister Smt. Indira Gandhi, Dharamvir Singh contested for the Fifth Lok Sabha in 1971 on Indian National Congress (R) ticket from the 34-BarhLok Sabha constituency. Outgoing MP and former Union Minister Smt. Tarkeshwari Sinha was contestingagainst him as an IndianNational Congress (Organization) candidate. The Firebrand stalwart Smt. Tarkeshwari Sinha had won four consecutive elections namely- the First Lok Sabha (3-Patna East constituency in 1951), the Second Lok Sabha (28 Barh constituency in 1957), the Third Lok Sabha (34-Barh constituency in 1962)and the fourth Lok Sabha (34-Barh constituency in 1967). Dharamvir Singh (184484 votes) created a new history in this area by securing 48.10 percent votes defeating an invincible MP like Smt. Sinha

After being elected to the Lok Sabha, he resigned from the membership of the Bihar Legislative Assembly, on which the flamboyant socialist leader Bhola Prasad Singh was elected in the by-election. Mrs Gandhi was highly impressed withDharamvir Singh and he was inducted into the Union Cabinet in 1971 as Deputy Minister of Information and Broadcasting, in his first inning as a Member Parliament, a position he held till 1977.

Several remarkable works have beenperformed in the Ministry during his tenure, the most notable event was the formation of "Doordarshan". On 1 April 1976, television broadcasting was separated from the radio network and replaced by the name "Doordarshan". In 1972, television service was started in the second city of the country, Mumbai. Prior



promote artistic films as well as con nercial and devotional films like "Jai SantoshiMaa". All India Radio Annual Awards were started in 1974. He led several Indian delegations abroad.

During the election of the Sixth Lok Sabha in 1977, there was a wave of Janata Party due to the student movement in the whole country Bihar was the center of this movement. Congress could not get a single seat in Bihar due to the anger of the people stricken by the Emergency. On Indian National Congress ticket, Dharamvir Singh got only 101945 votes and lost to a newcomer Shyam Sundar Gupta (372227 votes), the Mayor of Kolkata Municipal Corporation. In 1979, a separate political party named Congress (I) was formed by Smt. Indira Gandhi, but Dharamvir Singh decided to remain in the original party.

Due to mutual tussle and personal arrogance, the Janata Party government could not survive for its full term. In the mid-term elections to the Seventh Lok Sabha in 1980, Dharamvir Singh contested from the 18-BarhLok Sabha constituency as a candidate of the Indian National Congress (Urs) led by Shri DevrajUrs, the then Chief Minister of Karnataka. He defeated Smt. Kamla Devi (160801 votes) of Janata Party and Ramrai Pd. Singh (102566 (Indian) values and the second and Parliamentary Party of the Congress. He later aligned himself with SharadPawar-led Congress (S) and became the party's national general secretary. After Ram Lakhan Singh Yadav left the party to join Congress (I), DharamvirBabu was also given the responsibility of the post of President of Bihar unit of Congress (S).

In 1984, for the Eighth Lok Sabha, Dharamvir Singh contested again from the 18-BarhLok Sabha

constituency on Indian National Congress (S) ticket. In the election, he got full support of socialists like Karpoori Thakur. But he again fell victim to the sympathy wave triggered by the assassination of Prime Minister Indira Gandhi and lost the election to a controversial figure like Prakash Chandra alias Baby, son of Ram Lakhan Singh Yadav, who was contesting on Indian National Congress (Indira) ticket. Shri Prakash Chandra got 384719 votes out of total cast of 610745, while Shri Singh had to be satisfied with only 161983 votes. The people of the Barh area continued to repent of his defeat till the end. In 1986, at the National Convention of Congress (S) in Mumbai, Dharamvir Singh Singh proposed the merger of Congress (S) with Congress (I) in his capacity as General Secretary, which was accepted unanimously. The entire life of Dharamvir Singh

was dedicated to the nation. He wanted to see India as a great nation. The only goal of his life was to make the country self-sufficient and prosperous and to bring harmony in the society. He was constantly striving to achieve his goal. He was an articulate and fighting man. He was a strong supporter of the politics of honesty and remained unmarried throughout his life for the fulfillment of this motto. He was a skilled politician and a strong orator. His charitable life inspired him to travel to European countries. Dharamvir Singh was no match in the field of journalism. The editorials and articles written by him on various national as well as international burning issues in newspapers and magazines like WeeklyDinaman etc. hadfascinated the public.He was the flagbearer of the communication revolution in India.

On 5 April 1989 in the midst of the discussion on his election to the Raiva Sabha from Maharashtra. Dharamvir Singh went to Mumbai where he held detailed talks with the then Chief Minister SharadPawar on various issues. But on 06 April 1989, he suddenly passed away in a suspicious condition in Mumbai. A wave of mourning ran across Bihar and this shining star of Indian politics disappeared from the national horizon forever

The Face of Mumbai DD Pradeep Bhide **Passes** Away

Veteran news anchor and commentator Pradeep Bhide who was associated with Mumbai Doordarshan for over four decades, passed away after a prolonged illness due to brain cancer on Tuesday. He was 68 and is survived

With a commanding screen presence, a clear baritone

voice, and an engaging style, he also anchored special shows on Mumbai DD, (which was later renamed "DD Sahyadri"), a regional channel. He was much sought for the periodical state or national elections programs or the results and political analysis post-polls that were

watched avidly. Bhide hailed from the Marathi stage and had acted in some of the experimental plays staged by veteran playwright Ratnakar Matkari. Dilip Prabhavalkar, Vasant Soman, and Ravi Patwardhan were his co-artists. As such he had no stage fear. This benefitted him while reading news bulletins.

His father Jagannath and mother Subhalkashmi were teachers in Ravat Shikshan Sanstha set up by Karmveer Bhaurao Patil. Since they were shifted to the schools located at different places from time to time. Pradeep Bhide had to pursue his education in different schools located in villages of Maharashtra.

His parents were adept at Marathi. Sanskrit and Hindi and "Vishnu Sahasranamam' was recited daily at home. The recitation of "Vishnu Sahasranamam" helped him in voice modulation. Bhide had said in one of the earlier interviews. After SSC, he did B.Sc in Pune and later completed a journalism

The problem with those who study corruption is that they concentrate on the they manifestation of the material symptoms however they do not know the disease which generates such symptoms. For me, Corruption is primarily a mental disease and corrupt actions are basically resulting as symptoms of the disease.

What is the beginning of Corruption? What is the true genesis of corrupt behavior that generates corrupt practices? Or if I transform my queries and ask, corrupt body corrupt speech, corrupt mentality, which one is the worst? What would be the answer? If we are able to inquire deeper, we will easily discover that answer is mind fraud of corrupt mentality, because it is beginning of everything and is the worst. Thinking/generating corrupt thoughts is sinful however in order to consider it Sin thoughts must be acted upon, must be executed, put into action. Therefore, when people continuously think corruptly, by default it will automatically cause a corrupt action in absence of the presence of 'inner system' of checks and balances'. In Court of Law, we argue that elements must two

mandatorily involve in the Crime, the first is MensRea and the second is Actus Reus. The Mens Rea is a Latin term for the intention or knowledge of wrongdoing that constitute part of a crime as opposed to the action or conduct of the accused. The Actus Reus also a Latin term refers to action or conduct which is a

constituent element of a crime. as opposed to the mental state of the accused. In order to established crime, these two elements have to be present and be proven beyond reasonable doubt. So it is the mind that primarily is a culprit. Body is merely a slave of the mind, and therefore it is not wrong to assert that a person is engaged in the who corruption or corrupt activities (as listed before) is basically suffering from a serious 'Mental Disease' hence needs

treatment and cure. Let us inquire further and understand. An individual who engages in corruption suffers from several underlying problems. Are they craving for something? This could be wealth and materialism, or it might be something about the exercise of power and the temporary boost of confidence that gives. They are likelyengaging in some form of hatred or at least a lack of compassion for the victim of their crime, implying a further state of mental and emotional damage. There is a serious absence of moral insight or wisdom. They are likely to have moments of torment about corrupt practices (fear of being discovered, guilty feelings, anger, shame, defensiveness, a will to commit other crimes a will to commit other crimes to keep from being caught out). And, evidently, theywillfully engaged in sustaining ignorance about the world and the impacts of their choices through which sinfulactions have been generated hence aggravating their mental disease, as the

more the individual engages in these sinful activities. deeper the trouble gets, and the more serious the psychological, physiological and material consequences. Fundamentally, the corrupt official is also not in control of their mind: the craving desires, greed and ignorance dominate and torment the individual, poisoning their quality of life and the relationships with others. So, as we can see that the

problem of corruption is not really what we think it is. It is not just about pilling up of illegal money or involving in illegal, unlawful actions consequent to the breach of trust but much more than that. We have to understand that origin of corruption is relevant to ignorance which is a result of greed, clinging, hatred, arrogance, misconception, inconsistency and ignorance. So what the solution then

is? Before exploring the probable solution let us remind ourselves that corruption first breeds in mind and then it is translated into evil action. In this context, the primary duty, therefore, of a man is to control mind by developing the practice of 'mindfulness' and equanimity' to generate 'GOD CONSCIOUSNESS'.

Despite existence of several Laws and Law enforcing agencies corruption could not be curtailed in Nagaland rather it is increasing day by day. As previously mentionedcorrupt behavior is Mental Disease, therefore, it is important to challenge this behaviour with compassion and insight. guiding those individuals who

can change their behaviour to the government. Also, do so

As this evil condition arises in the mind, the transformation of the behaviour must also address knowing and guiding the mind. Such an effort may seem unattractive to a corrupt official, however, following a righteous and noble path is in itself rewarding, and brings real benefits, including inner happiness, self-respect, and the love of those around us. Where the individual is unable or unwilling to transform their behavior, appropriate sanctions should be pursued to prevent such behaviour which erodes the moral integrity of the current society and infects future generations and robe off their appiness. Also, in addition to what

has been argued here, in order to free the society from the tentacles of corruption, asset (Fixed and Liquid) disclosure campaigns (Self and Family members of Government officials including Class 1,2,3,4 employees, MLAs and Ministers)should be initiated by socially awakened, free spirited, visionary individualsand organizations. Let everyone who is holding the government office as an

official or a minister or MLAor just an employee lawfully reveal their assets periodically in the public domain. Also, speedy computerization of accounts system, implementation of B L O C K C H A I N TECHNOLOGY on a warfootingwill go great mile in curtailing corrupt practices in

strengthening and empowering citizens to hold government accountable will prove to be a sustainable approach that will help develop trust between government and citizens. For example, community monitoring initiatives can

contribute to the detection of corruption, reduced leakage of funds and improved quality and quantity of public service Moreover, a proper check and balance system be established to keep vigilance over mechanism through which government contracts which have been granted to private contractors.

However, if nothing works, I have a final solution. I appeal loudly to all my young students and friends to start asking questions to their parents about the source of their income. Ask them how their parents built mansions for family, ask how they can afford to keep fleet of vehicles, ask how they can buy you maybe one of the most expensive cars and bikes to go to College, ask them the how did they buy lands and properties, ask the questions. Such questions from own children- who are the real

architects and stakeholders of Nagaland might lit up the dead conscience and ignorant mind of the people suffering from the mental disease of 'corruption' and they probably could see the light of 'truth' which will lead them to the 'cure' and finally to the 'Pure life'-into the KINGDOM OF GOD.

Narendra Modi Govt's image has got a big jolt in gulf nations in last few days Toxic remarks by BJP leaders have potency to poison Arab mind for long

By K Raveendran New Delhi June 8.

The Narendra Modi government might in all probability be able to bring the friendly Arab governments round to softening their initial response to what they consider to be the most sacrilegious remark by BJP leaders against Prophet Mohammed. The government has already intensified the firefighting, with special efforts being made to explain the situation to the ruling dispensations in the Gulf and Arab world. While the more strident

among them, such as Qatar though with lesser clout, have demanded that the government of India tender an official apology for the remarks, the government may be able to persist with the stand that there is no question of the government apologising. There is no precedent for such a step. Even in the case of the Babri Masjid demolition, the government of India has never apologised.

The stand that the government and the party are two different entities is a diplomatically accepted norm and therefore one is not expected to act on behalf of the other. The government

has, however, mounted a special drive to take the Arab leaders into confidence and it might succeed in the effort as

But the damage it has caused to India's reputation among the Arab Muslim populations is bound to take a much longer time to repair. The collective Muslim mind has been poisoned beyond recognition and this will have far-reaching implications for Indian interests in what the Muslims consider as the Islamic 'nation' beyond that extends geographical boundaries.

Supermarkets and shops in some countries have already pulled out Indian products from the shelf as businesses vie with each other to win customer loyalty, particularly from more fundamentalist customers. And they will make a show of it to gain maximum advantage. At a supermarket in Kuwait City sacks of rice and shelves of spices and chillies were seen covered with plastic sheets, along with printed signs in Arabic reading: "We have removed Indian products". As some of the more sober

responses to the atrocious comments by the BJP spokespersons pointed out, terrorist and fundamentalist elements are bound to exploit the anger to take over the defence of Islam, which will

have dire consequences for Indians both inside and outside the country.

Terror group Al-Qaeda lost no time in getting involved, threatening to launch suicide attacks in Delhi, Mumbai, Uttar Pradesh and Gujarat to 'fight for the honour of the Prophet'. An Al-Qaeda letter in this regard has threatened to kill those who 'affront the Prophet' and that its members 'shall bind explosives with 'our bodies and the bodies of our children' to blow away the ranks of such people. It is significant that a

section of the Muslim public opinion has even termed Nupur Sharma's remarks as terrorism, making it an alibi for retaliation. Al-Azhar University, considered as one of Islam's most important institutions, said the BJP leaders' comments were 'the real terrorism', which could plunge the entire world into deadly crisis and wars'

Similarly, Saudi-based Muslim World League said the remarks could 'incite hatred'. Perhaps, in what emotes even more. Saudi Arabia's general presidency of the affairs of the Grand Mosque and the Prophet's Mosque called Nupur Sharma's conduct a 'heinous act'. There could be parallels with the aftermath of the

cartoons featuring Prophet Mohammed at different intervals of time. A dozen cartoons published by Danish newspaper Jyllands-Posten in 2005 led to widespread protests, some of which escalated into violence, claiming more than 250 reported deaths, with Danish and other European diplomatic missions coming under attack along with churches and Denmark being boycotted.

Swedish artist Lars Vilks. who stirred a controversy in 2007 with drawings depicting the Prophet with the body of a dog, was killed last year in a car crash in what is believed to be a revenge accident. The accident occurred while Vilks was travelling in a police vehicle.

Similarly, after French President Emmanuel Macron defended the right of a satirical magazine to publish caricatures of the Prophet Mohammed, a French teacher was beheaded by a Chechen refugee after showing the cartoons to his class.

These are no doubt fringe elements. But the real threat is that fringe elements would draw responses from other fringe elements, which despite their lack of representative character can cause immense harm. (IPA Service)
