State Cabinet holds its first meeting; First session of 12th Manipur Legislative Assembly on March 24

The State Cabinet held its first meeting yesterday, after the formation of new Government, with Chief Minister N. Biren Singh taking the chair. The meeting was attended by newly sworn in Ministers Thongam Biswajit, Yumnam Khemchand, Govindas Konthoujam, Nemcha Kipgen and Awangbow Newmai.

During the meeting, the State Cabinet approved to recommend to the Governor of Manipur for fixing the date and time of election of Speaker for the 12th Manipur Legislative Assembly on 24th March, 2022 at 9:00 a.m. The cabinet also decided to request the Governor to summon the first session of the 12th Manipur Legisla-tive Assembly on 24th March, 2022 at 10:00 a.m. and to de-liver the Governor's Address in the Legislative Assembly on the same day at 11:00 a.m.

The Cabinet approved '100 tasks in 100 days' programme, which consists of various targets set before the Government for achieving the new Government. This included policy decisions, construction works as well as systemic improvements.

The Cabinet decided that

there will be a 5-day week for government offices, without affecting essential services. Working hours will be increased on working days. There will be change in office timings. Office will start at 9 am. To sync with school timings and enable proper home management as well as ease traffic congestion, school tim-ings will also change with classes starting early at 8 am. The new system will improve output and productivity of government servants by pro-viding much needed rest & rejuvenation on weekends. It will also enable adequate time for school children to productively use afternoon hours.

Imphal, March 23:

A total of 2400 children aged 12-14 years were vaccinated against Covid 19 in Manipur till date even though the nationwide vaccination program for these age group of children was formally launched on March 16,according to official sources. Thus only about two percent of the targetted children (12-14 years) population of the state were vaccinated.

An official of the state health department when con-tacted said that the state's vaccination target for chil-dren aged 12-14 years is

Meanwhile the state on Wednesday reported 6 new Covid 19 positive cases, when 841 samples were tested in the last 24 hours, it said. Thus the state's total infection tally increased to 1,37,057. The total number of active cases stands at 80.The state reported no Covid death in the last 24 hours, official sources said.

The state's Covid 19 death toll increased to 2.120.On the other hand with just 7 new recoveries in the last 24 hours the total num-

cases in Manipur reached 1,34,851. Thus the state's re-covery rate increases to 98.39 %.Presently only 8 Covid 19 positive cases are under home isolation, Till date 1,59,6013 persons were tested for COVID 19 at the various testing centres in the state, the source said.

As per latest official reports, the state has so far given 27,68,428 doses of Covid vaccines including 15,28,372 first and 11,75,523 second doses besides 64,533 precautionary doses to the

Cleaning education sector: The curious case of former education minister

Sorokhaibam Rajen Singh. This name must be familiar, right? Well, everyone in Manipur must have known him for the last few years. If not, at least his name. The former edu-cation minister is, by far, the most famous education minister Manipur has ever seen. But, unfortunately, not by his

good initiatives and deeds. The reason, everyone knows.

He shot to fame during the last term of the BJP-led coalition government the Chief Minister N Biren Singh headed, with his speeches that drew controversies and criticisms from all sections of the society sans his die-hard disciples Curiosity, the people have, is: how and why former BJP decision-makers chose him to be the torchbearer of the state's education system? A dire need to ponder this statement. In one of his controversial statements regarding the re-

cruitment of around 923 graduate teachers at the education department, Mr. Rajen announced that the government would set an example, unlike previous governments, by declaring the results within three days after the exam. It didn't happen. But, it was no surprise. A lot of promises and anhappen. But, it was no surprise. A lot of promises and an-nouncements did not happen. History is the proof. The con-troversial part was when Rajen said: "We will try to recruit-ment on merit basis partially" Let's note: Not all, just partly. In Manipuri, he said, "Merit-basis ta eikhoi khara adum, khara sengna tounaba hotnagani." The statement comes at a time when Mr. Biren kept promising and boasting about a corrup-tion-free government and the overhyped "School Fagathansi Mission." Mission.

The controversy didn't end right there. In one of the victory speeches at Awang Wabagai on March 11, Mr. Rajen declared that 14785 electorates who voted for National Peoples Party contender Pukhrambam Sumati Devi have sold out their rights and therefore, they will be deprived of all the government entitlements for the next five years. What was more astonishing is that the people gathered there gave him rousing applause. Who would have expected this undemo-cratic assertion from a seasoned politician, a representative of the state, who was given the education portfolio twice?

Soon after filing his nomination papers, Congress candidate Likmabam Manibabu pointed out discrepancies in Rajen's educational qualifications. Setting aside their differences, his four rival candidates joined hands to accuse him of "dubious education records and even more dubious 'age history.' The former education minister had different claims His 2007 affidavit said he graduated in 1985 from Manipur University, In the 2012 election, Rajen claimed to have passed BA in 1992. In 2022, Rajen said that he got his BA degree from YK College at Wangjing, which is under Manipur University, in 1998. In his clarification, he asked rival candidates to file an RTI to know the information, and he never mentioned the two BA degrees he said in the 2007 and 2012 affidavits. The clarification is still due to whether he got three degrees or not. People are still reeling under this suspense. As affidavits sway people's opinions and choices, clarity is still demanded.

Leveling criticism on his English language knowledge and speaking ability won't be a good topic. Still, people hope for at least some English reading and speaking skills from the person handling the education sector shaping the future of our students and society. Leaving everything aside, the former minister did not even have the audacity to speak in the Manipuri language, one of the country's official languages, and his first language. Voluminous mockeries and memes came as replies to his speeches on social media sites by netizens, and people waited to watch his mouth.

The choice of the people is varied. Not everyone is wrong or right in a democratic setup. The majority wins the vote, and people are compelled to respect the result. Some people make decisions contemplating a candidate's merits and merits to being a lawmaker before pressing the button at the EVM. In contrast, many joined the mass in choosing a candidate depending on what near and dear ones and political leaders say. The Spiral of Silence theory of Elisabeth Noelle-Neumann perfectly fits here. The theory states that an individual's perception of the distribution of public opinion influences that individual's willingness to express their own political opinions. Therefore, blaming the constituents of Lamsang for electing Rajen to be their representative merited another editorial or a discussion.

People have lofty expectations from Education Minister to revamp the state's education system. Now that N Biren Singh has won the race to be the state's chief minister for the second term, the priority should be on who would bolster the education sector of the state? Here, the BJP needs to pull up its sock and assign the education minister's role to somebody who will not put the people of the state to shame through his unfounded and shocking comments. factory in terms of environ-ment and air pollution. The condition is that among the top 100 places which have been found to be most polluted on the earth, 63 Indian cities are included in the list. Not only this, some of our cities are leading the tally. For example, Delhi is the world's most polluted capital for four consecutive years. Pollution in the national capital has increased 15 times as compared to previous year. The condition of North India is worse in terms of air pollution. Delhi's air pollution ranks fourth in the world, while the most polluted city is Bhiwadi in Rajasthan. After this comes the city adjacent to the national capital is Ghaziabad of Uttar Pradesh. Ten of the 15 most polluted cities in the country are around Delhi, half of which are in Haryana and Uttar Pradesh.

A recent report of IOAir, a Swiss environmental firm, reveals that stubble burning in paddy fields in Haryana and Punjab is responsible for 45 percent of air pollution in Delhi. Now that the Aam Aadmi Party (AAP) governments are ruling in both Punjab and Delhi, it will be interesting to know that in the coming winter season whether the stubble smoke from Punjab will reach Delhi or not? As per the World Air Quality Report released by IQAir, no city in India has met the World Health Organization (WHO) air quality criteria. Smoke from motor vehicles, coal-fired power stations and industrial plants plays a major role in deteriorating our air quality. It is not just a matter of statistics, but this situation is directly affecting the health of the people in our country. Air pollution causes many heart and lung diseases, for which the country has to spend a huge amount for its treatment. For India, this amount is estimated to be more than \$ 150 billion. IQAir uses data from ground sensors and government agencies to

prepare the world air quality report.

It is also said that air traffic causes a lot of pollution. However, all the blame is put on the trucks. When all the VIPs travel by air, hardly any agency or country will think of banning airplanes. The condition of domestic air travel has been improving gradually. Union Civil Aviation Minister Jyotiraditya Scindia said in Parliament that in December, 3.8 lakh passengers traveled by air every day, whereas before Covid, 4 lakh people traveled by air on a daily basis. That is, the civil aviation industry of the country is rapidly returning to the previous level. Also, international flights are also going to start with 100% capacity from March 27. When the cases of Covid started in the country, then on 23 March 2020, international flights were suspended for a week, and later the ban remained in force for two years. However, in July 2020 a limited number of flights continued with the air bubble arrangement with 37 countries. Under the air bubble system, passengers going abroad were strictly prohibited from going anywhere other than the designated places from the hotels.

Many places in the northwest and cities along the southeastern coast report up to eight heatwave days per season. However, the regions in the extreme north, northeast and southwestern India are lesser prone to

This year, the geographical expanse of the latest heatwave spell was unusually large.

North and northwest India including Jammu, Kutch-Sauratshtra, Rajasthan along with parts Madhya Pradesh and Uttarakhand experienced heatwave last week.

In addition to such a large area being under the influence of heatwaves, the latest spell was a prolonged one too. It later spread to Gujarat, north Maharashtra and extended all the way to interior Odisha. "During the past few days, the southerly winds from Gujarat, south

Pakistan took the heat to southern and southwest Rajasthan. There were no active western disturbances, which otherwise brings colder winds. As a result, temperatures in Jammu, Rajasthan and neighbourhood areas remained higher than normal," said Mrutyunjay Mohapatra, director general, IMD. Missing rain and thunderstorms

Along with seasonal transition, the lack of pre-monsoon showers has contributed to the overall heating.

"There has not been significant thunderstorm activity and associated rainfall over most parts of the country in March," said Dr Mohapatra.

Heatwave in Antarctica

On March 18, surface air temperature recorded along eastern Antarctica were historic — up to 40 degrees Celsius above normal.

Normally, the temperatures around this time of the year should have been around minus 45 to minus 50 degrees Celsius. However, the south pole recorded somewhere between minus 18 and minus 12 degrees, which climate scientists are terming unprecedented.

Last week, Concordia, a station located on the Antarctica plateau and at

a distance of 1,670 km from the Geographic South, reported temperatures 50 degrees above normal. The situation has arisen due to warm westerly winds surpassing the Southern Ocean and reaching the interior parts of Antarc-

For many years now, bottled vater has been growing in popularity. People seem to favor the taste and convenience that this product can offer. It is water that is purified. is made safe to drink, is put into glass or plastic containers and is sealed. Bottled water seems like a silly product to consider using thanks to the reliability and safety of tap water around the world. but there are still many locations that need this product for basic life essentials. It is also very common to use a bottle of water as a way to stay hydrated while working, partici-pating in athletics, going to the gym and other physical activities of life. One of the reasons why it is such a common product is that it is highly affordable. For about 50% of the cost of a soda, juice product or tea, you can purchase a zero-calorie option that can leave you feeling afresh. It has been a good choice of beverage for hydration and many other health purposes. But while water is undeniably great for you, what about other factors such as the whole bottle part?

Bottled water offers you the ontion to drink water anywhere. It highly portable, durable and can be sealed. These reasons make it ideal for working out, travelling or doing virtually any activity where you may need to drink water. Bottled water is very convenient to transport or carry, especially in places where drinkable water is not guaranteed, hard to find, found at a great distance or not available at all. This is certainly one of the top benefits of bottled water, where you can just purchase it anytime and anywhere conveniently. Convenience is definitely its main selling point. Due to the fact that it does not expire and easily be stored, bottled water is ideal for emergency and disaster

situations. It is really always a good idea to keep some of this product stored in safe place at home just in case. Most of us would agree that bottled water taste exponentially better than tap water. This is because of the purification process that it goes through before it is made available for drinking, unlike tap water. Production of bottled water is strictly regulated and monitored to make sure that it is clean and free of contaminants. This puts the product highly in demand because clean and safe tap water is not always available. After a natural disaster, water lines might be disrupted, leading to contamination of water supplied to households. In situation like this, bottled water can be life- savers because it is clean and safe to drink. Bottled water is safe to drink due to the test for all sorts of chemicals and bacteria it would undergo before being bottled. For tap water, it can easily become contaminated, leading to severe illness especially in developing countries. Bottled water is readily available in supermarkets and grocery stores and comes in various sizes and content per bottle, giving consumers more choices de-

pending on their needs. However the cost of purifying, bottling, advertising, transporting and storing bottled water can trickle down to the cost of water itself. This means the product is significantly more expensive than the tap water. Buying bottled water is even more expensive if you are doing it very often. The cost will still depend on its size and brand. Remember that its price usually covers packaging, advertising, shipping and administrative operations. Experts even revealed that it is more costly than milk. Though you are drinking bottled water with a water-filtering system, you can still save more money in the end by filling your own water bottles if you like to drink bottled water every day. Mostly bottled water product contains chemicals such as biphenyl-A (BPA) in the plastic container. This com-pound can seep into the water which means you are most probably consuming them. This risk is greatly increased if the content is stored in hot areas like those where direct sunlight is present. Truth is- many bottled water products are just fil-tered tap water. This has been a troubling fact for many of us, but it has being fact for many of us, but it has been proven time and again. The same is reported in media recently in Manipur in which a product of bottled water (Silver Dew of Loktak Industry) found contaminated sub-stances. Most bottled water is produced by the same factories that are making soft drinks, using the same water. Considering that you may not even be getting better quality water when you buy bottled water, it can be a plain common sense to fill your own instead. You just need clean water and a good water bottle. Government supposedly adds fluoride to tap water to help protect our teeth from decay and other dental problems. On the other hand bottled water is produced without the sub-stance. Production of bottled water increases the use of fossil fuels With this in mind, you will be avoiding this by filling your own water bottles. Also the manufacture of the plastic for the bottle actually utilizes more water than it takes to fill your own bottle. It poses many unfavorable environmental hazards. The problem can start when empty bottles are not properly disposed which contributes greatly to the whole pollution problem. Huge percentage of bottles are ending up in trash cans and land fillings, having harmful effects on the environment.

According to a report, Americans buy more than 30 billion liters of water per year, most of which are contained in polyethylene terephthalate (PET) bottles. This means nearly 9000,000 tons of plastics which also take 17 million barrels of oil to produce what's worse; it is found that only 20% of these bottles make it to the recycling bin. The bottled water trend might be doing more for good health, but it is affecting the environment negatively big time. In fact, bottled water certainly has its place in today's society. Bottled water is an effective way to stay hydrated throughout the day. The overall availability of this product makes it easy to get some-thing that should be healthy to drink whenever and wherever you happen to be. The only problem is that you're paying hundreds if not thouyou're paying nundreds it not thousands of extra money each year to take the advantage of this convenience. When you purchase this item, most of your cost goes to plastic and the state of tic manufacturing instead of the liquid you consumed. Testing from NRDC found that 30% of bottled water samples showed sign of con-tamination. That means, it may not be safer than some tap water options that are available around the world. The best solution is to purchase a filtering product or even a reverse osmosis system that you can use at home with your current water supply. Then you can invest in reus-able water bottles that will help you to stay hydrated at a fraction of the cost of the individual bottles you might be purchasing thereby reducing environmental problem too.And people should start lessening their dependency on it and again become accustomed to the taste and simplicity of tap water.

India-Bangladesh Must Always Stand With Each Other

Under the initiative, India has promised to rescue 23,000 people from the Eastern European country by March 15. Besides, 147 foreign nationals from 18 countries including Bangladesh have also been rescued. According to a March 10 report in the Times of India, 13 Bangladeshis were rescued from the northeastern Sami city of Ukraine and taken to another city during the fierce fighting.

Expressing gratitude for rescuing Bangladeshis from the battlefield, Prime Minister Sheikh Hasina wrote in the letter, "I am writing this letter to express my sincere gratitude to you and your government for their assistance and cooperation in rescuing and evacuating Bangladeshis along with Indian nationals from Sami Oblast,

Covid-19 containment measures to end on March 31, says Centre, face masks, social distancing to continue

Agency New Delhi, March 23:

In view of a decline in coronavirus cases across the country, the Home Ministry has decided to revoke the provisions of the Disaster Management Act, 2005, for Covid containment measures However, wearing a face mask and following social distancing norms will continue as earlier.

In a letter to the chief sec-retaries of all states, Home Secretary of India Ajay Bhalla stated, "After the expiry of the existing MHA Order dated 25th February, 2022, no further Or-der may be issued by MHA."

The letter specified that the advisories issued by the Ministry of Health & Family Wel-fare (MoHFW) on containment measures, including on the use of face masks and hand hvgiene, "will continue to guide the overall national response to the pandemic"

The central government had issued orders and guide-lines under the Disaster Management Act upon direction from the National Disaster Management Authority (NDMA) for the containment of the virus in the country since March 24, 2020, when the pandemic first hit. The February 25 order is

set to expire on March 31, 2022. It had directed states to open up economic and social activities after assessing the risk of infection. It defined the parameters to identify areas where restrictions are needed as: Over 10% Test Positivity Rate in the last week and a bed occupancy of over 40 per cent (including oxygen supported or ICU beds). Further, Bhalla in his letter

stated that given the nature of the disease, "we still need to remain watchful of the situa-"Wherever any surge in the number of cases is observed, the States/UTs may consider taking prompt and proactive action at a local level, as advised by MoHFW from time to time," the letter

The total caseload in the country stands at 23,913 only (on March 22) and the daily positivity rate has declined to 0.28 per cent, he said. It is also worth mentioning that with the combined efforts, a total of 181.56 crore vaccine doses have been administered. Bhalla added

A 13-Year-Old Autistic Girl Swims **Across Palk Strait in Record Time**

A 13-year-old Miss Jiya Rai, daughter of a senior sailor of the Indian Navy, Madan Rai of INS Kunjali, and a student of Navy Children School, colaba, Mumbai, brought laurels to India by swimming across the Palk Strait from Talaimannar (Sri Lanka) to Dhanuskodi (Tamil Nadu India), a distance of 29 km, in 13 hours and 10 minutes on Sunday, March 20.

The swimming com-menced at 4.22 am on Sunday from Talaimanar and concluded at Dhanushkodi at 5.32 pm. She covered the stretch filled with water snakes, jellyfish, facing rapidly changing currents. A child with Autism Spectrum Disorder became the youngest and fastest female swimmer in the world to swim across the Palk Strait. The record was earlier held by Ms. Bula Chowdhary who swam the distance in 13 hours 52 minutes in 2004, an official statement said.

The event was conducted by the Para-Swimming Federa-tion of India (PSFI) with cooperation from many agencies including the Swimming Fed-eration of India, Sports Development Authority, Tamil Nadu, and the Autism Society of India. The Goa Shipvard Ltd. provided the swimmer financial sponsorship for the event.

During the event, the Sri Lankan Navy provided search and rescue cover in Sri Lankan waters while the Indian Navy and Indian Coast Guard provided similar support in Indian waters. Vice Admiral Ajendra Bahadur Singh, Flag Officer Commanding-in-Chief, West-ern Naval Command congratulated Jiya Rai and her parents on this stupendous achieve-

Akin to their male counter-parts, girls of the age group 16½ to 19 years will undergo three years of military training after successfully clearing the UPSC NDA written exam, Services Selection Board (SSB) interviews, and medicals. A total of 19 vacancies namely, 10 for the Army, 06 for the Air Force, and 03 for the Navy have been allotted by the respective Service HQs for the first batch of girls at NDA.

The training objective at NDA shall continue to remain as the centre of excellence for producing military leaders equipped with professional, moral, and physical attributes required for leading the troops to victory in the future battlefields. With minimum changes to the existing curriculum the training in Academics, Drill, Outdoor Training, etc. will be conducted in a gender-neutral manner. However, owing to physiological differences between male and female cadets the aspect of Physical Training may entail certain changes in the training of girl cadets.

The dedicated support staff will be provided for facili-tating the training of girl cadets. The majority of training activities shall be conducted jointly keeping their employability in mind, wherein the women officers are required to command the troops of men. A similar training methodology already exists in other Pre-Commissioning Training Academics like OTA Chennai, INA

Ezhimala, and AFA Hyderabad. For the stay of girl cadets, one of the squadrons has been identified and is being refur-bished with amenities and requirements specific for their training. Actions are underway to augment the existing infrastructure. Requisite modifica-tions will also be undertaken to conform to gender-specific lifestyle requirements Whereas, in the long term, a separate squadron is being envisaged exclusively for girl cadets, a Defence spokesman

Occasion for amending Lokpal Act has not arisen: Govt

Agency New Delhi, March 23:

The occasion changes in the Lokpal Act, to confer the anti-corruption ombudsman with the powers to reconsider and review its orders, has not arisen, the Lok Sabha was informed on Wednesday.

"Amendments to laws are considered as per necessity from time to time, if so required in public interest. The occasion for such an amendment has not arisen at this stage," Singh said in a written reply to a question whether the government aims to amend the Lokpal and Lokayuktas Act, 2013, to confer upon the Lokpal powers to reconsider and re-

view its orders.

As per section 20(10) of the Lokpal and Lokayuktas Act, 2013, the website of the Lokpal shall, from time to time, display to the public, the status of num-ber of complaints pending before it or disposed of by it, he

"Details of complaints are available on the website of the Lokpal," the minister said, when asked whether the Lokpal will make public the details of the prosecution in the corruption cases received by it in 2021.

To a separate question on the appointment of Director of Inquiry for conducting prelimi-nary inquiry into graft com-plaints, Singh said, "As per the provisions of the Lokpal and Lokayuktas Act, 2013, Director of Inquiry is to be appointed by the Lokpal". Imphal Times

search for peace, Rio appealed to all sections to rededicate to the cause of unity, oneness, understanding and true peace.
