### State Govt. frames new transfer and posting policy for Govt. employees

Manipur has framed a new transfer and posting policy its employees. Department of Personnel and Administrative Reforms (Personnel Division), Govt, of Manipur has issued a

notification on May 12, 2022. As per the notification, normal tenure of posting of a gov-emment employee will be a mini-mum of one (1) years and six months and a maximum of three (3) years in a place of posting. No transfer may be effected unless concerned employee completed 1 (one) year and 6 (six) months in a post, unless there are compelling reasons or

circumstances to do so.

The new policy is applicable to all employees under the Government and all its agencies, in-Societies, Agencies, Commissions, etc.

The state government framed the new transfer policy to ensure effective, efficient and responsive across the state, while taking care to minimize hardship to all due to frequent transfer and postings, and also to ensure equitable distribution of govt. employees at different locations in fair and transparent meaner and to maximize job

Other conditions for the transfer and posting of the state government employees are - Officer/official must be posted for a total period of not less than 9(nine) years in hill areas/diffi-cult places during the entire service period. This may be served successively or after breaks, as preferred by the Officer/official, subject to each stint being not less than 1(one) year and 6(six) months.

As laid down in Sub-para (iii) above, each such posting in hill areas/difficult places shall not be less than 1(one) year and 6(six) months. However, Officers/officials who are performing well and willing to serve longer in hill areas/ diffi-cult places may be allowed to serve for a period longer than 3(three) years as may be deCategorization of places for the purpose of difficult postings will be made by the respective Departments, in consultation with the Department of Personnel. IT-based Manpower Man-agement System will be used to manage the transfer and postings of all employees.

As far as possible, officials may be posted at their Home District, if the Official so chooses, 2(two) years before their retirement so as to facilitate ease in processing pension

Transfers shall normally be effected in the month of April/ May after the financial year is over so that disruption of work

All together 10 applicants were rejected for the said post. The notification also includes lists of 25 rejected applicants for the post of Deputy Registrar and another 16 rejected list of applicants for the post of Deputy Controller of Examina-tion.

### DRI seizes 15.93 kg foreign-origin gold worth Rs 8.38 crore smuggled via Indo-Myanmar border in Guwahati and Dimapur

New Delhi, May 13:

In another significant operation by the Directorate of Revenue Intelligence (DRI), against organised gold smuggling syndicates, code-named "Gold on the Highway", 15.93 kg of foreign-origin gold smuggled though the Indo-Myanmar border, and valued at Rs 8.38 crore, was seized yesterday in Guwahati and

Acting on the basis of specific intelligence, officers of DRI mounted discreet surveillance on two oil tankers and a truck travelling separately from Mao, Manipur to Guwahati, Assam. In the early morning hours of 12th May 2022, these vehicles were intercepted simultaneously at different points along the National Highway between Dimapur and Guwahati.

In the fiscal year 2021-22, DRI has seized 833 kg of gold valued at Rs. 405 crore during its operations across the country. Of this, in the North-Eastern states, DRI has seized more than 208 kg gold valued at Rs. 102.6 crore, smuggled through the highly sensitive Indo-Myanmar and Indo-Bangladesh border.

After intensive examina-

tion of the intercepted vehicles, 96 pieces of gold bis-cuits weighing 15.93 kg were recovered that had been care-fully concealed in different parts of the three vehicles Five persons of the syndicate have been arrested and three vehicles were seized in the op-eration. Further investigations are in progress.

DRI's ability to effectively detect and affect such seizures acts as a deterrent to those attempting to compromise India's economic frontiers DRI remains committed to continuing its relentless crackdown against the perpetrators

#### Healthcare is the government's responsibility

Last year people were so scared of Covid that the profits of the insurance industry increased manifold. Because of this, health insurance premiums in India registered a

growth of 25 percent last year. A report by the National Insurance Academy, which works under the Union Finance Ministry, revealed that in the year 2020-21, insurance companies collected Rs 58,572 crore as medical insurance premium, while in the next financial year this figure increased to Rs 73,330 crore. The report, released at an event of the PHD Chamber of Commerce and Industry, said that the health insurance market in India has been growing steadily at a compound annual growth rate of 24 percent, but it grew by around 34 percent during the phase of pandemic. According to NITI Aayog, 69 crore people are members of Ayushman Bharat scheme, while 26 crore people in the country are already associated with some health insurance scheme. That is, 70 percent of the citizens of the country are part of some health insurance scheme, the remaining 30 percent of the population, that is, around 400 million people are not yet part of any health insurance.

The central government also wants to connect 400 million uninsured Indians with the Ayushman scheme. The National Health Authority and NITI Aayog have prepared its draft on the subject. To take advantage of the scheme, each of these individuals will have to pay an annual premium of Rs 250 to 300, in return for which each of them will be able to get free treatment of up to Rs 5 lakh in a year. This will also include the facility of being treated in a private ward. This facility is not available in the current Ayushman scheme. The new scheme may be implemented in the next few months. Under the Ayashman scheme, treatment can be done in any hospi-tal associated with the PM-JAY scheme of the government. Even medical facilities will be available in other states. Meanwhile, the Rajasthan government is promoting its own insurance scheme through advertisements. For the first time, a state government has done a work of winning the hearts of the people by announcing the same free facility for all the citizens.

Health is a matter related to everyone and in the changed circumstances, health care has become a very costly affair, which is not available to everyone. Health insurance is expensive and not reliable either. The problems related to health insurance of private insurance companies come out every day. In such a situation, the Chief Minister Chiranjeevi Health Insurance Scheme of Rajasthan government is a commendable initiative. The insurance scheme of the state government includes free health insurance of Rs 10 lakh for each family, accident insurance of Rs 5 lakh and OPD and free medical tests in government hospitals etc. Under this scheme, apart from serious diseases like Heart, Cancer, Neuro, Covid and Black fungus, costly treatments like Cochlear Implant, Bone Marrow Transplant, Kidney Transplant, Heart Transplant, Liver Transplant, Knee Transplant and Dialysis are also included. More than 1.2 million people have got the benefit of this scheme in the state, which is worth Rs 1400 crore

# The Semiotic Interprretations of Traffic Policing

In the wake of yesterday's traffic abuzz happening in the Tuibong Traffic point, I would like to highlight some semiotics elements related thereto. The hand gesture efforts (as a sign) of a traffic cop amidst busy commuters under heavy rainfall is gaining much of

The term 'semiotics' apparer appears esoteric to understand which actually is not. I would like to illustrate the concept of semiotics in the light of the reward winning traffic police for having braved the heavy downpour in the line of duty.

Work is Worship
The Manipur's Tuibong resident B.T. Henjoy Vaiphei, a traffic police by profession was in the limelight. He endeared himself to the people of the state and beyond by not derelicting his duty notwithstanding the torrential downpour. He remained undeterred come what may! The responsible traffic cop was rung up from the state Chief Minister Office in less than 24 hours of him being in action going viral on social media. He was accorded a standing ovation in the posh CM office with a incentive of a cash reward, reportedly of Rs. 1,00000/- (One lakh only).

The Concept Semiotics or Semiosis or Semiology is the study of sign processes. The semiotic process explores the study of signs and symbols as a significant part of communications. Ferdinand de Saussure who coined the term defines it "as the science that studies the life of signs in the bosom of society". Generally, there are seven common semiotic systems such as audio, audio sounds, design, facial/hand gestures, linguistic, music and visual. Among them, I would like to bring out particularly hand gestures to our notice vis-à-vis the traf-fic management for a discussion here. A substitute for hand gestures of a traffic police is the traffic lights, where manual efforts of a person is not required. Hand gestures are more com-monly used in hill district headquarters of Manipur unlike advanced traffic light system which is highly in vogue in more developed areas like in the heart of Imphal, the state capital of Manipur.

Using a sign theory developed by Ferdinand de Saussure, we need to have clarity of understanding first on

the two signs: Signified and Signifier
The Signifier, according to Saussure, is the material form of the sign. This is a concrete object that we can see, hear, taste, touch, smell or is related to traffic codes. The traffic codes here signify traffic lights and/ or traffic cops who mainly control traffic at intersections. Another example is, think of a zebra crossing that is used to indicate traffic limit/warning signs. The zebra crossing itself can be described as a signifier. In same vein, traffic lights and the traffic cops (the sound of whistle for that matter) are said to be a signifier as the case

may be. However, a signifier cannot exist in sence of a signified. Therefore, a signified is the abstract idea or concept embedded in a signifier that is being represented. Taken them together constitute the linguistic sign. Generally, one cannot exist in isolation, thus their mutual relationship is called Signification. In a rare case if a signifier is found to be without a signified, then their relationship is said to be noise (in spoken language).

#### Statistics

The World Health Organization proposed the Global Plan for the Decade of Action for Road Safety 2011-2020. The WHO's initiative was aimed at reducing the number of victims in traffic accidents in countries with higher accidents like Mexico, India, China, Brazil, the United States, among others. In its report (2012, released in 2015),

it is shown that leading cause of death in young people in the 15-29 age group is traffic accident compared to other causes of death like suicide, HIV/AIDS, homicide, maternal conditions, lower respiratory infections, diarrhoeal diseases, drowning, ishchaemia heart disease and meningitis.

According to the Secretaria de Salud (2012), in Mexico City, the most accident prone zone turned out to be intersections, because pedestrians and drivers are wont to having more interactions at these points. This causes greater insecurity for the road users, esp. those who walk. One of the reasons for this insecurity is lackadaisical attitude of service providers- Government, if not CSOs or NGOs who work in this effect. Therefore, a keen interest in understanding traffic issues on the roads is being induced from a semiotic approach.

#### Goods & Service Providers

This responsible cop, Mr. Vaiphei reminds us of the science of semiotics in order to study road infrastructure otherwise known as communication development.

The theoretical contributions of

Ferdinand Saussure, et al have a lot to do with infrastructure development in so far as road mobility is concerned. Roads are a public utility where pedes-trians use them for work, walk, study, recreation and other activities of dails living providing a harmonious and safe way for people to move either on foot, by car, bicycle, public or private transport services.

To determine the safe or unsafe mobility of pedestrians on the roads by any medium, the semiotic interpre tations of signifier and the signified comes into picture. The semiotic interpretation based on the traffic personnel or a traffic light system as greenamber-red or red-amber-green light is the most reliable form to determine whether the road is a dangerous place or not for users.

It is high time all and sundry shunned the notion of Dominant Paradigm for development communication to occur which was prominent post-World War II. The emerging alternatives stress on community participation for social change. In a dominant paradigm, participation is almost ab-sent while in State dominated space, it is limited to listening to the State. According to Jurgen Habermas, in the alternative paradigm, a public sphere is created for more access to commun cation tools and voice. Jurgen Habermas is a German philosopher and sociologist in the tradition of critical theory and pragmatism. This new para-digm is likely to be initiated by CSOs and NGOSs, etc. in tandem with State to ensure an all-round participatory development. State should not muzzle responsible citizens in decision making processes, more so in this age of social media like FB, WhatsApp, Twitter, etc. Rendering them unheard of their voices would entail development ramifications, and this is called Voice Poverty. According to Jo Tacchi, voice poverty is "the inability of people to influence the decisions that affect their lives, and the right in that decision making". Tacchi is a development re earcher at Loughborough University, England.

In this way, when a signifier and the signified maintain their mutual relationship and walk the talk, there comes about transactional communication which stands for a consensual dialogue between service providers and the stakeholders or beneficiaries.

Thus, time and again, I pay salute to the traffic cop who deserves a pat on the back for his sincere duty. No less is my heartfelt gratitude as a responsible citizen to the CMO. ### India logs 2,841 fresh Covid cases, Active caseload dips to 18,604

Agency New Delhi, May 13:

With 2,841 new coronavirus infections being reported in a day, India's tally of COVID-19 cases rose to 4.31,16,254, while the active cases dipped to 18,604, according to the Union health ministry data updated on Friday. The death toll climbed to 5,24,190 with nine fatalities. the data updated at 8 am showed.

The active cases comprise 0.04 per cent of the total infections, while the national COVID-19 recovery rate was recorded at 98.74 per cent, the health ministry said. A decrease of 463 cases has been recorded in the active COVID-19

seload in a span of 24 hours. The daily positivity rate was recorded at 0.58 per cent and weekly positivity rate was 0.69 per cent, according to the health ministry. The number of people who have recuperated from the disease surged to 4,25,73,460, while the case fa-tality rate was recorded at 1.22

per cent.
The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has exceeded 190.99 crore. India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50

lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on Sep-tember 28, 70 lakh on October 11, crossed 80 lakh on Octo-ber 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19. India crossed the grim mile-stone of two crore on May 4 and three crore on June 23.

The nine fatalities include eight from Kerala and one from Maharashtra, according to the

India's cumulative vaccine coverage has crossed 190.99 crore doses. Over 3.12 crore first doses and over 1.13 crore

second doses have been administered for the age group of 12 to 14. Over 5.88 crore first doses and more than 4.36 crore second doses have been given to the 15 to 18 age group. Meanwhile, 2,91,27,285 precaution doses (booster shots) have been given to people above 60 years of age, healthcare workers, and frontline workers.

Meanwhile, coronavirus cases across the world are also witnessing an upward trend. North Korea on Thursday recorded its first patient and within a few hours, the country's leader Kim Jong Un announced a lockdown as the country has been enveloped in a health crisis. Six people are also reported to have died due to a fever that has spread "explosively", news agency Reuters reported, citing local media. ### State Govt. frames new transfer and posting policy .....

Government employees connected} with the conduct of elections shall not be transferred without specific consultation with Election Department.

Transfer of Teachers/Lecturers of Schools/Higher Secondary Schools/Colleges and other academic institutions shall normally be affected between the academic sessions i.e. just after the closing sessions so that disruption of teaching/

learning activities is avoided.
All transfer orders will indicate the first-mover and charge shall be handed over by the re lieved officer to the relieving officer after briefing him/her of the nected with the post.

Whenever cadre posts are to be utilised by non-cadre officers/officials, the transfer & posting orders to such posts shall be issued by the controlling authority of the cadre post. Officers/officials who do not belong to the said cadre will be deemed to be on deputation to the Department to which the

cadre post belongs.

Where both the husband and wife are in Government service, they may be posted conveniently at the same station/ District as far as possible, subject to availability of the post and keeping in view the interest of administration as well.

Physically challenged persons may be given convenient posting at their local stations, subject to availability of post.

Officers/officials suffering from identified category of diseases may be given preferred places of posting, to enable the officer/official to function without affecting the responsibilities of the post. (xvi) As far as possible, the State Government may provide for payment of incen tive for serving at difficult postings, provided it is not the Home District of the employee. The period of deputation of

officers/Officials from the Central Government or other State Governments who are appointed to any post/service under this Government on deputation shall normally not exceed 3 (three) years, which may be extended for another 2(two) years in deserving cases, with adequate justification and with specific approval of the Depart-ment of Personnel.

In respect of officers of nontransferable services like the Ministerial cadres in the Secretariat and in the Heads of Departments/Offices, no person shall be retained in a particular post with the same work allocation for more than 3(three) years. This may be relaxed, only in special circumstances, up to a maximum of six years, with specific approval of the Competent Au-

thority in this regard.

Creation of Zones for the purpose of transfers: Districts may be clubbed/organised into Zones for recruitment of Group III & IV posts, within which they will be transferrable. Such Group III & IV officials shall normally not be transferred outside their respective zones. The Zones for this purpose may be notified by the Department of Personnel

All posts sanctioned for specific purposes should be utilized only at the places for which the posts had been created. No transfer of post will be permitted under any circumstances. Only in extreme exigences of public interest, posts can be transferred with the approval of the State Cabinet.
Appointments/postings of

officers/officials to a higher post/non-cadre post on charge basis shall be strictly as per the guidelines issued by the Department of Personnel from time to time.

Power to relax: Notwithstanding anything contained in the policy, the State Government, with the prior approval of the Chief Minister, Manipur, shall be competent to transfer an employee to any place in relaxation of any or all of the above provisions after recording reasons justifying such relaxation. No transfer & posting which is contrary to this Policy shall be made by any Depart ment without the approval of the Chief Minister, Manipur.
