# Horticulture & Soil Conservation officials inspect Peh Village for alternative livelihood arrangements



#### IT News Imphal, May 17:

As part of Chief Minister N. Biren Singh's War on Drugs campaign, several gov-ernment agencies and departments have been cohesively working together to control the drug menace and fully destroy poppy plantations from the State.

The Horticulture & Soil Conservation Department, Government of Manipur along with the Manipur Organic Mission Agency (MOMA) has been majorly involved in the campaign by providing alternative means of livelihood against poppy cultivation to villages from where poppy plantation has been de-

stroyed.
Peh Village in Ukhrul District is one village where the department has initiated implementation of the alternative means of livelihood against poppy plantation. A team of

officials from the Horticulture & Soil Conservation department and MOMA visited the village to inspect the village and for implementation of alternative livelihood in the village

Peh Village Chairman Moon Shimray said considering the ills of poppy plantation on the society, future genera-tions, and youth, the Peh Village Council had destroyed poppy plantations taken up by some local youths in their area some years back.

Contented with the action of the village, Chief Minister of the State, N. Biren Singh had awarded the village with an amount of Rs. 10 lakhs, he said adding that a market shed was also constructed under the Mission for Integrated Devel-

opment of Horticulture. Further lauding the present government under N. Biren Singh, Shimray said that under the guidance of the Chief Minister, apple saplings are also provided to the village and plantation will begin if possible before June. He also thanked MOMA for identifying and providing funds to around 100 beneficiaries (10 groups).

These beneficiaries will begin

Kiwi plantations at the earliest,

he added. With these actions, the Chief Minister has shown that the brotherhood between the hills and the valley is not just in words but also in action, he said commending the Chief

Further stating that the village is fortunate to receive all the attention, he said the villagers are working very hard to ensure success with the alternative means of livelihood provided by the government and further sought further cooperation from the department. The village chairman also thanked the department for their support.

District Officer, Horticulture & Soil Conservation Ukhrul and Kamjong, Yeite Khupsorel Koireng said today officials of the department are in the village to inspect the village for implementation of the alternative means of livelihood against poppy cultivation in the village.

He said that around February last year, leaders and vil-lagers of Peh Village high-lighted to the Chief Minister the presence of poppy planta-tions in their village and the subsequent destruction of the cultivation. Following this, the Chief Minister expressed the desire to take up some alternative plantations as means of livelihood in the area, he added

He explained that the villagers have already started planting vegetables like maize instead of poppy plantations in their area and that they are producing ginger abundantly. He further assured to provide a means to market the ginger at the earliest.

He continued that during an inspection with the village leaders, the official team has found that preparation for longterm plantation of fruit-bearing trees like apple and kiwi has been made by the villagers.

The District Officer also said that the department will launch a scheme in the village with a cost of Rs. 50 lakh and further sought support and cooperation from the village for the successful implementation of the scheme. He further appealed to the village against poppy plantations in the future also and further assured all other assistance including the provision of seasonal seeds and fruit saplings.

# KSO-GHO and ANSAM condemn May 9 incident at New Checkon Tribal colony

Union minister of state for Education and External Affairs, Rajkumar Ranjan will inaugurate the media workshop while Maharaja Leishemba Sanajaoba ,MP will grace the occasion as the functional president.

The workshop will have four technical sessions, the topics are: (1) Imphal Smart City (2) National Education Policy 2020 & its impacts in Manipur (3) Health and Wellness and (4) Plastics: waste to wealth. The techni-cal session will be followed by interaction session with resources persons. More than 40 media persons of the state are expected to participate in the workshop.

The KSO-GHO and ANSAM, the apex students' bodies of Kukis and Nagas expressed serious concern in con-nection with the incident that took place on 9th May, 2022 at Tribal Colony wherein four people were seriously injured. We condemned the inci-

dent in the strongest term for the violation of rights of the tribal people. The residents of Tribal Colony have always conveyed to the government that they are not averse to the idea of development and welcome the government's plan to construct new multistoried buildings to accommodate more tribal employees of the state government. However, they have asked for an alternative arrangement to house the 187 occupants/ employees/residents during the interim period before the new construction and completion of the same", the joint statement

The statement added that following a show cause notice

for eviction served on 24-12-2020, the residents of the colony had filed a PIL vide Writ Appeal No. 11 of 1993 in the High Court and the High Court consequently issued an Interim Order WP(C) No.345 of 2021, dated 29-10-2021 which maintained that the petitioners (residents) should not be disturbed without an alternative arrangement by the government. How-ever, no such alternative arrangement has been made availby the state government till date and instead the state government attempts to bull-doze the residents.

"Such action of the government towards the Tribals is a stark violation of the stated interim order of the High Court. In addition the government has severed the drinking water sup-ply pipelines and electricity connection besides threatening connection besides threatening the local population by indis-criminately firing teargases and rubber bullets inside the occu-pied quarters. The Tribal Colony situated at New Checkon has a deep rooted legacy in the lives of many tribal people of the state

as it has served the welfare of the tribal employees for the last over 60 years", the statement

The colony was established exclusively for residential quarters of Grade IV tribal government servants and employees of Manipur Vide Manipur Ga-zette No: 94 dated 14-12-1960 with Secretariat Revenue No: 141/13/60-M dated 08-12-1960 and since then, the occupants of the aforesaid Quarters have been Tribal Govt. Servants till date. Presently it accommodates about 187 families and 9 churches.

The KSO, GHQ and ANSAM demanded the government to uphold the Interim Order of the High Court WP(C) No.345 of 2021 dated 29-10-2021 and refrain from disturbing the residents unless an alternative arrangement is made for them to relocate. The students' bodies also urged to uphold the Supreme Court Order dated 29-09-2009 and 16-02-2010 by regularization or relocation of the nine religious structures as the case may be.

Monsoon is expected to reach Kerala on May 27, slightly ahead of its scheduled time. Although the state is getting rains daily, even though it's not monsoon rain. When the tempreture goes up, people travel to higher places. If the element of religion is added to the mountains, things get better. Perhaps that's why there is a rush to go for Chardham Yatra. Over 34 pilgrims died on the way. From May 3 to May 16, more than 1.3 million pilgrims have registered for the Yatra. Most of those who died on the way had got Covid infection affecting their lungs. #### June-like temperature in May (Heat Hayoc)

As it is getting hot, it has not happened in the last many years. In May itself the temperature remains like June. This is the situation in most of the states of the country. On Sunday, the temperature crossed forty-nine degrees Celsius at some places in Delhi. It is not that mercury broke this record in Delhi itself. Even in Banda, Uttar Pradesh, the mercury was at forty nine degrees. However, in states ranging from Rajasthan to Punjab, Uttar Pradesh, Bihar, Madhya Pradesh, Telangana, Andhra Pradesh etc., the previous records of temperature have been broken in many cities.

For the last few years, it is also being seen that the hill states like Jammu and Kashmir, Himachal Pradesh and Uttarakhand are also coming under the grip of heat. When the plains are scorching, people turn to these hilly states. Therefore, if the mountainous areas of the Himalayas also start heating, then onetime surprise is bound to happen. It is being told that this time cities like Shimla, Kangra, Dharamshala are very hot. Shimla broke the record of the last eight urs. The temperature in Dharamsala went up to thirty seven degrees. It has been said that the season moves according to its time. There should

be heat in summer and severe cold in winter. But the seasons have changed in the last few decades. The effect of this has been that the cycle and duration of winter, summer and rain are all changing. Earlier, where it used to be very cold for three or four months, now it does not last even a month. Same is the case with summer. In April and May, all summer records were broken. However, the

duration of the heat wave is getting shorter than before.

It is also not that this weather is being hit only in India, most of the countries of the world are in its JD. In the last few years, many European countries have also become victims of severe heat. Heat and heat have wreaked havoc in America too. In fact, no human force can work on the weather. But a big truth that cannot be turned away is that most of the major factors affecting the weather have been created by man himself. Therefore, now we have to find ways to avoid it.

The heat wave for India is a matter of more concern because twelve of the fifteen hottest cities in the world are from India. All these four states belong to Raiasthan, Harvana, Uttar Pradesh and Madhya Pradesh. Not only this, six of the fifteen cities with the highest rainfall in the world are also from India. That is, the situation of India in terms of weather is becoming more sensitive than

Obviously, our meteorological challenges are also increasing. India's condition is already very bad in terms of air pollution. Excessive use of air conditioners and vehicles is a major reason for the rise in temperature. Most of the cities of the country including Delhi start facing water crisis as soon as summer comes. Greenery is necessary to reduce the effect of heat. But the condition of Delhi has become such that there is no space to plant trees here. tains of garbage start blazing every day. Obviously, the heat will increase and we will have to come forward to protect it.

# Cow: Deserve to be a National Animal



Abench of Allahabad High Court has passed an order on 1st September 2021, in which it has said that the cow is an integral part of Indian culture and the Central Government should bring a bill in the Parliament to declare the cow as the national animal of India. Earlier on 31st May 1917, Rajasthan High Court has also recommended the Centre to declare the cow as national animal. Strict law should be enforced against those who harm the cow. The right to life is above the right to kill and the right to eat beef can never be considered

a fundamental right. a fundamental right.

The judgement narrates that according to Rigveda, "Panchgavya" prepared using cow's milk, curd, ghee, urine, and dung helps in treating several incurable diseases and building immunity. "Gavyam Pavitram Cha Rasayanam Cha, Pathyam Cha Hridyam Balbuddhim. Aayuh Pradam Raktvikarhari. Tridosh Hridrogvishapaham Syat" (i.e.

beneficial as diet and for heart. It increases lifespan, strength and intellectual capacity and destroys all the impurities of the blood. It is the destroyer of three Doshas, namely Vata, Pitta and Kapha. It can cure cardiovascular disorders).

From a religious& cultural point of view, the cow has been the centre of attention and worthy of worship in Indian society since time immemorial. People of Sanatan Dharma have been worshiping the cow for centuries. According to Sanatan Vedic culture belief, 33 Koti (categories) of Gods & Goddesses reside in a cow. Lord Krishna got all his knowledge under the cow's feet. He said "Dhanunansmama Kamdhuk" (i.e. I am whatever Kamdenu is).

All four Vedas have highlighted the significance of the cow and termed her as the symbol of creation The Rigveda states that the cow, who is the mother of Rudra, the daughter of Vasus, the sister of Adityas (Agni), the store house of nectar (milk) is Aghanya and should never be killed. One can attain Moksha (salvation) by worshiping and serving her. According to Yajurveda, "Go SamanaNa Vidyate", i.e. the cow is the only one among the living creatures in the world to be useful from beginning to end. As per Samveda, all thing obtained from the cow are sacred. As per Atharvaveda, "Dhenussadanam Rayeenam", i.e.

The Cow was originally born during the Samudra Mantan (chunning of the ocean) and is one of the Navaratnas. She is the repository of eight kinds of wealth. The peasbecome wealthy with Golakshmi.

Cow is the national animal of the nearby country Nepal. In Indonesia, Muslims still maintain not slaughtering cows in respect of their ancestors, who were Hindus. Jesus Christ had said that killing a cow is tantamount to killing a man. Lord Buddha described the cow as the friend of man. The Jains have called the cow as heaven. Bal Gangadhar Tilak said that you can kill me but do not burt the cow Pandit Madan Mohan Malaviya had advocated for total prohibition of cow slaughter. Gandhiji called the cow "a poem of pity" and regarded her a symbol of Indian culture. He said that he does not want Swarajya in Bharat where the cows are being killed.

Although slaughter of cattle and consumption of beef plays a role in several Muslim festivals and culture majority of the Muslim leadership of the country have always been in favour of a nationwide ban on cow slaughter. Khwaja Hasan Nizami in his book "Tark-e-Gao Kushi" has written about not killing the cow. Even Akbar, Humayun, and Babar had appealed not to kill the cow in their Raj. Hyder Ali, the ruler of Mysore, had made cow slaughter a



## **Sedition Law has a long history since 1857** Sepoy Revolt till present

#### Charges Under Section 124A have been framed against 13,000 in last 12 years



An Indian subject who expressed disaffection by conduct or speech, was threatening the Crown by inciting people to rebellion. That was the reason for enacting Section 124A of the Indian Penal Code [IPC] in 1870. The law defined sedition and prescribed punishment for sedition against British rule. The British jailed many freedom fighters, notably Bal Gangadhar Tilak and Mohandas Karamchand Gandhi, for sedition.

We, the People of India, promulgated the Constitution of India on January 26, 1950, creating the sovereign, democratic Republic of In-dia as a Union of States. The Indian State is the sum of India's people with their social, cultural, natural and economic resources, living and working in accordance with the values and tenets of the Constitution, which

is our primary "rule book". The People elect their represen tatives to central and state legislatures. These people's representa-tives form the central and state governments from among themselves, with some of them becoming ministers to run the government and rule the country in the name of the

Thus, in our Republic, the State, the government and the executive elected persons - who are servants of the People, not monarchs - are distinct entities. However, it may appear that many politicians, bu-reaucrats and police personnel in state and central governments are not aware that the State, the government and elected individuals are discrete entities. Criticism of an individual or a government cannot be



interpreted as a threat to the sovereignty, integrity or security of the

In 1958, the Allahabad High Court and the Punjab High Court declared Section 124A void and struck it down. However, in Kedai Nath Singh v. State of Bihar (1962), the Supreme Court upheld Section 124A, but read it down, to make sedition applicable only if there is vio-lence or incitement to violence.

Today, Section 124A remains in force. Successive parliaments and central governments have failed to repeal the law, and elected govern-ments retain the powers of the erstwhile British Crown. Over the decades, central and state govern-ments have (mis)used Section 124A to suppress and punish dissent and freedom of speech and expression, not unlike the British.

FIRs based on Section 124A, have been filed, accusing people of demonstrating peacefully, or dis-senting with government policies, etc., or making "derogatory" comments about ministers by words or cartoons, and even against persons who were yet to make a statement/ joke or make a report. None of these can reasonably be interpreted as incitement to violence, but govern-ments view these as seditious

ments view these as sectitous threats to governments or the State. Reportedly, sedition charges were filed against 13,000 people be-tween 2010 and 2021, and most of them languish in jail, for nothing more than exercising their freedom of speech and expression. According to MHA data, in 2019 alone 93 sedition cases were registered, and analysis of NCRB data shows that from 2016 to 2019, sedition cases increased by 160% while the rate of conviction fell from 33 3% to 3 3%

During the peaceful demonstra tions at the Koodankulam (Tamil Nadu) nuclear power plant, on September 10, 2012, movement leaders and others were charged with sedition and "waging war against the country" – 8,956 people were charged in 21 cases of sedition. Of 380 FIRs lodged, 240 were withdrawn in October 2014 following a Supreme Court order. Such largescale charges of sedition were politically motivated, to crush the pro-

There is more similar data, but little difficulty in understanding that these indicate selective, ill-motivated, deliberate misuse of Section 124A, for political or personal pur-

There are nine petitions challenging the Sedition law, clubbed together for the consideration of the Supreme Court, with the Union of India (UoI) as Respondent. Until May 7, 2022, during hearings, UoI was arguing in defence of the law. However, on May 9, UoI altered its

UoI's affidavit filed in Court stated that although "there are [sic] divergence of views expressed in the public domain", the need for the law was "generally accepted by everyone in legitimate state interest" [of] "dealing with serious offences ... affecting the [country's] very sov-

ereignty and integrity".

UoI's affidavit also stated that "Hon'ble Prime Minister of India has ... expressed his clear and unequivo-cal views in favour of protecting civil liberties" ... and "we need to ... shed colonial baggage [the Sedition law]". Accordingly, the government "has decided to re-examine and re-consider" the law "before the Competent Forum", and the "Court may not invest time in examining the validity of Sec.124A once again ... and await the exercise of reconsideration before an appropriate forum"

However, on May 9, UoI altered its stance.

In its interim order, the Court observed that UoI agreed that "the rigors [sic] of Sec.124A ... is not in tune with the current social milieu, and was intended for a time when this country was under the colonial regime". Further, the bench expected that "till the re-examination of the provision is complete, it will be ap-propriate not to continue usage of the aforesaid provision of law by the Governments".

The Court's interim order of May 11, 2022, concludes that the interim stay granted on May 31 last year in two petitions will continue; the bench hopes and expects that State and Central Governments would refrain from registering fresh FIRs, continuing investigations or taking coercive measures under Section 124A; Courts will take the present order into account while examining reliefs sought by affected parties in fresh cases; all pending trials, appeals and pro-ceedings concerning Section 124A be "kept in abeyance"; and UoI may issue directives to State Governments/Union Territories to pre vent misuse of Section 124A, All these apply until further orders are

# 6 Dead, 2 missing as heavy rains trigger landslides; 35 stranded in Haflong Railway Station

Agency Guwahati, May 17:

Six people have died due to floods and five were killed in a landslide triggered by heavy rains in Assam, accord-ing to the latest bulletin by the state government. Of the total deaths caused due to landslides, four were from Dima Hasao and one death was re-ported in Lakhimpur. Two people are also reported missing, officials said.

The evacuation of about 2,800 passengers of two trains, which were stranded in the Lumding-Badarpur hill section in Assam for two days due to massive landslides and waterlogging on the tracks caused by incessant rains, was completed on Monday with help by the Air Force and other agencies, a Northeast Frontier Railway (NFR) spokesperson said. Many passengers were airlifted by the Air Force as incessant rain impeded rescue operations which were on since Saturday. when the two trains were stranded in Lumding section of NFR in Dima Hasao district, he

An official bulletin had earlier said three persons have been killed in the mudslide in Haflong revenue circle and



the floods. According to the latest bulletin. Assam received 545.66 mm of rainfall since May 6. Incessant rains have triggered floods in 14 districts: Biswanath Bongaigaon, Cachar, Dhemaji, Dhubri, Dibrugarh, Hohai, Karbi Aanglong, Kokrajhar, Lakhimpur, Nagaon, Nalbari, Jorhat and Kamrup Metro. Dis-tricts affected by landslides include Dima Hasao, Hailakandi

and Karimganj. The bulletin said 4,330 of the affected people have been lodged in 22 relief camps set up by the government. Fifteen relief distribution centres are op-erating in different affected dis-

A total 12,145 hectares of

crop land have been inundated in the current spate of floods, it said. The NFR spokesman said in Guwahati that about 18 trains in the section have been cancelled in the affected area since Saturday and more than 10 others have been short terminated as work for restoration of the damaged railway tracks are on in full swing despite the incessant rain, he said.

A report from Haflong, headquarter of Dima Hasao district, said most part of the New Halflong Railway Station is under water and an empty train stranded there has de-railed as the track loosened with the soil underneath was washed off by rain waters.

Road links to the district have also snapped due to the incessant rains and the landslides in multiple locations. While an IAF helicopter have successfully evacuated many, more than 35 passengers are still stranded in the station. National Highways and five

state highways are affected and cut off from the rest of the state due to heavy rainfall. The re-gion is also suffering from no electricity and mobile connec-

# With 1,569 new cases, India's daily Covid tally below 2,000 after nearly a month

Agency New Delhi, May 17:

India witnessed a significant dip in its new Covid-19 cases, as the country logged 1,569 fresh infections in the last 24 hours, pushing the overall caseload to 43,125,370, the Union health ministry's dashboard showed on Tuesday. In the previous 24-hour period, as many as 2,202 people tested positive, 29 per cent higher than the latest numbers.

There were 19 new fatalities as well, taking the related death toll to 524,260, the data showed. The nation also added 2,467 recoveries, with which the total number of such cases rose to 42,584,710. The number of active patients, on the other hand, declined further to 16,400-a reduction of 917 from the previous bulletin.

Recoveries, deaths and active cases account for 98.75 per cent, 1.22 per cent and 0.04 per cent, respectively, in

the cumulative tally. Also, with 357,484 samples tested for Covid-19, the daily positivity rate was recorded at 0.44 per cent, while the number of samples tested tested till now was at more than 844 million. The weekly positivity rate, meanwhile, came at 0.59 per cent.

"Across the Line of Actual Control (LAC) in the Tibet region, a lot of infrastructure upgradation is going on. The other side is continuously developing their road, rail and air connectivity as well as 5G mobile network to improve their position to respond to a situation or mobilise forces," Kalita said. He said the Chinese au-

thorities have built border villages close to the LAC and there are possibilities these can be used for dual purposes

"The border villages can

be used for civilians as well as to mobilise troops to the forward areas," said the Eastern Command GoC-in C.

He said that the border in the eastern frontier has varied challenges.

'The Indian Army has displayed exemplary profes-sionalism and bravery. It was extremely eventful during the past one year and we have dealt with all the challenges," Kalita added.

#### **Biological E slashes price for vaccine** from Rs 990 to Rs 400 per dose

Agency New Delhi, May 17:

After Covaxin and Covishield, the Hyderabadbased vaccine manufacturer Biological E dropped the prices of its Covid-19 vaccine to Rs 250 per dose (including GST). After accounting for Rs 150 to be charged by the health centres for their services, the end users will pay Rs 400 per dose of Corbevax, the company said. The mar-ket price (including GST and hospital charges) stood at 990

pper dose.
"BE has lowered the price of its vaccine with the aim of making it more affordable and help increase the reach to protect maximum number of children against the virus. The decision comes within weeks of Biological E. Limited re-



rization (EUA) for children be-tween 5 and 12 years of age," the company said in a statement.

This is the cost to people when administered at private centres. The vaccine is still available free of cost at gov-

ernment centres through the Centre's vaccination programme. It is currently being used for children between the ages of 12 and 14 years.

So far 43 9 million doses of Corbevax have been administered to children across the country, with the company already having supplied 100 mil-lion doses to the Centre.

In April, both Covishield manufactured by Serum Insti-tute of India, and Bharat Biotech's Covaxin were made available for Rs 225 per dose, down from Rs 600 and Rs 1 200 respectively, with private vaccination centres allowed to charge up to Rs 150 per dose as service charge over and above the cost of the vaccine

Biological E will also offer single dose vials, which are more convenient for smaller centres offering only a small number of shots daily. It reduces vaccine wastage

The vaccine was available in a 20-dose vial; once opened the vaccine could be used only within a few hours. Covishield is available in 10 dose vials and Covaxin in 20 dose vials.

on Monday. Nikhat handed India first medal by clinching a dominatmedal by clinching a dominat-ing 5-0 win against England's Charley-Sian Taylor Davison while Manisha got the better of Mongolia's Namuun Monkhor in the hard-fought 57kg quarter-final by a 4-1 mar-

gin.
The 25-year-old boxer from Telangana once again showed her technical supremacy to hand the country its first medal at this year's tournament with an impressive victory in the 52kg quarter-final. Nikhat's aggressive intent and clean attack left no chance for Davison as the Indian looked in complete control through-

out the bout.

Nikhat will now take on Caroline De Almeida of Brazil in the semi-finals. De Almeida thrashed the 2018 Common-

wealth Games silver Ireland's Carly McNaul of Ireland by unanimous decision.

Later Parveen also made her way into the 63kg semi-finals by thrashing Shoira Zulkaynarova of Tajikistan 5-0 and added third medal to India's tally. Parveen will be up against Ireland's Amy Broadhurst in the semi-final.

However, it was heartbreak for the country's four pugilists-Nitu (48kg), Pooia Rani (81kg), Anamika (50kg) and Jaismine (60kg), who suffered defeats in their respective Last-8 bouts.

Two-time Asian champion Pooja suffered a close 2-3 de-feat against Australia's Jessica too fell short of securing medals on her debut appearance at the World Championships after enduring 2-3 and 0-5 losses respectively against the reign-ing Asian Champion Alua Balkibekova of Kazakhstan and Rio Olympic bronze medallist Ingrit Valencia Of Colombia.

Jaismine too went down fighting against the former World Championships bronze medallist Rashida Ellis of USA

Later tonight, another Indian boxer Nandini will look to secure a medal at the presti-gious event, which has been witnessing exciting action in the presence of 310 boxers from 73 countries from across

the world. Semi-final matches will take place on Wednesday while the finals will be played on Thursday and Friday.

In the last edition of the urnament, held in Russia in 2019. Indian boxers clinched one silver and three bronze medals. India have won 36 medals, including nine gold, eight silver and 19 bronze, in the 11 editions of the tournament so far—third highest af-ter Russia (60) and China (50).
