### Agency Guwahati, Oct 3:

Fairly widespread to widespread light or moderate rain-fall with isolated heavy downpours have been forecast for Assam, Meghalaya, Nagaland, Manipur, Mizoram, and Tripura on October 3 and 4, according to the Indian Meteorological Department (IMD).

The city experienced mod-erate to heavy showers in isolated places early Monday morning, bringing the temperature down to 28 degrees Celsius during the day. There is a 97 per cent chance of heavy rainfall accompanied by thunderstorms and lightning in parts of the city. The evening is expected to cool a degree further with the night temperature expected to dip to 25 degrees.

# Action sought against organisers of Durga Puja that had Asura looking like Gandhi

### Agency Kolkata, Oct 3:

Outraged over the installa-tion of a Mahishasur idol that resembled Mahatma Gandhi at a pandal in southwest Kolkata, people on social media sought immediate arrest of Hindu Mahasabha leaders who

organised the Durga puja. Organisers Akhil Bharatiya Hindu Mahasabha, however, claimed that it was a "coinci-dence" that the Mahishasur idol, which had a bald head and was dressed in a white dhoti and round glasses, bore resem blance to Gandhi, but social media was not convinced.

"Immediately arrest the of-ficials of Hindu Mahasabha for depicting Mahatma Gandhi as asura in a Durga Puja at Kolkata," tweeted one Atanu Chakravarty, tagging Chief Minister Mamata Banerjee.

As the photos of the Durga Puja pandal went viral on social media, the Kolkata Police told the Mahasabha to change the look of the idol and also asked journalist Indradeep Bhattacharyya, who shared it on Twitter, to delete the photograph as it "may create tension" amid the festival. "The Hindu Mahasabha

# Let's take stringent steps to curb Smoking



Everyone is aware that "Smoking" has been criticized as the most letha weapon of self murder. According to the Tobacco Products Act, 2004, direct and indirect advertising of all tobacco products and its sale to minors is banned. Addiction to nicotine makes it hard to quit. The increasing incidence of heart attack in India, fast spreading among younger generation has been largely on account of smoking habits. The problem of Smoking in India is widespread but no studies have been done to estimate what percentage of

the population are smokers. Roadside paan shops bountifully stocked with cigarettes feed smokers continuing to exhale smoke from cigarettes. It is a fact that smoking is a hard habit to break because tobacco contains nicotine, which is highly addictive. Smoking harms not just the smoker, but also family members, coworkers, and others who breathe the smoker's cigarette smoke, called secondhand smoke or passive smoke. In fact, statistics tell us that approximately 70 out of 100 people who smoke want to stop but go on puffing, day in and day out, seemingly powerless to quit. Research has shown that non-smokers who reside with a smoker have a 24% increase in risk for developing lung cancer when compared with other nonsmokers

Owners of sales outlets must display boards with the warnings like "tobacco causes cancer", "tobacco kills" & "sale to minors is a punishable offence". Some-times it happens that notification prohibiting selling tobacco products to minors has no effect as the teenagers continue to buy tobacco/cigarettes on the pretext that they are buying it on behalf of their elders. Smoking also provides other side benefits which are real. Let us remember that staying smoke free helps more of everything—more energy, better performance, better looks, more money in your pocket, and, in the long run, more life to live. In India there is little campaigning save the statutory warnings printed in

small print on cigarette cartons and advertisements. Graphic health warnings using a mixture of pictures and words are part and parcel of every country' policy on cigarette marketing. The 40 per cent warning on one side proved ineffective as vendors displayed the packaging on the other side, so that con-sumers would not see the warnings. Cigarette manufacturers share the kitty with vested interest, hence their interest is well protected with simple modifications to fool the general public. It is agreed that the bigger warning can create an impact when a smoker buys a cigarette pack. But how do we resolve the issue when smokers buy one or two cigarettes and the packet is being opened by the shop owner who sells cigarettes for business. It is the youth who are the most vulner able group as far as the consumption of tobacco is concerned. Most of them begin smoking as a fad and even as a rite of passage. According to The Cigarette Package Health Warnings: International Status Report 2014 India has slipped to 136th position in the list of 198 countries that warn smokers about the hazards of smoking through graphic pictures on cigarette packages.

Can't we implement the ban on the companies manufacturing these tobacco products of intoxication. One would find (particularly smokers) like all laws in India, nothing will be implemented. Indians just do not have the psyche to obey laws. They believe that rules are meant to be broken. Smokers are unmindful of the consequences of passive smoking. Over time, the habit of smoking weaves its way through all of the activities in our lives, and we come to think we can't be happy or productive without cigarettes.

Various provisions that we implement time and again clearly states that People can smoke on roads or in their homes but not in any other place. More deaths are caused each year by tobacco use than by all deaths from AIDS, illegal drug use. alcohol use, motor vehicle injuries, suicides, and murders combined. It smells something else totally against enforcing the rule strongly across the

country as law enacted smoking is banned only for outside programada. Here, the Govt, is happy that it has a law, police is happy that it can earn more money, the eigarette companies are happy that they don't have to bother, the finance ministry is happy as there is no affect on taxes and the health minister is happy that he could do atleast one thing in his tenure - so what matters if it is not implemented.

It is reported that a cigarette smoker shortens his life by about 5.5 minutes for each cigarette smoked, almost the time he spends for smoking it. The increasing incidence of heart attack in India, fast spreading among younger generation has been largely on account of smoking habits. Nearly 30 million people in the country are estimated to be victims of heart diseases. No doubt, the Government has come out with good points to deal with the matter but at the same time taxes on tobacco products should go up to help smokers give up. Such methods will be long lasting.

Under such circumstances, it clearly shows that the anti- smoking Act will go up in smoke. But I feel that People must wake up to the danger of smoke to themselves and passive smokers before it is too late.

# **Digital University is the Future**

Digital university will play an important role in this. We can be-come Vishwa Guru by digitizing education. Students who cannot reach the city and university will have an increased access to skills and knowledge. We are hoping that these students will be able to become a strong wheel of our economic development vehicle in the future. We are talking about digital education. Even before this, distance education centers and many other. There is a system of e-courses. But, their role was seen only to confer degrees. Somewhere the digital university should not become a platform only for awarding degrees and through this we could not fulfill the objective of skill development. This is an important question. We will give priority to skill based courses in Digital University.

If someone is currently pursuing his graduation in economics and wants to take admission in any science subject then Digital University will give him a chance. The main goal of Digital University is to develop the skills of the youth. You are saying that the degree of distance education centers is not effective then what will happen to digital. There is a lot of difference between these two. Send instructional materials to the Open University by post or via PDF. Digital University will provide complete course material online so that students will be able to connect directly. Artificial intelligence will play an important role in this. Its examination system will also be dif-ferent, which will be able to assess

the students properly. In some cities, we will open computer centers where students can go for exams. Will be able I hope that when we open a digital university, you will also be its student as a media person. Media will always be equipped with new technology, so you will also have to be updated accordingly. It will not only involve young students but also working professionals. With the rapid progress of technology, people have to keep on learning. Only a digital university can give us a chance to remain a lifelong student. You talked about higher education at low fees.

Despite being a welfare state, India has a high Education is not cheap. Higher education is expensive in many states. There is a flood of private universities in many states whose fee structure is not controlled by anyone. Will there be a regulatory mechanism for this? Regulatory machinery like AICTE has clearly stated what the fee structure should be. There is also a Fee Monitoring Committee in all the states. Now a third are private universities, but the fees of most of them are controlled. But, those who have money, who can go to study by paying fees, why stop them from

going to private university go? It is also part of democracy that we can go to the institution of our choice. We keep talking to vicechancellors of private universities.

There are many universities which help the students of weaker section as a social responsibility. We conducted CUET so students accepted it happily. He was happy that there were questions in the exam which were easy to attempt We wish that the entrance exam should not become a burden for the students. I have always thought about board exam marks in terms of admission. He has supported a sys-tem like CUET. There are many types of boards in our country and everyone has different level. The combined examination will protect the interests of seventy percent students of the country. Out of four crore students, BA, BSc, BCom do nore. Five percent do engineering We got the idea that we should conduct a test and let go of whoever wants to go to the field. There will be an advantage that we can bring it twice a year. Those who did not do well once can take the exam a second time our education. There is a lot of diversity in the system.

In consultation with universities and other institutions, we will prepare the structure of one nation, one examination. There is a slowdown in the recruitment of vacan cies in central universities. How will it be fixed? M Jagadesh Kumar: Last week I held a meeting with the Vice Chancellors of Central Universities and gave instructions regarding the recruitment of all kinds of vacancies. One problem with the recruitment of non-academic posts is that every university has a different system. Will work on this very fast in the next few months, It is a policy work to fill the posts of the Faculties of Education. It is not that we are hiring computer operators that if we want four hundred, it is done immediately. When recruiting intellectuals the selection committee has to evaluate very carefully.

How capable an applicant is of the faculty, how far the university can take it, it all remains to be seen. If three hundred posts are adver-tised then hardly 150 are filled. After that the posts are advertised again. With recruitment, ten to fifteen percent also retire. University The main function of the Grants Commission is to manage the grant and educational system. Now there is a provision of 'Higher Education Funding Agency' in the new education policy which will work towards making the institutions autonomous. Then what will be the role of UGC? Have you been appointed at a time when you will be its last president? M Jagadesh Kumar: Let me elaborate on this point in your question. Under the NEP, it will have four components by bringing together all the regulators. One would have a regula-tory mechanism and the other

would have recognition. in the third only funding will work. In the fourth, we will work on

the quality improvement of the educational system. As of now, usually an agricultural university does not collude with other universities. Or IIT does not interact with the common university. Today, to solve the problems of the country, one has to come out of these bounded walls. If someone ants to introduce a new course, then he has to go to different universities and get permission. Along with the delay, one also has to deal with the bassles of bureaucracy. We come to the level of a holistic thinking working for 'Higher Education Commission of India'. Its draft bill is being prepared After the debate in the Parliament, Standing Committee, I am hopeful that it will come into shape.

Questions are being raised regarding grants in government universities. Four hundred percent fee has been increased in Allahabad University. There are also students from weaker section. Now it is be-ing said that loan should not be given by giving grant. How long will government universities sur-vive like this? How will university campuses become a part of the country's development? UGC's work is only grant do not give. Its main objective is to maintain the quality standard of higher education in the university. I agree with your concern. Now we have HEFA. To build infrastructure in the university, you can take a loan at low interest. You can easily repay this loan further. This allows you to fine-tune the structure of your research. After doing this in JNU, the project funding increased by four times

The university should think of generating internal resources. Give you degree online. Resources there are many different programs you can do to raise money. Indian Institutes of Management are do-ing this. One should not always depend on the government. If you increase your scope, you will also be able to raise resources yourself. Talking about JNU itself, the Vice Chancellor is a political choice. Your tenure in JNU was also full of commotion. What do you have to say on Politics Vs University Cam-

Selected purely academic from a purely academic point of view JNU is the pride of the country. If there is a question on JNU and politics, we are always there to ask questions to the students. Encourage you to always ask questions to your authority. Argue un-til you are satisfied with an argument. Our aim should be to develop reasoning power. Ideological clashes abound among the diversity of ideas. Now if this ideological activity is given the name of politics, then it is a different matter.

### **Beyond ODF – making way towards a 'Sampoorna Swachh Bharat'** By: Gajendra Singh Shekhawat

Swachh Bharat Mission (SBM) became more than just a government program, it became a people movement following our Hon'ble Prime Minister's clarion call for an Open Defecation Free (ODF) India from ramparts of Red Fort, on 2nd October 2014. The results are there for the world to see. 110 million toilets were built and 550 million of our rural population provided access to household sanitation facilities making India achieve ODF status and other sig nificant social impacts, on 2nd Oct 2019. The Hon'ble Prime Minister was presented the Bill and Melinda Gate Foundation's Global Goal Keepers Award2019, for the significantly improved health outcomes and subse

quent economic gains. A healthy nation is an empowered one. Under the dynamic and visionary leadership of Prime Minister Shri Narendra Modi, SBM has made a significant contribution in placing India as the fifth leading economy in the world. An independent study by UNICEF reported that on an average house hold living in ODF villages, ac-crued cumulative benefits of Rs.50,000 per year, and households with a new toilet saw a one-time increase in property value by Rs. 19,000. On average, the total benefits of new household toilets were found to exceed costs bv4.7 times.

As we gear up to celebrate Swachh Bharat Diwas2022 on the birth anniversary of Mahatma Gandhi - 2nd October, SBM is well over two years in its phase II and moving forward from achievement of ODF to now striving for ODF plus. Let us understand that better – 'ODF plus', the key objective of phase II of the SBM-G, comprises elements beyond construction and use of toilets and towards holistic universal sanitation delineating the sustained usage of toilets, eco-friendly and economically viable management of solid and liquid waste, including bio-degrad-able and non-bio-degradable waste generated from our homes and communities and subsequent visually clean surroundings. This is in line with the Gandhian principles of 'Sampoorna swachhata' and also sup-

ports our aim to generate livelihoods as part of phase II of the cleanliness mission, through the dedicated and specific technological interventions for Solid & Liquid Waste Management (SLWM).

In thousands of villages across India, solid waste is now being managed through waste segregation into wet and dry waste at the household level and through its door-to-door collection. Panchavats and women Self Help Groups (SHGs) have been and are being trained to manage the wet waste through composting and where possible producing biogas, subsequently becoming modes of income generation. Plastic waste from households and institutions is being managed through collection and segrega-tion centres set up across villages with

arrangements for forward linkages Plastic waste is shredded and converted into suitable forms allowing for further usage in activities like road construction and use in cement fac-tories, generating livelihoods in the process. For example, the sale of manure and dry waste collected in the Gram Panchayat of Vandse in Karnataka fetches around 88,000 per month. Similarly, aided by its 100 KLD water treatment system, the treated vastewater used for Pisciculture in the Gram Panchavat of Kurak Jagir in Haryana has raised about Rs 1 Lakh annually from Fish farming. These are just two examples among several similar stories reported daily from across rural India.

Also creating more such avenues is the GOBARDHAN scheme. Our vil-

lages face a challenge in managing ani mal and other bio-waste including kitchen leftovers, crop residue and market waste.Hon. Prime Minister Modi ji gave the idea of making 'kachhre se kanchan' (waste to wealth), hence Gobardhan, wherein, as many as 333 Gobardhan plants across 125 districts are not only providing clean fuel for cooking and/or lighting up numerous households, but also jobs and income source to many. This is truly a 'waste to wealth' sys-tem which supports bio-degradable waste recovery and conversion of waste into resources, reducing GHG emissions, and reducing our dependence on the import of crude oil. boosting entrepreneurship, and promoting organic farming. contd. on page 3

# Sixteen Indian Fishermen Land in Pakistani Jail

India records 3,011 new Covid-19 cases, 28 deaths

Sixteen Indian fishermen have been taken into custody and their two boats have been impounded by the Pakistan Maritime Security Agency (PMSA) for allegedly straying into Pakistani waters. "On September 27, Pakistan

Maritime Security Agency (PMSA), apprehended 02 Indian fishing boats along with 16 crew members. The appre-hensions were made by a PMSA ship during routine sur-veillance in maritime zones of Pakistan, the PMSA stated in a tweet on Sept 30. "The boats were appre-

hended for violation of Paki-stani Law and UN Convention of Law at Sea. After an initial investigation, the boats were towed to Karachi and the apprehended fishermen were handed over to Docks Police for further legal formalities" the PMSA's another tweet read. However, the boat owner Mulji Khorawa residing at Mangrol, Junagadh district (Gujarat) claimed that the boats-"Pusti Krupa" and "Matsyagandha" carrying 09 and 07 fishermen respectively, were within Indian territory and they were de-

tained illegally. Out of 07 fishermen, 06 hail from Aswali Village of Dahanu in Palghar district (near Mumbai) in Maharashtra. Their names were given as Navsya Mahada Bhimra, Sarit Umarsada, Vijay Nagvasi, Jairam Thakar, Umji Padvi, and Vinod Koli. The seventh fisherman Krishna Raman Bhujad is from outside Maharashtra. Similarly, the 09 fishermen on the boat "Pusti Krupa" are re-portedly from Gujarat.

Communist Party of India (Marxist) (CPM) MLA from

Dahanu Vinod Nikole in a letter, has urged Maharashtra Chief Minister Eknath Shinde to take up the matter with Union Government and seek immedi-ate release of the Indian fishermen since this is for the first time the fishermen in large number have been arrested by the

Pakistani authorities. "They have certainly not strayed with intention of poaching. The poor fishermen do not operate well-equipped sophisticated boats and there could be an error of judgment while navigating. The fisher-men from the Pakistani side also enter the Indian waters. As such there should be an agree-ment between both the countries to deport each other's fish-ermen", Nikole said in his letter dated October first.

"If the maritime authorities notice that the fishing trawlers are entering each other's exclu-sive economic zone, then the authorities from both sides (PMSA and Indian Coast Guard), could forewarn them and ask them to return to their respective country instead of taking a penal action", Nikole said.

The MLA has further stated that now these fishermen will have to languish in a Pakistani jail for 1 to 1/2 years. As such the Union External Affairs Ministry should immediately get in touch with the Indian Embassy in Pakistan and in turn the Em-bassy should hear the version of the arrested fishermen to resolve the dispute. The CPM demands immediate Government intervention of the authorities in the matter, Nikole added.

Nikole also pointed out that last year the fisherman Sridhar Chamre from Palghar died in the unjustified firing by the PMSA on an Indian boat. Unfortunately, the victim's family is yet to get any compensation.

### Agency New Delhi. Oct 3:

By-elections for seven assembly constituencies in six states will be held on November 3, followed by counting of votes three days later, the Elec-tion Commission of India (ECI) said on Monday, announcing the schedule.

Of the seats for which bypolls will be held, two are in Bihar (Mokama, Gopalganj),

and one each in Maharashtra (Andheri East), Haryana (Adampur), Telangana (Munugode), Uttar Pradesh (Gola Gokrannath), and Odisha

(Dhamnagar). The exercise was necessitated due to vacancy on each seat. Anant Kumar Singh of the Rashtriva Janata Dal (RJD), the-then MLA from Mokama, was disqualified in July after his conviction in a case, while BJP's Subhash

Singh, who held the Gopalganj seat, passed away in August. The Andheri East, Gola

Gokrannath and Dhamnagar constituencies, too, fell vacant due to the demise of their respective legislators: the Shiv Sena's Ramesh Latke (in May) and BJP's Arvind Giri and Bishnu Sethi (both in September). In Haryana, resignation by Kuldeep Bishnoi, and by K Rajagopal Reddy in

Telangana, led to vacancy on the Adampur and Munugode

**Enroute China Seeks Landing in Delhi** Agency New Delhi, Oct 3: A bomb threat was reported

Responding to the call by Mahan Air, Delhi ATC suggested the aircraft make an emergency landing in Jaipur, but the aircraft pilot reportedly refused to divert the plane and left the Indian airspace, according to ATC sources. The plane was also reportedly given another option to land at Chandigarh as well.
