#### **Revenue Deficit Grant (RDG)** of Rs. 7,183.42 crore released to 14 States

New Delhi, Oct 6:

The Department of Expenditure, Ministry of Finance has on Thursday released the 7th monthly instalment of Post Devolution Revenue Deficit (PDRD) Grant of Rs.7,183.42 crore to 14 States. The grant has been released as per the recommendations of the Fifteenth Finance Commission.
The Fifteenth Finance

Commission has recommended a total Post Devolution Revenue Deficit Grant of Rs. 86,201 crore to 14 States for the financial year 2022-23. The recommended grant is released by the Department of Expenditure to the recommended States in 12 equated monthly instalments. With the release of 7th instalment for the month of October, 2022, the total amount of Revenue Deficit Grants released to the States in 2022-23 has gone up to Rs. 50,282,92 crore.

The Post Devolution Revenue Deficit Grants are provided to the States under Article 275 of the Constitution. The grants are released to the States as per the recom-mendations of the successive

## 22 children among 34 killed in attack at Daycare

Agency Bangkok, Oct 6:

Thirty-four people were killed in Thailand on Thursday in a gun and knife attack at a daycare centre by a former policeman who killed his wife and child before turning his weapon on himself, police

There were 22 children among the victims of the suspected attacker, who had been discharged from the service last year for drug-related rea-sons, district police official Chakkraphat Wichitvaidya told media.

He cited witnesses as saying the gunman was also seen

wielding a knife.
About 30 children were at the centre when the gunman arrived, fewer than usual, as heavy rain had kept many people away, district official Jidapa Boonsom, who was working in a nearby office at the time, told Reuters.

'The shooter came in around lunch time and shot four or five officials at the childcare centre first," said Jidapa, adding that among them was a teacher who was

eight months pregnant.

"At first people thought it was fireworks," she said.

The gunman then forced his way into a locked room where children were sleeping. Jidapa said, to kill children there with a knife.

Videos posted on social media showed sheets covering what appeared to be the bodies of children lying in pools of blood at the centre in the town of Uthai Sawan, 500 km (310 miles) northeast of Bangkok in the province of Nong Bua Lamphu.

#### Rise in female feticide in India

pregnant women have been illegal in India for years. Sex determina tion tests, and preference for sons result in the selective termination of pregnancy. The widespread use of illegal tests to determine the sex of an unborn child is fuelling a rise in female foeticide cases in India. India banned sex determination tests in 1994, as the gender balance became increasingly skewed. Indian laws do not, under any circumstance, allow sex deter-

mination tests to be undertaken with the intent to terminate the life of a fetus developing in the mother's womb, unless there are other absolute indications for termination of the pregnancy as specified in the MTP

Act of 1971.
The Medical Termination of Pregnancy Act, 1971 (MTP)[1] Act, which prohibits abortion, was enacted with a view towards containing the size of the family. However, in some cases the desire for a small family may have outweighed the desire for a child of a specific gender, leading to abortions where the sex of the fetus was different from that desired by the family. In India, where aborted female foetuses have contributed to a nationwide gender imbalance, it's illegal for doctors to reveal the sex of an unborn child. But with boys still often far more valued than girls, a lucrative business thrives underground. Though, sex determination tests through techniques such as ultrasonography and amniocentesis are banned in India, female foetuses are still com-

monly killed in some regions where a preference for sons runs deep.

Under the Indian Penal Code, causing an abortion, even if caused by the pregnant woman herself, is a criminal offense, unless it is done to save the life of the woman. The offense is punishable by imprisonment for a period of three years, by fine, or by both. The PNDT Act mandates that all ultrasound facilities must be registered and medical practitioners must maintain records of every scan of a pregnant women. It states that pre-natal diagnostic techniques can be used only to detect "ge abnormalities or metabolic disorders or chromosomal abnormalities or certain congenital malformations or sex-linked disorders".

There were concerns that ultrasound technologies were being used to determine the sex of the unborn child and abort the female foetus, so the 1994 law made it illegal for medical practitioners to reveal the sex of a foetus. It is clear that sex determination and female foeticide continue because of insufficient monitoring of medical practitioners. It is observed that most parents celebrate the birth of a son, considered to be their family pride. The birth of a daughter can be a time of embarrassment and even mourning as parents, especially the poor, look toward the immense debts they'll need to take on to pay for marriage dowries. The focus on foeticide has been conveniently forgotten. Nothing is

done to check illegal foeticide & hence in ground reality, the one who is involved in foeticide & sex determination moves scot free. According to experts, the problem isn't with the Act but with its implementation. There is poor monitoring of ultrasound clinics. Such clinics are required to maintain records of the scans they conduct but the violators are often let off with a fine. On going through sex ratio at birth – the number of girls born per 1,000 boys – in India fell from 945 in 1991, to 927 in 2001, to 914 in 2011, according to census data. Government had failed in

to 914 in 2011, according to census data. Government had failed in enforcing the law with a huge lobby working in favour of sex selection. In order to minimize the possibility of foeticide and infanticide, it is now the need of the hour to bring a change in the PNDT Act by making it compulsory for all pregnant women to undergo a scan at government least the form. hospitals for sex determination of foetus.

#### Politics on freebies in Indian economy need a fresh look

#### Narendra Modi's 'Reveri Culture' rhetoric is purely political

While targeting political par-ties in opposition, the Prime Minister of India Narendra Modi had equated 'subsidies and freebies as 'reveri culture' which he wanted to be stopped. His lan-guages was politically surcharged in such a manner that game im-pression to the public that only political parties in opposition are indulging is such a culture and destroying the state finances, and BJP is not doing the same. How-ever, the fact is, BJP ruled Uttar Pradesh is among the top five states in the country with largest rise in subsidies over the last three years. State like Gujarat also spends over 10 per cent of its revenue expenditure on subsidies.

Thus, PM Modi's 'reveri culture' rhetoric is purely political, but now involving all the three pillars of democracy - executive, legislature, and judiciary, apart from economists, intelligentsia, and common men. Enthusiasts against giving anything to the poor for their well-being and sur-vival picked it up and went to the Supreme Court of India pleading for reasonable restriction on such expenditure on the ground that it estroys state finances. Supreme Court in turn set up a panel and wanted thorough discussions on it including what constitute 'free-

Everyone has one's own idea, and due to lack of and standard defined and acceptable definition available, all the diagnosis and treatments for this ailment seem to be wrong. The latest being the State Bank of India's economic report written by the groups chief advisor Soumya Kanti Ghosh, who suggested that the Supreme Court-led panel cap such welfare schemes at 1% of the state's GDP or of its own tax collection. The report presumes even wrong definitions and facts about freebies.

For example, one can see the online dictionaries or other resources only to find there that even loans taken or given with the intention of not paying back is a form of 'freebie'. But the SBI report misleads us twice - fist by telling us that 'loan wirte-offs are purely technical in nature' and secondly 'added back to bank books once recovered.' We have already proved cases of bank frauds which tells us that 'loan write-offs' and not always technical in nature, and also that large amount always remains unrecovered and hence there is no question of added back to the books. Therefore, the report saying 'equating the haircuts with freebies or even the loan writeoffs is at best a deeply flawed arment' is wrong.

Most objectionable part of the SBI report is concerning pension to the government employees, which had been only social security for government employees in the country before the scheme was done away with in 2004 under BJP rule. In its place, new pension scheme was implemented. Even at that time the BPJ's decision shocked the nation, because people (barring the rich and BJP's rank and file and bhaktas) believed that a person who sacrifices his prime time of his life in government service must get pension as financial security in his old age. It is unethical to leave them on their own fate. Now several political parties in opposition have promised to implement the old pension scheme if they come to power.
The SBI report presumes even

the 'old pension scheme' a free-bie, a very sad approach, since old pension scheme had always been treated as social security cover-age for the old people in return for their service and sacrifice throughout their productive life. However, the report now cites the example of just three states, Chhattisgarh, Jharkhand and Rajasthan whose annual pension liabilities estimated at Rs 3 lakh crore. When looked in relation to these states own tax revenue, pension liabilities are quite high for Jharkhand 217 per cent, for Rajasthan 190 per cent and for Chhattisgarh 207 per cent. The report argued that for

states contemplating the change, it would be as high as 450 per cent of own tax revenue in case of Himachal Pradesh, 138 per cent of own tax revenue in Gujarat, and 242 per cent of own tax revenue for Punjab.

The report also mentions the unfunded pension liabilities of the state which have gone back to the old pension scheme or pay as you go scheme, or planning to do so as percentage of won tax revenue, it's a staggering 450 per cent for Himachal, 138 for Gujarat, 207 for Chhattisgarh, 190 for Rajasthan, 217 for Jharkhand and 242 for Punjab.

The report argued that the combined liabilities of these states which have reverted to the old pension scheme or have promised to do so stood at Rs3,45,505 crore in FY20 and the same will go up as percentage of GSDP of Chhattisgarh to 1.9 and increased burden of Rs60,000 crore from Rs6638 crore.

For Jharkhand it was Rs 6,005 crore and will be 1.7 per cent of GSDP and will increase by Rs GSDP and will increase by Rs 54,000 crore; Rajasthan Rs 20,761 core, 6 per cent and will jump by Rs 1.87 lakh crore; Punjab - Rs 10,294 crore, 3 per cent and will rise by Rs 92,000 crore, Himachal Rs 5,490 crore, 1.6 per cent of GSDP and will rise by Rs 49,000 crore and for Gujarat the pension burden was Rs 17,663 crore in FY20 and will jump to 5.1 per cent of GDP and will rise by 1.59 lakh crore.

Merely on the basis of expenditure the state that used the prime time of life of a person must not desert them in their old age, which makes the state inhuman It is wrong to presume that pen-sion is a freebie and should not have been added to other liabili-ties such as loans taken by state to reach at an astronomical figure to influence decision in the Su-preme Court. The report pointed out that the budget borrowings of states have reached around 4.5 per cent of GDP in 2022, because of the guarantee of the state to support its citizens. Such guarantee amount is sig-

nificant at 11.7 per cent of GDP for Telangana, 10.8 per cent for Sikkim, 9.8 per cent for Andhra, 7.1 per cent for Rajasthan, and 6.3 per cent for Uttar Pradesh, While the power sector accounts for al-most 40 per cent of these guarantees, other beneficiaries include sectors like irrigation, infrastructure development, food and water supply.

The report has quoted RBI on financial assistance, utility sub-sidies, loan or fee waivers and interest free loans announced by the state in their budgets ranges from 0.1 to 2.7 per cent of states' GDP. The freebies have exceeded 2 per cent is some of the highly indebted states such as Andhra Pradesh and Punjab

Let us remember that the RBI's recent bulletin of June has re-minded, "While there is no precise definition of freebies, it is necessary to distinguish them from public/merit goods, expenditure on which brings economic benefits." (IPA Service) Imphal Times

## 121 kg gold seized since September by **DRI** in North East corridor

Agency Guwahati, Oct 6:

The recent gold seizures in the North East by the Directorate of Revenue Intelligence (DRI) indicate a spurt in the smuggling of gold through the NE borders of Bangladesh and Myanmar.

While the porous borders have been used for smuggling in the past, 11 cases of gold seizures of 121 kg in September 2022 alone show that the NE corridor is still extensively being used by smugglers de-ploying ingenious ways of

Acting on specific intelligence and in three coordinated interceptions at Patna, Delhi

and Mumbai, the Directorate of Revenue Intelligence (DRI) seized 65.46 kg of foreign-ori-gin gold worth Rs 33.40 crore. The gold was consigned from Aizwal to Mumbai in domestic courier consignment. The gold was concealed in gunny bags declared as clothes.

In yet another case of smuggling through the same route, the DRI seized another big haul of smuggled foreign origin gold weighing approxi-mately 23.23 kg and valued at Rs 11.65 crore (approx.) which was being smuggled from Myanmar.

Specific intelligence indicated that a substantial quantity of foreign-origin gold will be attempted to be smuggled

from Champhai-Aizawl, Mizoram to Kolkata, West Bengal by carrying/concealing them in the vehicle. To interdict the contraband, coordinated action was undertaken on 28th – 29th September 2022. The DRI officers mounted surveillance on the highway connecting Siliguri - Guwahati.

Four passengers travelling in 2 suspect vehicles were identified and intercepted. After thorough rummaging of the two vehicles over a period of 2 days, 23.23 Kg gold concealed in the vehicle body in the form of 21 cylindrical pieces, was recovered. The gold in this case was cast in order to fit in the specifically made cavity inside the pipe connecting the right and left rails of the chassis behind the rear wheels and suspension in both vehicles. The recovered gold had been smuggled into India from Myanmar through the Zokhawthar border in Mizoram. Four persons have been arrested in the instant case so far.

In another 9 cases in the month, DRI recovered and seized 27 kg of smuggled gold from various carriers coming from the North-Eastern part of the country to the rest of the country. These series of detections have helped unearth a novel modus operandi of smuggling foreign-origin gold into India from the North-East-ern part of the country.

## With 2,529 fresh Covid cases, India's tally rises to 4,46,04,463; active cases at 32,282

Agency New Delhi, Oct 6:

India recorded 2,529 new coronavirus infections taking the total tally of COVID-19 cases to 4,46,04,463, while the active cases dipped to 32,282, according to the Union Health Ministry data updated

on Thursday.

The death toll climbed to 5,28,745 with 12 fatalities which includes eight deaths reconciled by Kerala, the data updated at 8 am stated.

The active cases com-prise 0.07 per cent of the total infections, while the national COVID-19 recovery rate increased to 98.74 per cent, the ministry said.

A decline of 1,036 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

The daily positivity rate was recorded at 2.07 per cent and the weekly positivity rate at 1.38 per cent, according to the ministry.

The number of people

who have recuperated from the disease surged to 4,40,43,436, while the case fatality rate was recorded at 1.19 per cent.

According to the ministry, 218.84 crore doses of Covid vaccine have been administered in the country so far under the nationwide vaccination drive. India's COVID-19 tally

had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on Sep tember 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December

The country crossed the grim milestone of two crore on May 4 and three crore on June 23 last year. It crossed the four-crore mark on January 25 this year.
The four fatalities re-

ported in the last 24 hours include one each from Haryana, Kerala, Madhya Pradesh and West Bengal

## 13 dead, several missing during Durga idols immersion in 3 separate incidents

Agency New Delhi, Oct 6:

As the five-day-long Durga Puja festival came to a close on Wednesday, the distressing news of deaths during the idol immersion (visarjan) was reported from West Bengal, Uttar Pradesh

and Rajasthan. In West Bengal's Jailpaiguri, seven people died and several were feared miss-ing after flash floods hit the Mal River during Goddess Durga idol visarjan. The incident occurred around 9.15pm when several devotees gathered on the banks. "We res-

cued around 60 people, and 15 of them have been hospitalised. Initially, two bodies were recovered but five more were found later," Jalpaiguri district magistrate Moumita Godara Basu told the local media at around 11pm.

The flash flood in the Mal river is being attributed to heavy rainfall that the state has been receiving this week. According to the Met department's forecast, the state will again receive heavy rain this weekend (on Oct 8 and 9).

In Uttar Pradesh's Agra, a 15-year-old boy and two youths aged 19 and 22 drowned in the Yamuna river

during Durga idol immersion.
No one was found in the rescue operation carried out till late evening, news agency ANI reported citing officials.

In Rajasthan's Ajmer district, a similar tragic incident occurred on Wednesday where six people drowned in a ditch filled with rainwater during the immersion of a Goddess Durga idol. All six bodies were recovered during a res-cue operation, and will be handed over to family members after autopsy, news agen-cies reported. "The ditch where the incident occurred is often used for idol immersion by lo-cals often," Ajmer Superintendent of Police Chuna Ram Jat told PTI. The deceased thought it was a shallow ditch and went down, but it was deep and they all drowned," he informed.

Similar incidents were also reported during the Ganesh visarjan that took place on September 9. At least 20 lives were lost across Maharashtra. and eight people died in

#### In talks with EC to amend electoral laws, boost transparency on donations: Law Minister Kiren Rijiju released the proposed criteria ing times and situations," Rijiju

Union Law Minister Kiren Rijiju said that the government is considering providing legislative backing to some major electoral reforms suggested by the Election Commission of India through amendments in the Representation of the People Act adding that the change in electoral laws is the need of the hour. The minister said that the Centre is in talks with the poll body as in the wake of the coming Assembly polls, the commission recently for all the political parties to clearly reveal the details of their electoral manifesto promises and the sources to fund those promises.

In an interview with TOI Rijiju said that he was having elaborate discussions with the election commission to analyze some major overhauls in the RP act and other laws to bring transparency to the electoral process.

"The government will study and take necessary measures after due consultation for major reforms to suit the changadded when asked if the election watchdog had consulted the government before floating recent proposals.

The reform suggested by the Election Commission was majorly to avoid and curb the flow of black money in the electoral process. The poll body has recently written to the law ministry to bring changes in the RP Act to cap cash donations received by parties to 20% of their total receipts.

The poll body also proposed lowering the disclosure limit of anonymous donations 20,000 to Rs 2,000.

Meanwhile, the opposition parties have reacted strongly to the proposals by the ele tion commission and said that the individual donation for the political parties is beyond the purview of the poll panel and thus, should not be amended by them.

Notably the Bahuian Samajwadi Party, despite hav ing received crores in political donations, has always claimed nil individual donations received above Rs 20 000, thus not having to name

#### India probes maiden Pharmaceuticals' 4 cough syrups linked to death of 66 children in Gambia

Agency Mumbai, Oct 6:

The Centre is investigating the deaths of at least 66 children in The Gambia that the World Health Organization (WHO) said may be linked to a cough syrup made in India, news agency Reuters quoted two of its sources from the Union health

ministry as saying on Thursday. The cough syrups have been manufactured by M/s Maiden Pharmaceutical Limited in Haryana's Sonepat, another news report stated. It further quoted its sources as saying that as per the information available at this point, it seems the firm had exported these products only to The Gambia.

WHO Director-General Tedros Adhanom Ghebreyesus on Wednesday told reporters the UN agency was investigat-ing the deaths from acute kidnev iniuries with India's drug regulator and Maiden Pharmaceuticals.

The WTO on October 5 issued a medical product alert on four contaminated medicines in Gambia. The four substandard (contaminated) paediatric medicines identified by the WHO are Promethazine Oral Solution, Kofexmalin Baby Cough Syrup, Makoff Baby Cough Syrup and Magrip N Cold Syrup.

The agency informed the Drugs Controller General of In-

dia of the deaths late last month after which the regulator launched an investigation with state authorities, in tandem with the WHO probe, Reuters quoted its sources as saying. Maiden manufactured and exported the syrup only to the West African nation, they

Reuters' calls to a listed telephone number for Maiden went unanswered as did an emailed request for comment. Calls to the Drugs Controller General of India outside of office hours also went unanswered.

The Centre has asked the WHO to share its report linking the deaths with the cough syrup and will take "all required steps

in the matter", the sources were

The WHO said in its report that the laboratory analysis of samples of each of the four products confirms that they contain unacceptable amounts of diethylene glycol and ethylene glycol as contaminants.

It added that to date, these four products have been identified in Gambia but may have been distributed, through informal markets, to other countries

Issuing an alert about the risks from using these medi-cines, the WHO said Diethylene glycol and ethylene glycol are toxic to humans when con-sumed and can prove fatal.
