# **ATSUM submits memorandum to President:** urges to intervene the passing of three Bills skipping the interest of Tribal people

IT News Imphal Oct 9:

The All Tribal Students' Union of Manipur (ATSUM) had urged the President of India, Droupadi Murmuji urging to intervene the passing of three Bills namely - Bill No. 14, the Manipur Land Revenue and Land Reforms (Seven Amend-ment) Bill 2022; Bill No.15, The Manipur (Hill Areas) District Council's (Sixth Amendment) Bill 2022 and Bill No. 16, The Manipur (Hill Areas) District Council's (Seventh Amendment) Bill 2022, stating that it violated the provisions of constitutions of India particularly Article 371 C by the Government of Manipur.

Manipur. Fourteen Tribal Ex-Parliamentar-ians comprising Ex - MPs, Ex - Min-isters and Ex-MLAs (Ex - Members of the HAC) sought the interven-tion of the President of India, Droupadi Murmuji for violating the provisions of constitutions of India particularly Article 371 C by the Government of Manipur.

In a memorandum submitted to the President on 10th August 2022, the tribal ex- parliamentarians (Four-teen Tribal Ex-Parliamentarians com-prising Ex - MPs, Ex - Ministers and Ex- MLAs (Ex - Members of the HAC) had raised serious concerns regarding the unconstitutional pro-cedures and violation of constitutional pro-visions during 2nd session of the 12th Manipur Legisla-tive Assembly. The three bills namely (1) Bill No. 14, the Manipur Land Revenue and Land Reforms (Seven Amendment) Bill 2022 (2) Bill No. 15, The Manipur (Hill Areas) District Council's (Sixth Amendment) Bill 2022 and (3) Bill No. 16, The Manipur (Hill Areas) District Council's (Sev-enth Amendment) Bill 2022 had bypassed the interest of the hill people and shifted the authority of the district council to the state government and undermined its mandate. tionally passed in the guise of Money Bill and instead of tabling the already recommended bill, the government had referred a new bill

to the HAC The ATSUM statement said that such attempts of forcefully over-looking the constitutional rights of HAC stated in the scheduled matters and directly shifting the man-date of the autonomous district council to the State Government can only be done through constitutional amendment and not by a mere State Assembly since this provision is given through Article 371 C.

It added, the erstwhile "The Manipur (Hill Areas) Autonomous District Councils Bill 2021 was unanimously recommended by the HAC following the rules of proce dure. Yet, the State Government had without any stated mandate kept the recommended bill in abeyance and introduced another bill that was not recommended by the HAC. contd. on page 4

Porn addiction is rampant today. Don't we think that parents should have more quality conversation with their children instead of keeping it bottled up. If they open up, then children feel easy to communicate with them without a fear of being judged. More and more disturbed parents and spouses have been seeking help, and there is even a growing con-cern in schools. It hurts child's spirit and infects mind with unclean thoughts. Pornography consumption is not

Recently the Central Bureau of Investigation has smashed an international child pornography racket, being run for the past two years through a WhatsApp group that had 119 members from 18 countries. Porn or no porn should be decided by the common man and not by a bunch of bureaucrats. Pornography has existed for centuries and there has been a debate about whether pornography is socially or morally acceptable but as it involves adults, there is no law that is broken. But when children are involved in sexual exploitation, pornography is openly regarded to be a heinous crime in multiple nations. Adolescence goes downhill when there are too many restrictions. When obscenity becomes a commodity, it threatens to corrode the very bedrock of ethics on which a healthy society is founded. In such cases, sex education should be made compulsory for students before they reach puberty so that they understand sex and its functionality. Many schools focus exclusively on academics, paying little attention to effective counseling of adolescents. There has to be a policy to reduce the focus in the arran of sex in general if our women and children are to be protected globally. At an individual level, pomography addiction, including 'cyber pom addiction' is one of the most notorious problems associated with pornography use today. Child pomography is a real and pressing problem that exists on local, national and international levels. Child Protection Act, 2012 provides protection to children from sexual assault, harassment and pornography. In this Act, Section 13 makes use of children for pomographic purposes a criminal offence that can lead to being jailed for up to five years. The world of internet and social media appeals the child a lot and because of this young mind does not give a second thought on the dark side of that world. With the internet making its way into phones, people now don't even care about who is sitting next to them. The government has already told the Supreme Court that there cannot be a complete ban on Internet pomography in the country and legal actions are also not possible in a large number of cases. The only way out is for parents to spend their free time interacting with

their children instead of watching boring television soaps. The influence of cinema and television on our impressionable youth cannot be under estimated. There are so many other movies that have explicit scenes bordering on soft There are so many outer moves that have explicit sectors bottering on soft porn. At times, there are even advertisements for safe sex or use of condoms which depict young girls and boys. We all know of scientifically proven bad effects of porn films. They tear families apart, objectify women and pollute children's mind. Today the children addicted to pornography brings about various changes in values, attitudes, development and also gives rise to unwanted health issues. There are children who use to take money from their parents saying that need to download some study material from Internet to complete their homework, but instead spend them watching porn clippings at the cafes. It is a part of socialization seems to be a difficult proposition to accept as it is a by-product of child sexual abuse. It has become very important that as it is a by-product of child sexual abuse. If has become very important that people talk about child pomography so as to raise awareness of the implica-tions of such crimes in our society. Peer pressure is also a cause of child pomography. It is high time that child pomography is dealt with separately. Children being weak, gentle and meek should be protected from the world of priminely endergoet use and an experimentation of the second second

of criminals, shady people, and negative people and so on. These vulnerable kids fall prey to the predators of child abuse, child trafficking, child pomogra-phy etc. Sex Education today is both timely and apt as the importance of sex education cannot be overemphasized. Unfortunately, we do not take sex edu-cation seriously because there exists a huge communication gap between the political leadership and the scientific community. Schools are ideal places where students can get answers to basic questions on sex. With teenage pregnancies and abortions on the rise, and an increase in the number of those affected by AIDS, sex education for children is a must. Because of the conservative culture that exists in our society, children find it difficult to discuss sex with their parents or teachers. Due to lack of information and the cultural barrier, many of them become easy prey of pedophiles. It is necessary to prevent children from learning from bad peers and obscene books about sex. A holistic approach should be adapted to sex education by making available standard textbooks on the Internet for the middleclass children also. Banning pornography is not a solution. Sex education would help students develop personal values and understand interpersonal relationships as they explore their own sexuality. When sexual abuse comes from all quarter's viz. relatives, colleagues and strangers, it is mandatory to teach the children how to overcome and protect them-selves from such contingencies than about sex.

There is also an urgent need to keep the young informed of the measures to protect themselves against sexual exploitation. Effective counseling as an in-clusive aspect in schools will lead to the overall wellbeing and healthy development of the child. Participatory sex education will provide the impetus for discussion and discourage prejudices. Academicians and policymakers should evolve a syllabus that is relevant to the changing times. The hesitation to discuss sex in open classrooms can be overcome if women teachers teach girls and male teachers educate boys. Other schools in the city should make sex education part of the curriculum to avoid such misinformation and restrict child abuse. There must be a check on their activities by the parents while using net. They must also be made aware of the pros and cons of the high tech modern world and social media. It is important to develop an understanding of the problem so that laws are made and implemented to curb child pornography and the rights are given to children are actually practiced. The Indian cyber law needs to be amended and made more effective to curb access, use, transmission and publishing of porn. Also, cyber education and etiquette need to be inculcated in school curriculum to sensitize children about the huge porn con-tent available and how they should protect themselves from it. People should be educated to note the behavioural changes of the children and find out the reasons for abuses to save the child from trauma which may be prolonged. Sex education as a part of curriculum will create awareness and a healthier India.

Even though Manipur Chief Minister Nongthombam Biren and some of his cabinet colleauges boldly said in public many times that the state govemment remains firm on its decision to partially lift prohibition and will not step back from pressures, the pro-prohibitionist groups led by Coalition Against Drugs and Alcohol (CADA) and All Manipur Women's Social Reformation & Development Samaj, popularly known as Nupi Samaj continue to mount their pressure on Manipur Gov-ernment to roll back the Cabinet decision by holding sit-in-protests and ral-lies at various places. The cabinet of Bharatiya Janata

Party government led by Chief Minis-ter Nongthombam Biren on September 20 approved a proposal for partial lift-ing of the prohibition and regulating selling and brewing of alcoholic liquors in Manipur, besides opening of licensed outlets of Indian Made Foreign Liquors (IMFL)/Foreign Made Foreign Liquors (FMFL). Manipur became a dry state with effect from April 1, 1991 after the enactment of the Manipur Liquor Pro-hibition Act, 1991.

Next day, September 21 condemn-ing the state cabinet decision to lift the prohibition, the Coalition Against Drugs and Alcohol (CADA) demanded the government to immediately revoke the cabinet decision. Such a move of the state government to benefit some allied entrepreneurs will lower the morale and character of the youths, especially women, besides creating health issues in every family across the state, CADA Secretary General Geetchandra Mangang said while speaking to the media at CADA office in Imphal East.

He also questioned, "Will anything which is uncontrollable be legalised? Is the government also going to legalise drugs, corruption and prostitution which is uncontrollable?

"We demand a white paper from the government so that the public may discuss the merits and demerits of lifting the prohibition on selling and brewing of alcoholic liquors. But Manipur Government failed to respond to the demands," Geetchandra said, adding

that the protest will continue. Moreover, Nupi Samaj demands that the Manipur Government must review the cabinet decision that was taken to legalise brewing and selling of liquor. Leaders of Nupi Samaj warned of intense forms of agitations. Address-ing reporters at its office in Imphal Sep-tember 22, Nupi Samaj president Th Ramani cautioned that women in the state will hunds were form a form state will launch various forms of intense agitations if the state government fails to review the decision. She alleged that over 40 years of campaign by women against liquor and abuse of drugs went in vain by that decision of th

government. Ramani said that the government had taken the decision by sidelining the long struggle of women against li-quor to save the society. "The Chief Minister must immediately review the decision", she added. "If no positive response comes forth from the gov-ernment, the Nupi Samaj is ready to launch various forms of intense agitations along with like-minded civil soci-ety organisations," she also said. The decision to lift the prohibition showed that the government sees only the revenue to be generated and not the negative impact being given to society, Ramani alleged.

As declared by Nupi Samaj and CADA, Sit in Protests and rallies by Meira Paibis in protest against the Manipur Government's decision lifting total prohibition on selling and brewing of alcoholic liquors in Manipur have been continuing from September 23 in various parts of the state till to this day. While CADA, Nupi Samaj and

other organisations are demanding to revoke the Cabinet decision to partially lift prohibition of selling and brewing of alcohol liquor, Chief Minister Nongthombam Biren remains firm. Besides sale and distillation of local brew and IMFL in selected spots, he is now talking of establishing "a beer factory based on pineapple and ginger in Manipur"

Reiterating that the Cabinet deci-sion to lift prohibition on sale and consumption of liquor from the State was taken after holding thorough discussion and taking recommendation from committees formed earlier in this regard, Chief Minister Nongthombam Biren and some of his cabinet colleagues have said the Government has taken this step considering health issues of many people who are suffering from liver cirrhosis and other diseases due to drinking of spurious alcohols be-sides claiming revenue collection of Rs. 600 to 700 Crore annually from the distillation and sale of local brews

However, amid Nupi Samaj's ultimatum to launch intensified forms of agitation instead of democratic agitations from October 11 if the state government fails to make a response on whether the cabinet decision will be withdrawn or not by October 10 and the stand of CADA that they will not meet the government until a white paper on lifting prohibition is produced by Manipur government, a "DRAFT Manipur Liquor Regulation Policy" has

gone viral on social media on October 4 evening followed by another docu-ment entitled "General Public Information". Both the documents didn't have any official authentication.

Meanwhile, the CADA on October 6 has rejected the DRAFT Manipur Liquor Regulation Policy 2022 issued by Manipur government after receiving the same in the evening on Octoher 5 with a letter from Chief Minister's Office stating that it demanded a 'White Paper' and hence, it will not meet with the government until it produces a white paper but will instead support any form of agitation initiated by the Nupi Samaj.

Addressing the media at its office located at Pureiromba Khongnangkhong in Imphal East, Sec-retary General of CADA, Geetchandra Mangang said that the draft copy of located Pureiromba 'Manipur Liquor Regulation Policy 2022' will not be considered as white paper that CADA has been demanding from the government. Geetchandra said a white paper should include pros and cons on legalisation of liquor and should elaborate the queries made by the public including how the government is going to control the situation after liquor legalisation is implemented.

CADA demanded that before issuing even a draft policy, the government should make a declaration that the government has failed to ban liquor in the state under Manipur Liquor Prohibition Act, 1991 as background of the white paper. Research data should be included in the white paper highlight-ing health problems as said by the gov-ernment, social problems, cultural norms, crime, economy and others in order to convince the public, he added.

Moreover, the present issue on liquor legalisation has been a major is sue in the state whereas the draft copy sue in the state whereas the draft copy has only two pages without elaborat-ing any of the points, he said and al-leged that the draft copy was issued by the government in order to distract the people from the movement carried

against liquor legalisation. The two-page 'DRAFT Manipur Liquor Prohibition Policy' mentioned that the aims and objectives of the Manipur Liquor Regulation Policy are to work towards: (a) Eradication of distillation, transportation, possession, consumption and sale of illicit liquor. (b) Restricting the availability of local liquor as well as IMFL (Indian Made Foreign Liquor)/FMFL (Foreign Made Foreign Liquor); (c) Reducing the impact of illicit and adulterated liquor on health; (d) Reducing the demand of intoxicating drinks; (e) Address the menace of illegal drugs; (f) Generating em-ployment, and (g) Generating revenue of the state; (h) Address the problem of the state, (ii) Address the problem of the black market in liquor on account of 'prohibition'. For each of the aims and objectives

of the "Manipur Liquor Regulation Policy", some action plans are stated

in the two-page "policy". The government also issued a draft

copy of "General Public Information" consisting of 10 points which included that every retail outlet should invariably display in bold letters that "CON-SUMPTION OF ALCOHOL IS INJU-RIOUS TO HEALTH AND DON'T DRINKAND DRIVE". It stated that sale of liquor to per-

son below 25 years is strictly prohib-ited and liable to be prosecuted and punishable under Rule 351 (C) of the Draft Manipur Excise Rules, 2022; production of Government issued identity card is mandatory when demanded; no retail vendor can be located within 100 meters of educational institutions religious places, hospitals etc., under Rule 289 of the Draft Manipur Excise Rules, 2022

The draft copy further stated that employment of any person below the age of 25 years in liquor vendor is a punishable offence under Rule 351 (C) of the Draft Manipur Excise Rules, 2022; drinking liquor in public places attract a fine of Rs. 5000/- with minimum of 24 hours imprisonment along with relevant punishable offences under Section 501 of IPC r/w Rule 351(B) of the Draft Manipur Excise Rules, 2022.

Drinking and driving under the in-fluence of alcohol is a criminal offence and punishable under Section 279 of IPC r/w Section 510 of IPC, the draft warned, adding that driving a motor vehicle in a drunken state if found with Blood Alcohol Level (BAL) exceeding 30 mg of intake per 100 ml of blood detected with the help of a Breath analyser is punishable under Sec. 185

of the Motor Vehicles Act, 1988. However, Geetchandra on October 6 told to the media that the CADA is not against the government but it is ready to meet with the government only after the government produce a white paper in order to convince the people on liquor legalisation, adding that the draft copy was made without the con-text and CADA will not comment on the draft copy until a white paper is produced.

As pointed out by the CADA. As pointed out by the CADA, Manipur Government fails to give the background or context of prohibition of alcoholic liquor in Manipur from which a positive and clear aim and object of the policy should emerge, and other issues relating to brew, sale or use alcoholic liquors by whom, where and how etc are derivative matters

Now, what it can be drawn from the different positions and actions shown by Manipur Government and pro-pro-hibitionist groups led by CADA and Nupi Samaj is that there is no a com-mon understanding of the situation yet before considering to resolve the con flict between Manipur Government and pro-prohibitionist groups on prohibition of alcoholic liquor

loyalty, kindness, integrity, compassion and selflessness in students. When they are able to link their learning experiences to the real-world, they get clearer sense of purpose and the teachings remain with them.

Whether one is teaching Maths, Science, or History, values can be inculcated while talking about themes within each subject. History can help students learn about equality, liberty, patriotism, secularism. The sciences can be a medium to instill compassion towards nature and a scientific temper. Geography, for instance, can teach how to respect other cultures and ethnicities.

Developing an education system with values at the core will create students who are good global citizens., who are compassionate and caring, who work collaboratively to solve problems and have the resilience to face any uncertainties life may bring.

# EC freezes Shiv Sena's "Bow & Arrow" symbol ahead of Andheri by-poll

#### IT Correspondent Mumbai, Oct 9:

The Election Commission of India (EC) on Saturday freezed Shiv Sena's "Bow & Arrow" symbol ahead of Andheri bypoll slated to be held on Novem-ber 03 to fill the vacancy caused by the demise of Shiv Sena MLA Ramesh Latke.

The Shiv Sena has fielded Latke's spouse Rutuja, while BJP has fielded BMC's former Corporator Murji Patel, who was disqualified from corporatorship by the Bombay High Court in April 2019 for his failure to submit caste certificate in support of his claim that he belonged to the Other Backward Class. The last date for filing nominations is October 14.

The breakaway group led by Maharashtra Chief Minister Eknath Sinde has not fielded separate candidate, but has approached EC demanding that the Uddhav Thackeray faction be refrained from using "bow and arrow" symbol. Similarly, the Maharashtra Election Commission had sought clarification from the Election Commission of India about the status of both the factions

On Saturday, the EC passed an interim order directing both the Thackeray and Shinde fac-tions not to use the name "Shiv Sena" or the symbol "bow and arrow" in the Andheri East

"It is crystal clear that the complaint about the divide and rule among the hill people by Indian rule remain as hin-drance to our unity", the Chairman said. He added that both hill and plain people have to sit down together and discuss about this matter. On

"As the adage goes "The first impression is the last impression", the events such as the Annexation in 1949, the humiliation of constitutional monarchy with demoted Part-C state, swift repeal of the Permit System, and utilization of teensy development funds of about Rs.1 Crore in the First Five Year Plan (1951-56) illustrate the premeditated India's anti-Manipuri mind-sets. But most importantly, I must say that their arrogant and expansionist policies had ignited the anti-India armed struggle.

"Over the course of 28 years from 1951 to 1974 and 1980 to 1985, India had allowed Manipur to utilise around Rs.301 crores from the plan outlay. It is ludicrous that the cumulative development fund over the period of 28 years was below the yearly monetary loss of about Rs.400 crore in terms of agricultural products due to the submergence of arable fer-tile lands induced by the Loktak

project. "Even during British rule, it was estimated that Manipur's yearly agricultural surplus was around 25%. However, since the Ithai barrage inundated around 80000 hectares of fertile arable land. Manipur has been surviving on food import. be recognized by Commission and give three options of names in order of preference, anyone of which may be approved by the Commission and (ii) The symbols which may be allotted to the candidates set up, if any, by the respective groups. They may indicate the names of three free symbols, in the order of their preference, anyone of which may be allotted to their candidates by the Commission"

Ironically the EC continued to refer the Shiv Sena as :a recognized Party in the State of Maharashtra" in its deliberations. Shiv Sena MP Arvind Sawant said that lakhs of affidavits sup-

porting "original Shiv Sena" have been filed before the EC. It is surprising how the EC can decide the matter within four hours even without verifying the documents already filed. Deepak Kesarkar of Shinde faction said that this is a temporary order and his faction will eventually win the battle.

The Congress and the NCP have decided to support the candidate of the Thackeray faction of the Shiv Sena, their coa-lition partner in the Maharashtra Vikas Aghadi (MVA).

Shinde had raised a banner of revolt against Thackeray for entering into an "unnatural alli-ance" with the Congress and NCP. More than 40 of the Shiv Sena's 55 MLAs had supported Shinde, forcing the resignation of Thackeray from the post of Maharashtra chief minister on June 29. The dispute is pending in the Supreme Court

# India adds 2,797 Coronavirus infections, Active cases drop below 30K after 122 days

# Agency New Delhi, Oct 9:

India added 2 756 new coronavirus infections taking the total tally of COVID-19 cases to 4,46,12,013, while the active cases dipped to 28,593, according to the Union Health Ministry data updated on Sun-

day. The death toll climbed to 5,28,799 with 21 fatalities which includes 16 deaths reconciled by Kerala, the data updated at 8 am stated.

The active cases comprise 0.06 per cent of the total infections while the national COVID-19 recovery rate increased to 98.75 per cent, the

A decline of 658 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

ministry said.

The daily positivity rate was recorded at 1.15 per cent while the weekly positivity rate was recorded at 1.28 per cent. according to the health ministry. The number of people who have recuperated from the dis-ease surged to 4,40,54, 621, while the case fatality rate was recorded at 1.19 per cent. India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19.

The country crossed the grim milestone of two crore on May 4 and three crore on June 23 last year. It crossed the fourcrore mark on January 25 this year.

According to the minis-try, 218.97 crore doses of Covid vaccine have been adminis-tered in the country so far under the nationwide vaccination drive. The five new fatalities reported in the last 24 hours include two from Maharashtra and one each from Delhi, Tamil Nadu and West Bengal.

Despite the promises of a few decep-tive socialist programs under the election agenda, India is now becoming an Oligarchy.

"During the pandemic, In-dian billionaires doubled their wealth to Rs. 57.3 lakh crore. Eleven Indian billionaires amassed enough wealth amid pandemic which can cover the health budget or MGNREGA for 10 years. China has made a significant contribution to alleviating poverty around the world, while India has raised poverty levels by 57% in the last two years. Paradoxically, forty Indian billionaires were listed in World Billionaires Club during the second wave of Pandemic while the crematoriums were overcrowded with death bodies.
