## Students demand for resignation of Education Minister and Commissioner rising up

"Police foils protestors attempt to storm at the office of the Education Minister"

IT News Imphal, Jan 12:

With the state government authority giving no response to the demand for resignation of Education Minister and Commissioner of the Government of Manipur, large number of students of the GP Women College today staged protest and marched towards the Education Minister, Th. Basantakumar, at Secretariat complex here in Imphal today afternoon by carrying banners and placards by shouting slogans expressing their grievances.

The students also demanded appointment of regular Registrar, Finance Officer, and Controller of Examination of the University.

The girl students from the GP Women College were however stopped and disperse by a strong team of Manipur police before reaching the secretariat complex. There are no reports of any students being injured in police action.

Failure to comply with the rules and regulations that has to be followed by the DM University authority was established under Dhanamanjuri



University Act, 2017 and came into force on April 6, 2018, the University Grant Commission, Six student Organisations of Manipur including, MSF, DESAM, KSA, SUK & AIMS have demanded the resignation of Education Minister Thounaojam Basantakumar and Commissioner of Higher and Technical Education Gyan Prakash on moral ground

Earlier, a peaceful protest was staged inside the DM University complex. The student bodies are agitating over nonsending of the list of bonafide teaching and non-teaching staffs to the University Grants Commission. Thus as a matter of fact, the University is yet to be qualified for the acquisition of 12 (B) status of UGC as per the provisions of UGC 1956 Regulation without which the University cannot be recognised as a full-fledged University. As a result of not acquiring 12 (B) UGC status, DM University is consequently not qualified to acquire funding and overall development support. Moreover, the JRF holders, NET

qualified and non-NET PhD Research Scholars have been denied of their rightful access to scholarships and relevant stipends.

stipends. Meanwhile, a Special General Body Meeting of D.M. University Teachers' Association (DMUTA) held today morning at DM College of Arts Auditorium has resolved to Re-endorsed the suspension of Post-Graduate teaching and Pre-Ph.D. Course work; Re-endorsed the perusal of 12(B) status for DM University so as to make DMU

a full fledged University and to ensure timely release of scholarship and stipends for JRF, NET & Registered Ph.D. Scholars in D.M.U.; Re-endorsed the demand for placement and promotion of bifurcated teachers of DMU through D.M. University authority; The members resolved to continue with their demands and fully extend support to the line of action as to be undertaken by DMUTA, Imphal unless the Resolution as adopted in 1,2 and 3 are concretely addressed by the concerned authority.

## Ensure freedom to the 'Freedom of Speech and Expression'

Every learned citizen know that the executive, the legislature and the judiciary, which are the three vital organs of the government have separate functions and powers, and one organ does not interfere in the functioning of the others. In order to ensure that one organ abuses their power and does not become all too powerful, there is a doctrine in the Constitution called - Checks and balances. The unfortunate part is that there is no such provisions specifically mention for the media, which they always called – 'the fourth pillar'. Even though there are provisions that ensure freedom of speech and expression for all citizens. The non inclusion of 'press freedom' was justified by Dr. Ambedkar, the chairman of the drafting committee of the Constitution of India saying that — 'no special mention of the freedom of press was necessary at all as the press and the individual or a citizen were same as far as their right of expression was concerned. Perhaps, Dr. Ambedkar was right. Had there been any specific provision for 'press freedom' in the constitution, media may not be able to act as an effective organ of the society that can points fingers at the crumbling of the 'checks and balances' of power between the three vital organs running the government.

It's a fact that since human civilization evolved 'media' has always acted as the nation's conscience. It is today and will continue to be the nation's conscience. But what is concerned is that – Is our media on the right track reflecting the true picture of our society and the nation

Forget about the media around the world or in other state of India, the things that is worrying is whether journalists working in media in this small state of Manipur on the right track. Has today's journalists in Manipur able to points and provoke the authority to act to the crumbling relationships to the separation of powers between the executive, the legislature and the judiciary. What has gone wrong with those in media of today's Manipur? Yes, something is seriously wrong with the media in Manipur.

It is not because they are not paid well, but their pens have now been controlled by either the legitimate state authority or by non-state actors who are now under the controlled of those running the state. Today, future of Manipur's journalism sees no light at the end of the tunnel.

Judiciary – one among the three vital organ of our democracy is slowly losing its dignity with man in power dishnouring High Court order. For example, one Dr. L. Ranjit whose appointment as

For example, one Dr. L. Ranjit whose appointment as in-charge director of RIMS has been quashed by the High Court of Manipur continue to remain in the post and another top official of MSPDCL whose service extension has been quashed by the High Court was again re-engaged by a cabinet decision of the state government.

For expressing this, there may be intimidation to this writer through any means, or perhaps, may face the fate of Sr. Journalist Ningombam Hemanta, who was recently picked up from Home in connection with his comment in a TV discussion programme.

Some half cooked pseudo-intellectual often criticized resource citizens or even journalists as if they understand more the Freedom of speech and expression guaranteed under Article 19 (1) (a) and (2) of the Indian constitution. These pseudo-intellectuals seem to forget that violation of Article 19 (2) by any individual can be booked and convicted. No journalists in the state have violated this provision of the Indian constitution and non have been arrested and convicted under this provision.

Journalism is not only about reporting the development part. Rather it is about finding the wrongs in the process of development. There are lots of funds that can be utilized for publicity of every project to make sure that the development works taken up by the government reaches to all the public. Report about irregularity in taking up government project does not amount to violation of the Article 19 (2) of the Indian constitution.

As a student of journalism, we were/are taught that "Editorials condemn the venality of politicians and corruption in office. If there is a political or social controversy, media should have opinion one way or the other". The preconception idea of some people including po-

litical parties, that journalist can be bought and used should be immediately defied.

# Service extension of retired government employees irked ex-parliamentarian

Ex-parliamentarian B.D. Behring had showed serious concerned to the service extension of retired government employees when the government had taken stand not to it.

B.D. Behring, a former member of the Rajya Sabha and also a former member of the Manipur legislative Assembly, while talking to Imphal Times over phone said that he is not satisfied with the way that the state government is either extending or re-engaging retired government officers when there is an order issued by the Manipur Government in the past to not allow re-appointment or re-engage-

ment of retired employees. The former parliamentarian however demanded clarification on whether the order has been changed or not.

In a written statement, the former parliamentarian, B.D. Behring said, "It is the norm for a government employee to retire from their job after reaching 60-65 years of age and consequently make way for the next employee in line to succeed them via promotion".

However, in Manipur, there have been many cases wherein the retired employee extends his/her service by six months and so forth which stops the next senior-most employee from getting his/her due promotion which must have resulted in many senior

employees retiring before getting promoted, Behring added.

The ex-parliamentarian statement comes amidst government decision to re-engage or extended the service of some top government employee.

Earlier, spokesperson of

Earlier, spokesperson of the government headed by N. Biren Singh had stated that employees dealing technical related work may be extended if there are non to replace him as per qualification and experience. However, even after having more number of qualified engineers the state cabinet had recently re-engaged a top officer of the power department when there is already a court order quashing his extension earlier.

called millets. Now the craze for these coarse grains is increasing across the world. On India's proposal, the United Nations has declared 2023 as the International Year of Millets.

On India's insistence, the United Nations General Assembly adopted a resolution in April 2021, after which 2023 was declared the year of millets. ## India's 'sinking town'-Joshimath

Joshimath is the gateway to fa-mous pilgrimage sites like Badrinath and Hemkund Sahib and international skiing destination Auli.It is the winter seat of Lord Badrinath, whose idol is brought from the main Badrinath temple in Joshimath to the Vasudev temple every winter. Joshimath is an important pilgrimage center for Hindus. The unfolding disaster in Uttarakhand's historic town of Joshimath shows why the section of the Himalayas in this state is extremely fragile. Joshimath, located in a fragile

geological terrain, is dogged by construction, growing population, tourism and other human-driven pressures without adequate precautionary counter-measures, scientists and citizens seeking environment-friendly development. It is a weighty reminder that we are messing up with our environment to an extent that is irreversible. The Shankaracharya Math in the city has also developed cracks at many places, posing a threat to the Math. According to the expert report, Land subsidence in Joshimath is primarily due to the National Thermal Power Corporation's Tapovan Vishnugad Hydro Power Project and is a very grave reminder that people are messing up with the environment to an extent that is irreversible. Joshimath is a clear example of what one should not do in the Himalayas. The number of devotees in Char Dham towns was 24 lakh in 2017 and nearly doubled to 45 lakh by 2022. The burden on two major hill stations, Mussoorie and Nainital, is also increasing. With the exception of the two seasons affected by the Covid pandemic, there has been a significant increase in the number of tourists visiting these tourist destinations,

Prime Minister Narendra Modi has assured all possible help to save Joshimath. As per the reports, concerns about subsidence in Joshimath date back for decades. A scientific panel had in 1976 underscored that Joshimath is situated "on an old landslide zone and is sinking" and recommended that heavy construction be banned in the area.

In the year 1970 also incidents of land subsidence in Joshimath were reorted. A panel set up under the chairmanship of Garhwal Commissioner Mahesh Chandra Mishra had submitted a report in 1978, saying that major construction works should not be carried out in the city and the Niti and Mana valleys as these areas are situated on moraines — a mass of rocks, sediment, and soil transported and deposited by a glacier. There have been numerous climate risk events recorded like high rainfall events triggering landslides

It has taught us how an awakened Eastern Naga who was kept in a political amnesia for six decades woke up to stand upright to claim what belongs to him-"The Rights". This movement revealed hidden 'class system' in Nagaland which became successful in creating a modern 'Political Caste System' in last six decades where Man from the Eastern Nagaland has been thrown at the very bottom of the political system without any scope to reach political equality. This movement taught us the unity among 'broken and forgotten people'. This movement taught us as to how some leaders are men of iron solid integrity who cannot be bought and sold. This movement taught us as to how strong willed women leaders can lead the movement fearlessly. This movement also taught us as to how and why the honest leaders and the concerned people of the movement should protect the sanctity and purity of people's movement from the cruel eyes and evil designs of "JUDAS ISCARIOT" type characters.

Frontier Nagaland Movement is willing to write a new story in the

history of the Nagas through struggle and determination. Eastern Nagas have chosen the light. It is Nagas have chosen the light. It is easy to embrace darkness but diffi-cult to choose the light. When Eastern Nagaland was 'troubled' and 'harassed' left and right, mainstream Naga organizations kept mum, when money from Delhi never seen the door sill of the Eastern Nagaland, not a single main-stream Naga organization raised a voice, when government employees refused to remained in their stations in the eastern region, all closed their eves, when doctors-nurses-teachers disappeared from their jobs in various locations at Eastern region, Nagaland ignored, when Free Movement Regime (FMR) was becoming super-hot spot of Drugs movement & gun battles and an international highway for Human Trafficking. Kohima chose to tie "Black Cloth Bandage" on its eyes exactly like "Dhritarashtra" in "Mahabharata". Major problem in India is that there are hardly handful of people who understand "Nagaland and the Nagas", also, in Nagaland the epic problem is nobody understands Problem is nobody understands Eastern Nagaland and the Eastern Nagas. As I started openly advocat-ing the need for "Frontier Nagaland" many interesting devel-opments started happening around me. Many so called wise souls among friend circle advised me to not to jump on the conclusion 'too fast'. It is very convenient to offer suggestions, isn't it? However, all such comments came from people who never ever step out of Dimapur or Kohima to reach the eastern lands I do not respect intellectuals or who-ever, who have no courage or guts to dig out the truth with their own hands and brain. People who discover truth speaks different lan-

guage.

There is no legal, constitutional to deter Eastern Nagas to achieve their goal- The Frontier Nagaland however, they have to be very careful. Jealousy, lust for power, eye on political mileage and hunger for fame will ruin the GOD driven Movement. Wisdom does not come from sky, it has to be inculcated, and this wisdom will only save our Eastern leaders belonging to different tribes from falling prey to the traps of political, economic lust.

Frontier Nagaland Movement is certainly not a movement for 'backward' people who are enjoying stable, steady, prosperous life in Dimapur, Kohima or any other de-

reloped region in Nagaland.

## Bombay High Court lifts a ban on the Manufacture and Sale of Johnson & Johnson's Baby Powder

By Raju Vernekar Mumbai, Jan 12:

The Bombay High Court on Wednesday set aside the orders of the Maharashtra Food and Drug Administration (FDA), restraining Johnson & Johnson Private Limited from manufacturing baby powder at its facility at Mulund in North East Mumbai

petition filed by Johnson & Johnson challenging the cancellation of cosmetic manufacturing license of its baby pow-der facility by Maharashtra

The petition pointed out that the Joint Commissioner & Licensing Authority, FDA, Maharashtra had issued an order on September 15, 2022 cancelling the company's li-cense, effective from December 15, 2022. Five days later, the commissioner reviewed the order and directed the company to stop manufacture and sale of the baby powder manufactured at its Mulund plant with immediate effect

On Wednesday, a division bench comprising Justices GS Patel and SG Dige allowed the sale of product after noting the submission of Johnson that of the 11 to 12 samples of the baby powder tested by the FDA, only two were non-compliant with the concerned quality standards. The Court also noted that there was delay by FDA in taking action after the test results had come in 2018. The Court also questioned how non-compliance of a particular batch and deviation from a standard quality, can lead to shut down of all manu-

facturing activities.
In its order dated Novem ber 18,2022, a division bench comprising Justices S V Gangapurwala and S G Dige, had directed the FDA to send fresh samples of the baby powder to three laboratories for testing. It also agreed to FDA's demand that the sale or distribution of the baby pow-der should not be permitted for the time being. As per the order the samples were tested in three different laboratories.

Background

The action against the company began when the FDA tested the samples of the powder at its laboratories in Pune and Nashik on December 20, 2018 and June 27, 2019 respectively. The Govt Analyst, FDA, Maharashtra issued a report stating that "The sample does not conform to IS5339: 2004 concerning the test for pH". Then the FDA sent samples to the referral laboratory-Central Drugs Laboratory (CDL), Govt of India, Kolkata, which confirmed the report.

However the J & J chal-lenged the decision of the FDA to send the samples to

Then the FDA referred the samples to the Central Drugs Standard Control Organisation (CDSCO), West zone, which too confirmed the report of Govt. Analyst. As such the Maharashtra FA issued a final report stating that "the sample does not conform to IS5339: 2004 concerning the test for pH".

## ECI committed to free, fair and inducement-free elections in Tripura: Rajiv Kumar

The Election Commission of India (ECI) on Thursday said it is 'committed and duty bound' to conduct free, fair, and inducement-free elections

in Tripura. Chief Election Commissioner Rajiv Kumar said the ECI has taken all arrangements to allow voters to join the 'festival of democracy' and if a voter faces any threat or intimidation on the day of polling, he or she can use cVigil app to inform the election authorities.

"We had an in-depth discussion on the election pro-cess with the Chief Secretary, DGP, representatives of politi-cal parties, DMs, SPs and enforcement agencies for two days. The election commission is committed and duty bound to conduct free, fair, violencefree and inducement-free election", Kumar said at a press conférence here

Assembly elections in Tripura are due in February-March this year.

"All political parties will have to inform the voters about criminal cases if any of their candidates", he said. The CEC said each polling

station will have a micro observer to ensure free and fair elections. Tripura has 3,328 polling stations.

Kumar said security personnel will be engaged in poll duties on the basis of random-

ization to ensure impartiality. The CEC said there will be a three-ring security arrange-ment from polling station to guarding strong rooms with CRPF manning the first layer of security. The Centre has already sent 100 companies of security personnel to Tripura for the Assembly election.

"DEOs and SPs were asked to provide level playing ground to all the political par-ties during the election process", he said, adding webcasting will be done in all the polling stations without any failure.

Kumar, who arrived here on Wednesday along with two other Election Commissioners said that the banks and RBI will keep a close eye on the movement of cash in bulk. Besides, close vigil will also be kept at the airport.

To a specific question on the law and order situation, Kumar said, "We had detailed meetings with top security officials and central agencies. It is very reassuring and ex-tremely reassured. They all are on duty and serious. I am confident they will deliver. If there is any laxity or negligence, ap-

propriate steps will be taken". Earlier, the full bench of ECI held separate meetings with representatives of political parties and sought their views on the election process.

CPI(M) state secretary Jitendra Choudhury said the party has submitted a memorandum before the ECI full bench urging it to take all possible steps for free and fair elec-

"A sizeable number of electors could not cast their votes after 2018 Assembly elections be it Lok Sabha, civic bodies and last year's by-elections to four Assembly constituencies We categorically urged the ECI team to ensure voters could exercise their voting right without any violence, threat and intimidation", he said.

At the meeting with the ECI team, Congress MLA Sudip Roy Barman also de-manded free, fair and impartial elections. "We requested the ECI team to take all possible measures so that the people could exercise their democratic rights without any threat or intimidation", he said.

BJP vice president, Ashok Sinha, who met the ECI team also advocated for free and fair Assembly elections.

"We met the visiting ECI team and urged the poll panel to conduct the election free, fair and peacefully", he added.
